BACKGROUND:

1. On July 16, 1991 (the "petition date"), each of the
Debtors filed a petition for reorganization under Chapter 11 of

Category E: "Executory Contracts" - These are claims that appear to have been filed in anticipation that the Debtors would reject executory contracts or unexpired leases. The Debtors are moving to expunge these claims on the ground that the subject executory contracts or leases have been assumed by the Debtors and will be paid in accordance with the terms of the contracts pursuant to the Second Amended Plan of Reorganization.

Category F: "Parties to the Subcontractor Agreement" - These are claims that appear to have been filed in anticipation that the executory contract of the Debtors might be rejected or that the plan of reorganization would not be confirmed. As a result of the court authorized assumption of the subcontractor agreement and the confirmation of the plan, these creditors will be treated in accordance with the terms of the subcontractor agreement dated September 6, 1990. Therefore, these claims should be expunged.

Category G: "Disputed Contractor Claims" - These are claims by contractors which the Debtors dispute. The disputes are based upon failure to perform, defective workmanship, failure to perform in a timely manner and other material breaches on the part

of the contractors. The Debtors reserve their right to object to these claims on any grounds available under applicable law.


Category H: "Employee Claims" - These are claims made by employees for wrongful termination, or in some cases for personal injury which the Debtor disputes. Some of these claims are subject to arbitration and others must be expunged and/or reduced, or their priority challenged in this Court.

Category I: "Bondholders' Claims" - These are claims apparently filed by bondholders who were not required to file claims pursuant to the "Order Pursuant to Rule 3003(c)(3) Setting a Final Date for Filing Certain Proofs of Claim and Interest," the allowance and treatment of these claims are governed by the terms of the Plan of Reorganization.

Category J: "Miscellaneous Claims" - This category includes claims which are not subsumed within prior categories. It includes certain "class action" claims against the Debtors that have been settled, as well as other miscellaneous claims.

9. The Debtors have filed this motion at this time because the Plan of Reorganization may be interpreted as requiring the Debtors to pay in full on the effective date any creditors making a claim for liquidated sums if the claims have not been disputed by the Debtors as of the effective date. Therefore, the Debtors have undertaken to file the motion with respect to all such disputed claims prior to the effective date which is anticipated to be October 4, 1991. As a result of the time



You are free to make a similar request on appropriate motion. The hearing may be continued or adjourned from time to time by oral notice given at the hearing without any further notice to you.

The Debtors may have objected to your claim on more than one ground. Therefore, your claim and the reasons for its expungement or reduction may appear more than once on the annexed exhibits.

If you object to the relief requested, you must serve a copy of your response stating the reasons why you object on the co-counsel for the Debtors, Schwartz, Tobia & Stanziale, Attention: Ben H. Becker at the address listed below and file your answer together with proof of service on the Clerk of the United States Bankruptcy Court, 15 North Seventh Street, Camden, New Jersey 08102-1104 in a manner reasonably calculated to be received on or before _____, 1991.
