

**Haute-Durance, France:  
Damage to machines on the  
THT [VHV] renovation site**



16.01.16  
The proliferation of damage to machinery on the Haute-Durance electrical renovation project has led the Hautes-Alpes CCI [Chambers of Commerce and Industry] and the Construction Federation to express their "indignation". They thus decided to publish several pictures of "sabotage" found in recent days. Denouncing "the sad spectacle that the objectors to the project are giving us," they call for "calm and the smooth progress of the Haute-Durance site, in the interest of everyone."

"This degradation has a direct impact on the construction site itself, which is being slowed down, but especially on the high-Alpine construction companies of BTP present on the site which, we recall, are in an extremely difficult economic situation", indicates in a joint statement Eric Gorde, president of ICC, and Stéphane Scarafagio, president of the federation of BTP 05. Pointing out that "these companies employ 1,000 people in the region."  
The ICC and the federation BTP defend "the merits of the Haute-Durance project. The work aims to sustainably guarantee the security of the power supply but also in this way to develop the local economy. Economic development is reflected in the direct, indirect and induced impacts of the presence of the site on the department but is also defined by the number of local companies involved in the project. These long-term facilities will shortly allow digital inclusion through the installation of 200 kilometers of optic fibre lines, maintaining a quality electrical distribution service for High Alpine residents but also for the many tourists. characterized as an investment for the future, crucial for future generations."

For their part, several elected officials are moved by the situation on the site, but are asking them to suspend the RTE (Electricity Transport Network) site. After the departmental advisers of Chorges Valerie Rossi and Joel Bonnaffoux, ten of the fifteen councillors of Châteauroux-les-Alpes (but Mayor Jean-Marie Barral is not co-signer) wrote to the prefect Pierre Besnard. "The successive degradation of construction sites, the rising anger of the companies working there, the mobilization of police forces, the despair of anti-THT activists, legal proceedings initiated by the Haute-Durance Futures association and partners who support them, lead us to believe that a suspension of the construction site, likely to ease tensions in the department, would be appropriate," write the elected of Châteauroux.

Sometime in the night of January 3rd, 2016 individuals stole into the dark near so-called Cambridge and used a manual pipeline valve to restrict the flow of Enbridge's Line 7. We then applied our own locking devices to delay response time.

Line 7 is another recently-expanded tarsands pipeline operated by Enbridge, running parallel to Line 9 & flowing 180,000 bpd of tarsands crude. This action was undertaken to show our ever lasting love and support to the brave folks who've taken similar actions in the traditional territories of the Huron-Wendat, Mohawk, and Anishinaabek people. Further, we take action to counter the new narrative of the state; to swing back at the grossly inflated charges those in Sarnia received, and show that we will not be cowed.

We fight for the land and water; and we fight for our lives. We will always fight back, whether it's with the sun warming our faces, or the moonlight to guide us.

**Attack on yuppie clothing

In the early morning of Tuesday, December 22, we used chunks of porcelain to break a window of the yuppie clothing boutique at the corner of Notre-Dame and Delinelle in the Montreal neighborhood of St-Henri. We then used a re-purposed fire extinguisher to spray the interior of



the store with vomit-colored paint, wrecking the merchandise inside. Businesses like this one make the neighborhood more appealing to

rich people, driving up rents and the cost of living, forcing people out of their homes, and drawing heightened social control to the places we live. This action was in response to the call for a Black December. We chose this target because of all the obvious ways in which gentrifiers fuck with poor and rebellious people, and also in refusal of local politicians' Leftist discourse of mixité. We won't live peacefully alongside the individuals and businesses that are putting cops and security cameras on every corner and intensifying the power of bosses and landlords over our lives. We invite others to step up attacks against the concrete forms that capital and social control take in their surroundings.

## To Rebels, Insurrectionists, and Hacktivists Everywhere

I'm ten thousand miles in the mouth of a graveyard, but I'm still swinging with all that I've got. I gave the state an ultimatum: reinstate my communications or I'll refuse blood pressure meds – which will lead to heart attack, stroke, or aneurysm. The state hasn't budged and neither have I. I'm now out of meds and facing a spike in blood pressure. If I die I hope everyone reading this holds the same people responsible for my death as I do.

Odds aren't so good that I'm going to live through this no matter how it stacks up. My website is in a state of transition, my access to the radio show is essentially cut off, and it feels like I've been obliterated beyond prison fences.

I dropped the federal civil rights action. Fuck the hierarch courts. I'm now relying entirely on the potential of rebels, insurrectionists, and hacktivists to develop methods of direct action to drive this common enemy to its knees.

State terrorists now have home addresses posted at [blastblog.noblog.org](http://blastblog.noblog.org). These are State agents and collaborators who have employed a program of torture and ideological targeting. So, just to be clear – this isn't about me. I'm aware I'm not that important. In fact, by the time this is circulated, I may have already sputtered out. This is about a common enemy, those who serve the forces of non-freedom, and a real opportunity for those of us who envision a future that's not under their control to send clear a message : Those who maintain the program and dig the mass grave will pay for what they've done.

And again, in my own situation, this does not begin and end with prison officials. In legal documents, prison officials made clear that they were taking their marching

orders from the Federal Bureau of Investigation. The FBI. I don't know what field office or what agents, but whoever they are, I think it's important that they find out the rude way that they can be found too.

Just for the purpose of setting out what I think to be a healthy orientation, if the FBI can come after us, we can go after them. And we should. They have home addresses. They have personal vehicles.

Imagine what this can evolve into... disrupting their personal communications like cellphones... hacking into their personal systems...stealing their identities and destroying their credit... probing their government databases and melting them down... all while their cars burn...and their homes...and they tremble in fear in the Kroger parking lot when a stranger a stranger asks them for a light, because a coworker was knee-capped with a baseball bat when stopping for a dozen eggs and a loaf of bread on the way home from work...

We might make minor promises in exchange for meeting demands, but our ultimate demand is for a future without these fuckweasels running it.

And we attack, wherever we are, whatever our situation, until we get the world we deserve. We're not going to vote them out or petition them out or protest them out or sue them out.

We know that if the means you employ do not require you to wear a ski mask or its electronic equivalent, your just not serious.

We're serious.

If I'm already dead by the time this gets out, I want to express my deep gratitude to everyone who has extended my life in struggle, and to everyone who continues that struggle.

Gasoline is cheap. Matches are free. We own the future. And it's time to make them know it. Stay dangerous, Freedom, Sean

## Lecce, Italy: Arrested three comrades for the struggle against the CIE detention centre in Brindisi

16.01.2016



Following a greeting in front of the CIE of Brindisi – Restinco three comrades of Lecce were arrested on charges of resistance and non-authorized demonstration. They are now under house arrest. Below the leaflet distributed during the march that took place on January 10 in the city centre in solidarity with the arrested:

Since the beginning of October 2015, in the district of Restinco in Brindisi, a CIE(immigration detention centre for identification and expulsion) is open again after several revolts of those locked up inside had rendered it unfit for use. The CIE are true concentration camps where undocumented immigrants are detained. Life in a CIE is made up of harassment by soldiers and police and good earnings for the management bodies: in the case of Restinco, the cooperative Auxilium. Since the reopening of the centre some comrades often went outside those walls to bring solidarity to those locked up. After repeatedly being held by police, on Saturday, Jan. 9, three of them were arrested on charges of illegal demonstration and resisting a public official. We would reiterate that the main goal of repression is to make sure that this camp remains a place of segregation totally isolated and unknown to most people. Who is indifferent is complicit in these camps.

## Besançon, France: Attack of the premises of the PS and the Red Cross

16.01.16

A small gesture in solidarity with the undocumented and comrades in the dirty paws of the State

... At a time when the State is entrenching the state of emergency in the constitution and multiplying draconian laws, when blue and kaki uniforms are surging in the streets to assure the peace of the rich and dominant, when it is extending prison beyond the walls, when raids and deportations of undocumented are multiplying ... it's time to attack!

That is why, during the night of December 23 to 24 2015, the PS [Socialist Party] office had its facade covered in black paint. At the same time, the lock on the front door of the Red Cross, whose premises are located at the beginning of Gaulard Avenue, was sabotaged with glue.

The reasons for this last attack are obvious: this humanitarian organization - which has a long history of collaboration with the powers that be (from the Second World War and its collaboration with the Nazis up until today) - organizes raids, manages migrant flows alongside the police forces and murderous guards of the FRONTEx Agency, administers the detention centres ... It is entirely responsible for the miserable plight of the undocumented.

Right now, this humanitarian organization – perfectly in gear with this world of borders and poverty – is currently distinguishing itself at the Franco-Italian border between Menton and Ventimiglia, by chartering its lorries to transfer migrants to detention centres. The structures of the enemy can be found at every street corner. Let's not bow down to the state of emergency! Against the State, its cops, its borders! Sabotage the deportation machine!

I started robbing banks in 2002, but not because I liked an easy life. Besides, this kind of life is far from easy. I instinctively positioned myself against this inhumane machine that feeds itself on humans. I find this system unjust, a system that supports banks and is supported by them. I consider it violent and thieving. Robbers and terrorists are the banks. Criminals are those who support them. My decision to rob banks was my own lonely way of fighting them.

I have never organised myself in a political manner, and my contact with the anarchist milieu was and is personal and friendly relations I developed with some anarchist fighters whom I met in prison, especially from 2003 to 2006. I respect and appreciate their struggle, their selflessness and ethos. I think that they have justness on their side; however, I've never had any connection with any legal or illegal, unarmed or armed group or organisation. I believe also that my prosecution for participation in Revolutionary Struggle is done for communication purposes, to serve the theory for the anti-terrorist police of an allegedly operational link between "penal-code offenders and terrorists". I was ideal for this experiment of theirs as, on the one hand, I am a bank robber – a delinquent activity, which nevertheless has social acceptance – as opposed to being, let's say, a drug trafficker; on the other hand, it's known that I have personal relations with some anarchists. But personal relationships and likings are entirely a different thing compared to participation in a revolutionary organisation.

To serve their own propaganda purposes, the anti-terrorist police wish to charge me with involvement in more than two revolutionary organisations, if possible.

It's no coincidence that my name and photograph began to feature breaking news and front pages immediately after the arrest of Nikos Maziotis, portraying me as his right-hand man and other such

grotesque stories, when nothing in fact connects me to him, and there's not even a shred of evidence which can confirm such a scenario.

It doesn't suit my nature to make declarations of law-abidingness. I proudly declare that I am a bank robber. If I was involved in Revolutionary Struggle I would declare it so and defend my choice. But I've consciously chosen another path in my life.

My life itself is revolutionary as I've chosen it to be, as I've created it myself, through my choices in staying out of the automated lifestyle.

Furthermore, I have not participated in all the robberies I'm charged with. Even if I wanted to, it would be practically impossible to have done as many robberies as – according to accusatory documents – they try to charge me with, given the fact the ones I was involved in required several months of planning, in order to achieve the best possible result in the smoothest way, putting always the safety of citizens first, even at the expense of my own safety. In each of the robberies in which I've taken part not a single nostril bled, nor did I ever need to fire a single shot in the air to intimidate anyone. Those robberies were always planned in detail, and we always took all necessary measures to avoid putting anyone in danger.

The accusatory dossier before your eyes is a rough mishmash of police media releases and nothing more. Of the facts I am accused in this trial, I admit my participation in the Eurobank branch robbery in Akrata [Achaia], even though the evidence you hold is in fact inadequate if not non-existent.

I will not give further information and won't answer your questions.

## Brescia, Italy – Claim of the attack on the police training centre and communiqué of Cellula Anarchica acca



14.01.16

'During the night between 17th and 18th December we placed a device (8 kg of gunpowder) at the police 'training centre' in Brescia. A symbolic action intended to cause material damage.

We chose that time so as not to harm people indiscriminately. With this action we began our projectuality of Anarchist attack as Cellula Anarchica acca (C.A.A) in affinity with the black international, and add ourselves to the call for action for a BLACK DECEMBER.

We are joining this trajectory because: We like the idea of an international coordination of anarchists for direct action.

Our idea of 'complicity' goes beyond groups and factions. We are using the means we consider appropriate, seeking growth in the minimal details of the action. In that sense this action is nothing in terms of material damage, but it is important in arming our self-organization, especially at a time when we sense great resignation among anarchists in Italy.

We attacked one of the armed wings of the state. Cops from all over Italy and other states are trained at this 'school'. This is also a little signal against war. We are in solidarity with all those who struggle against all states and capital. Our thoughts go to the many comrades who are repressed, locked up, tortured or killed at the present time and in the past. In solidarity with all prisoners in struggle. This is a signal of complicity to those who are locked up: To Alfredo for shooting Adinolfi; to Chiara (NO TAV anarchist) for the attack on the construction site; to Nicola Gai, who with Alfredo kneecapped the Ansaldo managing director, which is the least he deserved; to Nico (NO TAV anarchist).

## Update from the Appellate Court of Athens concerning the 5 fighters students under threat of extradition



16.01.16

On January 7th at 9.00am the prosecutors announced the decision of the first trial for the two of the five comrades which denied the demand of the Italian authorities for their extradition.

At 10.00 am began the second trial for the next two comrades which lasted 6 hours. the procedure began with the presentation of their defense by their advocates. they then examined the witnesses and then came the testimonies of the two comrades. In her speech the prosecutor proposed that the two comrades should be extradited, while the procedure ended with the final speeches of the three advocates.

Once more the court room was full while about 400 comrades had gathered in solidarity outside. The judges decided against the extradition of the 2 comrades and lifted the probation terms set for them just like the first two.

The third trial for the 5th comrade took place on Monday the 11th and it was also against the extradition.

INTERNATIONAL DAY OF ACTION IN SOLIDARITY WITH TRANS PRISONERS



January 22, 2016 will be the first annual Trans Prisoner Day of Action: an international day of action in solidarity with trans prisoners. Trans Prisoner Day of Action and Solidarity January 22nd

This is a call to action against the system which seeks to erase our very existence. The survival of trans and other sex and gender minority people is not a quaint conversation about awareness, but a struggle for us to live in a world so determined to marginalize, dehumanise, and criminalise us – especially trans women, and especially Black, brown, and indigenous trans people.

We are discriminated against in every area of society including housing, healthcare, employment. Our survival is often precarious and many of us survive by work which is also criminalised – making us even more of a target for police harassment and the crime of “Walking While Trans”.

Once incarcerated, trans people face humiliation, physical and sexual abuse, denial of medical needs, and legal reprisals. Many transgender people are placed in solitary confinement for months or years, simply for being trans. Trans women are usually placed in men’s prisons, where there is a massive increased risk of experiencing sexual violence.

Just as our lives are violently repressed on the outside, trans people experience extreme suffering and death within the walls of jails, prisons, youth facilities, and immigrant detention centers.

Trans Prisoner Day of Action on January 22nd is a day to acknowledge the experiences of trans and other sex and gender-minority prisoners. It’s about collaboration. It is about forging new relationships and dismantling the isolation of prison. It’s about resistance to state violence. It’s about solidarity between those who experience the violence of the system first hand and those for whom the state hasn’t come yet.

Many prisoner support and prison abolition groups around the world do so much excellent work writing letters to prisoners, educating the public with letters to editors and articles for the media, holding protests and marches, organising queer communities to phone in and demand that trans prisoners be treated with respect and dignity, calling for an end to incarceration. Trans Prisoner Day of Action aims to make this work accessible to all who are in support – we encourage you to hold vigils for those in our communities who have been taken by State violence, to hold an event, host speakers, screen films, invite presentations, and hold workshops to spread the word on the experience of trans prisoners, share knowledge, and build strategies of resistance. Have dance parties and raise funds for people and groups already doing amazing work. Take action. Let’s join together and show our conviction in supporting each other and ending prisons once and for all.

This project was first imagined by Marius Mason, a trans prisoner in Texas, USA. Since then, through his friends and supporters, an international collective of people both inside and outside of prison walls have come together to make Trans Prisoner Day of Action a reality. We are trans and non-trans folks and friends and supporters. We join a long tradition of trans and queer people resisting state violence.

Join with us in the struggle for freedom.

On January 22nd events will happen all around the world. They will include letter writing gatherings, film screenings, public

**Chile: Phoenix Project – Incendiary attack against a security company by FAI-IRF**

“That’s why; against the tyranny of the reality you have imposed on people I choose forever the magic realism of anarchy and revolution that’s never ending...” – Christos Tsakalos in his political declaration to the court for the third Conspiracy of Cells of Fire trial in Greece, 04.11.2015

Fighting for freedom includes combating the impunity of those who repress and monitor our lives.

We opened fire on 2016 during the night of Sunday, January the 3rd with a delayed activation incendiary device attack against the headquarters of ISP SERVICE S.A., a private security company founded by a former intelligence agent of the Chilean dictatorship who, like many other agents of dictatorial repression developed their own security business in the private sector once democracy arrived. Our fire managed to successfully damage part of the building’s facade on Lord Cochrane street in the center of Santiago.

We are aware that the companies of guards, cameras and surveillance are a profitable business based on the ideology of security that is promoted by the State / Capital and supported by the social majority who without questioning the discourses of power reproduce and defend the concept of Total Security satisfied that on each corner in every neighborhood more cameras, guards and police officers keep appearing.

With our incendiary insurgent fire under the noses of those who are monitoring we have demonstrated once again the vulnerability of the network of domination; enhancing our decisions, relations and daily praxis in the direct attack against the buildings, representatives, administrators and defenders of social control.

We have said it before and we will say it once more: the power is never invulnerable, the anarchist attack is always possible.

From the anti-authoritarian informality we organize ourselves without specialists, without leaders or hierarchies, to carry out the praxis of anarchist conspiracy against power, giving continuity through fire to the project of the Informal Anarchist Federation / International Revolutionary Front, because the FAI / IRF comes to live whenever any individual, cell or group creates with it’s own AUTONOMY the DIRECT ATTACK, without giving rise to doubts about their intentions, with actions that are accurate and not indiscriminate, with the SOLIDARITY and the anarchic INTERNATIONALISM being the essential elements of a liberating sedition without centers or periphery that breaks the oppressive normality and creates the perspective of Total Freedom in the here and now.

Actions such as this one motivate the planning of more and better explosions and fire against the misery of the established order, always remembering to combine the knowledge of how to make incendiary / explosive devices with the necessary knowledge on how to detonate safely in the city and the right time to carry out conspiratorial clandestine action.

Let’s combine the diverse forms of struggle to demolish this and any other system of life based on power and exploitation!

We salute all those who responded with propaganda and action initiatives to the proposal for a Black December by the imprisoned comrades Nikos Romanos and Panagiotis Argirou in Greece. The impetus for action and debate does not stop, it continues and is planned and realized in strategies of struggle and more acts of insurrection that hinder and jeopardize the plans of power.

We salute each prisoner in struggle who remains dignified and consistent in the prisons of the civilized world.

We salute the struggle of the Mapuche warrior Matías Catrileo who was assassinated eight years ago (January 3rd, 2008) by the bullets of democracy fired on this occasion by the police officer Walter Ramírez Espinoza during an action to reclaim ancestral land.

We salute every animal and human struggling for their freedom through action against the world of authority.

And our comrades of the FAI / IRF, we will meet against in the flight of the Phoenix.

**Koridallos prison court: Trial statement by Giorgos Petrakakos – Greece**

14.01.16

On September 24th 2015, Giorgos Petrakakos – wanted for bank robberies – was arrested in the city of Volos together with his life companion Maria Theofilou (who is also the sister of imprisoned anarchist Tasos Theofilou). Both are currently held in Koridallos prisons, Athens.

On October 16th 2015, the second trial against Revolutionary Struggle began with regard to the attack with a car bomb containing 75kg of explosives against the Bank of Greece’s Supervision Directorate in central Athens on April 10th 2014; the shootout in Monastiraki on July 16th 2014, when comrade Nikos Maziotis was injured and recaptured by police; and expropriations of bank branches. The co-accused in this trial, all facing terrorism charges, are two Revolutionary Struggle members: Nikos Maziotis (imprisoned in Koridallos) and fugitive Pola Roupa; Antonis Stamboulos (remanded since October 1st 2014), who denies all charges; and Giorgos Petrakakos.

During court proceedings, Revolutionary Struggle member Nikos Maziotis assumed responsibility for two bank expropriations that took place while still underground (one at the National Bank branch in Methana, and another at Piraeus Bank branch in Kleitoria,

Achaea), as well as his participation in the bombing attack against the Bank of Greece (10/4/2014), and shooting of cops in Monastiraki (16/7/2014).

The second trial against Revolutionary Struggle is already close to its end, because the presiding judge has imposed fast-track proceedings – to prevent comrade Antonis Stamboulos from being released from prison before conclusion of the trial (as the pretrial detention upper limit in Greece is 18 months).

Below is the trial statement by Giorgos Petrakakos, whom the media/police have imaginatively portrayed as an “accomplice of Nikos Maziotis.”

I find myself accused because I have participated in some bank robberies.

No matter how many years of imprisonment you’ll impose upon me, I don’t understand and won’t be able to figure out why this is considered as an accusation rather than a title of honour, since banks are responsible for wiping out an entire population.

I am accused by this court for three robberies as an alleged member of Revolutionary Struggle. I am also accused, in other accusatory dossiers, for the robbery in Distomo and for aggravated possession of weapons as a member of an unknown terrorist organisation... An unknown terrorist organisation I was allegedly about to set up, or what the authorities would fantasise about... When I was caught, the anti-terrorist police accused me of and tried with various tricks to attribute my involvement in four armed organisations as well as Revolutionary Struggle. Apart from these four organisations, they’ve also allowed me an extra gift: Revolutionary Struggle.

I would not be surprised if in the coming months I’ll be accused not only for the robberies in which I did participate, but for any unsolved robbery that has occurred in Greece over the last hundred years.

I do not care at all about the sentence, and I know that the police are asking your court to convict me severely. For me, there’s no difference whether I’ll be sentenced for one robbery or three. So I’d like to explain a couple of things, not because I want to achieve a lesser sentence, but to officially testify to the truth.
