



Israel: Tania Golan's statement refusing military service

02.02.16



Tania Golan is an anarchist, a vegan, an activist in ecological struggles and a member of Ahdut-Wihdeh-Unity. She refuses to take part in the Zionist army. We publish her Declaration of refusal, which includes her reasoning and her social criticism.

Deciding to join or not to join the army is a political decision which everyone should be able to make on their own. I protest the law that threatens young teenagers into joining the army.

I have no trust in authoritarian hierarchy. The army is a hand of the bourgeoisie, the government and weapon manufactures. There are those who profit from Israeli-Palestinian conflict and will never let go of economic control over the West Bank. These powers have created racism and division. Government spending on the IDF (which also comes from the USA) tends to grow from year to year at the expense of education, healthcare and welfare; yet there is no security – there are many threats in Israel. I presume, our fear is exploited as a distraction and prevention of profound thought.

One can not build a just society based on injustice. I refuse to take part in a racist, fascist, discriminatory and oppressive organization. I refuse to take part in an organization which, for decades, holds millions without civilian rights.

On the other hand, there are people like us, with the same needs as us, who only want to live their lives. Arrests, administrative detentions, harassment by the army and Jewish settlers, wage slavery, no welfare — we cannot be safe if we give good reasons to fight us.

The army, just like school, is an institute that performs socialization. As the main objective of public school is to stitch together the society into a monolithic entity, so the main objective of the IDF is not to protect the people, but to be a melting pot (Israeli slang for the army as the institution which makes people the same) that keeps the ethos alive and makes people adore itself, while it actually protects only the hierarchy.

It is an institution with a clumsy bureaucracy, sectors that deal only with each other and have no bearing on the real world, and other sectors dealing with civilian affairs. This kind of structure is educating fresh youth into a dogmatic way of thinking that perpetuates the hierarchic relationship between the oppressor and the oppressed. This part of life is the final stage in entering adulthood in this part of the earth, between the river and the sea.

I think that joining an organization should be motivated by personal desire and thought. It works, we can take as an example the Democratic Federation of Rojava, not so far away; perhaps we can learn a thing or two from them. They have no conscription laws, but, nonetheless, they have similar percentage of recruitment to the YPG and YPJ as Israel have to the IDF. If there is no desire to protect something, it probably should not be protected.

I reject the reasoning in favor of joining the army: companionship, direction in life, experience, helping the community. I choose not to sacrifice myself to two whole years of rattles, humiliation, and oppression for nothing. I will not wear

Delayed Claim of Responsibility for Attacks in Brighton in 2014 – UK

Anonymous submission. Note: we have made one edit to the content, the author can contact us if they want to discuss this.

Words without actions are nothing but corpses rotting in the mouths of those “charming and sophisticated” ones, ever ready to smear and drown out the insurrectional project of anarchists of praxis with speech.

Actions without words will never be enough to address and confront our daily struggles for individual liberation and autonomy, for it is with both the pen and the sword, theory and practise, that one is properly armed to give context and coordination to our struggles, to share solidarity and proposals in the most unmediated form, the direct attack against civilisation.

When attacks against the world of power are not claimed or publicised, the potential for spreading radical discussion, tactics and solidarity between whoever is interested is negated. Thus the aims to build a reciprocal, polymorphous and dynamic anarchist offensive is hindered, and the knowledge of so many attacks are lost to the void of clandestinity.

This claim of responsibility has been delayed so long for two reasons:

Firstly, the initial communique was foolishly sent only to one website, and for whatever reason was not published.

military uniform, so I will not contribute to the public pressure to join the army. Refusing conscription is not a simple thing, but neither is joining the army. Last but not least, there is the social issue of justice. The army endangers the environment by spilling oil and sewage, getting rid of equipment by throwing it into the sea and ongoing activity which endangers the balance of flora and fauna. All of the above happens without the least amount of accountability, exactly as the army does with government spending. Secondly, due to some events around the time of these attacks, it made sense to postpone further debates on publicising our actions, for strategic reasons and to further develop our ideas and practises as individuals, outside of the temporary alliances forged in the context of struggle.

However, after almost 2 years of silence, I choose to lay my cards out on the table and do what i can to share these memories with



whoever is interested, so that they may continue to inspire further action, as the communiques and actions of comrades worldwide continue to inspire and empower me in this war against society.

If my mind worked like a machine, i could offer more precise dates, but due to the time that has passed since the original claim of responsibility i instead share with you a combination of facts and my personal feelings and emotions which make up these vivid memories, in a rough chronological order.

I do not offer “reasons” for our attacks, for anyone who truly lives anarchy needs no reason or justification for their conflict against all of the existent.

Around midnight on the 28th of January, 2014, I came across a CCTV and security installment vehicle belonging to the company Securesite, who i was well aware make a killing off of boarding up and securing abandoned buildings, studding the streets with CCTV cameras and make use of enslaved dogs to enforce civil normality and protect the wealthy majority of the city from those dastardly squatters, burglars, outlaws and other “undesirables”. Knowing which streets to take so that i may avoid CCTV on my day-to-day business, the attack was simple, i took a quick glance around to ensure that i was alone, picked up a big rock from a nearby garden and used it to smash the windscreen and wing mirrors of the vehicle.

Over the next weeks, either as individuals acting alone or small affinity groups, spray paint was carried nearly everywhere, the city was covered in provocative slogans, countless billboards were defaced and night time visits were paid to two churches in different neighbourhoods, covering the exteriors in messages of queer and nihilistic fury, and put in the stained glass windows of one of them with some stones from the wall surrounding the building.

Over 100 state and privately owned CCTV cameras were also destroyed in this timeframe, using a wide range of simple and easily reproduced methods, from improvised lassos, smashing with hammers, dropping bricks from above or simply using our bodies to tear down and destroy them. Determined gangs of thieves and individuals carried out well coordinated and extensive expropriations from high street shops on a daily basis, and thousands of pounds worth of products were taken to share amongst friends and keep our bellies full.

Then on the 28th of march, with the memory of our comrade and friend Darko Mathers burning in our minds, we concluded this phase of action with the spontaneous trashing of 4 luxury cars. We equipped ourselves with some nice “tools” found in a nearby bin, then quickly got to work smashing in the windows of a BMW, Merc, Audi and Jaguar – breaking the peace and quiet of some posh neighbourhood with the

sounds of screaming car alarms til the street was littered with broken glass and the shattered icons of wealth and prosperity.

Is it not clear enough already, that anyone with the will to attack does not need to wait for the correct moment? The new anarchist urban guerilla is no vanguardist structure or party requiring specialist tactics or knowledge, but a free-association of individuals who are ready to engage and experiment with anarchy here and now and create the ruptures in society that we wish to see.

It is with this claim that i raise my fist across the imaginary lines of borders and prison walls, to salute those uncontrollables, anarchists and nihilists, who without mediation or regret take it upon themselves to attack this vile technological society and its puppets with all the might they possess.

Nicola Gai, Alfredo Cospito and Gianluca Iacovacci in Italy.
CCF imprisoned Members Cell and their friends and relatives.
Nikos Romanos and all combative prisoners in Greece.
Gabriel Pombo Da Silva and everyone in the dungeons of FIES.
Tamara Sol and Nataly Casanova, and all nihilist/anarchist prisoners of war in Chile.
Sean Swain, Marius Mason and Casey Brezik in the USA.

And to all other anarchist prisoners and fugitives I cannot spare the time to mention you all in this communique, but let it be known that your courage and strength is contagious like a virus, infecting the minds of others with beautifully criminal thoughts, sowing the seeds of rebellion far and wide.

A big shout out to the the rest of the combative minority from Bristol, London, Nottingham, Scotland and Wales. May the fires of international anarchist praxis continue to burn here in Prison Island UK until we may one day dance together in the ashes of the cities or until we lie dead in their streets...

Forever two steps ahead of the enemy, not one step back!

TRIAL OF BILLY, SILVIA AND COSTA UPDATE – ITALY

On January 13, the first hearing of the proceedings against Billy, Silvia and Costa accused of possessing, transporting and receiving stolen explosives and for attempting to sabotage the IBM international nanotechnology research centre in Zurich was held in Turin. Comrades from various parts of Italy were present in court in solidarity.

To support their thesis the prosecution presented two witnesses: Digos inspectors from Turin who had followed the investigations that began immediately after their arrest in Switzerland. Only one of the two witnesses was cross examined by the prosecution and the defence. Apparently it seems that the trial will be quicker than was said at the beginning, the next hearing was set for March 2 where the prosecutor and lawyers will speak.

From the solidarity meetings in view of the trial there was a strong desire to continue a radical critical path and struggle against the technosciences. From 22 to 28 February there will be a WEEK OF AGITATION throughout Italy against the technosciences and the world that produces them. On February 26, a PROTEST AGAINST EFSA (European Food Safety Authority) in front of the EFSA headquarters in Parma, and many initiatives are being planned in various cities of Italy.

Parisian anarchist library threatened...by “anarchists”

Words of introduction by the translators (Dialectical Delinquents): The following is a translation of a communique sent out from the anarchist bookshop “La Discordia” in Paris, which has been tagged and been the subject of calumnies calling them fascists because of their critique of Islam.

Various comments have been circulating the Parisian “anti-authoritarian” milieu describing both La Discordia and non-fides (which are not the same thing, despite some people being involved in both, some are involved in just the bookshop/library) as racists and – at least in the case of non-fides – as anarcho-nationalists. Anyone looking at either of them for longer than 2 seconds would realise that there’s not only not the slightest bit of truth in these slanders, but also that they have consistently maintained an internationalist position contrary to some of the implicitly nationalist stances of some of the “anti-authoritarians” (e.g. a failure to critique Palestinian or Kurdish nationalism). Whilst this graffiti might seem a fairly trivial incident, such things, unless vigorously contested, can have a miserable result far worse than a tag. A lie goes half way round the world before the truth has time to get its boots on. And in a world of lies, most people are ready to believe anything as long as it conforms to their prejudices – lies are taken on faith, and most avoid checking things out themselves (one only has to look at the history of Stalinism to understand how vicious calumnies and amalgam techniques can become). So, in the spirit of solidarity with these anarchists, I have translated this text, despite it being of interest to fairly few people.

As planned long before, on Tuesday, January 26th, a debate entitled “Islamophobia: the conceptual political extortion racket” was held in La Discordia. We wanted to confront ourselves and others with a topic that is at the crossroads of the current widespread confusion over the condemnation of racism and the defense of religion. The joint discussions were interesting, and the sixty or so comrades and companions who came (we promise, next time we will rent a larger place, and with more chairs!) demonstrated that a lot of people find the need for a revolutionary critique of religions, every religion, even Islam, which others would like to palm off as the “religion of the oppressed.”

However, on arriving on Tuesday afternoon, we saw that the front of Discordia had been tagged, probably during the night. Some circled A.s (thank you!) and particularly



poorly written and thought-out invectives (“fascists” and “racists”) in black spray paint.

All accompanied by a leaflet of “demands”, asserting that we were acting as a vehicle for “Islamophobic and racist theories” and that we were “the drive belt for ideologies of power”, etc. Anyway, we’re not going to copy all their nonsense for you, which has given everyone a good laugh. If you want to read this, have a laugh with us (or attack us ourselves rather than the walls) at the library during our opening hours and discussions.

The answer to these insults was the success of the discussion of Tuesday 26th but also all the others.

Long story short, the insulting (and difficult to read) tags were cleaned off in five minutes (in terms of practice, much has to be improved, kids!), the circled A.s will stay! Our neighbours also had a good laugh about your bullshit, since your exploits have absolutely no bearing on anything or anyone except yourselves and your smelly boutique. Incidentally, one more small comment for the brave taggers/comedians: If you have not been filmed by the DGSI (General Directorate for Internal Security) it’s because we took and destroyed the camera that watched us (well before the promulgation of the state of emergency). Everyone will appreciate the difference between those who prey (pathetically) on an anarchist library already threatened by repression and those who are prey to more serious problems.

No other tag has been identified in the area, neither on banks, nor on the police station, nor on the schools working with DGSI, nor on churches, synagogues or mosques. What a great revolutionary attack then, and against anarchists. If we expected “attention” of this type (we thought of something a little more “consequential”), this won’t restrain us from any attempt to develop, share and disseminate clear revolutionary forms of discourse, without compromising with any kind of power, including religion, and without remorse in our criticism of the compromises of politicians

amongst some sections of the “milieu” – on the contrary!

A thought for the atheist “fascists”, the unbelievers, who, from Tehran to Saint-Denis, are now treated as “Islamophobic” as much by fearsome powers as by this arriviste of the French academic petit bourgeoisie who knows only the racism of his own class, and has shown that his only practise over 10 years is the ability to write an illegible tag on the front of an anarchist library and to organize...conferences with religious authorities. A practice on the same level as their discourse.

Obviously, if one coldly assesses the treatment that the State reserves for revolutionary atheists on the one hand, and the racist / theological-compatible Left on the other, one quickly understands what can truly be described as a “drive belt for ideologies of power “: those it usually represses? Or rather those to whom it offers its chairs in universities and its management/cadre positions in its institutions (indeed, this galaxy is composed primarily of academics and executives from the middle and upper class, immigrant or not). No wonder then, that their political subject gives neither respect nor an ear to this post-modern brothel, as all recent uprisings have proven, which cared one iota about the convoluted reasoning of our pious academics, from Bahrain to Baltimore, via Durban.

Finally, thank you to all those who showed up and who will show up again. Also thank you to anyone with information about our committed artists who are somewhat cowardly because they are unable to express their ideas in the open.

We call those who have revolutionary ideas and practice, whether anarchist or not, to intensify the offensive against this new reaction, and express solidarity with those who find themselves in the viewfinder of these born-again reactionaries, taking up their share of criticism, which doesn't require much courage. And cutting short the attempts to isolate anti-religion revolutionaries (so, is this no longer a tautology?).

Against all forms of power, against all religion and all racism, long live the revolution! Long live anarchy!

Belgium: No retreat: forward with the struggles for freedom

About the acts of sabotage against the high speed trains and an army base

About the acts of sabotage against the high speed trains and an army base

When darkness surrounds the neighbourhoods, immersing the city into a territory under siege – supreme affirmation of state power and its ideology –, it is easy to succumb to total resignation. When the trumpets of war and massacre are braying, crushing the struggles for freedom to leave only space for the fight between two powers that want to impose themselves, it is easy to think that everything is lost. When the media bombings are hammering the message of order, pushing all shouts of refusal and rejection towards the margins, it is easy to stop thinking by yourself and letting yourself be swept away by the bloody current.

And yet... This last week, the state has been aiming for a complete adherence to its values, threatening with brutal repression all those that don't bend. Faced with the jihadist gangrene which has devoured, first and foremost, the revolutionaries of so many countries (Egypt, Syria, Libya) – revolutionaries which have courageously risen up against the regimes and for freedom, and which all the states in the world have preferred to see massacred with statist bombs or slaughtered by jihadist executions –, the state has been striving to affirm the triumph of its vision on the world: a horrifying world of capitalist exploitation and statist oppression. The state is now trying to decree that the only war everyone is called to participate in is the war between him and an islamist competitor, thereby attempting to bury the only war which we, revolutionaries against all power – be it statist or religious – are ready to wage: the social war against

oppressors and exploiters. And the state takes the occasion to reinforce its repressive arsenal.

House raids around the clock. Tightening of the laws. Adaptation of the constitution to impose electronic bracelets to the ones threatening its order (and don't think that the revolted, the revolutionaries will be excluded from their black list). More means for the cops and the secret services. Arrests in abundance of people without papers and rebels. And beyond doubt as well an acceleration of the militarisation at the borders and the construction of new prisons, such as the maxi-prison in Brussels.

And yet... not all has been lost, the resignation continues to be as sick as it was a week ago, the necessity to think for yourself, outside of any canon, is the only possible way to demolish the ideology of the state and its competitors.

Two acts of sabotage took place in Belgium, two acts of sabotage during one single night. Two acts which announce that the fight for freedom can and must continue, here and now, even if the conditions are getting more and more difficult and the fields of confrontation will be less favourable. Two acts which show the abyss separating the state as well as those who think like a state (as is the case of the supporters of the new caliphate), both of them always ready to commit massacres, to sow terror to preserve or conquer power; an abyss thus which separates them from the ones fighting to break the hold that power has on all of us, those who go to the attack to liberate, not to subdue.

Two acts of sabotage, in the night of the 29th of November towards the 30th of November.

The first one was a sabotage, on four different spots, of an international high speed train network (TGV, Thalys, Eurostar). By putting fire to the optic fibre cables along the rail tracks close to Ath in the province of Hainaut, the complete train circulation has been paralysed for more than a day long. A day on which the international delegates and the ministers needing to speed to Paris for a summit were blocked, a day on which the

executives of companies, the eurocrats, the directors have been cornered in the station watching the screens announcing the cancelling of their trains. This act of sabotage shows us that by using simple means it is always possible to cut into the veins of power and its men, of its networks of transportation and data. And in the disorder thereby created, spaces are opened up which are not saturated by the speech of power, spaces where freedom can take a jump.

The second act of sabotage was aimed at no less than a military base, one of the most important ones of Belgium, where the Special Forces of the Belgian army and the military secret service are stationed, in Heverlee in the province of Flemish Brabant. Covered by the night, the saboteur(s) penetrated the base, avoiding systems of control and patrols, to trap five army vehicles with home-made fire bombs. The ignition system seems to have defected but the message cannot be more clear: you are occupying the streets of Brussels, massacring people in different countries over the world because the state orders you to do so, you are sowing terror with your uniforms, your armoured vehicles and your weapons of war, but you will never be out of reach for an act of sabotage. A single act has managed to ridicule the aura of the army and its grand master, the state, and this in the middle of a state of emergency. An act which somehow proposes to all who are sick of their wars to attack directly on the spot where they are produced: in the military bases, in the arms and security companies, in the technological research centres. An act which can only belong to the deserter of all wars, but who doesn't renounce the one of the social war against the war of power.

It is easy to abandon, but it is always at reach to continue. Faced with the war for power, lets blow strongly on the hot beds of the social war against all power. There are struggles going on which will face difficult times in the future, the struggle against the borders, the struggle against the maxi-prison, the fights against austerity measures and the capitalist reorganisation. Lets strengthen them so that they become points of reunion for the deserters, the indomitable, the rebels. And may acts of sabotage continue to illuminate the darkness.

Civitavecchia – FAI / FRI communique for attack on the court

My heart abhors and defies
the powerful of the earth,
my arm makes war on the cowardly
oppressor

We are living in a state of permanent global war, the perpetual war between oppressors, we know it and we know the main and secondary characters of dominion. Above all the oppressed know it, those who suffer arbitrary power over their lives.

Right now we are witnessing the passage of tanks and military in the streets of the rich and opulent West, the increase in controls and garrisons in defence of the order of commerce and consumption, the militarization of the territory.

Changes that strike even the most dormant minds, but which the strategy of global control will try to make us digest. Among the exploited, gentlemen, there are two classes of individuals. Those of one class, not realizing what they are and what they might be, take life as it comes, believe that they are born to be slaves, and content themselves with the little that is given them in exchange for their labour. But there are others, on the contrary, who think, who study, and who, looking about them, discover social iniquities. (Auguste Vaillant)

We are not so short-sighted as to believe that this global war has such clear and sharp sides. Just as we recognize the enemies of freedom, we cannot bear the resignation and tolerance of those who are willing to give a piece of their lives every day. That is why we don't delude ourselves that we are working for any revolution, we see clearly that the only anarchy realisable is what we experience when we finally free ourselves of every burden and decide to attack power. An experience that we feel we share with

comrades around the world participating in the project of spreading the F.A.I / F.R.I. anarchist seed.

Tonight we planted this seed in the form of an explosive device placed in one of the key locations of State repression dispersed throughout the territory: the court of Civitavecchia. We decided to take our freedom ourselves. We have sharpened tools, analysed tactics, because we thirst for anarchy, and we are impatient.

Courts and prisons are simply outposts of dominion; places that are not just symbolic, but physical, where the State and the authorities stamp those who do not conform to the dictates of global control with the brand of condemnation, guilt, imprisonment and exclusion.

While holy doors are opening wide to spread miserable feelings such as mercy and compassion, we are breaking down ideological and real walls to allow the real hatred that motivates us to be reconciled with the love of a free life. Today we acted convinced that don't want to carry the experiences of the comrades we have lost, like those who are locked up or on the run, in some antrum of our heart, but free them, leaving them to arm our hands, warm our flesh.

That is why our greeting goes to the comrades and prisoners who with their non-submission contribute to the spreading of joyful conscious subversion.

Dealing with techno-scientific power and its principal manifestations: biotechnology, nanotechnology, computer science, neuroscience is not just focusing on some aspect of this particularly harmful society. As Ellul wrote over fifty years ago, technology has made itself the system and mediates our lives beyond any will whatsoever. In this also the other animals and the whole planet are crushed and manipulated according to the needs of the moment under the technical imperative.

The techno-sciences are recombining and converging towards what has always been their ultimate goal: total control over living beings. Many wonder why we are paying so much attention to technology when the problems around us are so many. In a technical system like that of the present where everything is marked by the machine, technology represents the time, place, space that covers every form of exploitation. Sometime call it green economy, others scientific progress and yet others catastrophe management, covering the areas that once redesigned will widen the network where all the relations of power are developed in every link, such as the launching of a GMO or the manipulation of the germ line, from where there is no return. A struggle against toxicity cannot disregard the social context that produces it, is desired by it and rendered necessary for all.

This means that our criticism will fall into superficial common sense or pseudo environmentalism unless it reaches the actual problem. Power is fully deployed in every technological apparatus around us, a technological democracy that appears at every corner, oversees every intersection, controls every aspect of our survival to the point of entering our bodies, while its totalitarian essence remains fundamentally unperceived. A techno-power which, thanks to more and more nanoscale devices, is becoming more than it seems and starting to not appear at all. This week of mobilization is not to circumscribe a route or define boundaries, on the contrary we hope that these days will inaugurate new or reinforce past determination and the will to act. We think that each situation could use these days in its own territory to organise initiatives related to theme of noxiousness, especially that related to the converging sciences that are taking over the earth and bodies more and more. February 26 there will instead be a collective initiative at a national level: a protest against the EFSA (European authority for food safety) based in Parma.

EFSA is the internationally recognized body to which the European Commission refers to concerning toxicities such as GMOs, pesticides, chemicals and nanotechnology. It can authorize the commerce of GMO products and sows them in the open field for commercial and experimental purposes. Like the American FDA (Food Drugs Administration), it is no more than a government arm of the multinationals especially biotechnology, where very narrow close relations allow a continuous exchange of administrators, scientists, managers and the inevitable technical staff: what better way to permit a capillary

distribution of GMOs also in Europe. Thanks to contamination thresholds tolerated in food and seeds, GM feed, transgenic crops in the open field ... the work of spreading has been underway for too long. Europe has given itself a body called upon to guarantee the safety of every toxicity along the lines of the American FDA. To protect, as well as the interests of the biotech-chemical-pharmaceutical multinationals, an economic, political and social system that clings to the new bio nano-technological revolution, producing more and more environmental and social disasters that underlie techno-industrial development, of which the manipulations of the living are deadly.

We are not for the creation of a safer, transparent and democratic EFSA, which could never be realized even if one wanted to create it. A security organ like EFSA assumes that regularly harmful substances can be created and spread over the planet putting at risk its very survival. Just as a plant for the disposal of radioactive waste always requires the atomic plants of a war economy.

We totally reject this techno-system along with all its manifestations of death with the same determination and conviction whether they are used to create peacekeeping missions or to create war: their peace is already a perpetual war on the planet and all its life forms: already bad enough to put up a relentless resistance.

On March 2, at the court of Turin the new hearing will be held against Silvia, Billy and Costa, accused of attempted sabotage with explosives signed Earth Liberation Front against an international centre of research on nanotechnology in Switzerland of the multinational IBM.

For us continuing this solidarity means that we continue to hear the scream of a dying planet, which an ELF group in the US once wrote had motivated them in their path of resistance, not to be confused with passivity but with burning anger throughout the struggle.

Athens – Statement on the assault on anarchist prisoner Panagiotis Aspiotis for refusing to give DNA sample

07.02.16

Today on the 6th of February, our anarchist comrade Panayotis Aspiotis was meant to be transferred from Nauplio Prison to Korydallos for his interrogation on Monday by Eftychis Nicolopoulos. However, he was unexpectedly taken to the removal center on Petrou Ralli street where he was isolated and led to an area with no CCTV. He was viciously attacked by cops in balaclavas of the counter-terrorism unit who attempted to violently take a sample of his DNA. The uniformed pigs hit him on the head and hit him on the ribcage and the rest of his body. Eventually they managed to get a DNA sample during their second attempt since the first time the comrade swallowed the cotton bud they had used. After taking his DNA they continued to hit him in the ribcage for a long time in order to set an example.

Interrogator Eftychis Nicolopoulos, the counter-terrorism unit and the left-wing Ministry of Justice are exclusively responsible for this attack and we will stand against them. Let them know nothing remains unanswered from the people of struggle.

Saronno (Va) – Rotodyne headquarters attacked: action against the arms industry



We receive by anonymous email and spread:

“In the night between 28 and 29 January the headquarters of Rotodyne offices in Saronno was hit by a Molotov cocktail. Rotodyne develops equipment for the maintenance and construction of helicopters and warplanes (EH 101, NH-90, EuroFighter Typhoon), including the Lockheed F35 Lightning, designed and used by the Marines, the aeronautic and the US navy, as well as by many other NATO countries, including Italy. The distributors of its products, and the companies with which it collaborates, are Alenia-Airmacchi, Augusta Westland (Finmeccanica group), Aereotech, Patria Helicopters.

Its products have been adopted by the Danish, Irish, Greek, Oman and Italian

armed forces; by the Dutch, Swedish and Italian police; by the army, coast guards and the Italian navy.

It's impossible to remain passive in the face of those for whom war is a business. It is right to attack them before their products can contribute to causing death and devastation.

To stand by without acting would have made us accomplices. “
