Dealing with FaCS: top ten tips (NSW), 2016, [Booklet], Women's Legal Services NSW, 02 8745 6900, reception@wlsnsw.org.au

This booklet is intended to help women and families deal with Family and Community Services (FaCS), the department in charge of keeping children safe, which used to be called DoCS (Department of Community Services). The booklet explains the different types of actions FaCS can take at the early stages of their contact with families. It also includes a diary for recording details about contact with FaCS.

### Guides to the law

Case study of 'below the belt' phone app (Vic), 2016, [Online], Victoria Legal Aid, 03 9269 0120, publications@vla.vic.gov.au

This 'warts and all' analysis of a tech community legal education (CLE) project that did not work is a tool for other project makers. Victoria Legal Aid (VLA) had developed an interactive mobile phone app offering targeted, relevant and free legal information to young people on legal issues that affect them. The project cost over \$40,000 in app development, shared between six commissions, but had low uptake and its use was suspended for an internal evaluation. Subtitled 'Learning from projects that don't meet expectations', the case study looks at why the project failed and things to do differently in the future. The experience was considered instructive and invaluable and has already guided other fruitful projects. The VLA published the study to share the lessons learnt for the benefit of other project makers.

Changes to NSW associations incorporation laws (NSW), 2016, [Web page], Justice Connect (NSW), 02 9114 1793, admin@justiceconnect.org.au

Changes to the Associations Incorporation Act 2009 (NSW) and the new Associations Incorporation Regulation 2016 (NSW) commenced on 1 September 2016 and include amendments to the model constitution, new matters that must be addressed in constitutions, provisions allowing for electronic ballots, clarification of the duties of committee members, allowance for financial records to be kept electronically, and changes to the fee schedule. Information on how the amended Act and new Regulations affect your incorporated association is available on the Not-for-profit Law information hub. A webinar is also planned on the new laws and their implications.

Debt dating (NSW), 2016, [Video & Website], Financial Rights Legal Centre, 1800 007 007

The video and accompanying website are part of a new financial literacy campaign aimed at steering consumers away from 'debt management firms' using high pressure sales techniques to sell unsuitable products towards free and independent financial counselling services. Debt management firms include credit repair companies who claim to fix credit ratings; money managers who charge to manage your income, bills and debts; debt negotiators who present debt negotiating as something they do as a 'professional'; and debt agreement brokers who direct people into debt agreements, a form of insolvency. Two new online resources, the divorce and separation financial checklist and the asset stocktake calculator, have been developed by ASIC to help people navigate the financial aspects of divorce and separation. They provide guidance on separating finances and getting money on track, post separation and divorce and beginning the property settlement process, by providing a summary of assets and debts. The resources are supported by a video featuring Anne Hollonds who explains how the divorce and separation financial checklist can help navigate finances when a relationship ends. Available online.

The online updated popular pamphlet has a new look and its 12 pages contain the latest law, regulations and penalties for this offence. The scenario-based videos dramatise each step of the NCAT process from lodging an application through to case preparation, the hearing and the decision. The four videos deal with common matters heard by NCAT – on tenancy: 'Long overdue rent', guardianship: 'Managing my sister's affairs', home building: 'My home has not been built properly' and review of administrative decisions: 'A licensing issue'. An updated version of the manual was placed online in August 2016. Changes include the introduction of the NSW Civil and Administrative Tribunal (NCAT), which replaced the Consumer, Trader and Tenancy Tribunal (CTTT), and changes to the law dealing with public housing, boarding houses, and residential parks. Copies of this book are also available in the Tool Kit at local libraries.
