## **Defend the Hackney Anti-racist Three**

N Wednesday 4 December branch officers of Hackney Unison intended to present a draft report on racism to Hackney council's race equality scrutiny group. The intention was to allow the council to comment on the draft before it was finalised and sent to the Commission for Racial Equality (CRE). We understand that the report argued that the council has continued in its racist discrimatory employment practices and that the council had failed to comply with a non-discrimination notice already served by the CRE in 2000.

It is believed that the report also contains criticism of the Council for having an inadequate race equality action plan and that it calls on the CRE to seek a high court injunction restraining the council from further breaches of the Race Relations Act. On the afternoon of December 4th, the council phoned the national union office and threatened to sue for defamation unless the report was withdrawn. As it remained in a draft form, and had only been tabled for the council's comments Unison agreed to its withdrawal.

On Wednesday 11 December Hackney council suspended the Unison trade union's joint branch secretaries Brian Debus and Will Leng and the Equalities Officer, John Page. While the specific allegations against each of them vary in form, essentially they are alleged to have distributed the draft report, and in so doing have disclosed matters that the council believes they should have kept 'confidential'.

John Page has a further allegation arising from his union representation of a number of women who had complained of bullying and sexual harassment by their manager. Following numerous failings in the council's response to the women's grievances (including threatening to sack one of the women), and what appeared to be a wilful refusal by managers at any level in the organisation to follow council procedures, he wrote, in his role as Equalities Officer, to the elected Mayor requesting that their concerns be properly addressed.

Only in Hackney could this perfectly proper action of a trade union representative be considered gross misconduct!

The council has made it plain that it intends to dismiss all three branch officers.

The threatened dismissals, if carried out, will be an act of victimisation as defined by the Race Relations Act and will be unfair dismissals on the basis of whistleblowing and trade union activities. The council is well aware of this and is apparently willing to pay whatever it costs at employment tribunal in the hope that they will at least silence the criticism of racism in the borough. This is a challenge to the whole of the trade union movement, as well as undermining the right to challenge racism.

# Campaign support meeting

Hackney Trades Union Council called a 50 strong support campaign meeting on Monday 16 December. Present were a number of Unison Branch Secretaries from across London, and representatives of numerous black workers groups. Speakers from Hackney black and minority ethnic community organisations within the borough voiced their support and others have sent personal messages. Speaker's offered advice, support and office space to the campaign to get Brian, Will and John back to work, and to get the CRE to enforce its nondiscrimination notice.

#### **Council workers protest**

Despite the inevitable shock and accompanying fear resulting from the council's actions, council workers have already made public protests at the suspensions. On Thursday 19 December, Hackney Unison called a lunchtime lobby on the town hall steps to protest at the suspension of the branch officers. A request for an industrial action ballot has also been made. In a number of workplaces workers have already met and voted for strike action.

#### Out on the streets

Supporters were out on the streets of Dalston and 'the Narrow way' in the heart of Hackney on Saturday 21 December petitioning and publicising these issues. There is massive goodwill towards the Unison activists, who are well know in the community, for their commitment to fighting racism, their defence of community services, and their fearless challenges to what has been labelled by the Audit Commission as the worst performing council in the country.

## Call on the CRE to enforce the non-discrimination notice

# The Audit Commission agrees with Unison's conclusion

Is the council complying with the Non Discrimination Notice? In answering this question Unison and the Audit Commission appear to be in agreement. On Thursday 12 December, the Audit Commission issued its comprehensive performance review. It stated '*In response to a non-discrimination notice placed by the Commission for Racial Equality, the council devised a five year action plan in 2001 and produced a Race Equality Strategy (RES) in May 2002.* 

The quality of the plans is fair, but corporate performance targets for the RES have yet to be agreed and the collection and monitoring of equalities information to support the action plan is fragmented and unreliable across the council. The Phoenix Programme is a positive project to develop black and visible minority staff within the council, but the lack of clear outcome information on the progress of staff undertaking the programme reduces the confidence of participants in its ability to deliver change.

- Hardly a ringing endorsement!

#### Brief background to racism in Hackney

**1984** Hackney was served with its first 'non-discrimination notice' by the Commission for Racial Equality for persistent acts of discrimination.

1986 Black workers in Hackney stage a protest march against racism.

**1987** Publication of Arden report into freemasonary and corruption in the council

**1993-1996** CRE becomes satisfied that the council has discriminated on racial grounds against its black and ethnic minority staff

**1996** The council sends a list of workers with 'African sounding' names to the Immigration and Nationality Department of the Home Office, leading to numerous workers of African origin being harassed on the unfounded suspicion that they are illegal immigrants.

**1997** Lincoln Crawford QC finds evidence of widespread discrimination; in particular; 'No disciplinary action was taken against those managers responsible for discriminating against visible minority staff.'

**1998** During the Transforming Hackney era, black women are unlawfully prevented from returning to work from maternity leave. Unison obtains support from the EOC to successfully challenge this malpractice.

1998 CRE serves 'draft' non-discrimination notice on the council.

**2000** Hackney Unison produces report into racism in Hackney and lobbies successfully for the CRE to serve a second formal non-discrimination notice.

**2002** Unison drafts a second report to CRE asserting that the nondiscrimination notice is not being adhered to and that the CRE should take further enforcement action. The draft is sent to the employer for their comments in advance of publication. The response is to threaten to sack three Unison branch officers.

After over 20 years of CRE involvement and record numbers of employment tribunal cases, it must be time for the CRE to take further enforcement action against Hackney!
