I am directed to refer to your letter No. MFSM/work/1/2015-16/580 dated 07-07-2015 forwarding therewith the proposal for NFSM-Rice, Wheat, Pulses and Coarse Cereals with the unspent balance of last year i.e.2014-15 under NFSM to be implement during 2015-16 for an amount of Rs.7239.91 lakhs and to convey the approval of Competent Authority for implementation of NFSM in Madhya Pradesh state with an outlay of Rs.602.285 lakhs for NFSM-Coarse Cereals only during 2015-16. The intervention wise physical targets and financial outlays as approved by Government of India under NFSM for unspent amount of the year 2014-15 are indicated in the enclosed Annexure.

The State shall implement the Action Plan as per norms of NFSM- guidelines. State may submit Quarterly Progress Report of physical and financial achievements to this Ministry on regular basis.

It is observed from the above proposal that, large amount of unspent balance of last year i.e. 2014-15 under NFSM – Rice, Wheat and Pulses is proposed to utilize under the intervention "Farm Machinery". It is requested to submit the reasons for this and the final progress report of NFSM 2014-15 for Madhya Pradesh at the earliest.
