Sir/Madam,

Kindly refer to this Department's letter No. 20-1/2012-NFSM(CA-V) on the above noted subject (copy enclosed).

- 2. Andhra Pradesh vide letter No. NFSM/AP/01/2015, dated 01.05.2015 has reported total unspent balance of Rs. 2473.53 lakhs as on 01.04.2015 (calculation sheet is enclosed) as per component-wise Provisional Utilization Certificates (PUCs).
- 3. Due to changed funding pattern (sharing pattern of 50:50 between Centre & State) of the NFSM scheme during 2015-16, it has been decided that the State may spend last year's unspent balances during this year on activities which were approved in the last year's action plan but could not be completed, as per funding pattern of last year. These activities will be in addition to the activities approved in the Annual Action Plan (AAP) of Andhra Pradesh for 2015-16 for which releases have been made separately during the current year.
- 4. You are therefore, requested to implement NFSM scheme vigorously in your State and submit 100% component-wise UCs of last year's Unspent Balances on activities which were approved in the last year's action plan but completed in current year (2015-16) in Form GFR-19 (A) as well as 50% Utilization of funds released in 2015-16 through both physically and financially Quarterly Progress Reports (QPRs) on the activities of current year's approved Annual Action Plan (AAP).
- 5. You are also requested to release the State share as per approved Annual Action Plan (AAP) of 2015-16 and intimate us.
- 6. You are requested to expedite the information/material called for in **Para 4 &:** 5 above so that further release of funds can be considered. You are also requested to send the requisite information by post as well as in e-mail:

Sir/Madam,

I am directed to refer to the subject noted above and to state that National Food Security Mission (NFSM) Scheme has been approved as a part of Krishi Unnati Yojana (State Plan) with Central Share of Rs.1300.00 crore (Rupees one thousand three hundred crore only) and being implemented with interim sharing pattern of 50:50 between Centre & States during current financial year i.e. 2015-16.

- 2. NFSM was 100% funded by GOI during 2014-15 and funds were released to State Governments. Due to delay in release of funds to the State Agriculture Departments, some States Governments have reported unspent balances of 2014-15 under NFSM.
- 3. It has been decided by the Competent Authority that States may spend last year's unspent balances during this year on activities which were approved in the last year's action plan but could not be completed, as per funding pattern of last year. These activities will be in addition to the activities approved in the Annual Action Plan (AAP) for 2015-16 for which allocations have been made during the current year. In case any modification in activities is required, State Governments may take approval of DAC. However, State Government must ensure compliance of guidelines/instructions relating to implementation of the scheme, as also financial rules & procedures, as may be applicable.
- 4. This issues with the concurrence of AS&FA of the Department of Agriculture & Cooperation vide Dy No. 6628/AS&FA dated 19/05/2015.
