Sir.

Please refer to your letter No. NFSM-25/2015/94/Agri dated 31/08/2016 furnishing therin AUC of 2014-15 and PUC of 2015-16 for release of 1st installment of Grants-in-Aid (Central Share) to Bihar under NFSM during 2016-17.

- 2. In this connection, it is stated that as per AUC submitted by the Govt. of Bihar, an amount of Rs. 4490.33 lakhs of 2014-15 is lying as unspent balance under NFSM-Rice, Wheat, Pulses & Coarse Cereals with Bihar. A statement indicating component-wise opening balance, Allocation, release, expenditure & closing balance of last 3 years is enclosed.
- 3. The funding pattern (60:40 between Centre & State) of the NFSM scheme has been changed from 2015-16. The unspent balances under NFSM- Rice, Wheat, Pulses & Coarse Cereals of 2014-15 can be revalidated for utilization during 2016-17 only if it is treated as part of Central share for current year (2016-17) and the State contributes matching share as per the sharing pattern (60:40) between Centre and State. Otherwise, the State Government may refund carried forward UBs under NFSM- Rice, Wheat, Pulses & Coarse Cereals 2014-2015.
- 4. You are therefore, requested to confirm whether Bihar is willing to contribute matching share of the UBs of 2014-15 as mentioned above and release matching State share (40%) in 2016-17 or refund UBs of 2014-15 under NFSM- Rice, Wheat, Pulses & Coarse Cereals and intimate us.
- 5. You are also requested to send a line of confirmation as sought in Para 3 & 4 above so that the case of Bihar can be processed further for release of funds under NFSM.
