I have had a response from our Technical area, and they are of the opinion that the wording of the Salary regulations remain unchanged and that the rent free amount must be included in salary for superannuation.

The Superannuation (CSS) Salary Regulations 1978 specify the types of allowances that can be included as salary for superannuation purposes, including sub-regulation 5(e) which provides that;

"the rent free use by an eligible employee of premises or quarters made available by reason that he holds a particular office or performs particular duties or work"

is to be automatically included as salary for superannuation purposes (ie the 12 month criterion does not have to be met).

They do however state that there needs to be care to ensure that the rent free use is, in fact, available because the member holds a particular office or performs particular duties of work; ie there needs to be a direct correlation between the member's job and the provision of rent free housing.

For example, in the case of the NT Police, it is common for a house to be provided for an officer, often as part of the actual police station in smaller communities, so that the officer is, in effect, available 24/7. This is a clear example of there being a direct relationship between the job and the provision of premises or quarters in relation to that job.

Another example would be light house keepers who are required to tend a lighthouse and therefore live on site.

An example of where this would not apply is where a member is relocating and the employer pays for their accommodation for a certain period of time. In this situation, the payment for the accommodation is not directly linked to the job; ie it is not a requirement of the job that the member concerned live in that particular accommodation.

This needs to be kept in mind, therefore, when providing advice regarding this allowance.

Please let me know if you are going to approach regarding this, as he currently has a query with us, and I'll inform him that you will be taking care of it.

I've been thinking more about the definition of this allowance - particularly the comment below:

An example of where this would not apply is where a member is relocating and the employer pays for their accommodation for a certain period of time. In this situation, the payment for the accommodation is not directly linked to the job; ie it is not a requirement of the job that the member concerned live in that particular accommodation.

Our employees are offered to stay in a Bureau house when they undertake remote postings, rotating locations every 2 - 3 years. However, it is not a requirement for them to live in the Bureau house in order to perform their duties. Noting that they would then travel from the Bureau house to the Bureau office in order to perform their role - i.e. their living quarters are not located in/next to the Bureau office.

Do you know of any other Commonwealth agencies that currently apply this allowance? I've spoken with Defence, but their employees contribute to the rent of their housing, so their not exactly in the same situation as the Bureau. Perhaps you have other examples from other agencies, i.e. Immigration, Customs, Fisheries?

Hi Monique

I have had a response from our Technical area, and they are of the opinion that the wording of the Salary regulations remain unchanged and that the rent free amount must be included in salary for superannuation.

The Superannuation (CSS) Salary Regulations 1978 specify the types of allowances that can be included as salary for superannuation purposes, including sub-regulation 5(e) which provides that;

"the rent free use by an eligible employee of premises or quarters made available by reason that he holds a particular office or performs particular duties or work"

is to be automatically included as salary for superannuation purposes (ie the 12 month criterion does not have to be met).

They do however state that there needs to be care to ensure that the rent free use is, in fact, available because the member holds a particular office or performs particular duties of work; ie there needs to be a direct correlation between the member's job and the provision of rent free housing.

For example, in the case of the NT Police, it is common for a house to be provided for an officer, often as part of the actual police station in smaller communities, so that the officer is, in effect, available 24/7. This is a clear example of there being a direct relationship between the job and the provision of premises or quarters in relation to that job.

Another example would be light house keepers who are required to tend a lighthouse and therefore live on site.

An example of where this would not apply is where a member is relocating and the employer pays for their accommodation for a certain period of time. In this situation, the payment for the accommodation is not directly linked to the job; ie it is not a requirement of the job that the member concerned live in that particular accommodation.

This needs to be kept in mind, therefore, when providing advice regarding this allowance.

Please let me know if you are going to approach regarding this, as he currently has a query with us, and I'll inform him that you will be taking care of it.
