## 5. Student Presentations

### My role as instructor is to:

1.provide general framework for the course, 2. provide readings which introduce the various topics which we will be discussing in this course, 3. provide introductory lectures with background material not covered in the readings, 4. steer discussions when needed, 5. guide you as you delve into one particular topic in more depth in order to write your term-paper, 6. evaluate and comment on your written and oral assignments.

## Your role as student is to:

1.do the reading before class so that you can participate in discussion (attendance will be taken randomly throughout the semester, 2. participate in a more structured way by presenting your term paper to the class, 3. interact with the instructor by visiting me during office hours.

**Grading** will be based on a mid-term (30%), effective classroom participation and response papers (30%), a term-paper and its presentation (40%). There will be no final examination.

**Response papers**: The course is divided into 4 parts. At the end of **the first, the third and the fourth part**, you are expected to submit a response paper addressing all or a subset of readings up to that point. The objective is to write a concise, well-crafted question and answer that will test not only the knowledge but also analytical thinking of a student that completed all the readings and participated in all the lectures within that part. Your paper should not be longer than 500 words.

A **term paper** must be between 12-15 pages in length (double spaced, font of 12). **Deadlines:** One-page proposal: Oct. 21, upload to turnitin until 5pm. First draft: Dec. 1, upload to turnitin until 5pm.
