Disarmament

In 2009, PAEF's Policy and Organizing Director attended two meetings between representatives of arms control and disarmament groups and senior administration officials, John Holdren, the President's Science Advisor and Tom D'Agostino, Administrator for the National Nuclear Security Administration. PAEF will continue to seek opportunities for direct contact with policy makers in the President Obama administration.

PAEF participated in the Nuclear Non-Proliferation Treaty (NPT) Preparatory Committee meeting in May. Following the conference, PAEF partnered with several national and international allies, including the Japanese peace group Gensuikin, and launched a nuclear abolition petition campaign. The objective of the campaign is to urge President Obama to start negotiations for a treaty to eliminate nuclear weapons.

PAEF is providing leadership and resources to the International Planning Committee for Nuclear Abolition, Peace and Justice, (IPC) serving as the repository for petitions gathered in the US as part of the international effort. PAEF staff established and maintains a website for the campaign: (www.peaceandjusticenow.org/).

In 2009, PAEF had the honor of co-chairing the United Nations Department of Information Non-Governmental Organizations conference in Mexico City. Over 1,600 international NGO's accredited by the United Nations attended the conference, which, at the behest of the Mexican government, focused on peace and disarmament. A member of Peace Action's International Committee was chosen the Conference Co-Chair. PAEF staff participated in the conference.

PAEF activists also participated in Congressional Education days designed to directly engage and educate lawmakers about the new nuclear danger. PAEF is a founding member of the Alliance for Nuclear Accountability which sponsors 'DC Days' each spring.

PAEF activity in commemoration of Hiroshima and Nagasaki Days continues each year and, in 2009, was tied to cross-generational observances to the current struggle to prevent further nuclear proliferation and promote the abolition of nuclear weapons. In addition, PAEF's Executive Director, represented PAEF at the 64th Anniversary Observances of the Bombings of Hiroshima and Nagasaki in Japan.

PAEF also participated in key coalition meetings such as the Arms Control Collaborative, Nuclear Weapons Working Group, Alliance for Nuclear Accountability and the Peace and Security Initiative as well as yearly meetings with key congressional staff.
