# Court Wire litigation intelligence in action

## SCENARIO 1

### Lawsuit filed against a sector leader

#### SITUATION

A trader holding stocks of XYZ Pharmaceuticals, a large and well-known drug company, receives an alert that a tort lawsuit has been filed against the firm.

#### ACTIONS

The trader quickly clicks on the alert and reviews a summary of the situation. The trader then scans the at-a-glance overview of stock price changes for large-cap companies in the sector that had similar lawsuits filed against them.

#### CONCLUSION

The trader notices that XYZ's top three competitors had price drops within the first 120 minutes of the announcement, but regained the losses within 24 hours. With this historic context, the trader chooses to hold all positions in XYZ.

## SCENARIO 2

### Patent infringement for small cap equity

#### SITUATION

A trader in a small-cap focused portfolio receives an announcement that a portfolio holding has a pending patent-infringement case.

#### ACTIONS

The trader reviews the historical data, sorting by "patent" cases in the "small cap equity" capitalization category.

#### CONCLUSION

The trader realizes that two other companies with similar cases experienced a significant and sustained stock price drop, since the case was in regard to a core product. The trader decides that price fluctuations could occur rapidly, and sells the portfolio's holding in the stock as a result.

## SCENARIO 3

### Reviewing industry exposure

#### SITUATION

A major lawsuit is filed against a large financial company — with the potential to impact other companies in the sector. The trader holds a variety of positions in financials.

#### ACTIONS

Reviewing historic data for the industry, the trader uses Thomson Reuters Eikon's sophisticated charting functionality to visualize the impact a lawsuit on company can have on other similar ones.

#### CONCLUSION

Believing the impact of the suit could extend across the industry, the trader reduces exposure to the industry and considers short positions.
