Task Order of Review



- SOP WG Task: Review DTAG Structure and Operations and possibility of creating a new interagency committee: the Interagency Trade Advisory Group ("I-TAG")
- Purpose: Address the need for a policy forum to address joint ITAR and EAR issues under ECR
- Scope: support complex technology reviews to include review of "Defense articles" crossing jurisdictional authority
- Ensure that the I-TAG is permitted by existing legal requirements for Federal advisory groups

- Federal Advisory Committee Act (FACA) (1972)
 - The statutory foundation defining how federal advisory committees operate
 - Defines "advisory committee" in part as a group:

"established or utilized by one or more agencies, in the interest of obtaining advice or recommendations for the President or one or more agencies or officers of the Federal Government"

Special emphasis on open meetings, chartering, public involvement and reporting



- Federal Advisory Committee Management
 Final Rule 2001
 - New advisory committees should only be established when deemed to be essential
 - Can be established or utilized by one or more agencies after consultation with the GSA Committee Management Secretariat
 - Permits "subcommittees" defined as "a group, generally not subject to the [FACA], that reports to an advisory committee and not directly to a Federal Officer or agency, whether or not its members are drawn in whole or in part from the parent advisory committee."



- DTAG Terms of Reference and Charter
 - The DTAG functions solely as an advisory body to the Department of State's Bureau of Political-Military Affairs in compliance with the provisions of the FACA
 - Established Charter defining DTAG structure
 - To provide a formal channel for regular consultation and coordination with U.S. private sector defense exporters and defense trade specialists
 - The Terms of Reference establish two DTAG Working Groups -Policy Working Group and Regulatory/Technical Working Group
 - The DTAG Charter permits DDTC to establish Working Groups and Task Forces to assist the DTAG to carry out its work and report to the DTAG (not to USG officials)



- TAC Terms of Reference and Charter
 - The TACs advise and assist the Secretary of Commerce, Secretary of Defense, and any other US Government department or agency delegated authority by the President under the Export Administration Act (EAA)
 - Provide a formal channel for regular consultation and coordination with U.S. private sector industry
 - TACs are Chartered as necessary via a processes described in the EAA and Export Administration Regulations (EAR)
 - TACs have individual Technical Work Groups (TWG) to address specific issues
 - TWG membership can be outside the TAC
 - TWGs can be on-going (even over years) to reach closure for specific items
 - Presently 8 TACS to address different issues:

Emerging Technology

Information Systems

Materials

Material Processing Equipment

Sensor and Instrumentation

Transportation and related Equipment

Regulations and Procedures

Path to an I-TAG




- Creating an interagency collaboration mechanism
 - Similar to current stakeholder committees
 - New I-TAG
- Take steps within current laws and regulations
 - Order of review, consider DTAG, TACs and other working group tasks with overlapping policy considerations
 - Interaction at various levels within the Gov't and industry
- Unique Charter in furtherance of ECR
 - Sustainability continuous issues, long term solution identification rather than short term project based matters

DTAG use of working groups could be


