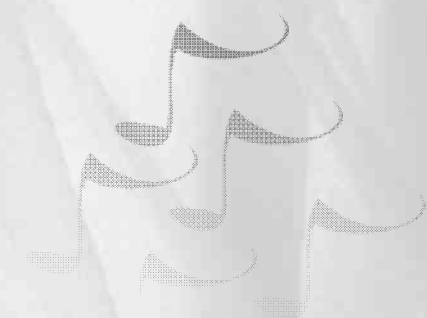

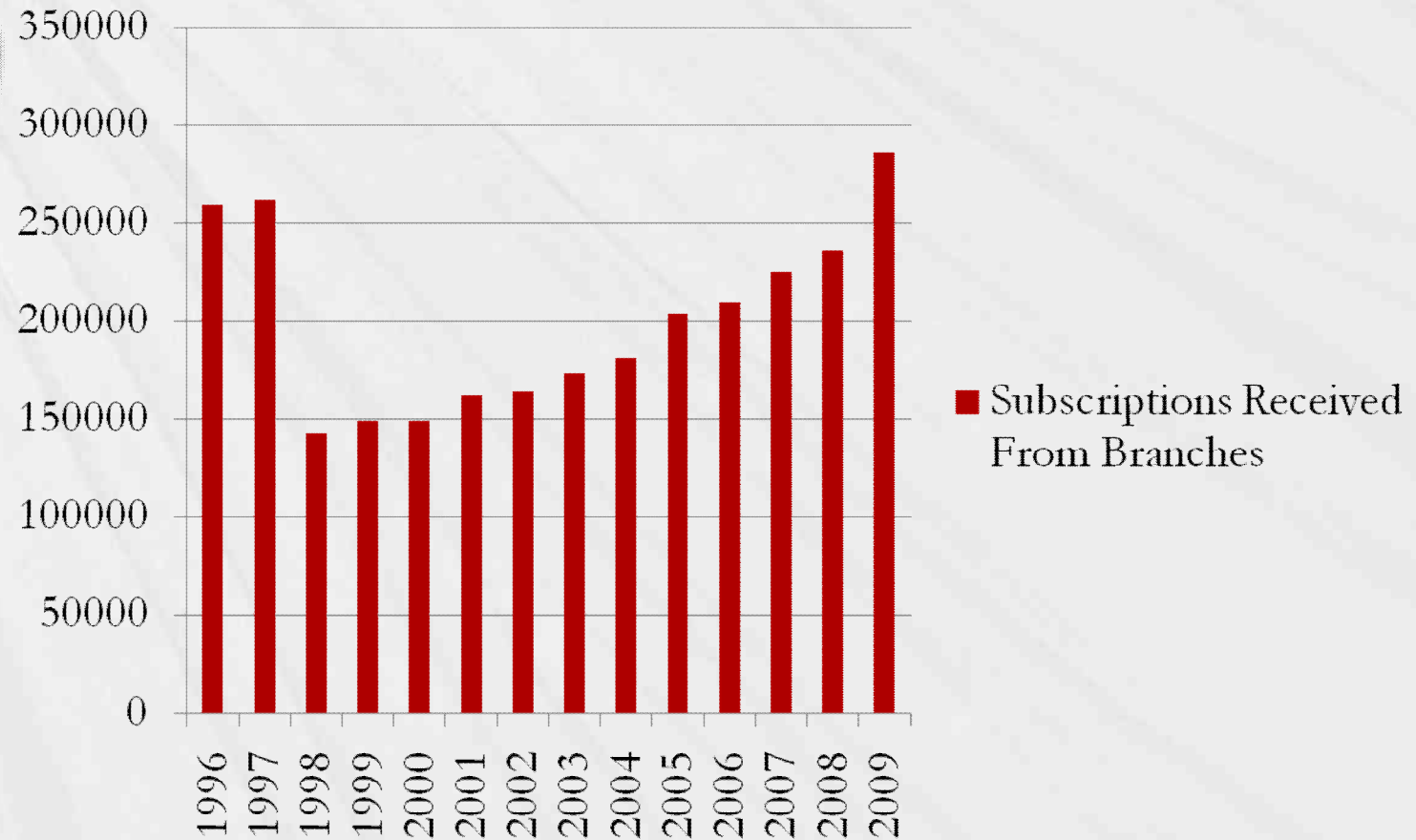

TODAYS VALUE OF THE 1996 BRANCH SUBSCRIPTIONS

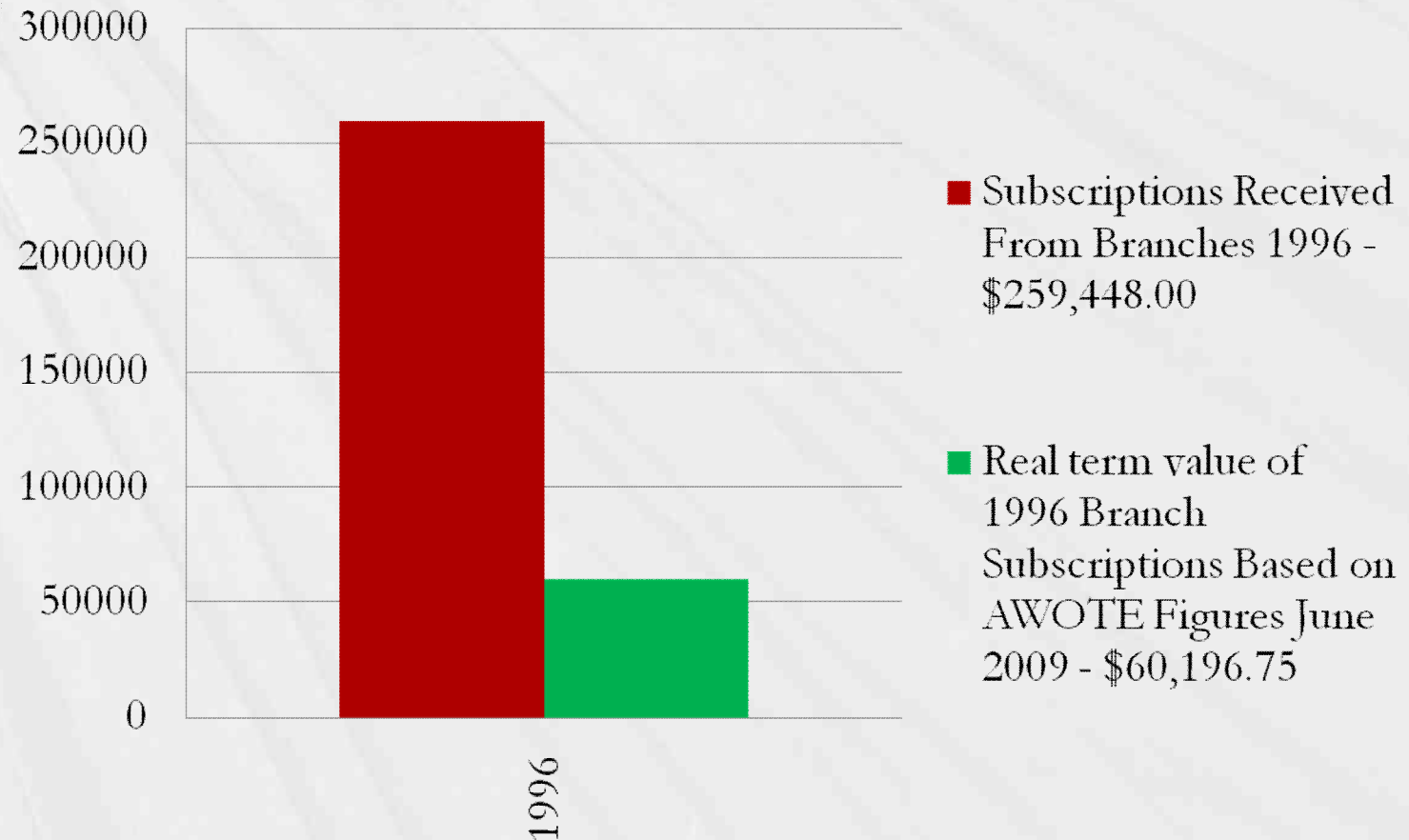
- ❖ In 1996 the Branch Subscriptions to the National Union was \$259,448.00

In 1996 the National Office had employed:

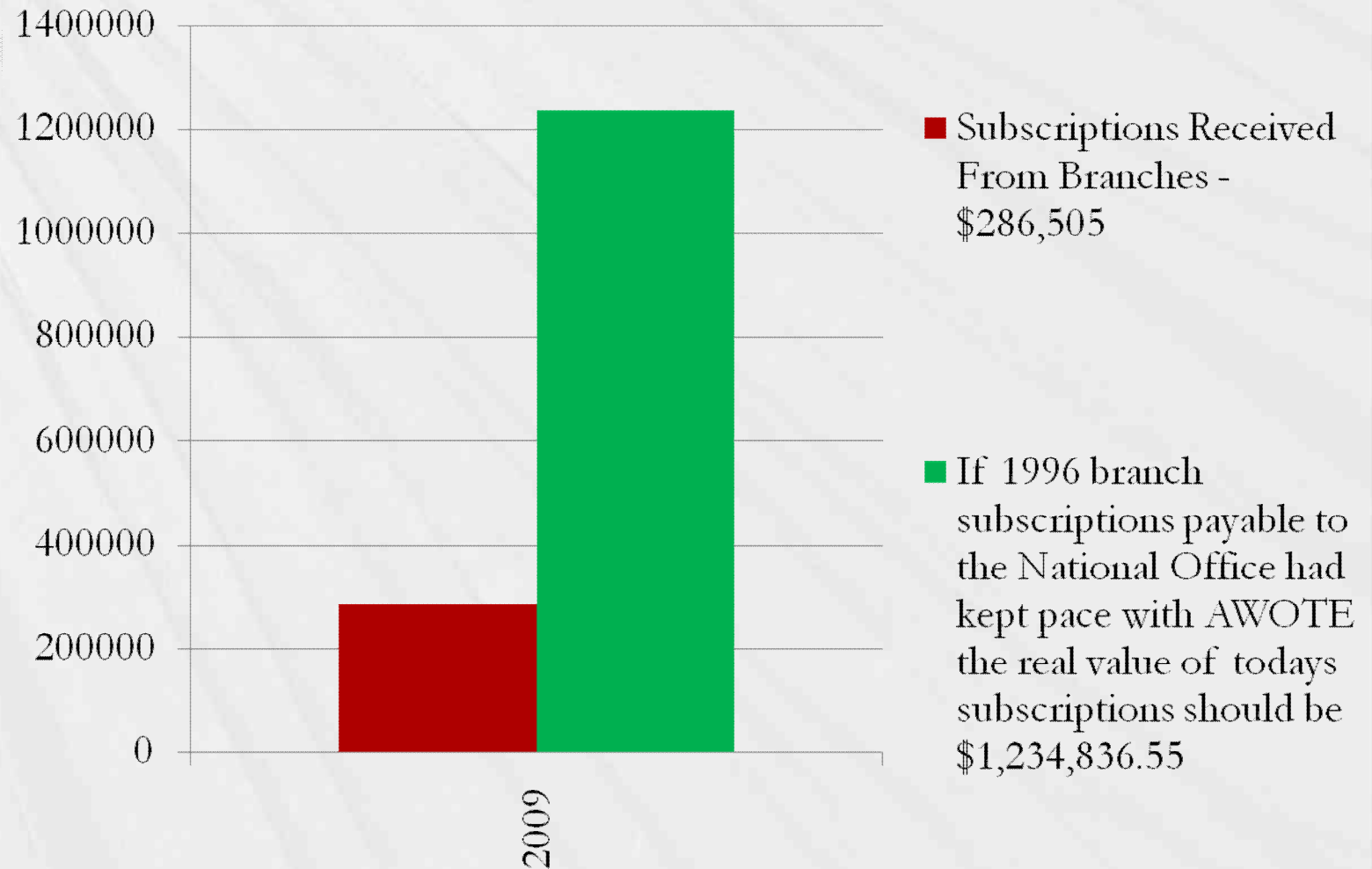
- ❖ One full time National Secretary
