DON'T BLAME MABO

June 1992 the High Court of On the 3 Australia found that indigenous Australians had rights to land in law because of their prior occupation of this land before white colonisation. The decision sent shockwayes throughout Australia because it overturned the long held legal fiction that this country was not occupied "terra nullius" before it was colonised. The Mabo decision forced the state to act to legalise the illegal occupation of this continent.

The Mabo case named after Eddie Mabo, one of the three plaintiffs from Mer in the Torres Strait, who initiated the case, could have been the beginning of a reconciliation process between indigenous and non indigenous Australians based on justice, not charity. Today there is a tendency among both indigenous and nonindigenous Australians to blame the 1992 Mabo High Court decision for the problems surrounding indigenous Australians obtaining land rights today. Sixteen years after this pivotal High Court decision the spirit of the decision has been buried in an avalanche of legislation that has made it difficult, if not impossible, for indigenous Australians to achieve land rights through the courts. Those that manage to achieve a court decision do so at the expense of giving up rights they had won in the Mabo decision.

Sixteen years later Aboriginal and Torres Strait islanders continue to live in fourth world conditions in a first world country despite the extraordinary profits that are being made by private corporations extracting wealth from their lands. The 3rd June, Mabo Day, continues to be celebrated despite the efforts that have been made by governments, private corporations, and historical revisionists to bury the Mabo High Court decision because it challenges the myths this country is based on.

Mabo Day gives the people of Australia the opportunity to acknowledge the wrongs of the past and set out on the long journey towards reconciliation between and indigenous indiaenous non Australians that is based on justice, not exploitation or charity.

QUEENSLAND OF ALL PLACES Queensland of all places should be familiar with the dangers of lead poisoning. In the 1930's Queensland doctors, in ground breaking medical research, linked the large number of deaths of young children in Queensland from kidney failure with lead based paints. In the hot climate flakes of lead paint broke off the railings enclosing Queensland's guintessential verandahs.

Medical researchers demonstrated children who developed kidney failure did so because they had eaten flakes of paint while playing on the verandah. lt's inconceivable the Queensland government, mine owners and the Federal authorities did not have the foresight to put steps in place to ensure the residents of Mt Isa especially their most vulnerable citizens - young children under ten, were not tested and protected from a problem that everyone has known has existed in areas where lead is mined for decades.

Serious questions have been raised by this totally unnecessary disaster about the price mining and surrounding communities are being asked to pay to fund the current mining boom. This disaster demonstrates how governments, mesmerised by the thirty pieces of silver they are being paid by the mining sector, are willing to turn a blind eye to mining practices that no civilised society should tolerate.

The unhealthy relationship that has developed between the growth at all costs dominating corporate and mentality business activity in Australia today and governments that are willing to turn a blind eye to dubious mining practices, because they're blinded by the money flowing into state coffers as a result of the mining boom, need to be urgently addressed so the largely avoidable problems that have developed at Mt Isa never happen again in this country.

Removing many of Bill Henson's one of the most important days in the photographs from Roslyn Oxley9 Gallery in Sydney so they can be used as evidence in a possible obscenity trial against the Gallery and Mr. Henson, reminds me of the time Christian Missionaries forced indigenous women and children to wear neck to ankle Mother Hubbards because their nudity offended the Missionaries. The Bill Henson fiasco is the latest example of the moral burga descending over secular freedom loving societies as they grapple with the problems associated with child pornography and child sex abuse.

> Nudity is not the issue, the issue is the 21st century sexualisation of children in a society where everything has its price. Paedophilia is not a new phenomenon, it has always been an issue that has troubled and continues to trouble communities. Nearly 90% of children who are sexually abused are assaulted by a family member or somebody who is known to the child. It is normally a crime of opportunity that until recently has been ignored. It was one of those issues that communities were not willing to acknowledge, let alone do something about.

> Fortunately over the last few decades child sexual abuse has become a significant community issue, because society can no longer ignore the damage caused to individuals and to society long into a sexually abused child's adult life. The strides that have been made in bringing this serious community problem to the public's attention and in tackling this scourge, are in danger of being over turned if the country is wrapped in a moral burga that makes no distinction between childhood nudity, the sexualisation of children for adult sexual gratification and profit and child sex abuse.

I'd like to thank the Prime Minister for telling the truth. Unlike Brendan Nelson who is punch drunk after the Howard government's electoral drubbing, Kevin Rudd seems to have a grip on reality. The Prime Minister is unfortunately right when he says his government has done all it can to halt spiralling petrol and food prices. He's right when he says that he does not have the power to control the marketplace.

Through his admission, Rudd has Australia's demonstrated what we all know but are unwilling to acknowledge, real power doesn't lie in parliament, it lies in the board rooms of national and transnational to corporations. Its ironic people are willing to give parliamentarians a signed blank cheque to make decisions for them for the next three years when they know that parliament and the Prime Minister are not able to exercise power over that small section of society that owns the means of production, distribution and exchange.

Kevin Rudd has demonstrated once again that power and wealth go hand in hand. You can sit at the kitchen table and make the decision to take your family to the South of France for a long holiday, but if you don't have the resources to make that decision a reality nothing will change for you and your family. The same analogy can be extended to parliament. The economic decisions parliament can and cannot make are directly related to the power it is able to exercise over the economy. The wholesale privatisation of public assets over the past few decades has markedly decreased the power parliament is able to exercise over the economy.

Prices of goods and services are directly related to the power corporations are able to exercise over the economy, not the demand for goods and services. In a society where wealth is concentrated in the hands of totally unaccountable corporations, no amount of finger waving by the Treasurer or passionate speeches by Brendan Nelson will have any impact on the prices of goods and services in a deregulated economy where economic activity is dominated by a few large corporations.

POOR OLD FRED HOLLOWS

Poor old Fred would be devastated to learn that thirty years after his trachoma blitzkrieg into indigenous communities in central Australia, the rate of preventable blindness among indigenous Australians due to trachoma has not decreased. While we pat ourselves on the back at having the best health system money can buy, every available health indicator from infant mortality to life expectancy among indigenous Australians is similar to health statistics in poorer third world countries.

Trachoma is a chronic infection of the eye caused by a bacteria called Chlamydia. It is totally preventable. It's ironic, despite military intervention in the Northern Territory, indigenous Australians continue to live fourth world lives in a first world country. (the term "fourth world" is used to describe the third world living conditions of communities living in a first world country)

Nothing highlights this more than Trachoma. Australia is the only developed country in the world that has a trachoma problem. Countries like Iran and Oman have eradicated it completely, while countries like Sudan and Zambia have made huge inroads into the problem. In

indiaenous communities Professor Fred Hollows, nothing seems to have changed. The failure of this country tackle trachoma in indigenous communities highlights the piecemeal, stop, start health care initiatives that are the norm in indigenous communities.

Trachoma is a bacterial infection of the When you set up the trust its important you put its conjunctiva of the eyelids. It causes pus to discharge from the eyelids as well as painful and swollen eyes. It can eventually cause blindness. It is both curable and preventable. The lack of success in the fight against trachoma in Australia highlights the failure of state and federal governments to take the problem of health care in Australia's indigenous communities seriously.

ANARCHIST QUESTION AND ANSWER Q. The anarchist world will rise from the ashes of the old?

A. I'm afraid not. Anarchists don't need to reinvent the wheel to create an anarchist society. Nothing needs to be destroyed except our way of thinking. Anarchism is about creating a society without rulers where the people involved in a decision make that decision and use the commonwealth to make that decision a reality. No manual tells us we need to destroy the gains made by 10,000 years of civilisation to create an anarchist society.

Destroying everything and starting from scratch does not guarantee success. Why waste resources, time and human life so we can go back to year zero. We don't need to start again. We need to abolish the state and the corporate sector and replace them with a federation of community and workplace councils based on direct democratic principles. I'm not saying this is an easy task. Of course its not. There are few examples in history of people giving up power without a fight. The struggle to create an egalitarian community is a difficult but not impossible task.

An anarchist society is not created from the top down, its built from the bottom up. You can't blow up a social relationship. Social relationships change with changing community dynamics. Every successful anarchist revolution has been reliant on mass support. Without mass support you cannot create an egalitarian community. Those activists who think everything needs to be swept away before you can build something new will find all they have done is lay the groundwork for the creation of an authoritarian community. In all authoritarian communities, power is held in the hands of a minority that attempts to mould the majority into a "perfect" society by the use of force. I have grave doubts that anything but a dog eat dog world would rise from the ashes of the old. Destroying everything to rebuild a new society is a recipe for barbarism, not anarchism.

EVEN WHEN YOU'RE DEAD YOU CAN HELP

Have you noticed how rich and powerful people love to leave their mark on society long after they're dead? They use their money to set up foundations, name buildings and support their favourite charity in a last desperate bid to achieve immortality. Well you too can emulate your masters. Why should only the rich and powerful play the life after death game.

I know it's unpleasant but you and I are going to die. Dying isn't the end. Even if you're an atheist, dying isn't the end. Your influence can continue long after you're gone. If you've spent most of your life promoting libertarian alternatives why don't you give a thought to ways you can continue to be part of the movement long after you've died. If you have a little money left over after you've made your will, why don't you think about leaving it to an anarchist group you know to continue their activities.

despite the heroic efforts of people like Instead of leaving them a lump sum which could disappear in a few months, why don't you organise for the capital to be held in trust and the interest generated from the capital to be distributed to the anarchist movement in your city every year. This way your legacy will continue for years after people have forgotten who you are. Not only will your legacy continue, but you will be able to give real support to the movement when it needs it most.

AUSTRALIAN RADICAL HISTORY THE EUREKA SERIES No. 4 2008 **"SORRY STATE OF AFFAIRS"**

The city of Ballarat has always been uncomfortable about its radical past. Even during the 150th celebrations during 2004, Ballarat councillors made the statement, too much emphasis was placed on the Eureka revolt around Australia. The Ballarat story has survived despite the Ballarat people's lack of interest in their own history. The Ballarat City Council continues to fly the Australian Flag on top of Ballarat Town Hall on 3rd December. They have consistently refused to fly the Eureka flag on the major flag pole on the Town Hall to mark the anniversary of the Eureka Rebellion.

Eureka Park resembles the contested space in the church that was erected in Bethlehem to mark the spot where Jesus Christ was born. Different Christian factions jealously guard their patch occasionally coming to blows over who owns what. In Ballarat the Eureka flag continues to be displayed in the Ballarat Art Gallery. The Gallery continues to claim ownership of the flag. The original Eureka Memorial Society is housed in an old building at one corner of the park while the brand new Eureka Centre sits at the other end. All groups participate in the annual lunch which is held on the first Sunday after the 3rd of December.

Unbelievably NOBODY celebrates EUREKA DAY on the date it occurred, 3rd December, unless it falls on a Saturday or Sunday. This year, like last year when Eureka fell on a Monday, only the Anarchist Media Institute will be conducting a series of events around Ballarat to mark the day. As usual the Ballarat media, "official" Eureka groups and most of Ballarat will not be marking the day.

BOOK REVIEW

LIBERATING PINE GAP "The story of one small group's efforts at resisting war' Authors : Christians Against All Terrorism Publisher – LeftPress 2007

This tiny 26 page pamphlet packs more punch per square inch than one of those glossy coffee table books that people glance at once in a while. The purpose of this booklet are two fold, it documents the actions of Christians Against All Terrorism, a small Christian focused group that invaded Pine Gap, the secret United States controlled military base outside Alice Springs in Central Australia, that plays a pivotal role in the United States occupation of Iraq and Afghanistan.

Six people, Donna Mulhearn, Sean O'Reilly, Jim Dowling, Bryan Law, Adele Goldie and Jessica Morrison, caused consternation in military and government circles when they conducted a successful citizens inspection of the top secret base at Pine Gap under the noses of the authorities in December 2005.

The front cover of the booklet shows Adele Goldie flashing a peace sign sitting on the roof of a building in the middle of the base next to one of the tracking stations that are used to direct United States military operations around the world.

The booklet highlights the absurdity of the current invasion and the authorities attempts to make an example of them. The four who walked into Pine Gap were charged with:

- Destroying or damaging Commonwealth property
- Trespassing on Commonwealth land
- Unlawfully entering a prohibited area
- Taking a photo on a prohibited area -
- Unlawfully damaging property

The booklet highlights the absurdity of the Supreme Court trial. The pages are peppered with choice morsels of information that show who really benefits from the "terrorist threat". Raytheon, a United States company that makes over 21 billion dollars profit a year from the military industrial complex, were responsible for security at Pine Gap. If the Pine Gap four hadn't put up a banner on the perimeter fence and used cameras with flashlights, they would never have been caught. They were fined for their involvement in the peaceful protest. The Pine Gap four were also presented with a \$10,000 bill for making a few cuts in the perimeter fence. The Howard government, shocked by the leniency of the sentence, appealed to the full court of the NT Supreme Court. The story in the booklet finishes before the government's appeal before the full bench of the Supreme Court in the Northern Territory was heard. The story finishes in 2008 when the Northern Territory Supreme Court dismissed all the charges against the Christians Against All Terrorism who had invaded Pine Gap to carry out a citizens inspection of the facility.

PERSONAL OBSERVATION

I wonder how many people reading the Anarchist Age Weekly Review know anything about Reconciliation Week. This year it begins on Tuesday 27th May and ends on Tuesday 3rd June. I'm sure you've heard about it. Well just in case you didn't know it's a relatively new concept. It begins on Sorry Day, the day eleven years ago when the Bringing Them Home report was tabled in Federal Parliament and it ends on 3rd June, the day sixteen years ago when the High Court of Australia decided in their wisdom to bury the legal fiction - Terra Nullius. For over two centuries Terra Nullius was used to justify the illegal occupation of this land. The High Court acknowledged that indigenous Australians had a right to land in law because of their prior and continuous occupation of this land.

Have you ever wondered why life is so miserable in so many Aboriginal communities? Have you ever wondered why life is so difficult for many indigenous Australians? Even after the horrendous consequences of colonisation indigenous Australians still work towards reconciliation between us. I wonder whether vou'd be interested in reconciliation if somebody booted you out of your home, killed your father, raped your sister, gave away your younger brother or sister, turned your mother into an unpaid domestic, destroyed everything you owned, prevented you from practising your religion, punished you for speaking your language, worked you into the ground for food, stole your wages and made sure you continued to be treated as an outcast in your own land, the butt of disgusting vile jokes.

I wonder how you would cope? Maybe, just maybe you'd comfort yourself with alcohol to dull the pain. I find it extraordinary that during Reconciliation Week, many indigenous Australians are willing to extend the hand of friendship to the descendents of the very people who have benefited from their pain and their loss. We can't solve the problems that exist between us in a year or two, what we can do is use Reconciliation Week to begin a journey not based on quilt but a journey that acknowledges the past and takes steps to rectify the injustices of the past by striving justice today. It's time our children's lives are not blighted by the unfinished business that exists between indigenous and non indigenous Australians today. Enough is Enough. I encourage you to lance this boil by becoming involved in Reconciliation activities between the 27th May and the 3rd June 2008.

STOP PRESS PARDONED

The execution of Colin Ross for the rape and murder of 12 year old Melbourne schoolgirl Alma Tirtschke in 1921 and the state governments decision to pardon him posthumous (The Age 27/5) needs to be examined within the social and political context of what was happening within the government, the judicial and policing circles in Victoria in the 1920's. In the middle of an austerity drive in the early 1920's, the Victorian State government decided, like the Kennett government decades later, that police numbers and police conditions needed to be rationalised as part of their drive to make significant budgetary cuts. Victoria Police had a rudimentary pension system, did not receive overtime rates, received little if any compensation if injured during work and had to do their job on a population basis with far fewer police than any other State in the post WWI period.

As a result of growing discontent within the police force, the State government appointed a Police Commissioner in 1922 - Alexander Nicholson, who was willing to do whatever it took to deal with discontent within the force. Rank and file outrage at his attempts to reduce numbers and cut conditions, led to a petition being circulated in April 1923 by Constable William Brooks that called for the restoration of pensions and conditions and parity with police conditions in other States. Day to day policing in Melbourne in the early 1920's was to a large degree carried out by single police constables who lived in substandard accommodation in the Russell Street barracks.

By October 1923, matters had come to a head and over 600 police constables had walked off the job. Army personnel were placed on guard outside Commonwealth buildings throughout Melbourne. Government appointed baton wielding vigilantes roamed the streets causing more harm than good. Although not one of the 636 police constables who took strike action were allowed back into the police force, the State government faced with the unpalatable consequences of the strike, conceded almost all the demands made by the striking police.

Colin Ross was just one of the victims of the government austerity drive; the gang violence and underworld murders that swept Melbourne in the 1920's were a direct consequence of the government's attempts to save money by refusing to allocate the necessary resources to fund a police force that could do the job required of it.

In many ways the current batch of former police officers being processed through the criminal justice system, the disbanding of both the Drug and Armed Offenders Squad, payment of compensation to people wrongly imprisoned and the formation of active criminal networks between sections of the Victoria Police and the criminal underworld, and the gangland violence that has made Melbourne the murder capital of Australia, can be directly related to the Kennett government's austerity program. This program resulted in a drop in police numbers, a deterioration in police conditions and morale, and forced police hierarchy to abandon the checks and balances that are necessary to stop the growth of corruption within the police force to meet unreasonable budgetary constraints.

Colin Ross' execution in 1922 had as much to do with government incompetence and mismanagement as it had to do with the failure of policing, the judicial system and trial by media. It is appropriate that Rob Hulls, the current Victorian Attorney General, put place in motion the processes that led to the posthumous pardon of an innocent man who was executed as a result of misguided government policy.
