## About This Guide

This Quick Start reference deployment guide discusses architectural considerations and steps for deploying security-focused baseline environments on the Amazon Web Services (AWS) cloud. Specifically, this Quick Start deploys a standardized environment that helps organizations meet the National Institute of Standards and Technology (NIST) SP 800-53 high-impact security control baseline, as well as supporting various assessment and authorization frameworks that include the requirements from the high-impact baseline:



- NIST SP 800-53 (Revision 4) high-impact security control baseline. This baseline is for workloads that are categorized as high-impact systems, per NIST FIPS Publication 199.
- The Committee on National Security Systems (CNSS) Instruction 1253
- Federal Risk and Authorization Management Program (FedRAMP)
- The DoD Cloud Computing Security Requirements Guide (SRG)
- NIST SP 800-171
- The OMB Trusted Internet Connection (TIC) Initiative FedRAMP Overlay (pilot)

The Quick Start includes Deep Security, which is a host-based security product from Trend Micro. This Quick Start deployment guide was created by AWS in partnership with Trend Micro.

The deployment guide includes links for viewing and launching <u>AWS CloudFormation</u> templates developed by AWS and Trend Micro that automate the deployment.

This Quick Start is part of a set of <u>AWS Enterprise Accelerator – Compliance</u> offerings, which provide security-focused, standardized architecture solutions to help Managed Service Providers (MSPs), cloud provisioning teams, developers, integrators, and information security teams adhere to strict security, compliance, and risk management controls.

### **Quick Links**





Figure 2: Standard three-tier web architecture depicting integration with multiple VPCs (notional development VPC shown)

If you have an AWS account that already meets the <u>technical</u> <u>requirements</u> for the NIST deployment, you can <u>launch the Quick</u> <u>Start</u> to build the architecture shown in <u>Figure 2</u>. The template is launched in the US East (N. Virginia) Region by default. If you have an AWS GovCloud (US) account, you can <u>launch the template in the</u> <u>AWS GovCloud (US) Region</u>.

The deployment takes approximately one hour. If you're new to AWS or to NIST-compliant architectures on AWS, please read the <u>overview</u> and follow the detailed <u>pre-deployment</u> and <u>deployment</u> steps described in this guide.

If you want to take a look under the covers, you can <u>view the main</u> <u>template</u> used in this deployment. The main template includes references to child templates and provides default settings that you can customize by following the instructions in this guide. For

### About Quick Starts

<u>Quick Starts</u> are automated reference deployments for key workloads on the AWS cloud. Each Quick Start launches, configures, and runs the AWS compute, network, storage, and other services required to deploy a specific workload on AWS, using AWS best practices for security and availability.



## Overview

#### AWS Enterprise Accelerator – Compliance Architectures <u>AWS Enterprise Accelerator – Compliance</u> solutions help streamline, automate, and implement secure baselines in AWS—from initial design to operational security readiness. They incorporate the expertise of AWS solutions architects, security and compliance personnel to help you build a secure and reliable architecture easily through automation.

This Quick Start includes AWS CloudFormation templates, which can be integrated with AWS Service Catalog, to automate building a standardized baseline architecture that aligns with the requirements within NIST SP 800-53, NIST SP 800-171, the FedRAMP TIC Overlay pilot, and the DoD Cloud SRG. It also includes a <u>security controls matrix</u>, which maps the security controls and requirements to architecture decisions, features, and configuration of the baseline to enhance your organization's ability to understand and assess the system security configuration.

## NIST-based Assurance Frameworks

**NIST FIPS PUB 199** establishes security categories for various federal government information and information systems, and provides guidance for determining the security category for a given information set or system. <sup>1</sup> A system can be categorized as high impact if "the loss of confidentiality, integrity, or availability could be expected to have a severe or catastrophic adverse effect on organizational operations, organizational assets, or individuals."

This Quick Start supports the following requirements:

- NIST SP 800-53 (Revision 4) high-impact security control baseline
- CNSS Instruction 1253
- FedRAMP
- The DoD Cloud Computing SRG
- NIST SP 800-171
- The OMB TIC Initiative FedRAMP Overlay (pilot)

**NIST SP 800-53**<sup>2</sup> security controls are generally applicable to Federal Information Systems, "...operated by an executive agency, by a contractor of an executive agency, or by another organization on behalf of an executive agency."<sup>3</sup> These are typically systems that must go through a formal assessment and authorization process to ensure sufficient



protection of confidentiality, integrity, and availability of information and information systems, based on the security category and impact level of the system (low, moderate, or high), and a risk determination. Security controls are selected from the NIST SP 800-53 Security Control Catalog, and the system is assessed against those security control requirements.

**NIST SP 800-171** is generally applicable to Nonfederal Information Systems that store or process federal Controlled Unclassified Information (CUI), but must appropriately protect the confidentiality of the CUI data in accordance with CUI Federal Acquisition Regulation (FAR).<sup>4</sup> These are typically businesses, educational institutions, and research organizations that legitimately store and process federal CUI on their own systems. NIST SP 800-171 chapter 3 contains a set of security requirements that align with the moderate confidentiality requirements within the NIST SP 800-53 security controls.

**The OMB Trusted Internet Connection (TIC) Initiative** is designed to reduce the number of United States Government (USG) network boundary connections, including Internet points of presence (POPs), to optimize federal network services, and improve cyber protection, detection, and response capabilities.<sup>5</sup> In its current form, a TIC-compliant architecture precludes direct access to applications running in the cloud. However, the TIC program recently proposed a draft Federal Risk and Authorization Management Program (FedRAMP)–TIC Overlay that provides a mapping of NIST SP 800-53 security controls to the required TIC capabilities. In May 2015, GSA and DHS invited AWS to participate in a FedRAMP–TIC Overlay pilot. The purpose of the pilot was to determine whether the proposed TIC overlay on the FedRAMP moderate security control baseline was achievable. In collaboration with GSA and DHS, AWS assessed how remote agency users could use the TIC overlay to access cloud-based resources, and whether existing AWS capabilities would allow an agency to enforce TIC capabilities.

**The DoD Cloud Computing Security Requirements Guide (SRG)** provides security requirements and guidance for the use of commercial cloud services by DoD mission owners.<sup>6</sup> It provides security controls implementation guidance for cloud service providers (CSPs) that wish to have their cloud service offerings (CSOs) accredited for use by DoD components and mission owners. In August 2014, AWS became one of the first CSPs to be granted a Provisional Authorization to Operate (P-ATO) to store and process DoD Impact Level 4 data. DoD mission owners that operate their workloads on AWS can use our P-ATO as part of the supporting documentation that their authorizing official (AO) uses to grant the workload a system Authorization to Operate (ATO).



## Architecture for NIST High-Impact Compliance on AWS

Deploying this Quick Start builds a multi-tier, Linux-based web application in the AWS cloud with comprehensive protection using Trend Micro's Deep Security. Figures 2 and 3 illustrate the architecture.

The sample architecture includes the following components and features:

- Basic AWS Identity and Access Management (IAM) configuration with custom IAM policies, with associated groups, roles, and instance profiles
- Standard, external-facing Amazon Virtual Private Cloud (Amazon VPC) Multi-AZ architecture with separate subnets for different application tiers and private (back-end) subnets for application and database
- Amazon Simple Storage Service (Amazon S<sub>3</sub>) buckets for encrypted web content, logging, and backup data
- Standard Amazon VPC security groups for Amazon Elastic Compute Cloud (Amazon EC2) instances and load balancers used in the sample application stack
- Three-tier Linux web application using Auto Scaling and Elastic Load Balancing, which can be modified and/or bootstrapped with customer application
- A secured bastion login host to facilitate command-line Secure Shell (SSH) access to Amazon EC2 instances for troubleshooting and systems administration activities



- Encrypted, Multi-AZ Amazon Relational Database Service (Amazon RDS) MySQL database
- Logging, monitoring, and alerts using AWS CloudTrail, Amazon CloudWatch, and AWS Config rules
- Policies for Deep Security proactive host-based protection to include preventing, monitoring, logging, and alerting for anti-malware, web reputation, file integrity, IPS/IDS, and host firewall

### **AWS Services**

The core AWS components used by this Quick Start include the following AWS services. (If you are new to AWS, see the <u>Getting Started section</u> of the AWS documentation.)

- <u>AWS CloudTrail</u> AWS CloudTrail records AWS API calls and delivers log files that include caller identity, time, source IP address, request parameters, and response elements. The call history and details provided by CloudTrail enable security analysis, resource change tracking, and compliance auditing.
- <u>Amazon CloudWatch</u> Amazon CloudWatch is a monitoring service for AWS cloud resources and the applications you run on AWS. You can use Amazon CloudWatch to collect and track metrics, collect and monitor log files, set alarms, and automatically react to changes in your AWS resources.
- <u>AWS Config</u> AWS Config is a fully managed service that provides you with an AWS resource inventory, configuration history, and configuration change notifications to enable security and governance. AWS Config rules enable you to automatically check the configuration of AWS resources recorded by AWS Config.

**Note** The AWS Config rules feature is currently available in five AWS Regions: US East (N. Virginia), US West (Oregon), EU (Frankfurt), EU (Ireland), and Asia Pacific (Tokyo).

- <u>Amazon EBS</u> Amazon Elastic Block Store (Amazon EBS) provides persistent blocklevel storage volumes for use with Amazon EC2 instances in the AWS cloud. Each Amazon EBS volume is automatically replicated within its Availability Zone to protect you from component failure, offering high availability and durability. Amazon EBS volumes provide the consistent and low-latency performance needed to run your workloads.
- <u>Amazon EC2</u> The Amazon Elastic Compute Cloud (Amazon EC2) service enables you to launch virtual machine instances with a variety of operating systems. You can



choose from existing Amazon Machine Images (AMIs) or import your own virtual machine images.

- <u>Elastic Load Balancing</u> Elastic Load Balancing automatically distributes traffic across multiple EC2 instances, to help achieve better fault tolerance and availability.
- <u>Amazon Glacier</u> Amazon Glacier is a storage service for archiving and long-term backup of infrequently used data. It provides secure, durable, and extremely low-cost storage, supports data transfer over SSL, and automatically encrypts data at rest. With Amazon Glacier, you can store your data for months, years, or even decades at a very low cost.
- <u>Amazon RDS</u> Amazon Relational Database Service (Amazon RDS) enables you to set up, operate, and scale a relational database in the AWS cloud. It also handles many database management tasks, such as database backups, software patching, automatic failure detection, and recovery, for database products such as MySQL, MariaDB, PostgreSQL, Oracle, Microsoft SQL Server, and Amazon Aurora. This Quick Start includes a MySQL database by default.
- <u>Amazon VPC</u> The Amazon Virtual Private Cloud (Amazon VPC) service lets you provision a private, logically isolated section of the AWS cloud where you can launch AWS services and other resources in a virtual network that you define. You have complete control over your virtual networking environment, including selection of your own IP address range, creation of subnets, and configuration of route tables and network gateways.

## **Trend Micro Deep Security**

Trend Micro's Deep Security is a host-based security product that provides Anti-Malware, Host Firewall, Intrusion Prevention, File Integrity Monitoring, Log Inspection, Web Application Firewalling, and Content Filtering modules in a single agent running in the guest operating system.

- Anti-malware with web reputation protects cloud instances against viruses, spyware, Trojans, and other malware with zero in-guest footprint. Performance is optimized to avoid antivirus storms commonly seen in full system scans and pattern updates from traditional security capabilities. This feature provides protection from sophisticated attacks in virtual environments by isolating malware from critical operating system and security components.
- **Intrusion prevention** examines all incoming and outgoing traffic for protocol deviations, policy violations, or content that signals an attack. This feature automatically protects against known but unpatched vulnerabilities by virtually



patching (shielding) from an unlimited number of exploits, pushing protection to thousands of servers in minutes without reboots.

- **Bidirectional host-based firewall** decreases the attack surface of cloud instances and servers with fine-grained filtering, policies per network, and location awareness for all IP-based protocols and frame types.
- **Integrity monitoring** monitors critical operating system and application files, such as directories, registry keys, and values, to detect and report malicious and unexpected changes in real time.
- **Log inspection** collects and analyzes operating system and application logs in over 100 log file formats, identifying suspicious behavior, security events, and administrative events across your cloud. Events can be forwarded to security information and event management (SIEM) products or centralized logging servers for correlation, reporting, and archiving.

### **Best Practices**

The architecture built by this Quick Start supports AWS and Trend Micro best practices for high availability and security:

- Multi-AZ architecture intended for high availability
- Isolation of instances between private/public subnets
- Security groups limiting access to only necessary services
- Network access control list (ACL) rules to filter traffic into subnets as an additional layer of network security
- A secured bastion host instance to facilitate restricted login access for system administrator actions
- Standard IAM policies with associated groups and roles, exercising least privilege
- Monitoring and logging; alerts and notifications for critical events
- S3 buckets (with security features enabled) for logging, archive, and application data
- Implementation of proper load balancing and Auto Scaling capabilities
- HTTPS-enabled Elastic Load Balancing (ELB) load balancers with hardened security policy
- Amazon RDS database backup and encryption



## How You Can Use This Quick Start

You can build an environment that serves as an example for learning, as a prototyping environment, or as a baseline for customization.

Since AWS provides a very mature set of configuration options (and new services are being released all the time), this Quick Start provides security templates that you can use for your own environment. These security templates (in the form of AWS CloudFormation templates) provide a comprehensive rule set that can be systematically enforced. You can use these templates as a starting point and customize them to match your specific use cases.

### **Cost and Licenses**

You are responsible for the cost of the AWS services and Trend Micro Deep Security software used for this Quick Start reference deployment. There is no additional cost for using the Quick Start. As of the date of publication, the cost for using the Quick Start with default settings in the US East (N. Virginia) Region is approximately \$0.96 per hour for AWS services. See the pricing pages for each AWS service you will be using for full details.

Ten trial licenses of Trend Micro Deep Security are included in the stack (expiry 01/08/2017), which will protect one EC2 instance. Please contact Trend Micro at <u>aws@trendmicro.com</u> to purchase software licenses for additional workloads, in AWS or in your data center. ## AWS CloudFormation Templates

An AWS CloudFormation template is a JSON (JavaScript Object Notation)-formatted text file that describes the AWS infrastructure needed to run an application or service along with any interconnections among infrastructure components. You can deploy a template and its associated collection of resources (called a *stack*) by using the AWS Management Console, the AWS Command Line Interface (AWS CLI), or the AWS CloudFormation API. AWS CloudFormation is available at no additional charge, and you pay only for the AWS resources needed to run your applications. Resources can consist of any AWS resource you define within the template. For a complete list of resources that can be defined within an AWS CloudFormation template, see the <u>AWS Resource Types Reference</u> in the AWS documentation.



## AWS CloudFormation Stacks

When you use AWS CloudFormation, you manage related resources as a single unit called a <u>stack</u>. In other words, you create, update, and delete a collection of resources by creating, updating, and deleting stacks. All the resources in a stack are defined by the stack's AWS CloudFormation template.

To update resources, you first modify the stack templates and then update the stack by submitting the modified template. You can work with stacks by using the <u>AWS</u> <u>CloudFormation console</u>, <u>AWS CloudFormation API</u>, or <u>AWS CLI</u>.

For more information about AWS CloudFormation and stacks, see <u>Get Started</u> in the AWS CloudFormation documentation.

### Templates Used in this Quick Start

This Quick Start uses nested AWS CloudFormation templates to deploy the <u>architecture</u> for a multi-tier, Linux-based web application with comprehensive protection provided by Trend Micro Deep Security.

The Quick Start consists of a main template and eight child templates: IAM, logging, production VPC, management VPC, Trend Micro Deep Security, Config rules, NAT instance, and application. These templates are designed to deploy the architecture within stacks that align with AWS best practices and the security compliance framework. The following table describes each template and its dependencies.

Application stack (template-application.json)	Sets up EC2 instances for reverse proxy and web application, an Amazon RDS database, HTTPS Elastic Load Balancing, Amazon CloudWatch alarms, and Auto Scaling groups.	Production VPC stack

The **template-main.json** template is the entry point for launching the entire architecture, and also allows parameters to be passed into each of the nested stacks. The JSON templates for those nested stacks deploy the resources for the architecture.

To deploy the entire architecture (including IAM and Amazon VPC), use the **template-main.json** template when launching the stacks. To deploy the full package, the IAM user must have permissions to deploy the resources each template creates, which includes IAM configuration for groups and roles.



You can also edit **template-main.json** to customize stacks or to omit stacks to be deployed. This can be useful for provisioning teams who must deploy the initial base architecture in accounts for application owners. For more information about deployment options and use cases, see <u>Deployment Methods</u>.

Additionally, you can deploy each stack independently. However, this requires that you pass individual parameters to each template upon launch, instead of relying on the main template to pass these values automatically.

## Managing the Quick Start Source Files

We've provided a GitHub repository for the tools and templates for this Quick Start so you can modify, extend, and customize them to meet your needs. You can also use your own Git or Apache Subversion source code repository, or use <u>AWS CodeCommit</u>. This is recommended to ensure proper version control, developer collaboration, and documentation of updates.

The GitHub repository for this Quick Start includes the following directories:

### Uploading the Templates to Amazon S3

The Quick Start templates are available in an Amazon S3 bucket for Quick Starts. If you're using your own S3 bucket, you can upload the AWS CloudFormation templates by using the AWS Management Console or the AWS CLI, by following these instructions.

#### Using the Console

- 1. Sign in to the AWS Management Console and open the Amazon S3 console at <u>https://console.aws.amazon.com/s3/</u>.
- 2. Choose a bucket to store the templates in.
- 3. Choose **Upload** and specify the local location of the file to upload.
- 4. Upload all template files to the same S3 bucket.
- 5. Find the template URLs by selecting each template file, and then choosing **Properties**. Make a note of the URLs.



#### Using the AWS CLI

- 1. Download the AWS CLI tool from <u>http://aws.amazon.com/cli/</u>.
- 2. Use the following AWS CLI command to upload each template file:

```
aws s3 cp <template file>.json s3://<s3bucketname>/
```

### Updating the Amazon S3 URLs

The template for the main stack lists the Amazon S3 URLs for the nested stacks. If you upload the templates to your own S3 bucket and would like to deploy the templates from there, you must modify the **vTemplateUrlPrefix** in the Mappings section of the **template-main.json** file.

## Planning the Deployment

### Prerequisites

#### Specialized Knowledge

This Quick Start requires a moderate to high level of understanding of the process to achieve and manage NIST 800-53 control requirements and compliance processes within a traditional hosting environment.

Additionally, this solution is targeted at Information Technology (IT) NIST 800-53 assessors and security personnel, and assumes familiarity with basic security concepts in the area of networking, operating systems, data encryption, operational controls, and cloud computing services.

#### Familiarity with AWS Services

This deployment guide also requires a moderate level of understanding of AWS services and requires the following, at a minimum:

- Access to a current AWS account with IAM administrator-level permissions
- Basic understanding of AWS services, AWS service limits, and AWS CloudFormation
- Knowledge of architecting applications on AWS
- Understanding of security and compliance requirements in the customer organization



AWS offers training and certification programs to help you develop skills to design, deploy, and operate your infrastructure and applications on the AWS cloud. Whether you are just getting started or looking to deepen your technical expertise, AWS has a variety of resources to meet your needs. For more information, see the <u>AWS Training and Certification website</u>, or read the <u>AWS Training and Certification Overview</u>.

#### Familiarity with Trend Micro Deep Security

This deployment guide also requires a moderate level of Trend Micro's Deep Security product knowledge:

- General understanding of host-based security implementation and management

## **Deployment Methods**

You can deploy the Quick Start templates by using AWS CLI commands or from the AWS Management Console. You can also deploy the template package as an <u>AWS Service Catalog</u> product. AWS Service Catalog enables a self-service model for deploying applications and architecture on AWS. You can create portfolios that include one or more products, which are defined by AWS CloudFormation templates. You can grant IAM users, groups, or roles access to specific portfolios, which they can then launch from a separate interface. We've provided step-by-step instructions for the AWS Management Console deployment option in the following sections.

## **Pre-Deployment Steps**

Before you deploy the NIST Quick Start templates, follow the instructions in this section to confirm that your account is set up correctly:

- Review the service limits and service usage of your AWS account and request increases if required, to ensure that there is available capacity to launch resources in your account.
- Ensure that your AWS account is set up with at least one SSH key pair (but preferably two separate key pairs) **in the AWS Region where you plan to deploy**, for use with the bastion login host and other Amazon EC2 hosts.
- Ensure that you have manually set up AWS Config in the AWS Config console, if you are deploying into an AWS Region where AWS Config is available. AWS Config is currently available in the following regions: US East (N. Virginia), US West (Oregon), EU (Frankfurt), EU (Ireland), and Asia Pacific (Tokyo).

## **Review AWS Service Limits**

To review and (if necessary) increase service limits for the resources you need for the NIST Quick Start deployment, you use the AWS Trusted Advisor console and the Amazon EC2 console. You'll need the resources specified in the <u>Technical Requirements table</u>.

Use Trusted Advisor to view the existing service limits for Amazon VPC, IAM groups, and IAM roles within your account, and ensure that there is availability to deploy additional resources:

- 1. Open the Trusted Advisor console at <u>https://console.aws.amazon.com/trustedadvisor/</u>.
- 2. In the navigation pane, choose **Performance**.



- 3. On the **Performance** page, scroll through the list of performance checks until you find **Service Limits**, and expand that section.
- 4. Scroll through the service limit names and compare the **Limit Amount** column to the **Current Usage** column, to ensure that you can allocate the following without exceeding the default limit in the AWS Region you will deploy this Quick Start into (US East [N. Virginia] is recommended):
  - Two (2) more VPCs
  - Six (6) more IAM groups
  - Five (5) more IAM roles

If an increase is needed, you can choose the limit name to open the limit increase request form shown in Figure 4.

Now use the Amazon EC2 console to check your limits for Elastic IP addresses, load balancers, and Auto Scaling groups:

- 1. Open the Amazon EC2 console at <u>https://console.aws.amazon.com/ec2/</u>.
- 2. In the navigation pane, under Network & Security, choose Elastic IPs.
- 3. Count the number of allocated Elastic IPs (if any) displayed in the list, and ensure that you can allocate three (3) more without exceeding the default limit of 5 (or the limit increase you previously requested).
- 4. In the navigation pane, under Load Balancing, choose Load Balancers.
- 5. Count the number of existing load balancers (if any) displayed in the list and ensure that you can create four (4) more without exceeding the default limit of 20 (or the limit increase you previously requested).
- 6. In the navigation pane, under Auto Scaling, choose Auto Scaling Groups.
- 7. Count the number of existing Auto Scaling groups (if any) displayed in the list and ensure that you can create two (2) more without exceeding the default limit of 20 (or the limit increase you previously requested).


### Create Amazon EC2 Key Pairs

Make sure that at least one Amazon EC2 key pair exists within your AWS account in the region you are planning to deploy the Quick Start in.

- 1. Open the Amazon EC2 console at <u>https://console.aws.amazon.com/ec2/</u>.
- 2. Use the region selector in the navigation bar to choose the AWS region where you plan to deploy.
- 3. In the navigation pane, under Network & Security, choose Key Pairs.
- 4. In the key pair list, verify that at least one available key pair (but preferably two available key pairs) exist and make note of the key pair name(s). You'll need to provide a key pair name for the parameters **pEC2KeyPairBastion** (for bastion host login access) and **pEC2KeyPair** (for all other Amazon EC2 host login access) when you launch the Quick Start. Although you can use the same key pair for both parameters, we recommend that you use a different key pair for each.

If you want to create a new key pair, choose **Create Key Pair**. For additional information, see the <u>Amazon EC2 documentation</u>.

**Note** If you're deploying the Quick Start for testing or proof of concept, we recommend that you create a new key pair instead of specifying a key pair that's already being used by a production instance.

### Set up AWS Config

If AWS Config has not yet been initialized in the region where you are deploying this Quick Start, follow the steps below **in the region where you are planning to deploy the Quick Start**.

- 1. Open the AWS Config console at <u>https://console.aws.amazon.com/config/</u>.
- 2. Use the region selector in the navigation bar to choose the AWS Region where you plan to deploy.
- 3. In the AWS Config console, choose Get Started (or Get Started Now).

## **Deployment Steps**

Follow the step-by-step instructions in this section to sign in to your AWS account, customize the Quick Start templates, and deploy the software into your account.

### What We'll Cover

The procedure for deploying the Quick Start architecture on AWS consists of the following steps, which we'll cover in detail in the following sections.

#### Step 1. Sign in to your AWS account

• Sign in to your AWS account, and make sure that it's configured correctly.

#### Step 2. Launch the stacks

- Launch the main AWS CloudFormation template into your AWS account.
- Enter values for required parameters.
- Review the other template parameters, and customize their values if necessary.

#### Step 3. Test your deployment

- Use the URL provided in the **Outputs** tab for the main stack to test the deployment.
- Use the IP address for the bastion host provided by the **Outputs** tab for the main stack, and use your private key if you would like to connect to that host through SSH.

## Step 1. Sign in to Your AWS Account

- 1. Sign in to your AWS account at <u>http://aws.amazon.com</u> with an IAM user role that has the appropriate privileges (see <u>IAM Permissions</u> earlier in this document).
- 2. Make sure that your AWS account is configured correctly. See the <u>Technical</u> <u>Requirements</u> and <u>Pre-Deployment Steps</u> sections for information. Note that if you plan to use an AWS Region with the AWS Config capability, you must first set up the AWS Config service manually by following the instructions in the <u>previous section</u>.
- 3. Use the region selector in the navigation bar to choose the AWS Region where you want to deploy the NIST high-impact controls architecture on AWS.

Amazon EC2 locations are composed of *Regions* and *Availability Zones*. Regions are dispersed and located in separate geographic areas. This Quick Start uses the **m3.large** instance type for the WordPress and Nginx portion of the deployment. m3.large instances are currently available in all AWS Regions except China (Beijing). The AWS

Config Rules service is currently available only in the US East (N. Virginia), US West (Oregon), EU (Frankfurt), EU (Ireland), and Asia Pacific (Tokyo) Regions.

**Tip** Consider choosing a region closest to your data center or corporate network to reduce network latency between systems running on AWS and the systems and users on your corporate network. If you plan to use the optional AWS Config rules capability, you must choose the US East (N. Virginia), US West (Oregon), EU (Frankfurt), EU (Ireland), or Asia Pacific (Tokyo) Region until AWS Config rules become available in other regions.

4. Select the key pair that you created <u>earlier</u>. In the navigation pane of the Amazon EC2 console, choose **Key Pairs**, and then choose the key pair from the list.

## Step 2. Launch the Stacks

This automated AWS CloudFormation template deploys the Quick Start architecture in multiple Availability Zones into Amazon VPCs. Please review the <u>technical requirements</u> and <u>pre-deployment steps</u> before launching the stacks.

## 1. <u>Launch the AWS CloudFormation template</u> into your AWS account.

#### Launch

The template will be deployed into the AWS Region that appears in the navigation bar at the upper-right corner of the AWS Management Console. You can change the region by using the region selector in the navigation bar. Note that if you select a region where



AWS Config is available, make sure to manually initialize the AWS Config service in that region.

If you have an AWS GovCloud (US) account, you can <u>launch the template in the AWS</u> <u>GovCloud (US) Region</u>.

The stacks take approximately one hour to create.

**Note** You are responsible for the cost of the AWS services used while running this Quick Start reference deployment. There is no additional cost for using this Quick Start. As of the date of publication, the cost for using the Quick Start with default settings is approximately \$0.96 an hour for AWS services, and you can complete the initial deployment for about \$3.00. Prices are subject to change. See the pricing pages for each AWS service you will be using in this Quick Start for full details.

The Quick Start deployment includes ten trial licenses for Trend Micro Deep Security, which will protect one EC2 instance; see <u>http://aws.trendmicro.com</u> for additional licensing and purchasing options.

You can also <u>download the template</u> to use it as a starting point for your customization.

- 2. On the **Select Template** page, keep the default settings for the template URL, and then choose **Next**.
- 3. On the **Specify Details** page, provide the required parameter values for the template. These are described in the following table.



**Note** You can also <u>download the main template</u> and edit it to create your own parameters based on your specific deployment scenario.

4. On the **Options** page, you can <u>specify tags</u> (key-value pairs) for resources in your stack and <u>set additional options</u>. You can use the tags to organize and control access to resources in the stacks. When you're done, choose **Next**.



5. On the **Review** page, review the settings and select the acknowledgement check box. This simply states that the template will create IAM resources.





- 6. Choose **Create** to deploy the stack.
- 7. Monitor the status of the stack being deployed. When the status field shown in Figure 12 displays **CREATE\_COMPLETE for all the stacks deployed**, the cluster for this reference architecture is ready. Since you're deploying the full architecture, you'll see eight stacks listed (for the main template and seven nested templates).




Figure 14: Landing page for Quick Start on AWS

This deployment builds a working demo of a Multi-AZ WordPress site. To connect to the WordPress site, choose the URL provided for the WordPress application on the landing page shown in Figure 14. This URL is also available from the **WebsiteURL** link on the **Outputs** tab shown in Figure 13 for the main stack.



**Note** WordPress is provided for testing and proof-of-concept purposes only; it is not intended for production use. You can replace it with another application of your choice.

**Note** The WordPress application included in this Quick Start deployment is for demo purposes only. Application-level security, including patching, operating system updates, and addressing application vulnerabilities, is the customer's responsibility (see the <u>AWS</u> <u>Shared Responsibility Model</u>). For this Quick Start, we recommend that you delete the AWS CloudFormation stacks after your proof-of-concept demo or testing is complete.




Figure 16: Deep Security Manager Console

For Deep Security, this deployment provides a web console for configuration and management, illustrated in Figure 16. To access this web console, choose the URL provided from the **DeepSecurityConsole** link on the **Outputs** tab (shown previously in Figure 13) for the main stack.

## **Deleting the Stacks**

When you've finished using the baseline environment, you can delete the stacks. Deleting a stack, either via CLI and APIs or through the AWS CloudFormation console, will remove all the resources created by the template for that stack. **The only exceptions are the S3 buckets for logging and backup. By default, the deletion policy for those buckets is set to "Retain," so you have to delete them manually.** 

**Important** This Quick Start deployment uses nested AWS CloudFormation templates, so deleting the main stack will remove the nested stacks and all associated resources.



## Troubleshooting

If you encounter a **CREATE\_FAILED** error when you deploy the Quick Start, refer to the following table for known issues and solutions.

Error message	Possible cause	What to do
The following resource(s) failed to create: [rConfigRuleForRequiredTags, rConfigRuleForUnrestrictedPorts, rConfigRuleForSSH, rConfigRulesLambdaRole]	The <b>Support Config</b> parameter was set to <b>Yes</b> , but AWS Config isn't available in the region you selected, or AWS Config has not been initialized.	Set the <b>Support Config</b> parameter to <b>No</b> , or select another region. Also make sure that AWS Config is set up properly, as described in the <u>pre-deployment steps</u> .
Maximum VPCs limit reached	You've exceeded the number of VPCs allowed in your account.	Delete VPCs and/or request a limit increase. Try to create the stack again. For more information, see <u>technical</u> <u>requirements</u> .
Maximum EIPs limit reached	You've exceeded the limit of Elastic IP addresses in your account.	Disassociate Elastic IPs or request a Elastic IP limit increase, and try to create the stack again. For more information, see <u>technical</u> <u>requirements</u> .
Other limits exceeded	You've exceeded the use of resources in your AWS account.	See <u>technical requirements</u> , and <u>request</u> <u>service limit increases</u> as necessary.

If the problem you encounter isn't covered in this table, we recommend that you relaunch the template with **Rollback on failure** set to **No** (this setting is under **Advanced** in the AWS CloudFormation console, **Options** page) and open a support case in the <u>AWS</u> <u>Support Center</u> for further troubleshooting. When rollback is disabled, the stack's state will be retained and the instance will be left running, so the support team can help troubleshoot the issue.

**Important** When you set **Rollback on failure** to **No**, you'll continue to incur AWS charges for this stack. Please make sure to delete the stack when you've finished troubleshooting.

## Integrating with AWS Service Catalog

You can add the AWS CloudFormation templates for this Quick Start to AWS Service Catalog as portfolios or products to manage them from a central location. This helps support consistent governance, security, and compliance requirements. It also enables users to quickly deploy only the approved IT services they need.

This latest compliance Quick Start for NIST SP 800-53 high-impact controls on the AWS cloud featuring Trend Micro Deep Security includes the following security and compliance enhancements:

- HTTPS load balancers with custom security policy using TLS and auto-generation of a self-signed certificate for testing purposes
- Network access control list (ACL) rules for filtering ingress/egress traffic as an additional layer of network security
- Security groups to limit both inbound and outbound traffic to only available ports and protocols
- AWS Config rules automatically deployed for monitoring specific resources most relevant to compliance
- Secure Amazon S<sub>3</sub> policies for logging and application buckets, including custom lifecycle policies for archiving objects in Amazon Glacier and use of versioning
- Custom CloudWatch alarms and notifications for specific security-related events in CloudTrail logging of root activity, IAM changes, and changes to logging policies
- Simplified AWS CloudFormation templates that decouple components, including VPCs, to allow for easier modification and reuse
- Reduced set of AWS CloudFormation parameter groups and labels to simplify console use during the deployment process
- Elastic Load Balancing and Amazon S3 access logging enabled for the application layer
- Deployment of a secured login bastion host for SSH access to Amazon EC2 instances within the architecture
- Elastic Load Balancing for the Deep Security Manager
- Multi-AZ redundancy for the Deep Security Database through Amazon RDS
- Deep Security Anti-malware and web reputation enabled
- Deep Security Intrusion Prevention rules deployed to protect against network attacks and provide shielding from known vulnerabilities and exploits
- Deep Security Firewall enabled to provide logging on network traffic



- Deep Security Integrity Monitoring started to detect and report unexpected changes to files and the system registry
- Deep Security Log Inspection rules to turn on alerts for important security events
