The Native Title Determinations Summary document provides a national overview of native title determinations. The document provides links to determination summaries on the National Native Title Tribunal (NNTT) and the Agreements, Treaties and Negotiated Settlements (ATNS) websites. The document also provides links to the relevant case law on the Australasian Legal Information Institute (Austlii) website.

Following the determination in September 2008 of the Prescribed Body Corporate in relation to the *Rubibi* determination, the NNTT considered its approach to reflecting that determination, and two other earlier conditional determinations *Miriuwung Gajerrong* (Western Australia) and *Mandingalbay Yidinji* (Queensland) on the National Native Title Register (NNTR). It was decided that the NNTR entries should be amended to reflect a single entry per court decision, rather than separate entries for parts of the determination which came into effect on different dates. Accordingly, statistics in relation to determinations of native title have changed as the affected NNTR entries have been consolidated. The NNTR entries for *Rubibi* and *Miriuwung Gajerrong* (Western Australia) and *Mandingalbay Yidinji* (Queensland) have been updated to reflect a single entry for each judgment, and the statistics have been updated accordingly.
