### 'APPROVED FORM' FOR THE PURPOSES OF NON-VOTER PROCEEDINGS

Commonwealth Electoral Act 1918 Subsections 245(3), 245(6), 245(9) Referendum (Machinery Provisions) Act 1984 Subsection 45(3), 45(6), 45(9)

I, Tom Rogers, Electoral Commissioner, in exercise of the power under subsection 4(1) of the *Commonwealth Electoral Act 1918* (Electoral Act) and subsection 3(1) of the *Referendum (Machinery Provisions) Act 1984* (Referendum Act), do hereby:

- 1. **REVOKE** all previous 'approved forms' for the purposes of section 245 of the Electoral Act and section 45 of the Referendum Act;
- 2. **APPROVE** the forms that appear in the Schedule to this instrument to be 'approved forms' for the purpose of issuing notices:
  - a. under section 245(3) of the Electoral Act and section 45(3) of the Referendum Act;
  - b. under section 245(6) of the Electoral Act and section 45(6) of the Referendum Act; and
  - c. under section 245(9) of the Electoral Act and section 45(9) of the Referendum Act.



#### Dear

You were recently sent a penalty notice about your failure to vote at the recent <<elec desc>> held on Saturday <<elec date>>. In my opinion, the reason you have provided for not voting is not a valid and sufficient reason for the failure to vote. Under the Commonwealth Electoral Act 1918 and Referendum (Machinery Provisions) Act 1984 it is a criminal offence to fail to vote without a valid and sufficient reason.

As you did not provide a valid and sufficient reason for why you did not vote, you may:

- avoid having this matter dealt with by a court by paying \$20.00 to the Divisional Returning Officer by <<due date>>; or
- 2. allow the AEC to pursue the option of referring the matter to be dealt with by the courts by completing the form below and returning it by <<due date>> in the envelope provided.

If you do not meet either of the requirements above this matter may be referred to a court.

Having the matter dealt with by a court may result in a maximum fine of \$180.00 (plus any court costs) and a criminal conviction may be recorded against you.

If you are unable to respond someone else can complete the form or pay the penalty on your behalf. Should you require any further information, please contact this office on the phone number above.
