

# NSW Aboriginal Land Council the freddy fricke scholarship

## 2017 Application Guidelines

- **1. ELIGIBILITY.** Make sure you're eligible to apply before you commence your application.
- **2. EVIDENCE.** Make sure you attach all the relevant supporting documentation.
- **3. SELECTION CRITERIA AND WEIGHTING.** Know what we are looking for.
- **4. DO'S & DON'TS.** Things to remember and things to avoid.

#### 1. ELIGIBILITY.

To be eligible to receive a scholarship you must:

- Be Aboriginal,
- Be a resident of New South Wales,
- Be enrolled full-time in a Diploma or Undergraduate degree at a university in NSW &
- Include evidence and supporting documentation

#### 2. EVIDENCE.

To be eligible for a scholarship you need to include all necessary supporting documentation in your application including, but not limited to:

- Academic records/transcripts
- Enrolment in a University Course, and
- Confirmation of Aboriginality:
   The NSW Aboriginal Land Council will only accept the following documents as Confirmation of Aboriginality:
  - a) Confirmation from a LALC: If you are a member of a Local Aboriginal Land Council (LALC), please provide confirmation of your membership and submit it with your application. This will confirm LALC membership and Aboriginality.
  - b) If a parent is a member of a LALC, please provide confirmation of a parent's membership.
  - c) Declaration from a NSWALC Councillor: Each region in NSW has a elected Councillor, www. alc.org.au/about-nswalc/our-council.aspx. You can request a Councillor Declaration form and more information at <a href="mailto:scholarships@alc.org.au">scholarships@alc.org.au</a>.

#### 3. SELECTION CRITERIA

CRITERIA	WEIGHTING	WHAT WE ARE LOOKING FOR
Membership of a LALC	5%	Rewarding members for being actively involved in the community.
Other Scholarships	5%	Initiative in applying for assistance.
Academic History	15%	A strong commitment to study demonstrated through sustained engagement with educational opportunities.
Involvement in the local community	15%	Sustained engagement with the local community demonstrated through genuine interest and participation in the local community.
Importance of completing the course	15%	Significant motivation to undertake tertiary education to realise personal goals.
Impact on family and community	20%	Tertiary education will have a significant, positive impact on family and community through the transfer of skills and knowledge.
Financial Barriers	25%	A genuine need for financial assistance to overcome significant barriers, despite demonstrated ambition.
Overall: Assessment of need and equity	100%	Need: The discrepancy between current circumstances and desired future outcomes. Equity: How the completion of the course will impact the applicant, their family and the local community.



### 4. DO'S & DON'TS. OTHER POINTS TO CONSIDER.

- Please try to keep your responses concise and to the point.
- There are no right or wrong answers. Read the question, and respond honestly.
- Please complete applications individually (please don't have someone else do it for you).
- Please ensure your writing is legible. If you prefer to type responses and attach, you can.
- Make sure you submit your application by the due date, **9am**, **30th January 2017**.
