While the United Nations Conference on Trade and Development (UNCTAD) has yet to announce the world investment results for last year, it was a remarkable achievement for Hong Kong to come second in 2014 in the global league in terms of foreign direct investment (FDI).

Significantly, global FDI shrank by 16% in 2014, but Hong Kong bucked the trend with FDI soaring to US\$103 billion, second only to China, but superior to the US, the UK and Singapore in that order. So it is an unequivocal vindication of our sustained attraction for overseas investors.

The 7,500 companies from overseas and Mainland China that have set up shop in Hong Kong are testament to the fact that there is no better or easier place to do business.

Hong Kong is well-placed in seizing emerging business opportunities

According to InvestHK, a government body tasked to facilitate inward investments, it has notched a new record by helping 375 overseas and Mainland companies set up or expand their businesses in Hong Kong last year, representing an increase of 5.6% year-on-year.

In an earlier press conference, the jubilant Director-General of Investment Promotion Dr Simon Galpin pointed out that those 375 completed projects came from 36 economies, with the Mainland continuing to lead with a total of 78 projects, followed by the US with 49, the UK with 36, Japan with 31, and France with 20.

For the first time, InvestHK helped two companies from Latvia and the Seychelles to set up in Hong Kong. In terms of emerging subsectors, there was a growing number of companies in the IOT (Internet of Things) and FinTech (financial technology).

Dr Galpin said that despite ongoing challenges in the global economy, Hong Kong continues to attract overseas and Mainland investors because of its enduring advantages and emerging business opportunities. He named the Mainland and the Association of Southeast Asian Nations as the department's priority areas in the current year.

New economic order

In his 2016-17 Budget Speech, the Financial Secretary John Tsang summed up Hong Kong's competitive edge over the years: "Our trade network is highly internationalized, our market is transparent and open, and our society is clean and law-abiding."

But he was also at pains to point out that we live in a 'new economic order'. The global economy, he noted, has undergone sweeping changes since the 2008 financial tsunami.

"With the global economic gravity shifting towards the East, emerging markets are playing a much more important and influential role," he said. "Breakthroughs in IT development have also brought about paradigm shifts in different economic and social spheres, changing our daily lives and business modalities."

The two forces, he pointed out, have not only offered new directions and provided room for developments for both traditional and emerging industries, but also lowered the threshold for start-ups and created a more open market ecosystem.

Tsang highlighted the fact that Hong Kong has world-class IT facilities, research and development (R&D) institutes and personnel, financing platforms, and above all, a well-developed system to safeguard intellectual property (IP) rights. The neighbouring Pearl River Delta Region, and Shenzhen in particular, has developed into a manufacturing hub of advanced technology products in recent years. The immense synergy effects so generated will provide powerful support for Hong Kong's internationalised corporations in material application, prototyping and production.

"Having regard to Hong Kong's practical circumstances, comparative advantages and the direction of our urban development, we can widely apply and commercialise R&D results in the three areas of robotics, healthy ageing and smart city to boost economic development and enhance the quality of life," he added.

In this respect, Government has earmarked funds in support of a number of academic institutions, NGOs and the private sector, with SMEs in particular, to pursue their R&D initiatives with a view to facilitating their commercialization.

Fintech under focus

A major focus of this year's Budget Speech is on financial technologies (Fintech) which capitalize on developments in mobile communications technology and artificial intelligence. It offers consumers novel experiences in managing their finances and provides financial institutions with tools to improve their operational efficiency.

"Provision of financial services is no longer confined to traditional financial institutions such as banks and insurance companies," Tsang said. "By leveraging the Internet and mobile technologies, telecommunication companies, e-commerce enterprises and start-ups are now able to provide financial services to individuals and enterprises."

Fintech can be applied to a wide range of areas such as electronic payments, robo-advisors, distribution of financial products, big data analytics, cyber security, equity crowdfunding and peer-to-peer (P2P) lending. Some studies predicted that global investments in Fintech will surge from US\$12 billion in 2014 to over US\$46 billion in 2020.

In recent years, a number of international financial institutions and professional services firms, including Accenture, the Commonwealth Bank of Australia, KPMG, Nest and Tuspark, have chosen to establish laboratories and incubation programmes in Hong Kong. "This underlines our edge in developing Fintech," Tsang emphasized. "Government will set up a dedicated team under InvestHK to organise international events and facilitate start-ups, investors and R&D institutions to establish their presence in Hong Kong."

Belt & Road initiative

Hong Kong is also watching closely the emerging markets covered by China's Belt & Road initiative, as they are likely to become the new impetus for our future development. And in the same context, Hong Kong will continue its active discussion with the Asian Infrastructure Investment Bank (AIIB) and the Central Government on its participation in the AIIB as a non-sovereign territory, and seek to leverage our expertise to service AIIB in capital markets financing, asset management and dispute resolution.
