She was with the best doctors and the best Every day ..... alcohol, she therapist. couldn't ..... just brought out this monster and the monster won. When ..... yeah, that would HANDSJUK: Oh qosh. ..... thank you. Thank you. Just weeks left and she's probably ..... ANTONY HAMPEL: I never want to ...... I never want to ..... so hard, and that was O.K. because I knew HANDSJUK: Yeah. ANTONY HAMPEL: But she didn't believe anyone loved her, and that was the illness, you know? She didn't believe that she was worthy of ..... didn't want to burden her family anymore, and that's ..... brain. The little things ...... I know exactly what was going through her head, I know ..... and it wasn't her, it wasn't your daughter.

I know that.

HANDSJUK:

Yeah.

ANTONY HAMPEL: ...... you know, she's a sweet ...... I thought she was ..... it was such a cycle, you know, she'd just pick herself up again and try a new way but each time she woke up ..... kept going. And I had no reason to worry that day. I knew ..... the day before I came home, I think ..... all the way and that night I gave her a bath, I made her dinner, I gave her her vitamins and I just knew the normal cycle if she didn't wake up, then she'd beat herself up and then she'd pick herself up again and off she'd go. But this time she woke up and started drinking again.

HANDSJUK:

How, how do you know that was drinking?

ANTONY HAMPEL: When I got home and there was a little shrine on our bed, there was a photo of us and there was a photo of her cat and all her rambled notes. And there was a note she liked that she ..... that didn't make a lot of sense and, but then when I walked into the, into the kitchen her bag was there, her keys were there, her wallet was there. She'd never ever ever ever leave the house without her bag, because that was her thing, she knew if she ever had to escape she had her bag.

I'm a bit like that with my bag.

ANTONY HAMPEL: She was ...... in bed in the morning and ....... didn't leave her side for two days, he was curled up in a ball, he knew something was wrong, he didn't move, did not move for two days.

And in the morning she was just sleeping peacefully and that's why I didn't wake her, because I knew she'd be O.K. And ......

HANDSJUK: So was that before you went to work? Was that before?

ANTONY HAMPEL: Yeah. And I rang her all day on the landline, but not out of panic, just to say, Hey, you know, what are you doing? And - - -

HANDSJUK: And did she answer?

ANTONY HAMPEL: No. And her phone was broken for two days. She'd broken ...... went out. I sent it off to get fixed.

I got home and she was O.K, I mean, you know, she was all right, so I made her dinner and a bath, and I thought, All right, well, let's not worry about it now, and don't apologise now, and let's just get you healthy and then we'll work out another plan, you know, we'll try something else. And she agreed. And the next morning she was asleep, just sleeping peacefully but she'd never ever get up again and start drinking ..... this time, I think, I think what's happened is that, she said when she went out on the, I don't even know what night it was, the Tuesday when she wandered the streets all day and the Tuesday night she finally got home and I said to her on the Wednesday, you know, What did you drink? Where did you go? What did you do? And I said, Did you take any other drug? And she said, Ecstasy. And I thought, You know, what's happened, if it was just the alcohol she would've gotten up

whatever, and think this time she'd woken up with nothing but the Ecstasy, she'd woken up so far down more. And I think that's what did it, I ......... drinking.

HANDSJUK: Did she say who she, who she was with?

ANTONY HAMPEL: Oh, that fuckwit Bren or whatever his name is.

HANDSJUK: , Did she say she was with Bren?

ANTONY HAMPEL: I knew she was with Bren on Monday night.

HANDSJUK: No, but did she say she was with Bren on Tuesday?

I'm pretty sure that's what it was, because the Ecstasy would've sent her so much lower than she'd normally be, and she had no way to cope, you know how fragile she was. She was just so delicate, you know. And I rang and she couldn't pick up the phone, she knew I wasn't angry with her, and I said, Let's not worry about it now, let's not talk about what's happened, let's just get you healthy again. I said, Don't worry about your boss. He just said, Come back whenever you want, but just ..... too much. I know I've only known her for 18 months but from what you've told me, I mean, she lived with this every minute of every day for God knows how many years, and you know, who could. I don't have any guilt. I don't have any blame. And I'm lucky like that, and I didn't find her, and I don't even know what's happened. You know, I know I did everything. I know she tried to do everything. And she doesn't blame anybody. It's just this illness that no one understands.

HANDSJUK: So did she come back with a broken phone on Tuesday?

ANTONY HAMPEL: That's why she couldn't answer anyone's calls

...... so I took it to work with me on Wednesday

and dropped it off to get fixed.

HANDSJUK: Oh dear.

ANTONY HAMPEL: She had her other phone, her spare one and she lost it somewhere while she was out, so she had no contact, and I think that probably made her feel more lonely. But I rang the landline 10 times all day, she didn't want to answer. I think she was just sleeping?

HANDSJUK: Oh God. And so do you know who found her? I mean, there's so many things as a mother that I just don't understand. Who, do you know who found her?
