












Whoever you vote for.....

THE GOVERNMENT ALWAYS GETS IN

Is anybody really under the illusion that voting in an election is going to change things? The last time I voted I felt afterwards I'd been sucked in again. Just like Charlie Brown in the Peanuts comic strip when his sister tells him that she'll hold the football on the ground so that he can run up and kick it but at the last moment she snatches the ball away and Charlie Brown goes flying up in the air before coming down for a heavy fall. Every time she promises she won't snatch it away this time round and he believes her but as always she snatches the ball away and laughs at him for being such a sucker. Time after time he gets fooled.

It's the same with the voting game. People know in their heart of hearts that nothing will be any better after the big hoo-ha's over. The same cops

will still be going around harrassing bashing and people, homeless people still won't housed, be hospital wings will still be closed the down. politicians will still be talking out of their arses as if they know what's best for all of us and the working class - the vast majority of us will still be shat on by the rich.

Many people go along to the polling booths every time election an around, comes hoping that perhaps this time it might make a difference. "Vote against the Liberal/National

coalition because they are even more anti-working class than Labor". Or the "better the devil you know than the one you don't" argument. At least if you vote, you won't have the hassle of getting fined or having to go to court for not voting. In Australia, we have at least the right to vote, unlike some other countries, but in reality this right means sweet F.A.

On the other hand more and more people are coming round to seeing the futility of it all as they realise that the politicians aren't the ones with the real power anyway. They're just puppets whose

strings are pulled by the largely unseen controllers: top public service bureaucrats, the big banks, company directors and the super-rich like Kerry Packer and Rupert Murdoch, NONE OF WHOM ARE ELECTED. People are seeing through the lies and giving the finger to this whole stinking, corrupt system that is directed by wealth.

The number of informal votes is increasing as each election goes by; the ruling class media say it's because people don't understand the ins and outs of proportional representation, the voting system we have in Australia, but of course there's more to it than that. Coupled with this, heaps of people don't even bother to register on the electoral rolls. After all, the authorities don't have the resources to chase up everyone who doesn't vote.

The State the (that is that apparatus administers capitalism...ie. the government, the etc) bureaucracy has kept voting compulsory to maintain the illusion that everyone fundamentally approves of this system and that every adult has an equal say in this wonderful 'democratic' society. 

way of life' we have here. They try to make working class people believe we all have a stake in capitalism, that there is no contradiction between boss and worker, rich and poor. What a load of utter rot! If you are unemployed with no money what the hell do you have in common with a millionaire who cruises past in a Mercedes?

NOTHING, apart from the fact that you and s/he both happen to be living in Australia.

A boss, a rich bastard probably doesn't care to much for award wages or human rights. They

might want to use you to increase their capital, employing you for \$5 an hour or \$10 or \$15 an hour if you're lucky. If they can't make a profit out of you then maybe they'll employ someone in Indonesia where workers are desperate enough to work for \$2 a day. At the same time you're worrying about how you're going to pay next weeks rent and put food on the table. The kids can't eat cardboard. Everyday is a new battle for most working class people. This daily battle to make ends meet is never experienced by those with money and power. Their world is completely contradictary to that of working class communities. When a boss wants to screw you to maximise profit as they inevitably do, Liberal and Labor are standing alongside them eager to help out, taking a cut for themselves at that!

The more people that don't vote, the less our 'leaders' can claim any kind of mandate to continue with this system that they've been getting away with for so long. The right to vote must surely include the right not to: withdrawing your participation in the electoral farce, just like going on strike when you object to the wages and conditions. As far as Angry People are concerned, parliamentary elections are pretty well irrelevant. Their elections are just a scam to divert our attention away from the class struggle, which is not fought in the comfortable surrounds of plush parliamentary chambers but at the grassroots level, out on the streets and in our workplaces, in our communities and in our minds. More effective methods of social include: demonstrations, boycotts, change bombings strikes. riots, sabotage, and assassinations. Why bother to vote for politicians if you can shoot the bastards? In the final analysis votes are made of lead. It's the ultimate veto.

If you're pissed off with something there's not much use pleading with a pollie to do something about it. You'll probably be ignored anyway. Take things into your own hands. Be courageous and daring. Get organised. Maybe organise a picket or demonstration or an occupation with your mates. Get the media to come along and cover the event they love conflict and confrontation - but don't count on them portraying the event how you'd like it portrayed; the point is to get it covered so people can see that something is going on. This at least creates curiousity and interest in what you're doing. Have a few placards and banners with leaflets explaining the issue and what you're doing about it. Don't be intimidated by the authorities and their hired thugs, the police. Don't back down until you get what you want or at least a substantial part of it. Don't get sucked in by politicians and bureaucrats saying they will 'look into the matter' at a later date or stuff like that. Show that you're committed and determined and you'll gain the admiration and support of more people.

Above all, don't bother waiting till the next election to register your protest, it'll probably be too late by then and anyway if voting really could change things they'd make it illegal!!

BIFFO IN THE FOREST

Why on earth are timber workers thumping Greenies and protesting on behalf of the Boral Corporation on NSW's north coast? A bloody good question because the interests of the working class and the interests of the rich bastards are completely different. The answer has to do with country life, pissweak unions and an environment movement which is exclusive, middle class and has a very limited agenda.

Historically timber workers have been about the worst paid of workers and even now the money is poor. It's deadly dangerous in the mills,

constant requiring alertness in spite of the tedium and boredom. But no amount of care ensures you will go home with all your fingers at the end of each day. Things go wrong very quickly when you deal with moving machinery, saws and bloody heavy timber and it's often the older workers who cop the accidents because they feel safe and take things a bit easier.

Timber workers know that the good timber is almost gone and some are more open about it than others. There are few jobs in the country and an ethos of "pulling together" pervades country life. Class is rarely spoken about but the starkness of class differences makes workers aware of class, even if only unconsciously. The middle class have a bloody good life in the country. A big house on five acres and a full range of sport and cultural activities. Driving twenty miles to a new restaurant is no problem in the new four wheel drive, there's easy parking and you can leave the house unlocked because the plebs are docile.

But for the working class it's a constant struggle. Country roads wreck the old car; it's poor housing and landlords that don't give a bugger. Grow your own vegetables because wages are low and prices and rents are high. You need a job. The dole is a sentence to a life of poverty and of going nowhere: unless you own your own place and are superorganised. For working class kids leaving home with nothing there isn't a choice.

On NSW's north coast, the timber industry is basically Boral with many smaller "bush" mills. The Boral mills are a closed

shop: the Construction, Forestry, Mining Energy and Union (CFMEU) have it all sewn up. This has allowed the union to become inactive in the mills and it just takes it's five dollars weekly union dues, thank you very much. The feeling among workers is basically anti-union (with notable exceptions - shearers and miners!) and so there is very little rank and file activity in the mills. The union says it can only be as radical as it's membership which means we have unions behaving like another arm of the company, promoting industry interests: like knocking over old growth. This is a pathetic response and ignores the education and grass roots activity that a fighting working class organisation would be

willing to use to educate its membership.

In a mill the whole show can be shut down by one or two men: the saw operators who are skilled in getting maximum yield out of each log. I've heard these blokes whinge about their low pay and they know they have the power to stop the whole mill but they won't do it - even when they have the company over a barrel. In another mill a couple of the better paid workers have just left the union in spite of the closed shop agreement and the union is being truly piss-weak - they are going to wait six months and then

> summons these blokes for dues owing. With rank and file little support the union is not game to push and enforce actively the closed shop agreement. This says heaps about the "look-after-yourselfand-stuff-the-rest"

> attitude that the company loves to generate in its employees and that our capitalist society tries to promote in the hearts of all its citizens!

Into this comes the Greenies like visitors from a foreign planet. Middle class children of priviledge with a private school accent they make no allies among timber workers even if they are trying to.

Of course the greenies are right. Old growth forests are cathedral-like and flush with life and power. You can see why the dead men who run Boral want to knock it all down - these places are inspiring and uplifting. You feel like singing out among the undisturbed big old trees. Capitalism can't have this - it might distract the wage slaves from the grim reality of concrete, car-yards and a docile lifetime of work and consumption. Problem is, the green agenda is strictly limited and offers nothing

to win the allegiance of the working class. After the old growth is saved timber workers can go hang themselves or work some other shit job. A better world for all of us is not on the green agenda.

Yet both workers and Greenies have common a interest in saving the old growth and creating a sustainable timber industry. For instance small mills easily employ more workers per timber volume cut than large mills and are really careful about the timber they get. To create jobs small mills are the way to go as well as value adding through kiln drying and the development of speciality uses for timber in furniture, flooring etc.

But the large corporations are moving the industry right away from the small mills particularly towards woodchip, which will come to dominate the timber industry and do the small guys right out of business by taking the second quality timber and thinings that the small mils now get. Quite a few small mills exist solely by "cleaning up" after Boral, taking crowns and branches the big company leaves behind. There are timber workers losing their jobs NOW as Boral mills get the timber and small mills close down, unable to get logs to cut.

We need a unity between timber workers and those fighting for the forests because both have the same enemy: the deadhearted rich men who run our world and are turning it into concrete and boredom.

Saving the old growth is only one part of the struggle. There's got to be an end to wage slavery and to the life of meaningless shit-work and poverty that the working class are putting up with right NOW!

NO PLATFORM - THE ONLY WAY



The fascist threat has grown drastically in Europe over the past five years, not only in Germany but in just about every other European country including England. Racist attacks are commonplace and in some parts of England the nazi boot boys own the streets. This could happen in Australia! The majority of these fascists are working class but they represent a huge threat to the formation of a united class struggle. They are the puppets of the rich used to divide and rule. If different races of the working class are fighting each other, how can we hope to challenge the power and authority that the rich so desparately cling to?

Anti-Fascist Action exists here in England to physically and ideologically confront the fascists where-ever they raise their ugly heads. We believe that it is the responsibility of the local working class people to organise to ensure that nazi activities are stopped before they start.

Since the rise of fascism has become a 'fashionable' topic many left-wing groups (most of whom are middle class students!) have launched anti-fascist fronts mainly as a recruiting and publicity stunt. Groups like the Socialist Workers Party have launched the "Anti-Nazi League": as the threat grows in Australia



this may well happen too. These people feel that signing petitions and putting up posters will stop the extreme right, they appeal to the government to outlaw rightwing parties and rely upon the pigs to protect them demonstrations. We cannot rely upon the government to do anything for us. We have to do it ourselves. It is no good shouting and waving placards saying "Nazi's off our streets". Actions speak louder than words! Let them know that if they show their faces they had better watch their

backs. **No Platform** means not allowing the fascists to preach their race hatred. They stand for the abolition of rights for huge sections of working communities. different races, trade unionists, left-wingers, gays and lesbians - the fascists DO **NOT** have a right to speak.

If we physically oppose nazi activities they will find it much harder to recruit and spread their lies. in turn driving their movement underground until only a few core members remain. Working class youth will find the idea of joining the boot boys a lot less attractive if they know they run the risk of getting a kicking themselves. The battle against the fascists is everywhere, even in Australia - you can stop them before they gain momentum.

What more could anyone say about such a display of aggressive impotence? The whole game of protesters who liase with the police, court the media on every occasion and put their energies into single issue campaigns so safe as to be totally harmless, has become such an institution in Kennet's Victoria. Much to the smug amusement of the rich and their media.

And why shouldn't they be smug? If I was in the upper class the thought of thousands of working class people obeying every law, feebly marching by, chanting, passing the bucket round, the odd straggler being picked off by my newly armed and empowered police force and isolated as "professional bovver boys" by the dailies whilst the rest go back to their homes and their jobs (if they have either), all in protest at what my mates and I have already decided to do; I reckon I'd be feeling pretty bloody smug myself. No wonder Kennet walks around with that insufferable leer on his mug.

It's even got to the point where the so-called revolutionary left are not only buying into it but taking control of the whole charade. There's truth to the rumours that lefty mobs like the ISO, DSP etc are getting their paws in on this. You only see 'em while a campaign's getting plenty of media coverage, with their banners, papers and paraphenalia to boot, but once the camera's disappear so do

they. This is one reason they've been targeted by the police so much in Melbourne because the image of being seen to be doing something is more important to them than ACTUALLY doing These cynical something. bastards do not have "Save Albert Park" as a priority on their agenda but instead "building the party" comes first and foremost. What a boring bunch of nohopers! And the worst thing is they've been doing it for yonks. It's just gotten more trendy these days, thanks to Kennet.

point is, YES, The Kennet and every other bastard in power have been fucking up our lives. So what do we do about it? Unfortunately for most working class people pissed off and wanting change it's the usual "protest and survive" routine, because it's all that's offered but it'll start sinking in soon that the protest - rally - march game gets nowhere fast, now that it's trendy. The one hundred thousand strong Trades Hall manipulated protest against the Kennet government the biggest demo in Victoria's history - was described by His Highness as "I believe there was disturbance outside window". If that ain't a dead giveaway I'm Santa Claus.

OK, so does this mean we're calling for full scale rioting on the streets, the blood of the police choking our gutters and the last capitalist hung with the guts of the last Leninist? Only for starters.....

Look as long as we play the "democratic protest" game their way we'll lose because they set the rules. How can it be any other way? Angry People respect the right of genuine activists to protest any way they want but we also understand that some things work better in a particular situation and others don't. Our methods of protest and resistance need to be discussed and developed so that we may find the best possible course of action available to us in our campaigns and struggles. It is the task of revolutionaries to put forward examples of working class self-activity and the various consequences that came from this activity - not as know-it-all's, not as controllers, not as an abstract vanguard but as equals to demonstrate to our class that we are not losers and are in fact destined to realise our aspirations of political and economic liberty.

These Nice People that Hamilton writes about are more an attempt on his part to convince people that a pleasant, mild, civil, well mannered avenue of gradual change exists than a general documentation sections the protesting Most protests and populace. campaigns are carried on by people of all sorts of characters. with differing experiences and prefered courses of action - often these differences within a group or a wider campaign compliment each other and add to the strength of the overall struggle. What Hamilton is trying to do

here is divide protest groups and in turn the whole working class between Nice People and Ugly People - between those who know their place, respect the law and are conned that they have an interest in the survival parliamentary democracy and capitalism and those who have grown tired and cynical of the idea that we're meant to be at the bottom of this society, that have lost all notion of respect for the law of the few and that are increasingly questioning the common sense, usefulness and "caring nature" of the system that governs us.

As a class, as conscious class, aware of the whole tirade of exploitation that we each and all face, we will set our own agenda and work out our own strategies, be they "violent" or "non-violent". We won't care for such meaningless tags when we fight our class enemy and their supporters. Their laws, their ethics, their name calling will all come to only so much bullshit and drivel, when working class people realise who they are and what they can do, together.

GREEN BAN PARKS

Politicians will promise most anything at election time and truth is always the first casuality.

Fahey's faultering Liberals have made a great show of establishing a koala reserve in south-western Sydney. However little mention was made of the campaign by local residents and animal activists who for years fought this same government to prevent the site being flogged off to urbansprawl developers.

In their battle the campaigners were supported by a Construction, Forestry, Mining and Engineering Union (CFMEU) who imposed a green ban on development of the area.

Another struggle for green space has seen inner-city Erskineville residents resist, for more than two years, attempts by the government and the Roads and Traffic Authority (RTA) bureaucracy to sell off two small parks in their suburb. Erskineville has the lowest level of open space in NSW with 4 hectares of park per 1000 people.

This campaign has also been supported by the building trades union.

In recognition of the CFMEU's support, and to apply further pressure on the government, residents gathered on Saturday

February 18 to name the parks Green Ban Parks.

Being election time, that time of miracles, the residents "green knight" appeared in the form of deputy opposition leader and member for Marrickville Andrew Refshauge.

Despatetly needing to bolster Labor's flagging green credentials with inner-city residents after the third runway debacle, Refshauge 'promised' to dedicate the land open space if Drug Marshall Carr falls across the line later this month.

While these community ammenities may yet be saved, RTA shortsighted bloody-mindedness has resulted in the loss of more than 60 off-street parking spaces that served nearby King Street shoppers.

Their actions will clearly result in further congestion and inconvenience for residents, but the bureaucrats, while disposing of "their assets" at market value, flippantly disavowed any responsibility for the chaos that their road building campaigns continue to generate.

For these simpletons vehicles simply disappear into the ether when they reach their destination; much like election promises.



Two Sides to Every Story

The most frequent shot fired at the forest protection movement by the forest destruction movement is summed up by the large bumper stickers you see around rural areas of the south coast of New South Wales:

<<GREENIES COST JOBS>>

This exercise in confusing the issue is the most powerful weapon available to the logging industry. It's one which neatly polarizes people and appears to make this a workers issue in the opposite way to what it really is.

Certainly, if all logging was stopped right now, a fair few people would be out of a job. But a lot of these people will be out of a job soon either way. There's no future in being a logger or a sawmill worker when all the forests are being rapidly

destroyed by the multinational companies. The timber industry likes to pretend it's sustainable, everyone but who lives in the bush knows it's not really. Almost all of the forest that existed in



land today. And



a lot of that is getting very close to becoming desert.

Where's the jobs for loggers there?

They pretend they've changed, but they haven't. Just like every other area of capitalist industry, they're grabbing everything they can and running. Boral, Harris Daishowa and the rest don't give a fuck about sustainability. They just want the quick bucks now - tomorrow they'll be plundering something else and their workers can get fucked as far as they're concerned.

Boral have control of 80% of the logging rights on the north coast of New South Wales. They are forcing small mills to close and put their workers on the dole. As always, the international companies are bulldozing everything in their path. They don't give a fuck about the fact that small mills run by locals employ more people per tree cut than they do. Or that when they've grabbed their plunder and moved on there will be fuck all left for the locals to do - no work of any sort.

Not only that, the locals will be lucky to have water to drink or grow vegetables and trees with.

Old growth forests are an essential part of the water cycle. Without them, this continent becomes a virtual desert. Regrowth doesn't hold water in anything like the way old growth does.

This talk of water may not mean very much to city people, who only have to turn on a tap, but it's life or death in the bush. You've only got to look at the effects of the recent drought on the rural population to see that. Farmers all round Australia are going bust because their stock's all died or had to be killed. This is an inevitable product of deforestation in a continent like ours.

When rain falls on forests, it sinks slowly into the ground and comes out slowly into creeks and rivers. When that forest is cleared the rain rushes over the surface and very quickly carries all



the topsoil with it into those same creeks and rivers. This makes it virtually impossible anything else to grow there and soil without plant cover bakes hard instantly in hot sun. making water penetration even more impossible. The end result is a kind of semidesertification.

This can be seen in vast, almost unimaginable areas of east coast Australia.

With no trees left to log and no land capable of growing food on or supplying water for drinking and irrigation, the timber workers are going to quickly realize they can't eat their redundancy payoffs for ever.

This is not bullshit. The way logging has been carried out in Australia is not and never has been sustainable. There are a fraction of the number of forestry workers now than there were in the past - just the same as in every other capitalist industry. The capitalists don't care. There will always be someone, something, somewhere else to exploit when there's nothing left to take where they are now. Their lying propaganda about us costing jobs is merely a little part of their process of exploitation and theft.

Boral costs more jobs than the green movement could ever hope for!

Crime and Community

We all know that the pigs are useless against crime. Most of the time they are hassling us on the street or sticking their noses in where its not wanted or needed. Most working class people agree that the pigs are scum and should basically be wiped off the face of the earth. But what are the alternatives? The most common question among our class when it comes to crime is - what happens when our shit still gets ripped off, when a carload of thugs try to beat the shit out of us, when my husband comes home drunk and beats the crap out of me and the kids, when the car has been trashed and the tyres slashed? We still get shat on and the worse part is that it's our own class brothers and

sisters that are doing it to us - the frustration of poverty, work, life and boredom turns us against our own. This is understandable in a society divided by classes but is

NOT ACCEPTABLE.

We already get shat on enough, we don't need

people in the same boat as us rubbing it in. We have to direct our anger and criminal activities towards those that deserve it - the wealthy and the rich - and we have to defend our community from scabs. Scabs aren't just those in our class that cross industrial picket lines, we have to have our own class community picket lines where we unite against anti-social elements that wreck solidarity - we all know what's acceptable and what's not. We don't need the ruling class and their middle class lackeys laying down the law and then getting their thugs in blue to make sure we follow their fillthy morals and values.

When we talk about community policing we do not mean the pseudo-Big Brother Neighbourhood Watch schemes or any other police-controlled scheme where the neighbourhood is supposed to do the dirty work of spying and reporting and the pigs do the rest - we mean real community policing where the community has the real decision making power and ultimately performs an actively policing function - in an organised, voluntary and egalitarian

way. True community policing does not involve extremely hostile stop and search methods, inquisition-style questioning, suspicion, enforcement of petty non-violent "crime" such as loitering, drug use, etc but is purely social defence against socially alienating and destructive behaviour such as muggings, rape, domestic violence, burglary, etc

It is obvious to our class that there is a difference between snooping over the fence to make sure our neighbours aren't growing dope and intervening down the road when we can hear the screams of someone being beaten. However to the pigs there appears to be no difference or even a reverse priority. The point is that as a community,

we are in a much better situation to know when and how to stop antisocial scabs than a beat cop who is told how and when by his or her superiors who have neither the knowledge of local and personal factors nor the class solidarity to understand what is

deliverance from dirty deeds - far from it. It's the people who live in a particular area that ought to be running their own anti-crime squads. Why? Because local people usually have a good idea of who's up to what and secondly are more suited to deal with local criminals because they will have a much better understanding of why someone is doing something. Police are almost always outsiders, do not live in the area they work in and consequently have little understanding, if any, of the needs of the area and the people who live and work there.

We cannot count on the police for protection or

to be confronted and how best it can be effectively solved. Community solidarity is the starting point and the ending point to any social policing.

The most effective way to prevent antisocial behaviour is simply looking out for each other in the area - something we do every day. At times physical confrontation will be necessary to defend our communities and when this has to happen it must include as many people as possible in the process - it has to be voluntary, accountable, inclusive and rotated - if it's left up to the same people and not shared, elitism sets in and we have another set of vigilante cops.

We can start by developing solidarity links with our fellow class comrades in our neighbourhood, building trust so that when physical and practical support is needed in confronting antisocial scabs, it will be there, automatic and effective. Through this we will gain the confidence and assertiveness to actively combat community "crime" and show that our class can and will defend itself.

The police have not always been around, although the way some people talk you'd think civilisation would collapse without them and that they must have been around since year dot. The police force of today was developed in the early 18th century in response to widespread working class anger and militancy and to take over the role the military used to have to crush working class popular action. Nowadays, this role is becoming increasingly the dominant role of the police and crime prevention is taking a back seat. We have to tackle crime prevention ourselves and recognise the police as the class enemies that they are.

REDFERN AT WAR AGAIN!



Unfortunately they still managed to carry out the arrests - although some sustained injuries during the riot. Cops have had a number of shots at crushing local dissent in those few "notorious" streets of Redfern but are continuously met with fierce resistance from those who have nothing to lose.

These few streets are populated mainly by Aborigines who are branded by local police as troublemakers deserving nothing

but contempt. Redfern Aborigines have shown on numerous occasions that their path toward self-determination will not be crushed. Now, ain't it about time we took a leaf out of their book?

HANDS OFF COLEDALE!

As is becoming more and more evident, our hospitals are becoming places of rest and



healing for the rich only. Poor people: working, unemployed or retired are finding it increasingly hard to get medical assistance, operations or a bed as these services, a birthright to all, are privatised and ran for wealthy business people to profit from. When privatisation of the public health system is complete it is working class communities that will suffer for this change. It is us that will have to wait years for an operation whilst beds in private hospitals sit empty and unused. FRUIT PICKERS WANTED!

It's on again: "We don't have enough pickers.
It's good money for people who are not afraid of hard work!" says the smiling true believer from your local CES office.

But before you leap in the old car, have you ever wondered why they always need pickers each year. That's right, pickers don't turn up again for the next season and it's obvious why once you give it a go.

It's piece-work: you are paid by the amount of work you do. This favours the employer because it makes pickers flog themselves and is much cheaper than paying an hourly wage. Only the young and fit can keep up at that pace - day after stinking hot day. That's if you don't fall off a ladder or get your fingers crushed by bins and trailers or get seriously injured in a tractor accident or get just plain heat-stroke. These are exhaustion induced injuries - you're too tired to be careful - and are usually called "accidents" but they are the inevitable result of piece-work and the blame lies directly at the hands of the employers.

And at the hands of the union. The union is piss-weak and doesn't give a bugger. Any picker who tries to organise or "stir up trouble" will be blacklisted by employers and will not find work anywhere in the district.

The "you-can-make-bags-of-money-if-you-workyour-guts-out" idea tends to pervade among pickers and when they've had enough they'll walk off - not organise or act in solidarity.

Even experienced pickers are only bringing in \$60 to \$80 a day before tax and this money has to tide them over for rainy days, travel between jobs, sickies and constant car running. It's pathethic money. You provide your own work clothes, boots, hat and suncreams. If it rains you stop. If it keeps raining you go back to your tent. There is no appearance money, no minimum days pay. You lose.

Coming back to your tent unwashed to cook your meal after a really hard day's work is just more bloody work so the pub becomes a desperate refuge. Counter meals and cold beers and watch your hard earned money disappear! People get stuck and can't afford to leave - too broke to pay for the petrol home. And I haven't even mentioned the danger of the sprays they use: "Oh, it's safe" they say. Yeah, pull the other one.





GOALS AND VISIONS

Noam Chomsky, dissident US intellectual and anarchist sympathiser, made a long awaited visit to Australia in January.

As part of the Visions of Freedom conference, Sydney anarchists hosted a Sydney Town Hall

public meeting that was filled to capacity.

Noam spoke about his personal vision, a fairly traditional anarchist one, the in rooted enlightenment and liberalism, classical liberalism before it was demolished by rising industrial capitalism and goals that are often in conflict with these visions as one is forced to state defend some institutions to allow a public of semblance while participation working to bring about their ultimate demise. These contradictions are the conflicts of daily life.

A highlight for many anarchists in the disparate audience was unassuming the demolition job Noam performed the on marxist-trotskyite-leninist losers during question time.

Even the evocation of the bearded icon Marx himself, in whose name the authoritarian socialists slaughtered countless working people, failed to halt his delegation of these leftist dinosaurs to the historical trash can

Unfortunately the Visions of Freedom organisers felt that the success of the meeting and the tour generally was in no part due to the proprietorial behaviour of the East Timor Relief Association (ETRA) whose invitation precipitated Noam's visit.

In an open letter, yet to surface in the leftist press, the committee states in part:

Not only were other East Timor groups only minimally involved in the 'tour' that ETRA organised, but the opportunity to broaden the East Timor

> struggle by engaging social justice other activists and Chomsky supporters, was hardly explored. And the opportunity for similar struggles to support and complement each other, for internationalism, was lost.....


Public interest in Noam's thought activity and proved, as we and others predicted, to be enormous and grew cumulatively as one event led on to another. If ETRA had been willing to take the risk of open, egalitarian collaboration supporters with Noam's diverse interests perhaps there could have been a huge, week long teach-in on human liberation, with emphasis upon the East Timor struggle but in a broader



context than mere national self-determination..... We, as anarchists, defend the East Timorese in their struggle against Indonesian colonialism; but we emphasise the need to examine the nature, the form and the context of the resistance, and in particular the organisations that have come to represent the people of East Timor.

The anarchist meeting raised \$4,500 for Timor resistance which it hopes will be spent on the ground in East Timor where it is most needed and not on the self-promotion and aggrandisement of globe unrepresentatives. trotting

The working class are a varied bunch of people from all sorts of backgrounds who make up the bulk of the population. We are the ones who make this world tick. It's us who built the schools, the hospitals, the warehouses, the factories, the docks, the railways, the shops, the houses. The rich who pocket most of everything never lifted a finger to create anything. At the same time, we, the working class have created all that exists except for nature itself. One day soon the cosy world rich silvertails have gained at our expense will be shattered. Our banners read only: BEHOLD: YOUR FUTURE EXECUTIONERS.



Capitalists can always find excuses when there's a buck to be made.

they want to take all the credit for stopping the French tests with their peaceful, nonviolent protest tactics and martyrdom that look good in the media. One of their bosses, Jean McSorley, said they didn't want other

boats to go out to the French testing site, Mururoa Atoll, as well. She gave the reason that it would be dangerous and that their safety couldn't guaranteed. The real reason is that Greenpeace wants all the honour and glory themselves so that they get and more coverage and so that more and people more send They money. don't anyone else stealing limelight. I was a paid-up member of Greenpeace at one time but I got sick of their

with all there nuclear weapons which have been terrorizing the world for the past fifty years. That's terrorism, not burning down a building which represents the French government and hurting noone. We assume the building owner will recover the loss with insurance so what's the big deal? (not that we give a toss if the owner gets a cent or not) It was a clear warning. Hobart's French heeded the warning and did the right thing: he resigned. Hit the capitalist bastards where it

endless requests for money and their glossy propaganda. Sure they do some good stuff like stopping pollution and anti-driftnet campaigns and so on but their general approach is "DON'T DO ANYTHING YOURSELF. Leave it all to us. Just read our literature, buy the merchandise and send us your money". It doesn't do much to empower working class people. In fact it alienates us

from environmental campaigns as do most other institutions in system. money-mad this Greenpeace one apparently staff member got sacked for talking to the media about social class and its relevance to the environmental struggle. They were probably afraid that membership yuppie their would be offended by talking of this taboo topic.

Chirac will be forced to back down in the end. Not because of Greenpeace (despite what Greenpeace claims) but because of the sheer force of working class anger. So many people are up in arms about it. How dare the French State dump it's toxic, radioactive shit on us!

Neither Nationalisation Nor Privatisation

Privatisation has become a key issue in radical politics. With state governments wanting to sell-off 'public' assets like prisons, parks, hospitals etc, everyone from the far left to more conservative institutions, from anarchists to church groups, are making the fight against privatisation a priority.

There's no doubt that this mass sell off that both state and federal governments are into now is bad news for the working class. By selling amenities such electricity, for example, to a private company who then sells it at a profit to local government who then sells it to us, basically translates in real life terms as a higher cost for a shittier service. Many industrial countries who have already taken this step have resulted in richer bosses and poorer workers. There is no simpler way of explaining privatisation: it means you pay more for less.

But in the debate of for and against privatisation, one thing seems lost. This is surprising, as it's a basic reality for most of us. That reality is that nationalised services aren't much better and aren't much cheaper. In Victoria, Victorian Council of Social (VCOSS) document Services that government explained assisted relief funds were more frequently going to help pay for energy bills, especially in winter. This begs the question: how much better off are we under nationalisation? If it's 'our' power, 'our' gas and 'our' services, why are we paying for it? How many times have you had your phone cut off or had to starve yourself to electricity bill? the



Privatisation would only make matters worse and should be fought, but does the fight have to be restricted to maintaining the present system? We say that community control isn't an abstract political theory. when you apply it to these questions. Workers running their industries, who of course face job cuts and pay cuts as privitisation comes in, need to organise to take control of these industries. Not under the present trade union their own but by burden. organisations. Surely these workers, who know the nuts and bolts of the system they work, can give their communities a far superior service than at present. This, however, means a change of heart from the ideas of 'I just work here' to ' this belongs to belongs to this workplace, this belongs to my community, this belongs to everyone.' The boss, whether a government or a corporation or a trade union leader, won't get a look in. Workers have the power and imagination to run and provide the sort of services we all need. We can do this by ourselves for ourselves.

But we'll have to fight for it. And that means revolution. A far cry from what the 'radical' movement is begging for now.

I was interested to see some Angry People stickers recently that suggested car thieves should steal from the rich and not the working class. This struck a chord with me as I remember feeling the same way myself when I was seventeen. Coming from a working class area I was aware of the day to day struggle to keep the metal monsters on the road and the inconvenience it caused neighbours waking up to go to shit jobs in the morning to find their regular, less-painful means of transport ripped off. At least with their own vehicle they spent less of their free time at

I distinctly recall one guy who worked as a cleaner and lived in a suburb with only bus routes (no trains). His car was stolen and he lost his job because of it as he couldn't make the 4am start. The anti-social bastards (who didn't even live in the area) burnt it out in nearby bushland after a twenty minute joyride. I knew the car because I helped

him swap an engine in it

once.

When I was about eighteen and moved to Sydney, me and my cash-starved mates concentrated on BMW's. and some older Ferrari's and Porsche's. We could get heaps off bent wreckers for a whole car full of parts. Naturally these cars tended to have alarm systems which made it fucking difficult at times but I couldn't be as slack as to pinch an old Holden just

because it was piss-easy. I'm not saying we never took working class cars but that if we did it was because we had to get around in a hurry and I remember feeling bad about doing it.

The good thing with posh cars was that they were usually full of fuel, had good sound systems (extra cash at another place, plus heh, you had to have tunes!) and they drove bloody well. Let me assure you, the best car to drive down George St at 3am at about 120kph plus is definitely a Jag. These cars were built for it, not to carry the fat arses of rich bastards around from one meeting to another.

This was the mid-eighties and luxury cars were going through a cheap-shit, plastic, alloy stage which made it nice and convenient to us as the locks were easier to bust. From younger blokes now I hear that the lock mechanisms are even shittier. Car alarms were a pain, disconnecting the swarky things takes ages and getting around all the cut-outs and safeguards could drive you mad! Getting in was easy with a "hammer" (an American invention) which consisted of a spring propelled "lock fucker" and a turnbar. They're not too hard to make (a mate from school who was an engineering apprentice made mine) but are only really effective on doors as they were sometimes too cumbersome for steering locks.

Steering locks on luxury cars are a bastard. Most European cars use a springed pin, unlike Australian cars which use a fixed pin that can be snapped away. The springed pin involves a bevelled pin which is springloaded. If you force the pin it will move but the spring pops it back into place once you steer the wheel back that way. The only way around this bastard is to take the steering wheel off and bust it out of the way: luxury cars then didn't have any special bolts on the steering wheel. We'd do this for long trips or for short trips we'd use a nail file slipped inbetween the wheel and lock once it'd been moved. Sometimes the file moved so we used a big blob of that great invention Blu-Tack to hold it in place - they should

put that amongst the list of uses on the back of the packet!! Of course you can be a perfectionist and use pick-locks and shit (about the only way to get into a Roller - unless you're a rich arsehole) but with six-tumbler and upwards barrels this can take all night, even for the most

the TOURIST HEW & the & DRUGMARSHALL

At the end of April, US Help End (HEMP) Prohibition Marijuana founder Jack Herer began his Australian tour to promote the first local edition of his best selling book The Emperor Wears No Clothes. Published under the title Hemp and the Marijuana Conspiracy, this edition contains an essay on the history of hemp in Australia by John Jiggens. Jack was accompanied by Lynn Osburn, a cannabis researcher and co-author of the recently published book Green Gold the Tree of Life: Marijuanain Magic and Religion. Lynn contributed a section in The Emperor... on the hemp biomass debate.

The central thesis of The Emperor... is that the hysterical campaign that saw cannabis banned in the 1930's was not because of the intoxicant "marijuana" but because corporations like DuPont, Hearst and the W Grace company had invested large sums of money developing products alternate to those provided by this multi-faceted plant. Jack contends that hemp can provide sufficient fibre. medicine, fuel, paper, food and shelter for all the world if the plant is relegalised.

The tour kicked off in Sydney with a press conference at Parliament House where Ann Symonds (ALP member of the Legislative Council) and Michael Moore (ACT Assembly member) welcomed Jack Australia. Within hours newly elected Premier Drug Marshall Carr was a huffin' and a puffin' about not changing the NSW cannabis laws. In a magnamous gesture he promised to conduct a judicial review that would ensure that noone in NSW would be sent to prison
for personal possession of
marijuana. You can bet your last
cone that Bob's definiton of
possession will be so narrowly cast
as to ensure the continued
incarceration of large numbers of
people for the everyday occurrence
of having a few bags for friends or
for growing a few plants in the
backyard.

Jack Herer has been recognised as the person most responsible for the modern hemp industry. Unlike many of the new wave of hemp entrepreneurs who prefer to talk only about fibre, paper and ecology, Jack refuses to ignore the civil liberties and criminal justice issues inherent in the prohibition of marijuana.

In a lively talk at Glebe Town Hall, Jack outlined how he became involved in marijuana law reform and the promotion of hemp as "the most important plant on our planet" and urged his audience to inform their colleagues, get the information out and "never quit till we've won".

"In 1969, I started dating a young lady. She said to me, "Jack did vou ever smoke any marijuana?" I said, "No, absolutely not". She said, "Well you need to, your very uptight, you need to relax" She rolled up three joints of this pot, two hits would get me stoned out of my mind. Now I'm not afraid of it, I'm gonna show off to her. I started smoking and she said, "Hold it". I held it. I let it out. I got stoneder and stoneder. She kept passing the joint back and I was going 'wow' and my head was going I listened to

music through earphones. I could see each instrument playing, I could see each note coming out, all these notes, all this incredible music. I'd never liked music as much as that day. I'd never seen it in full living colour. I said, "This is great"."

After writing his first book called G.R.A.S.S which sold in head shops throughout the United States, Jack became involved in the campaign to legalise cannabis, researching the issue with Captain Ed Adair. "One night in 1974 we were loaded out of our minds on many different things. We were so stoned. All of a sudden, we had a realisation that we hadn't had before; that nobody on Earth had had for 400 years: marijuana was going to save the world. We can make all the paper. all the fibres. We can make all the clothing and all the fuels. We can run the cars, we can make food. We extrapolated it to the nth degree and everything came back to; marijuana was the most important thing on our planet. We thought when we came down we'd realise how ridiculous the idea was. But when we came down it was still true. We told our families and the children said, "Dad your nuts, don't say this, your going to be an embarrassment to us. Don't say that marijuana is going to save the world. Please don't say this in front of our friend"."

At first Jack and Capt. Ed were denounced as crazy; but after a three page article appeared in the Los Angeles Times in the early eighties: "Suddenly, we had tens of thousands of people that believed in hemp as one of the, if not the, greatest ecological thing on earth. Hemp is the greatest plant, but there is a negative side. The cops will shoot you because of the misinformation put out by the US government.

The companies that funded the campaign to outlaw hemp in the 1930's stood to loose billions of dollars if it was known that hemp had these qualities. During WWII they had to re-legalise it. Isn't it strange that the government would outlaw the number one plant just

when machinery was invented that brought hemp production from 2 to 3 hundred man hours per acre down to 1 hour.

That's what we're stuck with. We can't legally grow a plant that is the healthiest, strongest, the biggest and the best of all the plants on earth for all the paper, for fibre, and for fuel. It will produce more fuel annually and sustainable than any other annual on the earth. It's really neat of the powers that be, of the gods, that we have a plant that does this for the human race, without poisioning it. Yet, this plant is outlawed.

It should be honoured. In any sane society they would be congratulating us, kissing us and thanking us for growing cannabis; not putting us in jail. We have the highest incarceration rate in the world. Right

now in the United States 190,000 people are in prison, 160,000 in jail, and 800,000 on parole and probation for marijuana. I want them out; I want all this to end.

Yet they will not teach one word of this information on hemp. Nor will they deny it, they try their best to ignore it, but they can't ignore the information here or in the US if you keep knocking on the door telling it to them, getting in their face and challenging them. They will come down".

The public meeting called on Drug Marshall Carr's government to:

- Remove immediately all criminal sanctions against the personal use and possession of cannabis
- Support the development of an economically and environmentally sustainable hemp industry
- Introduce cannabis medicine trials

After a hectic round of media interviews, Jack flew to Nimbin to launch the new film *The Hemp Revolution*, produced by Anthony Clarke from Tilba Hemp, judge the third annual Cannabis Cup and enjoy some local hospitality. Jack also addressed the thousands

strong crowd that attended the mardi grass street parade and drug law reform rally. Other speakers included U.S. author and marijuana activist Ed Rosenthal and Southern Cross University law lecturer David Heilperm.

In Brisbane Jack was special guest at HEMP Week celebrations. Hemp activists presented Premier Goss with a pot plant for his office window while he was at Queensland University to deliver the T.J.Ryan memorial lecture. Not surprisingly Goss, the person who almost single-handedly has ensured that 'The Joke', so well documented by the Fitzgerald Royal Commission, continues, declined the kind offer. He too is running the 'we won't be anyone to jail possession non-argument' while a well known 'marijuana addict' is



heavily involved in the running of his re-election campaign. Such is the hypocracy that surrounds this issue. Jack also visited Melbourne and Adelaide for more media and public appearances before he flew back to California to continue the campaign promoting cannabis and seeking to overturn its senseless prohibition. HEMP is working toward having the California Cannabis Hemp and Health Initiative included on the November '96 ballot.

Following the success of this years May Day celebrations, Nimbin is

now a town under seige. NSW's finest, or at least those not doing doggy-tricks for the Wood Royal Commission, are conducting a payback campaign of road blocks and strip searches to intimidate locals and visitors in a futile attempt to stop people from making their own recreational drug choice. This is the implementation of Marshall Carr's do-nothing policy. While he seeks sympathy in the monthly tabloid magizines for the drug related death of his brother, this poor excuse for a Labor politician seeks vengence against those who resist the criminal sanctions of the very laws which prevented his brother from obtaining a prescribed dose of his drug of choice.

This vengeful attitude is seen elsewhere in the Marshall's

comments: during election crime auction and more recently regarding the seizure of family income from people. Drug convicted Marshall Carr is scapegoating innocent people for his being a party apparatchik and later parliamentarian in government that for twelve years failed to reform the drug laws; the very real consequences of which he's known only too well.

Meanwhile, the bagmen and criminal syndicates continue to arrange, mutually agreeable protection while making payments to party coffers. Law enforcement agencies and the judicary continue their selective application of these

unpopular laws that give the State draconian search and seizure powers. The 'wippy' and the 'scrumdown' become part of training. The police commit perjury and "the rules are long due for an overhaul". The legal establishment grows fat on exhorbitant fees paid with the proceeds of crimes they so sanctimonously decry. Carr is a dope, Wood is a joke, legalise it! Pass me the mull bowl, I'm in need of a good 'laugh'.

here's been a lot of hoo-ha in the media once again about people with guns. We've got innocent citizens defending both life and property against slimy home invaders or burglars getting blown away by gun-crazed people depending on which side of the debate you're on. We've right-wing extremists infiltrating the Australian Defence Dept and preparing for a war with Asia or good-thinking, god-fearing calling for their patriots countrymen to take up arms against an increasingly undemocratic

government, again depending on which side of the debate you're on.

In amid the inevitable cries for "common sense", however, a few issues have yet to be raised. Let's look at this "home invasion" thing. Most people think it's OK

for you to defend your life and personal property against a burglar, attacker or whoever and whatever. Well this should be obvious! Whether it's a good idea or not to blow someone away for coming through your window may depend on whether you're an old age pensioner or not. But no-one seems to want to ask why people are breaking into other peoples' homes.

Living in a society of poverty, oppression from police, bureaucracy and government and a divided community inevitably leads people, WORKING CLASS PEOPLE, to turn against each other. Whether they're in need of money for food and bills, a drug

habit or just in it for the kick, behind are reasons burglaries and home invasions. We at Angry People have always called for those who insist on breaking into houses and stealing to get by to take their business to the wealthy suburbs of the rich and influential and OUT of the communities of the poor and working class. Unfortunately, it's our houses that are easier to get into than the patrolled fortresses of the boss class. This is why more and more working class people, who are not right-wing gun freaks, are merely

people with all their needs and not just the basics like food and shelter but real human relations -(a living, breathing, dynamic sense of belonging with those who live and work around us) doesn't have to rob off itself and doesn't have to defend itself against it's own. So the real answer here is class solidarity and mutual aid. But is this possible when things seem so fucked up? It probably sounds like a lefty pipe dream because few people are talking about it and acting on it. Hopefully, this paper can start shedding some

light on the idea.



Any Koori, Murry and other indigenous people will tell you that this is, for them, a police state. While people in poor areas have taken an average \$8000 drop in real income since the mid 70's, those in rich areas have gained an average \$12,000. In real terms 'threat to social cohesion' means an escalation of the class war, precisely what puts the fear of god into rich scumbags.

With working class people realising that the money they earn or are paid can buy less and less and the daily drudgery of work and dole queue provide no outlet for creativity or fulfillment we are going to see more and more pissed off individuals. And these individuals come together that's when the fun really begins....

LOCKED OUT

"Hopelessness is in the air. Parramatta Jail Oval, were once teams would play football and the running track was cut deep into the grass, is now pristine. Old timers at Long Bay say everyone is lazy now, morale is bedrock. Prisoners wander zombie-like through the yards or flop in the sun. Cells are unloved and dirty. Prisoners are only time-serving. Nothing more is required, needed or useful to them."

In May last year, the International Year of the Family, Justice Action (JA) initiated a survey of prison visitors. JA sought the assistance of aptly Orwellian-named Department of Correctional Services implement the survey. Acknowledging the value of the survey, the Department then spent six months redesigning questionnaire and adding a few questions of their own. They then sent out the survey without giving JA a chance to comment on the final package as had been agreed. The letter posted to visitors, clearly and most unnecessarily, identified the nature of the survey. This improper action by the Department angered many visitors who felt their privacy had been invaded. Not satisfied with

this slight of the families and friends of prisoners, Department then did nothing with survey responses that, for this type of survey. clearly indicated a genuine interest by visitors in the benefits that would result from the survey's proper

analysis and implementation. Eight months elapsed before the Department agreed. following intervention by the new Minister, to 'crunch the numbers' and provide JA with the results. Is it any wonder that such an appalling state of affairs exists in NSW prisons when the Department behaves in such a caviller fashion toward the families of prisoners. The Department must decide if it wants community involvement in the rehabilitation process or a return to the bad old day where the biff and bash reigned

BOOKSHOP RAIDED!

Melbourne has seen an upsurge of kop/fascist activity, in circumstances

that seem to indicate that there is a certain level of organisation between the two. Barricade Bookshop, which sells radical books and also operates as an anarchist information centre, has come under fascist harassment. Their windows were smashed in on one occasion by fascists. A week later, police conducted an armed raid on their premises for 'objectionable' material - and seized t-shirts with slogans 'Jesus is Cumming' with a picture of Jesus and his erect dick as well as a 'Fuck the World's Police -No World Order' t-shirt and a poster showing two anarchist activists having sex. During the raid, the occupants were threatened with guns and the place was ransacked. The search warrant was unsigned, hinting that the raid was primarily for intimidation rather than for any legal reason.

A week later, fascists again smashed the windows of the shop, feeding off the police raid. The police invited the bookshop to retaliate so as to cause a gang fight, and the kops promised to shove the winners in jail! While racism is seen as a political streetfight between the extreme right and left, the police and the ruling class can sit back and watch the show! The fascists in Melbourne



study According to released in May, one in ten children Australian living in poverty. That's four thousand kids hundred The report, nationwide. titled "Facts, Figures and Issues" also found that twenty thousand children are homeless. What sort of society are we living in you may well ask yourself where basic necessities are denied to those who need them?

In a capitalist society like the one here in Australia the needs of the working class come second place to the profits of the middle and upper class. It's as simple and nasty as that. Housing, shelter from the elements, a place to call home, a base, whatever way you look at it, decent housing is a birthright to all and no reasonable person could argue it any other way.

In this country, like many others, many houses are owned by absentee landlords. That is to say that those who have acquired these houses done SO as investment and do not live in the houses they own but rent them out so they can amass wealth from ordinary peoples' daily needs and, for that matter. often have the mortgage paid off in the process. This racket has been going on for years at the expense of the working class, who because of their social position, are unlikely to ever own their own homes, let alone someone else's as well.

On the other hand advertisements everywhere encourage us to take out mortgages: "at least I'll will own the place sometime in the

future" or "at least I'll have something to leave the kids and start them off in life". We're being played for suckers as mortgages become less available to the working class. Employers have found asset-stripping fashionable in the nineties, better known as less jobs for less money. Without regular work and decent pay, mortgages are beyond the scope of ordinary folk. We're being laid off, locked out, retrenched, sacked and given few opportunities in the first place: all these factors are going against us and will continue to until we bring down the social arrangement that currently governs us. To do this the wealth and power must be distributed equally amongst all across this land.

Gone are the days when we could pay off our homes in twenty odd years and gone are the sixties where you could purchase a house on a block of land in the suburbs for under ten gran'. <u>IT'S ALL GONE</u>, just parents' and grandparents' stories now - it's little wonder this generation is pissed off with the way of things.

Secondly, as more of us are shoved into the dole queue with all the bullshit that comes with it, plenty of us are being evicted through foreclosure: the bank says you ain't paid on time or you ain't paid enough or fast enough so they turf you and your family out. Advance Australia Fair? It's a load of old cobblers that any fairness exists out there when bosses can chop your job and livelihood at the drop of a hat, when bank executives and managers can decide whether you'll have a roof over your head this month or not, when DSS and CES workers can terminate your payments upon any whim.

That's right, we've been pushed around since day one and it's about time we did something about it. For a start we could house ourselves by shifting into buildings left empty. Why pay rent to a landleech and let perfectly liveable houses rot to death? It's the easiest of equations: if you've got homeless people on the one hand and empty dwellings in the other you put the homeless people in these dwellings. It ain't mind-boggling at all - it's what we at **Angry People** have always considered COMMON SENSE.

We could go on to organise our own tenants' groups to co-ordinate and solidify attempts by renters' and mortgagees' to make some gains at the landlords' expense. These groups would remain independant of the Housing Dept, Real Estate bodies, government bureaucracies and political parties in order to keep them from being corrupted. This would also ensure an internal democratic process and that the aims of the various groups were those of tenants' and mortgagees' and not those of landlords' and property owners'.

Organising in this manner can and should lead to solidarity and mutual aid fundamental planks to working class unity (and *Angry People's* thinking). To shed some more light on this repairs could be arranged and carried out for each other by sharing skills that we each have whilst pooling tools and other resources can make a hard life that little bit easier. Such experiences can only serve to pull people together which brings us to another point that *Angry People* have often trumpeted: neighbours' who get to know each other are more likely to look out for each other thus minimising the chance of burglary and other anti-social behaviour. A genuine feeling of community can come to life through this sort of social organisation.

FASCISM IN THE NEW AGE

You can find *Nexus Magazine* in your local health food store. It looks like another flying saucer and pyramid power "New Age" mag full of conspiracy theories and alternative health care advice.

But sitting tucked away next to the voices of the great pyramid and the dangers of electro-magnetic exposure we have the blatant propaganda of the fascist extreme right.

Take a look at the June-July '95 edition and you'll find for starters, an editorial column that claims the Oklahoma bombing was masterminded by the CIA: there was a second bomb and Timothy McVeigh, the man charged with the bombing carries an implant put there by the military to control him. That's right. Nexus seriously wants us to believe the US government blew up one of its own office blocks plus a day-care centre full of kids. This is material direct from the right-wing extremist militia's of the US and further justification for the militia's arming up against the total government control that the US government is supposedly putting into place. While the truth is that it was the paranoid, conspiracy fantasies of the militia's which led directly to the bombing.

Nexus also carries an article entitled "Big Brother's Recipe for Revolution" which details the supposed impending government control in six conspiracy filled pages. The magazine is also replete with references to the "New World Order" - an old standard bogey for the extreme right, as it is the "New World Order" which will supposedly bring this total government control.

Any lingering doubts about the attitude of *Nexus* to the fascist right is made clear in the ad's carried in the mag. Next to the ad's for hypnotherapy courses and books on UFO's we have a special offer to *Nexus* readers, two for the price of one, for purchacing a copy of "The Fine Print" by Sydney's own Brian Willshire. This book is a veritable catalogue for the conspiracy theories of the extreme right and is a basic text for right wing groups here in Australia. Nexus also carries ad's for *Veritas Press*, the publishing house for the *Australian League of Rights*.

The presence of right wing propaganda in Nexus goes way beyond niavity or unawareness on behalf of the publishers. It goes beyond the sympathy that New Age conspiracy nuts might feel for another bunch of conspiracy nuts. Nexus is knowingly involved in spreading the fundamental tenets of the new fascists and is propounding their propaganda as gospel

So do your bit, get *Nexus* out of your local health food store and off the shelves where ever you see it and act against the rising voice of the new fascists.



PICKED OFF!!

As an anarchist activist and a seasonal worker I would like to respond to the 'Fruitpickers Wanted' article in *Angry People*, issue 10. Whilst I agree with most of the statements about the exploitation, lack of a union, and the lack of safety in seasonal work, the defeatist and disempowering attitude of the writer I found frustrating and detrimental to what a lot of activist fruitpickers are trying to do.

Many anarchist and other activists do seasonal work because it gives us a relatively greater degree of control over our work than the bulk of city based jobs, it allow us to travel where we like and work alongside people. It does take experience to make good money from picking and. like in most jobs and skills, their are numerous basic picking tecniques which save time and energy and need to be learnt, so that you don't have to work your guts out. I struggled along for about a year and a half until I was able to make more money than a lot of city yuppies! It's not just the young and fit. I've known people in their 60's and 70's make as much or more.

There is a high degree of solidarity among fruitpickers. We do look after each other, form solid, temporary communities, often with people from all over the world, and form a sort of loose network throughout rural Australia. I've been part of successful stopworks for better pay rates and I constantly hear of large and small successful picker's strikes wherever I go, all totally without union support. Rural workers in general still have a strong connection to the militant past when unions were strong and still grassroots; much more, it seems to me, than their city counterparts. But the last time seasonal workers were really organised was at the beginning of this century by the Wobblies (Industrial Workers of the World, or I.W.W.)

Instead of telling people, especially people who read anarchist zines, how shit fruit picking is, I'd be sharing basic information about how to pick, where the best and worst farms are, and how to help organise among pickers. The only way for new pickers to learn the skills and the know-how of how not to get exploited is from other pickers with

experience. The more anarchist and politically minded pickers who are prepared to help change things, the better.

Already there is a pickers zine called 'Crossback News' published in Victoria (address below) which shares such info for and by pickers and is worth getting a copy. The potential to organise pickers is huge and far-reaching. Beginning with basic issues such as health and safety, sexism and discrimination. proper on the job training. accomodation standards and especially pesticide exposure, the long-term potential is to help undermine the power of multinational agribusiness, redistribute power back to small farmers and be an important part of the struggle for sustainable, organic and socially just agricultural systems. If we are ever to have a 'strong, united working class' then, please, don't just criticize, help organise!



with elections as long as the delegates or representatives standing for election are accountable, recallable and rotatable - and not one, single politician is!

Angry People are all for popular rule, that is, power to the people and we're quite serious about organising the embryo for such a future phenomenom.

A Nation At Work?

As more and more people in Australia find themselves unemployed as a side-effect of this system, the ALP is trying to sweep them under the carpet and keep them hidden from those of us who have jobs. They don't want us to know just how widespread unemployment is for fear we'll organise ourselves to do something about it and draw potential or existing ALP voters into more grass-roots forms of organisation, which, if done, would seriously discredit the ALP's role in the chaos caused by mass unemployment.

The Labor Government's 'Working Nation' is a master stroke of public relations, electoral campaigning and number crunching. As the political parties wank on and the media takes sides, all the unemployed can see is their lives growing more and more out of their control.

At the moment I'm on a scheme with the pleasant name of 'New Work Opportunities': one of those wanky catch-phrases that fool only the stupid. It's a six month programme designed to take the long-term unemployed off the dole and give the illusion that it's helping us. Here's how it works.

The CES, via it's new branch of soft cops called 'Case Managers', who are assigned a certain number of unemployed to harass personally, gather up as many of us as possible to put into the 'New Work Opportunities' For six scheme. months we do low level maintenance work at selected schools and for one day a week we go to TAFE college to learn such skills as tiling, plastering, carpentry, painting etc, except over the school holidays we're at the TAFE full-time. The promise to us caught in this exercise in futility is that it will make us "job ready"; having recent work experience and training will apparently make us more employable.

The flaws in this line of thinking are obvious so let's look at them. Firstly, the reasons why there are no jobs have nothing to do with us at all. Whether it's because bosses won't hire us on decent wages or because industries are collapsing because of the world economy or even for the simple fact that there's simply not

enough full-time work to go around (an inevitable result of capitalism) unemployment will never disappear. Rather than admit the system's fucked, the State, as usual, chooses to place the burden of responsibility on us, the unemployed. All the scheme's in the world won't get us all jobs.

the Secondly, is training To superficial. learn a trade, such as plastering for instance. takes months and years of hard work and practice. Those of us who have never held a trowel in our lives won't pick up the basics at TAFE one day a week for five weeks (one day a week on plastering for five weeks, one day a week on tiling for five weeks and so on). In any case, many of us are already well trained and experienced various trades, so for them this is all a waste of time and the rest of us and feel stupid for not picking it up in two seconds.

Thirdly, after all this, what makes the CES and the

government think that superficial experience will make us more attractive to potential employers ahead of other, more experienced workers? With the umpteen million of us looking for work (that is, being forced to look for work), simply being placed from the "long-term" to "shortterm" unemployed list, via a few months of bullshit, isn't going to fool anyone. The bosses are stupid but not that stupid. The only advantage is that the government will have more impressive stats to point at when a few of us do get hired.

There are other considerations too, most notably the crap rate of pay. I take home \$230 a week after tax. One bloke in my little mob who trains at TAFE is getting less from this than he was on the dole, owing to the fact that he has to look after two kids. He's not the only one. It's no living wage, not for a week's work. Also.

there's no unions involved. I was told at interview for the training scheme, that the scheme actually was designed to get around the unions. The unions, of course, have demonstrated

their impotency once again by failing to resist this hated scheme.

This is only a sample of the problems. Many of us have been forced onto these schemes by offthe-planet Case Managers. Others accepted the 'offer', simply because, with the Case Manager system, we'd only get hassled into something

eventually. It's important to remember that

the whole Case Manager way of things is designed solely to get us off the dole. Whether it's into a training scheme, a job or simple oblivion means nothing to these pigs. How the Public Sector Union, which covers CES workers, allowed their members to enforce such draconian measures onto us is beyond understanding. Did the PSU even try to encourage its' membership to oppose the introduction of the Case Manager system? It may be that we, the unemployed, should start targeting these class traitors for

special consideration. If they moan, we can only reply that if it's OK for you to hassle us, it's OK for us to slash your tyres, ring your office and follow you home.

Such organisation doesn't need any

'official' group with initials, a charter or constitution or whatever. Just a few like-minded individuals with the guts to go ahead and the sus not to get caught.

In any case, far too many of us will

be put through the grinder before we can successfully organise as a class to eliminate this load of bullshit from our lives. But doing what we can in the meantime can make the bigger task of revolution that much easier.

They will deliver nothing to the working people of NSW and the rest of the country. The Otympics are portrayed as the ultimate sporting event by pollies and the media and we are supposed to feel privileged for hosting the games. Maybe back when the original ideas of the Olympics, as an amateur sporting event to promote

goodwill in sport were still around, we could be glad to be host to such an event but the Olympics nowadays are about as amateur as Murdoch's Super Leaguell Sport is a huge money spinner and sporting entrepreneurs know they can make big profits whilst they builshit that they are promoting the interests of the sport. The only interests they are promoting are their own. The law of big business says that no rich seum will fund sport for sport's sake if the profit margin isn't high enough!! The same with the Olympics. All the money generated will be going into the pockets of the sporting, entertainment and tourist entrepreneurs, many of them already millionaires. These people have already asked the government to protect their profits by regulating the industry through price fixing during SO Olympics entrepreneurs don't rip off the public: more like ripping off the industry fatcats, by trying to get a slice of the billion dollar piell

Under the 2000 Olympics, the working class will suffer as the Olympics will be used as an excuse to justify attacks on our wages and conditions.

Tourist areas will be extra-policed making it safe for tourists to spend their money as we serve them in shitty paid jobs. Police will be actively keeping the 'undesirables' out: those without the money to afford the inflated cost of tourism, and who are not there to spend, spend, spend! The inner west, around the Olympic site, will be bought up by developers hoping to cash in and which will cause rents in the area to skyrocket as property owners try to cash in on tourist accommodation.

Many of us will never share the profits of the Olympics. The only real winners are the egos of the sporting business elite and the profits that they make, industry employers will exploit the working conditions of the tourist industry: part-time work, poor unionisation, under-award wages, shabby conditions, vulnerability of typical part-time workers: youth, students and women. Griener tried to

bring in Kennett-style labour laws, but was not totally successful. Kennett's laws will be made the model of future governments. Even though the Labour Party whimpers pathetic opposition to these laws we will see them implement them - the Amateur Liberal Perty always finally adopts Liberal Party policies, for example, Kennett's 'reforms' are already adopted policy of the Victorian Labour Party, so voting Labour in Victoria in 1996 will change nothing, except the speed with those changes implemented. Rest assured that no matter what government is in power in NSW just before the year 2000, they will follow the advice of the business lobby groups who will be claiming that "the labour laws are too restrictive for the private sector to fulfil the demands of the Olympics".

It is also a sign that the government has no control over the economy or ideas about tackling unemployment. The only lobs that will be created are in the construction, entertainment and tourist industries. Construction lobs will only last for the next couple of years. So what's going to happen when all the Olympic sites have been built?? It's obvious that It's only a short term measure and we've seen that the construction boom in the eighties led to massive lob losses in the late eighties and early nineties. And as for the tourist industry, what happens after the two weeks and the whole circus shuts up?? They are going to need to come up with another gimmick to keep the tourists around and spending which is why they've come up with this plan of a nine month "Festival of Sydney" in 2000. And we're all familiar with the 'perpetual beach party' line that Carr tried to sell Sydney to the Yanks in order to convince them to come over and spend their dosh. Well maybe not all of us have the time and money to party all day at the beach! Most of us are too busy working or recovering from work or are in a frenzy looking for non-existent jobs through constant harassment by the CES.

The only way to fight back against the Olympics is to hit them in the pocket: through strikes, sabotage and goslows of any construction work, fighting against wage cuts in the tourist industry and resisting gentrification of our areas. Cause a massive budget blow-out and then when the State attempts to impose a household tax to pay for it - which they have not ruled out - refuse to pay the tax!! The poll tax in the UK (which is what the household tax will be!!) was defeated when huge numbers of working class people who could not afford to pay organised non-payment campaigns and no-go areas for bailiffs trying to seize non-payers' property. As the 'new rich' drive us from our traditional areas we run like rabbits from the hunt.

Now it's time to TURN BACK THE TIDE!

At the moment, all over Australia, the process of gentrification is in full swing. The powers that be and those that wanna be, the yuppies, are making the cities unliveable for working class people in a variety of ways. This is the latest part of a class war found in every society where the people that own the wealth think they can lord it over others and tell them how and where to live. It's always been like this and we're still no better off in real terms than the serfs who slaved for a 'living' on the land of rich landowners in Tsarist Russia. The were owned by the landholders - they were rent!

When serfdom was abolished in some areas the 'free' serfs found their new lives so hostile under capitalism that they went back to tilling the land of their previous owners. How many people in this country today would be willing to make the same decision given the lack of rights, say or respect they get just because they have no capital?

Working class areas exist in every city; unfortunately, often in overcrowded, industrial sections of suburbs deemed 'undesireable' for the affluent classes. As populations rise they spread out looking for new places to inhabit. The wealthy types, who can afford to live in the trendy parts of the inner city think it might be 'nice' to look for areas that aren't so crowded, that offer natural vistas and a more relaxing place to bring up their 2.3 kids. Consequently they put their feelers out and gradually transform suburbs that are for everyone into exclusive, expensive ghettoes.

The threat of yuppification shouldn't be under-estimated. When yuppies move in they raise the cost of living across the board. They create extra demand on housing which leads to higher rents - higher rents that make sure real estate buyers and developers move in for the kill. Once an area has a sufficient number of 'new rich' they begin to cater solely to themselves by replacing corner deli's with gourmet and exotic food outlets. Practical

clothing shops become boutique fashion stores and furniture shops with good, cheapish, second-hand furniture are now antique shops for those with more money than sense. And it's another shot at us when yuppies send their kids to private schools putting more pressure on kids in state schools to 'perform'.

Take a look at what's happenned in the traditional working class areas of Newtown in Sydney and Carlton in Melbourne. This is the result of what happens when greedy real estate owners and developers smell the yuppies coming and set off to evict shopkeepers and residents in order to cash in on the invasion. In order to catch the rich fish landlords can simply discriminate on grounds of race, gender, class, whether or not you have a job and even if you have pets or kids!

With all these things to keep you down it's easy to see who will always win out over you - rich bastards! Over time, this kind of selective process creates a ghetto of snotty-nosed scum who won't lower themselves to associate with someone on a lower socio-economic level than they are. These attitudes have created real problems with community bonding. Yuppies aren't pulling us

together, they're driving us apart.

In the US it is a huge trend to live in a fortress-like suburb, literally fenced off from the world around it, patrolled by security guards twenty-four hours a day with people's movements viewed via the security cameras that line the perimeter. These high-class concentration camps are springing up all around Australia with Surfer's Paradise being the most

horrendous example of this trend. Needless to say they are only one of many options for the well-to-do, who fear the 'thieving' classes that the media tells them creates all the crime. Places like this only serve to make class tensions worse: the have-nots kept away from the haves by eight foot walls. Some of these places in the US even have shopping centres within

their walls, not for use by those outside, mind you. Break into one and help free those inside from their own irrational fears.

Talking of security, the Sydney suburb of Zetland has been honoured by being the first in Australia to try......drum Neighbourhood roll....."Junior Watch". It works like this: cops are nice - cops talk to kids about 'crime' the kids learn to trust the cops - they look out for 'criminals' in the streets when playing or going to the shop etc - they tell mum and dad if they see any 'suspicious' behaviour - mum and dad rings the cops - and hey presto! another area cleaned up for a 'better' class of people to move in!!! This kind of thing is like a scenario from "1984" or Stalinist Russia. No-one will trust anyone before long and the powers that run this society will get what they've wanted all along: a divided working class. Someone go and talk to these kids before these tactics spread. More bad news for Sydney is the 2000 Olympics. Real estate hounds have

> already sniffed out the sites and suburbs where they will force out low income tenants, build 'high (read: quality' expensive!) housing two-week for the tourists and sell them after the event to those who can afford them. This happens in every city that hosts the Olympics, along with the burden on those who have to pay for the damn thing through taxes. Sydney

Melbourne are bidding for the 2006 Commonwealth Games with Perth and Brisbane also thinking of trying.

Which unlucky city that gets them remains to be seen.

The Kennett regime in Victoria has promised to spend \$72 million on the Games if they get them which should be going to essential state services. Kennett has turned Victoria into a fatcat's playground. As he and his rich mates privatise everything in sight it's

Before too long an enormous shower of class power will rain down on the rich and their lapdogs. Their days of power and priviledge will come crashing down around them and they will have only themselves to blame. And as the sun shall rise the following day, streuth, they won't

The income ratio betwen the richest 20% of the world's population and the poorest 20% has grown from 30:1 to 60:1 in the last thirty years. Approximately two million Australians live below the government appointed poverty line. State assets designed ostensibly for all, which in reality are obviously not for all, are being sold off as government and big business deals are made either behind our backs or in front of our eyes. Privatisation is the last step in the process of the State saying "if you can pay, good; if you can't, tough!". Old age retirement villiages ensure even the elderly are divided on a 'who can pay, wins' system. While thousands of houses remain empty around the country some people wait from five to fifteen years for public housing accomodation. There are over one hundred thousand (100,000) empty houses in Melbourne alone! If you can't pay the rents -TAKE! Squat with some friends. Spray paint suburbs where you see fancy estates going up - let the newcomers know they're not welcome and not wanted. Smash the windows of near-finished yuppie homes and make 'em pay for coming into your suburb and making you pay!

1990 Tramways Dispute

On January 1, 1990, for the first time in the history of the Melbourne Tramways, the tram depots were occupied by the tramways workers and the service was run for free. At most depots the service ran according to official timetables, however at South Melbourne Depot the service was run according to a timetable drawn up by the depot Timetable Committee which included extra services in non-peak periods. The response of management was predictable and they issued an order to cut off the power. Tramways workers were tipped off and organised a blockade of The Central Business District with almost every available tram before the power was eventually cut. For the next thirty three days depots were occupied and picket-lines maintained and hundreds

of trams lay idle in the streets.

The issue that precipitated the dispute was the foreshadowed removal of conductors from trams converting the service to a one-person operation. In August 1988, the Metropolitan Transit Authority (MTA) opened a "Met Shop" in Elizabeth St. to sell tickets. It was obvious that this shop, and others that were planned, was the first step toward removing conductors. Despite this, the official union, the Australian Tramways and Motor Omnibus Employees Association (ATMOEA) chose to do nothing other than condemn the move. South Melbourne Depot took wildcat action and stopped work from 8am to march to the Met Shop opening ceremony. When they arrived there they found that the government had provided free sausages and orange juice for the public. South trammies

immediately scoffed the lot for breakfast then proceeded to abuse, heckle and jostle the Transport Minister, Mr Jim Kennan, who described the trammles as "the Western Oval outer in green" and "fucking wildcat cunts". Later that morning, they marched to, and occupied briefly, the office of Chief Executive Kevin O'Shea and extracted a promise from him on television that conductors would not be taken off

trams. Incensed by their union officials' inaction, they marched to Tramways House in King St. where they found a severe shortage of union bureaucrats.

For the next eighteen months there was much discussion in the industry about the Issue. SPARKS magazine, published by the Public Transport Workers Association (PTWA), an affiliate of the Anarcho-Syndicalist Federation - International Workers Association (ASF-IWA), had been advocating workers control of the public transport industry since 1986. SPARKS was very popular and widely read throughout the industry. The possibility of a tram blockade as a response to any move against conductors was discussed at Union Executive

meetings in 1989. An attempt by management to introduce part-time conductors in November 1989 was thwarted by picket lines at the depots. The government has also introduced 'scratch' tickets in preparation for one person operation of trams. January 1, 1990, was the day slated for the introduction of conductorless trams. During the thirty three day occupation the trammies were assisted by Depot Support Groups initiated by Melbourne ASF groups which included 24-hour occupation of trams strategically located in the CBD. Two mass meetings held in January overwhelmingly rejected calls by union officials to return to work. However, in early February, a mass meeting voted narrowly to return to work after two Federal Officials had signed an agreement stitched up by ALP 'Centre Unity' faction heavies with the government. In response hundreds of outraged

trammies and their supporters occupied Jolimont Railyards briefly before being ejected by police.

Despite all of this, there are still conductors on trams to this day (although many are gone) because the government has been unable to develope a reliable automatic on-board ticketing

Workers' control of public transport has and still can provide a far better service.

EVICTION in the TOP END

Darwin Music Development Centre is given the boot by the Territory Government



Just before Xmas, on 21st December 1995, the Darwin Music Development Centre (DMDC), alias the Petro-Chemical Love Club because it was situated near the oil companies Shell and BP, alias the Darwin Workers' Club due to the fact that they were the previous tenants of the building, was finally evicted by the NT government, the landlord of the building, after occupying it in one form or another since 1989.

The reason given for the eviction was 'noise complaints' but that was bullshit. Nineteen noise complaints to the police over two years doesn't sound like too much of a problem. On many occasions when the police came down there to say there'd been a noise complaint made, they themselves reckoned the complaint was unjustified! Generally the cops didn't mind the place because there was far less violence and disturbances than from other pubs and clubs around town. The eviction letter, which gave just fourteen days notice to vacate, stated that the government had tried to solve the problem of the noise. This was totally untrue. The letter also stated that the government had also tried unsuccessfully to find new premises for the DMDC. This was a lie too. They did absolutely nothing for us.

So what was the real reason behind the eviction? The organisation got no funding from the government whatsoever, apart from two trainees working there on a Federal government subsidised training scheme for the long-term unemployed. Because of the eviction this scheme was brought to a halt. In fact the DMDC was giving the NT government a lot of money for numerous things, among them rent, rates and sewerage. Because it got no government funding it was beyond government control. A stark contrast to other arts organisations receiving government money which become dependant on the funding and don't dare do anything controversial or radical for fear of jeopardising that funding and their jobs. That's called 'Not Biting The Hand That Feeds You'.

The DMDC had evolved and grown over the years. In 1992 it gained government approval to be developed into a fully-fledged, self-managed, music venue and performance space. It was transformed from a boring government building into a vibrant, thriving venue through the hard work of dozens of enthusiastic volunteers. It became a unique place: there was certainly nothing like it in Darwin, maybe not in Australia. Sure there were problems, arguments and disagreements. But these were worked out. It was an institution, well known for its' friendly, laid-back, tropical atmosphere. There were no bouncers hassling people, no dress codes: you could come as you

are or get dressed up, no problem. Everyone was welcome, including kids and dogs. Drinks were reasonable prices.

There was no racial discrimination at the DMDC. Racism was simply not tolerated, unlike at some other venues. In fact some biggest crowd-pullers were Aboriginal events such as NAIDOC (National Aborigines and Islander Day Organising Committee) Day gigs and gigs by Aboriginal bands such as Sunrize Band from Muningrida, NT, and Yothu Yindi. The list of Darwin, Territory, interstate and overseas bands and performers that have appeared at the DMDC would run into several hundreds. Some bands such as Darwin band Crimplene, who held their CD launch there just before the eviction, say frankly that if it hadn't been for the DMDC they wouldn't even exist.

There were problems with lowlifes breaking into the place at night to steal whatever they could get their hands on. They stole grog, CD's, a stereo. It was an easy mark because the place was not very secure, especially after the back wall of the building was knocked down to make it more open and because people were trusted. The worst was when an artist and musician had been around for years and was treated like a brother, ripped off a \$600 DMDC cheque and cashed it, leaving us with very little cash flow to work with. We haven't seen the bastard since. The episode left us bitter and saddened. Nevertheless, the lowlifes did not succeed in closing down the DMDC. We had planned to beef up the security with alarms. Angry People stickers saying "DON'T RIP OFF YOUR OWN KIND. NO MUGGERS OR BURGLARS. IF YOU WORKING FROM CLASS PEOPLE YOU'RE A BLOODY LOSER" were stuck all around the building. We hope they made would-be thieves think again. It's one thing being shafted by the authorities: we expect that and are prepared for it. What really hurts is when it's done by people who are pretty much in the same boat as us. A lot of these people are too fucked-up by alcohol or drugs to realise that they're hurting their own sisters and brothers and of course, the rich are sitting up there laughing at us when this happens. That's exactly what they want to see: one group of working class people against another, forgetting the real enemy: the bastards at the top.

Anyway we're not beaten yet, far from it. There's far too much for community support DMDC for it to simply die. NT Chief Minister Shane Stone refused to negotiate or even communicate with the DMDC. He said the closure was "non-negotiable" and kept on in the noise the about complaints. When people resisted the eviction he called it "world war three".

declined to have any contact with the DMDC. Then, right after the eviction, he appeared miraculously at the DMDC (probably the first time in his life he'd actually been there!) with ABC TV cameras saying that we'd trashed and vandalised the place. Capitalising on some minor damage that had unfortunately occured in order to score some political points. Well fuckface, you wanted a war and we'll give you a war alright. You're not even honest enough to admit that the political groups which gathered at the DMDC - East Timor activists, the anti-nuclear mob, the Territory Greens, Coalition Against Police and the long-term Violence unemployed group - was a factor in you evicting us. We also know that some of the city pubs who were annoved and felt threatened by the success of the DMDC and that your corporate lawyer mate who'd payed good money to move into the area' had more to do with the closure than any so-called noise complaints.

The resistance is growing. Heaps of letters in the NT News have appeared supporting the DMDC. There's usually at least one each day, sometimes three. Posters taking the piss out of Shane Stone have been put up around town. There has also been stencilled graffiti art saying "SHANE STONE YOU GOT A DUNNY FOR A SOUL" and "CLP V. DMDC". CLP is Stone's ruling junta the Country Liberal Party. We'll see what happens. Chances are Shane will end up stone dead rather than the DMDC!

I WAS A TEENAGE SOCIALIST

Like many people before me, I had become disillusioned with mainstream politics. In my second year at university and prior to the federal election in 1993 I attended an anti-Hewson rally. I despised Hewson but when looking at the alternative I thought there must be something better. I really wanted to find a political movement I could focus my energy into and try to reverse some of the apathy of my generation.

It was at this time that I joined the International Socialist Organisation (ISO). The party seemed to have many worthwhile objectives. Such objectives included the fight against sexism, racism, homophobia and especially their involvement in the fight for workers rights and the class struggle. It was for these reasons I ioined the ISO.

I was welcomed with open arms. I attended meetings at the university and became a seller of the paper "The Socialist Worker". I was extremely motivated for the first six months after joining the organisation. I enjoyed talking to people about socialism but I also enjoyed hearing differing opinions. In a way my habit of listening to different opinions led to my leaving the ISO.

The first problem I encounted with the ISO occurred on a day when I was selling the paper. On this particular day I was told I was selling the paper the wrong way. While I was never told in what way I was selling the paper incorrectly I assumed it was because I was not selling one hundred papers a day. The ISO was very focused on rating success by the amount of papers sold. While selling papers means circulating Socialist ideas, I often felt we forced many paper sales onto people who were only interested in finding out about the organisation and we actually alienated these people. The ISO seemed to think that selling the paper was more important than just talking to people.

The next problem I encounted was while postering for a public meeting the ISO was holding. As we passed McDonalds, I stated how much I hated McDonalds and everything they stood for including the oppression of their workers. The person whom I was postering with told me the reason the ISO don't hate or protest against McDonalds is that many workers eat there and if we discuss problems about McDonalds we will alienate the workers.

The way ideas were dismissed as not worthy of discussion if it didn't 'toe the party line' was heart-breaking. There were numerous occasions when people with different opinions were totally rejected without longer serving members trying to understand.

Money is a major concern for the ISO. "Are your fees up to date?" was a familiar catch-cry, replacing "Hello, how are you?". I even saw a girl who didn't have \$2 rejected as a member. It came to the point were I was asked to sign a withdrawal slip so membership deductions could be taken out of my bank account automatically!

It's a pity I was worn out by the negative attitudes and not the positive.

I still have friends who are Socialists and are good people. However I feel it's a shame differences between left-wing groups causes conflict over the 10% of issues that they have differences on, instead of fighting together for the 90% of things they agree on.

Utopia won't arrive in one day and fighting over what's going to happen after the revolution doesn't get us any nearer the revolution.

DT BEAT

In every election the pollies trot out the old hang 'em and flog 'em, law and order policies. In the tabloids they use scare tactics to try to convince us that the State needs more powers in order to protect us from ourselves. By convincing us that there is a rapist in every dark corner, a mugger behind every tree in every park and every kid is a delinquent that is going to flog your car and take it for a spin, we are made to live in a climate of hysteria fear The generated creates a mood in which ordinary people feel powerless and that they must rely on the State to provide a sense of physical and psychological Consequently security. voters are encouraged to support the pollie on the law and order ticket and the police who are the army of the rich are able to bolster their numbers and

The truth behind the law and order facade is that poverty unemployment increasing, the middle and upper classes are starting to worry about how they are going to protect their worldly possessions from the rest of us.

These bludging silvertails are calling for more police on our streets, more prisons, longer sentences and the like so that they can imprison and murder us more effectively when we try to take back a bit of what we, ourselves, have worked for. Don't be fooled, these people and their policies are designed solely to protect their own interests, wealth and property. As far as the rich are concerned the rest of us can go to hell.

It is the working class that these measures are designed for. The history of the police and prisons is that they are used to control the working class. Three quarters of the prison population are unemployed at the time of going inside and a majority of crimes are crimes of poverty: welfare fraud and theft are just two examples. The bullshit spewed out about law and order has real consequences for us; running alongside the push for greater law and order measures is the push for privatised prisons and harsher and more repressive conditions in prisons. While we cop this, the upper classes get off with suspended sentences or some cushy stay at a prison farm with the Governor's personal service!

Greater powers has also led to the cops and screws having greater freedom to do what they want to us. The bottom end of the working class contains the vast majority of Aboriginals and it is these people that are especially vulnerable when it comes to imprisonment because these people lack access to money and legal representation. The political system that has developed in this country has been nurtured by the 'got-it-alis' and is based as much on racial discrimination as it is on class discrimination. If you've got any doubts, just ask any Aboriginal.

When you consider that Aboriginal people make up less than 1.3% of the adult population, yet account for over 17% of all deaths in custody it becomes quite clear that the judicial and prison system are extremely racist. Aboriginals are over eighteen times more likely to go to prison than non-Aboriginal people and in some states the population of Aboriginal prisoners has increased by more than 150% in the last five years. On average Aboriginals who are sentenced by a court of law receive a prison term that is 30% longer than that of others imprisoned for similar offences. It's hard see this as anything other than another step in the continuing genocide of Aboriginal people in this country.

1995 proved to be one of the worst years on record for Aboriginal deaths in custody with fifteen deaths reported in police and prison custody and already as of February this year a further four deaths in custody have taken place. Aboriginal deaths in custody are increasing at an alarming rate proving that despite the 339 recommendations handed down by the 1991 royal commision into Aboriginal deaths in custody, nothing has changed.



Working class people are being literally pushed aside as the wealthy classes take over our suburbs, our pubs and our houses. We don't have many hang outs these days where we can feel comfortable to relax with friends apart from the local pubs. These to many people are a needed cooling off period after a shitty day at work and a lot of steam is released. It's just a pity that the large majority of frequenters are still men and you have to be sipping a drink so as not to upset the publican.

Working Class people need to open their homes and hearts to each other in order to realise that there's no shame involved, but a need for comradeship in all of their lives and the involvement of women is vital. Real Estate Agents are upping the prices as the Yuppies flow in to our communities breaking up what little familiar territory we have left to grow on. It's not just progress taking place, but an invasion which is calling us the aliens. While you're waiting for some vital repairs to be done on the house you're renting, the stingey owner may well be spending thousands on renovating his third house for a new upper class tenant who'll pay three times the rent and you're house might be next. It's easy to say that the ball is in his court but it doesn't have to be. Whilst you are insignificant to him and out of the way doing your weekly routine, you could be putting some of your working class pride and suppressed anger to use. Asking for a hand from some of your mates shouldn't be a problem, after all they are comrades and know you would do the same for them. A little bit of support goes a long way, especially when you're in the right. Rocking up to the Real

Estate office, with a few of your mates outside the window watching on, is going to make the agent think twice about shrugging you off this time. Oh, and you can forget about watching those crap current affairs segments on prime time TV, where the media does a poor working class family a good turn in similar situations. That's their way of getting your vote, the working class, the majority vote and support for the other crap they fabricate in this warped society. It's our family and friends that we must work together with. Why should we continuously be pushed out, of our communities, where we'll lose the friendly faces we meet on the street and in our shops who know us by name. We are losing everything familiar to our lives which we cherish. We have shaped our community into something as comfortable as it can be under this governments rules. We respect each other and get along as best we can, able to acknowledge people with a nod, the person behind the counter at the local shop values us as a needing customer and we try to not whinge when the prices go up. But it's time to whinge now and not only that but to recognize those of us that feel the same way. Small businesses are going broke as they can no longer afford their lease renewals and in comes a speciality shop full of trendy overpriced clothes and next to it a shop exclusively decked out with ridiculous designer socks. It's not that we're getting old and no longer understand the new generation. This is not another generation, it is class another entirely, making themselves at home with their money. And what about us? We go that extra mile to find our provisions at a decent price, then settle down at our local pub, to feel at home with friends, thinking that this place could never change. It will, and haven't the bar staff already got flash, new uniforms. The publican isn't always going to be there to lend you fifty bucks just cause your pay hasn't come in on time. You and the other worker's have to sort the problem out where it's happenning, with the fuckwits who think you can wait for your hard earned money, just cause their pockets are bulging.

JUSTICE for the

ABORIGINES of AUSTRALIA

Aboriginal Australia was crudely attacked at large by white colonialists from the British Empire. This empire was built on avarice, bloody conquest and an ideology of superiority. Aborigines were given no choice in the white occupation of their land. Had they possessed such a choice, with the power to enact it, White Australia would be a contemptuous lie.

On a January day in 1788 the Endeavor, headed by a white supremist, an invader, a liar and thief named Captain James Cook, found land to set down on. A few days later the Union Jack was unfurled to flap in the wind: the white for their skin, the red for the blood of those who died defending themselves, their families and their livelihoods against advancing, imperialist conquest and the blue for the blood of the British Monarchy: the parasites upstairs who have maintained their comfortable position in society at the expense of all colonised nations.

White colonialists set out to plunder world of the Aborigines immediately. There was consultation. This is a white lie of enormous scale. In order to take the land of another, you must first convince youself that you have a more just right to this land. To reason with yourself, again and again, and still arrive at this conclusion defies the very notion of fairness and equality for all. This mindset is the garden that is nurtured in all of today's tyrants and those who aspire to be tommorrow's.

The invasion of Australia is not simply defined in terms of geographical space. When you take land in a tribal society, a peasant society, any society that literally lives off the land then you are not simply taking space away from others to

make your own. You take a peoples' livelihood, their purpose for living, breathing, eating, loving. You take their source of food and deny them sustainance nourishment; mothers need to feed their young and the old need to stay strong. If you take this land and change it's composition in any way, shape or form then you will drive out the indigenous food supply and local's will be forced into more desparate circumstances: they will attack you for what you have (what has been stolen from them or denied them unfairly) and in the process treat you with the contempt that you have always treated them with.

Colonialists, of all backgrounds, know that to conquer a land you must first conquer its people. Never did it cross the minds of the illegal aliens of the Crown that negotiation with the Aborigines should be engaged. They thought nothing of it and prepared themselves for a bloody war. A mindset of white supremacy was to come and nurse them in their hours of need.

Inevitably a race war erupted on this sunburnt country. This war had all the characteristics of all imperialist wars past and post. The gradual build-up of the invading force, the bearing of arms and the flexing of muscles, the spreading of lies and insidious propaganda, the attacks upon the Aborigines and their attacks and counter-attacks upon the whites. The blood on the soil and the screams for vengeance! The glory of victory and the agony of defeat.

A remarkable difference: The invaders had a choice between showing the hand of friendship and solidarity of international humankind or inflicting a wound so gaping upon Aboriginal Australia. The invaders chose the latter. Aborigines had no

such choice and engaged in a war for independence after this war had been thrust upon them. Their war was a response to invasion, theft murder and rape. The war for white supremacy in Australia was a premeditated event culminating in the almost complete destruction of Aboriginal civilization.

As this war enveloped Aborigines on a larger and larger scale with executions of individuals turning into wholesale massacres of entire tribes and more and more Aboriginal women became the bearers of white



babies through acts of rape, Aboriginal people stood up and mobilised themselves in order to combat the forces of terror that were descending upon them. Aborigines embarked on a campaign of guerilla warfare, and fought this war to suit their own methods of organization

and based it also on the terrain of the battleground. They were and still are smart movers and clever thinkers and not the intellectual dupes we are told they were and are.

Musquito, Pemulwuy, Wandradyne are just three of many Aborigine warriors who fought a war for freedom and ultimately died for that freedom. Liberty bells may chime in swanky cities of decadence built on the blood of a thousand bleeding nations, but the Aborigines of Australia are yet to hear them ring. When Aborigines gaze upon the world of white supremacy it is likely that they see a world of twisted morals, macarbe thoughts and hypocritical lifestyles. Shipping hulkloads of convicts, many of whom were Irish warriors and working class advocates of true socialism and who came from a position in their own country that was not unlike the position Aborigines now found themselves in in their land of sweeping plains, white colonialists

could show no barer truth of the

KISINAL

society they espoused - they were hunters looking for the kill and they were proud of it.

Heretics, Miss-Fits, Treasonists, Arsonists, Republicans, Freedom Fighters. The imperialist army of the rich came and put the working class down again and again. Ringleaders, Big-Mouths and Martyrs-To-Be were

framed and nailed to the wall. Locked up, shot down, locked down and shot up.

Transported unwillingly to a land unknown for "crimes" against the Crown, that tiara of torture and symbol of blood-letting, these whites were not colonialists by any choice although some almost certainly adhered to racist, white ideology. Being in the circumstances that convicts were in, they to, often, saw the colonialist actions of the British Empire and its murdering Navy for what they were and wanted no part of their foul deeds carried out against the Aboriginal people. Most Irish prisoners were victims of the war for independence in their own land, they had no desire to live elsewhere, in fact they were fighting to stay exactly where they were. Good luck to them too!

If Aborigines were ever to be convinced of the righteousness and superiority of white standards that possibility was destroyed the moment the hulks arrived. Chained up, lashed, beaten and starving; and white's are saying that we have something far better about ourselves that Aborigines should be jumping at the chance to "turn white".

In the early days of white colonialist conquest on Australian Aborigines and white anti-colonialists sometimes found themselves together, fighting a war for liberty shoulder to shoulder, arm in arm. In recent times we have seen this in places too, like the white support for Aboriginal Land Rights, support for specific land claims. involvement in and commitment to social and class justice organizations and prisoners' action groups: many Aborigines are imprisoned because racist cops don't want "the coons walking the streets".


To marry these two parties traditionally at war with each other will be a long and painful process. It cannot happen overnight but it would certainly happen faster if white, working class people took up the cause for Aboriginal Sovereignty and Self-Determination in greater numbers than present.

BREAK THE BACK OF RACISM! FREE ALL ABORIGINAL PRISONERS OF WAR!

What can I do?

- Bring up the issue of equality for all people, including Aborigines, with friends, workmates and comrades.
- Try to get your union to support the cause for Aboriginal Land Rights - like the way the BLF used to.
- Design a poster or two in support of Aboriginal Self-Determination and paste it around your local area.
- If you publish printed matter of any sort, or contribute to it's publishing, then work towards creating a regular space to cover the Aboriginal Struggle.
- Confront racist and snobbish attitudes whenever possible.
- Participate in the annual John Pat Rally that takes place around the end of September.
- Contact Aboriginal organisations for information on current developments in their struggle for total control over all aspects of their lives.

White people must take the initiative to make contact with Aborigines. We are the ones who benefit from white skin priviledge and therefore we are the ones who must demolish it by throwing it to the wind.



GETTING BURNT

and fighting back

What follows is a brief account of what can happen to anyone, but definately did happen to this man. His story is one of many, where working class people are screwed by the rich and powerful. In this case though, Alexander Prus-Grzybowski has stood up to these scheming parasites and is still doing so today!

In 1973 Alexander Prus-Grzybowski paid a law firm, Everingham and Co., to draw up a water-tight lease for him for a chicken farm he wished to lease from a William Whitlock. Everingham and Co. is owned by former NT Chief Minister Paul Everingham.

Soon after this a number of disputes with the landlord erupted regarding water supply to the farm and Prus asked Everingham and Co. to begin legal proceedings against Whitlock for alleged breach of contract.

However, after waiting months for these proceedings to begin but having nothing eventuate, Prus went

to the only other law firm in town, Martin and Partners, to get his case dealt with. Brian Martin of Martin and Partners is now Chief Justice in the Northern Territory. Prus claims that he had drawn up an affadavit Everingham and Co against Whitlock but that Everingham and failed to lodge it in the Supreme Court.

As if that weren't enough to wind you up, Prus then discovered that

Everingham and Co. were now representing Whitlock!

After many adjournments the case against Whitlock was finally heard. Peter Dean, acting on behalf of Whitlock for Everingham and Co. argued in court that the lease Everingham and Co. had originally drawn up for Prus was illegal. Basically the original lease was for six months with a renewable option for ten years and any agricultural lease longer than two years had to be approved by the relevant minister by NT law - which it wasn't.

To add salt to the wounds, Prus, who had sold his house to lease the farm,

WAS THEN EVICTED. Can you imagine losing all you possessed through a minor legal oversight?

Inflamed with a sense of revenge that only a person wronged can know, Prus then turned up at Alice Springs courthouse with a rifle and looking for Peter Dean, shot a lawyer in the shoulder. Unfortunately though, due to a cruel twist of fate, Prus actually shot Ted Skuse, the lawyer he had recently hired to act on his behalf from Martin and Partners. Prus was then arrested and charged with attempting to murder Ted Skuse.

Prus retained Martin and Partners to

their involvement. Prus writes "It becomes clear that there was no independent lawyer but it was B.Martin who took charge of my case".

Prus was tried in the NT Supreme Court on the 26th of August 1975. It was conducted, in his words, "in a truly stalinist way" - there was no jury, witnesses or defence. A fair hearing?

The trial lasted one hour and seventeen minutes. Prus was sent down for eight years and served five and a half, mainly in a mental institution in SA. Prus claims that Foord not only failed to corroborate

his evidence but actually

contradicted it!

In 1978 Prus lodged a writ against Everingham and Co. in the NT Supreme Court, alledging negligence and breach of legal contract in their representations on behalf regarding Whitlock. After twelve years waiting for some semblance of justice, the matter was finally settled out of court in March 1987 and an undisclosed amount of money was paid to Prus. Prus can't say how much he

was paid under the terms of the settlement but he wasn't happy with it

Later that year Prus then sent a statutory declaration to the Attorney General in Darwin accusing Brian Martin and John Foord of criminal obstruction of justice and requested a case be heard against them in a court of law.

As of yet, Prus is still waiting. Good luck mate, *Angry People* wish you all the very best in your striving for justice.

Some of these people have come back to Darwin and have been living on the streets because they have no money.



UNDER THE INFLUENCE?

It probably had to happen. In Victoria, the Kennett government, in conjunction with the daily tabloid 'Pravda' has declared.....oops! I meant 'Herald Sun' has declared a "war on drugs". Youth unemployment, asian immigration, police powers and umpteen other issues are touted to the full, all reports pushing the usual conservative or right-wing line. But the virulence of this "war on drugs" is such that even the liberal "end prohibition" line is being smothered.

Let's try to cut through the bullshit. Firstly, drugs like heroin, speed and ecstacy are synthetic drugs produced by huge, vested interests. Criminal vested interests perhaps, but in a capitalist society any money made is good money made and only the poor get the laws, for the rich it's virtual anarchy. The "big bosses" that the 'Herald Sun' calls to be caught and punished are just well-off drug dealers who're occasionally sacrificed to the public. This gives the illusion of a competent and motivated police force as well as a 'working system'. In reality no such thing exists: the capitalist system is chaotic at best and the cops are corrupt loafers. The "big bosses"

are just that, big bosses, but we at Angry People know better than make allegations, much less name names, which we don't know. thanks to the law. However, an ear to the ground and a bit of sus is all it takes to work

out that the smart-suited, ponytailed, sunglasses-wearing stereotypes are only middle class individuals in what is only another layer of the capitalist, class system. Perhaps the police's, shall we say, tolerance, of the drug trade needs to go without mention........

These drugs are provided by the system. Their illegal status only serves to help legitimise a system that wants to appear as honest. Maybe a lot of cops and politicians do hate these drugs but the fact that they're widely available and under the control of large, vested interests shows that they're doing little about it and that drugs have their place in a system obsessed with money, products to sell and profit from and keeping you under control. Drugs are just another product in the marketplace.

Such drugs, like the ones mentioned above, it can be argued are the ultimate capitalist product. They give you the one thing we all crave: <u>ESCAPE</u>. For a few precious hours we are not slaves to bosses, victims of each other, stuck in ruts. Nothing matters but the sensations we feel.

But there's always a price to pay. And as in all things, working class communities have paid a heavy toll.

Drugs destroy the individual. They effect your brain and the way your

brain functions. You enjoy sensations caused by the drug, you enjoy the escape from reality, you enjoy thrill the of illegality. In many, too many cases. the individual surrenders themself to this.

The drug takes over. You become dependant. As it destroys the mind it also follows that it destroys the body. Physically these drugs play havoc. Mentally

and emotionally they turn you into something else: a user, and if you go too far: a junky.

Drugs destroy the individual's relations with others. You're no fun to be around when you're stoned. You're either a mumbling, lethargic bore or a hyper, overthe-top menace. You do things you wouldn't normally do and the drug becomes a handy excuse. The drug and your dependancy on it alienate you from others, best friends, families and neighbours.

As the dependancy grows the need for money grows too. That leads to deception: asking for loans from friends on pretences other than buying drugs, stealing from friends and neighbours, whoring yourself........

destroy communities. Drugs People are important but people who have no control over themselves or their actions also effect others. Homes are broken into, people are mugged and people turn to prostitution. For some prostitution can **lucrative** alternative 'conventional' work. For others it's the only way to support a drug habit and these people vulnerable especially helpless. It's bad enough that they have a monkey on their backs than to have to let bastards act out vile, sexual fantasies on them or suck a cop's prick to avoid jail. Worst of all, people just die. All this turns our communities into when warzones and government decides to 'get tough' we're all under siege. And it's always the poorest, working class towns that suffer the most. No rich occasionally doubt the overdose but that's just a bit of light, comic relief for us. Too many of our people are DIEING! Dieing inside their minds and their bodies and eventually dropping dead for good. This is drugs. This is what they are: a capitalist



commodity provided by yet another arm of the bosses' system. This is what they do: fuck our brains, ruin our bodies, turn us into treacherous scum, separate us from our loved ones and destroy our communities.

Of course it's possible for people to take such drugs in moderation. Unfortunately though, whether you take drugs to excess or not it won't stop the police attempting to put you away if they catch you using drugs. Angry People aren't trying to scaremonger here but we want to illustrate that the police have a long and sordid history of using hard drugs to get their way. As more and more people become active against the system police will use drugs against individuals and groups. Even the most wellmeaning, reliable friend can be pulled in and if forced to talk, put away and used as an excuse to crush that person's associates. Hard drug use breeds trouble for everyone, not just the individual USEL

Would legislation help? There's no doubt that people who work in needle exchanges and campaigns to end prohibition are courageous and honourable workers, wanting only to keep people alive and sane. They should be supported. But even many of these people would agree that it would be better if people didn't use heroin, speed or ecstacy. In any case there will always be illegal drugs regardless of what is legalised. It's too lucrative a market for the bosses of this industry to surrender. And what of the legal drugs? Alcohol, tobacco, valium etc? Don't these drugs kill us? Keep us apart? Keep our communities in the dirt? The system always accomodates. have plenty programmes to 'rehabilitate' drug users. Funded by church groups, rich individuals, donations and sometimes the government itself these programmes have varying agendas. Does 'rehabilitation' mean empowering the individual to think for themself, to be able to work cooperatively with others? Or is 'rehabilitation' turning the user into a 'good citizen', a church goer, an obedient worker or a submissive housewife? What the

fuck drives so many of us to drugs

in the first place??

Right, so that's the bad news. Now for the revolution......

revolutionaries recognised drugs for what they are and fucked them off. From the anarchists in Spain in the 1930's to the Black Panther Party for Self Defense to the Autonomists in Europe today, those who see the system and its' bosses as the scum that they are have fought against the influence of drugs. alcohol to smak. themselves and their people. Interestingly, in the case of the Panthers and the Autonomists, marijuana was and is seen as permissable. Perhaps there's always an exception or two. This has made them serious enemies

We at Angry People call for revolution - total, outright, allempowering revolution. We say that it's too important to throw your mind, body and life away for the bosses bank balance and the

convenience. polices' Many people fuck drugs off and find satisfaction in more friendships and labours when they have the time and free will to do so. It's not impossible. It takes hard work but that in itself empowers you. A dedicated effort. whether a drug programme, a in lifestyle, using change alternatives that benefit you like exercise. meditation, creative work or organising against the system will attract real friends who will help you. Remove vourself from the subcultures and ghettoes that glamorise drugs and you'll find that these groups aren't rebellious but just another empty. soulless scene created capitalism's endless search for products to sell and profit from. Create your own REAL CULTURE aid on mutual based cooperation and you'll find you won't need drugs to dull the pain and boredom of life under a crooked system. And if you slip, you have to pick yourself up and not dwell on the bullshit but keep trying to keep yourself clean and active. Grass roots self-help groups exist, and in places where they don't, try to form your own. You'll need people around you who want to help and if you're sincere, you'll find them. Maybe moving to another town will be necessary but remember: your life is important. Once it's in order you'll be able to re-acquaint with old friends.

Above all remember: drugs are a weapon against you and your friends, family and community. Fucking drugs off and taking full control of your life is an outright revolutionary act and another victory for our class in the class war, whatever you choose to do with the rest of your life. LIFE IS HARD, BUT RESISTANCE IS THE ANSWER, NOT SUBMISSION. The more we throw off all of the bosses constraints on our lives the stronger we grow and the closer we get to a world we can all really live in.

From Behind The Bars

With all the hype from top politicians and diplomats over the 'terrorism' of the firebombing of the French Consulate in Perth splashed out over the headlines of the media, it is interesting that the arrest and trial of the two young people who admitted responsibility did not get the same coverage. Could it be due to that the fact that it was not 'international terrorists' but just two ordinary young people who did the bombing? That this act had demonstrated the uselessness of Keating's empty hypocritical gestures of protest? That extended media coverage over the perpetrators of the consulate bombing may give inspiration to other concerned activists who realise that the politicians of this country don't give a shit about nuclear testing in the Pacific (never mind the nuclear testing performed on Australian soil!!) because they are too worried about keeping up Uranium exports and they know that diplomatic sanctions are totally powerless?

Keating's chirade was only to whip up support at home, knowing that many people in Australia are concerned over nuclear testing but realising that he has fuck all power to do anything about it, even if he wanted to. Keating's own faction in the ALP tried to expand Uranium mining at the last ALP national conference which clearly shows that his interests lie with the nuclear industry. He cleverly walked the delicate tightrope of appeasing the French nuclear and Australian mining interests as well as joining the popular protests against nuclear testing. His hypocrisy is even more obvious when China's nuclear detonation met a wall of silence.

The half-assed protests fizzled out as quickly as they were called, the French kept on testing, knowing that no-one could stop them, knowing that the major nuclear countries of the world secretly supported them and that the general popular concerns of people world-wide could be safely ignored. It is crucial at this stage to remember those people who have decided to take action into their own hands, and who are being ignored by the media, and even the nuclear protest movement, because that movement doesn't want to rock the boat and its support for so-called terrorists will undermine its job of keeping protest safe for the ALP.

Bosco Boscovitch and Maya Catts were found guilty of arson of the French Consulate in Perth. Bosco copped six months, while Maya is on remand awaiting sentencing. Bosco released a statement from Casurina Prison on 2/10/95. He has now been transfered to a prison farm.

"I am devastated again. The French have today detonated No. 2 in this series, and I'm in a 6sqm cell. Incarcerated in a maximum security prison. Why am I punished? Why am I here? It was for you, it was for our children. The law the judge, the media, society - snap out of it! I feel an utter contempt for the society I am from, will they ever evolve? I am in jail! They have locked me away because I care so much. Oh, there is just me in the mirror, a hard bed, a big heavy steel door and bars. I see my eyes reflected - they are red. I have been crying - the young idealist. I can live with what I have done, it all depends on what you value and from what perspective you view the world, 'our world' - its incongruous. It's hard to breath in."

Eleven Men Dead in a Oueensland Mine

You might have wondered why **Angry People** call for class war and what are we so angry about anyway? Don't we live in a decent country, you might ask, with a fair go for all?

Well sometimes something happens which crashes right through the nice, decent facade of Australian life and shows the reality behind it:

On August 7, 1994 the gas in a coal mine at Moura exploded and killed eleven men working in the pit. Working class men - coalminers. Another gang of ten men escaped from another shaft and were lucky to get out with their lives.

In January this year (1996), the coroner's report revealed "management neglect and non-decision" as well as an understaffed Government Safety Office. Mine management ignored warning signs that the mine could blow and the shift was sent down the mine. Miners were not told of the danger or asked whether they wanted to go down the mine or not.

The only thing that really mattered at the Moura mine were the dollars to be made from ripping out coal for BHP. To put safety as a priority would have cut into profit margins. The workers don't matter. We just don't matter.

To crown it all no charges will be laid. When the coroner's decision was handed down the men in suits from BHP shook hands with their solicitors and congratulated themselves. The ruling class has closed ranks to protect its' own.

The only time in our 'civilized' society when you are allowed to kill openly and get away with it is in war. And when you kill in the interests of a 'higher ideal' you are a hero.

That is just what happenned at Moura. The class war rages. Eleven miners dead in the pursuit of profit, the rich man's only ideal.

A Driver's Story

Driving the cab in the inner city when I picked up these three blokes. Best torn jeans, leather jackets and inner city tough. Their hair was perfect, like they'd each done termiles on a Harley, no helmet.

They ignored me and talked revolutionary politics. And they bagged 'the workers' for not being revolutionary, for being apathetic, for not doing what they should.

I couldn't believe it. Here I was, a 'real worker' and these clowns acted like I wasn't there. But there were my hands on the wheel and my foot pumping petrol, so what was I? A servant or something? They talked about 'the working class' as if such people were miles away on another planet.

Bored of politics they took turns trying to impress each other with their next overseas trip. I dropped them off and was glad to be rid of them. No - don't stop to say thanks, your politically correct movie must just be starting. No, no, don't stop to ask me about work, or twelve hour shifts or life as 'a worker'.

Then it dawned. These jerks were just the aspiring revolutionary leadership of some stupid party. The ISO or DSP or some other mob of private school, born to rule, middle class wankers!!! And I'm suppossed to follow them??!!

the Wobblies are still alive after 99 years

The Industrial Workers of the World or Wobblies are a militant union born in the USA out of fierce labour struggles at the turn of the century. The first local group in Australia was formed in 1907 and 'the Wobs' quickly gained a reputation for uncompromising industrial action. With a philosophy of "one big union" to cover all workers in any given industry the IWW became a real force among miners, itinerant rural workers and workers in the cities. They organised among low paid and unskilled workers who received little comfort from the established 'craft' unions and they also drew militant workers frustrated by the cosy club of trade unions, employers and Labor governments.

At public meetings and in their paper "Direct Action" the Wobs were ferocious in their attacks on the rich who lived lives of luxury while their workers sweated. The IWW advocated 'class war' and believed in fighting to win. They saw the government as toadies of the rich and the established unions as being compliant with Capital in

the exploitation of the working class.

The IWW was almost entirely alone in opposition to the First World War when it erupted in 1914. They at first got little sympathy but as the extent of the slaughter became apparent they began to get a hearing. The Wobs argued that it was the wealthy who were profiting from the war but that it was the working class who were doing the dying. By 1916 war recruiting had begun to dry up and the Australian Government began pushing for conscription.

The Wobs took part in the Great Conscription Battles within a loose coalition of unions, church groups and pacifists. Conscription was beaten but it was the Wobs who were marked for repression. The State could see the real danger they posed to the partnership between Capital and unions that kept the lid on working class revolt. The Wobs were fanning the flames of discontent just a little too brightly for the comfort of the established order.

The IWW was declared illegal in Australia in 1917. Their offices were raided and their presses seized. But the Wobblies kept speaking out. Dozens were arrested and many were deported. Twelve members were imprisoned for terms of up to fifteen years as a result of a frame up. However,

the Wobs did not disappear. The organisation survived in Queensland for a few years where repression was less than elsewhere and many members kept in good standing with the US administration of the union.

Wob influence was seen in the "one big union" movement, in the early communist party and right through to the present day. In the 1960's the fierce strike at Mt Isa was won by miners who had elected a Wobbly, Pat Mackie, to lead them. Pat had become a Wob as an American merchant seaman in the 30's and is typical of the militant

ideals of the IWW.
Into the 1990's the Wobs remain active in
Australia with groups in Sydney and
Melbourne and a commitment to radical
grass roots controlled unionism.

LAND AND FREEDOM

About a month ago I went to see "Land and Freedom" at the new Dendy cinema in Newtown. This was ironically fitting. For those of you from out of Sydney, Newtown is a part of the inner west rapidly losing any concrete connection with its past, as it becomes the latest focus of accelerated gentrification.

The socialists selling newspapers on the pavement were a regular feature of Saturdays on King St, even before the arrival of the cinema. That day they revelled in the reflected credibility of the opening of a film that told their story. Before they were just another element in a chaotic mix of students, beggars, shoppers, cafe dwellers and an increasing army of affluent residents. On occasion I've stopped to ask the person offering me 'Green Left Weekly' or some ISO tract if they know what happened in

Spanish civil Or for that matter Kronstadt or any of the other instances authoritarian

socialist violence against workers and particularly

anarchists - usually I ignore them. Like people who push religion door to negative door reactions don't register. Many have lost the simply capacity independent thought.

In taking on this subject, director Ken Loach set himself a formidable task. The Spanish civil war

confronts us not only with the menace of fascism but with the failures of revolution and the all too often hidden face of authoritarian socialism. Like many remembrances of war it is a story of tragic failure. If it makes the people selling papers out the front think again, it will have been

worthwhile. But I won't hold my breath.

Loach's solution to navigating the ideological maze of 1930's Spain will be seen as elegant by many film goers. 'David' our central character dies peacefully in contemporary Liverpool and his daughter is moved to look through some letters and photographs. We now travel with him as a young communist who first learns of the fascist threat to the Spanish Republic at a film night put on by a local party branch. Like thousands of others from around the world he decides to leave for Spain and join the fight. During the process of this character's development, we begin to see that the objectives and

means of this fight are entirely different from various perspectives even on the republican side. Initially he is with the POUM; the group of revolutionary Marxists that Orwell joined and wrote about in 'Homage to Catalonia'. The POUM, like the anarchists and other ultra left-wing groups, are fighting for revolution and immediate collectivisation. However the only major source of weapons is via the Russian Communists who support the republican government, believe that Spain is not ready for revolution and ultimately brutally crush all other antifascist forces, before being defeated by Franco themselves

Women fight alongside men at first in the POUM. We are actually disturbed to see 'Blanca' and the other women of 'David's' unit, sewing and cooking later on when gender

roles have returned. The relationship that forms between 'David' and 'Blanca' puts into relief a conception of sexual freedom that goes far beyond recycled '60s lifestyles. It is also a vehicle through which we see the political naivety of 'David' in his belief in the party. He leaves the militia unit for a time to fight with the better equipped and trained communists. He returns shortly disillusioned before the POUM are imprisoned, exiled or disarmed by the communists.

Loach's gritty approach been used powerful effect before,

'Ladybird Ladybird' is a good example. The selective release of script just before shooting also greatly adds to the overall tension, in that the actors did not know who was scripted to die in any particular battle until they had

Land and Freedom is an excellent film whose natural audience should be socialists as well as people with little or no political knowledge at all. A set of complex events are treated with elegant simplicity. For anarchists and others however, there are still many traps to be avoided. The endless contemplation of Spanish history is in danger of making us a society for the remembrance of martyrs. We will only begin to celebrate stories of triumph once we have grown out of seeking confirmation of the purity of our desires in film or any Arts.



Nexus Update

In the last issue of *Angry People* we ran a brief article on the 'New Age' mag *Nexus*. We highlighted the blatant propaganda of the extreme right which sat openly in its pages.

But it looks like **Angry People** only got the half of the story. Our thanks to the **Green Anarchist** of Oxford, England for a copy of **New Statesman and Society** from June '95 dealing with "New Age Nazism". It turns out that over the last couple of years **Nexus** has been a blatant propaganda journal for the ideas and conspiracy theories of the U.S. militias.

We have had **Nexus** articles by Linda Thompson who is the self-styled 'adjutant-general' of the U.S. militias as well as by Mark Koernke of the Michigan Militia. Also appearing are articles openly favourable towards Hitler and ads for Nazi publishing houses.

In Britain **Nexus** is promoted by David Icke who is an outspoken supporter of the U.S. militias as well as the violent British neo-nazi group Combat 18. We also have the British agent for **Nexus** running around telling anyone who will listen that "there were no gas chambers at Auschwitz" and other anti-Jewish bullshit.

The Australian editor of **Nexus** Duncan Roads has connections that lead to the **Australian League of Rights** which is about what you would expect.

We could go on, but the links are clear, NEXUS IS NOXIOUS!
