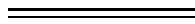

3 **BUILDING AND CONSTRUCTION INDUSTRY (IMPROVING PRODUCTIVITY) AMENDMENT BILL 2017**

Mr Dutton (Minister for Immigration and Border Protection), pursuant to notice, presented a Bill for an Act to amend the *Building and Construction Industry (Improving Productivity) Act 2016* in relation to the Building Code, and for related purposes.

*Document*

Mr Dutton presented an explanatory memorandum to the bill.

Bill read a first time.

Mr Dutton moved—That the bill be now read a second time.

Debate adjourned (Mr Dreyfus), and the resumption of the debate made an order of the day for the next sitting.

4 **SOCIAL SERVICES LEGISLATION AMENDMENT (OMNIBUS SAVINGS AND CHILD CARE REFORM) BILL 2017**

Mr Porter (Minister for Social Services), pursuant to notice, presented a Bill for an Act to amend the law relating to family assistance, social security, paid parental leave, veterans' entitlements, military rehabilitation and compensation and farm household support, and for related purposes.

*Document*

Mr Porter presented an explanatory memorandum and a regulation impact statement to the bill.

Bill read a first time.

Mr Porter moved—That the bill be now read a second time.

Debate adjourned (Mr Dreyfus), and the resumption of the debate made an order of the day for the next sitting.

5 **CORPORATIONS AMENDMENT (CROWD-SOURCED FUNDING) BILL 2016**

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—*And on the amendment moved thereto by Mr Husic, viz.—That all words after "That" be omitted with a view to substituting the following words:*

“whilst not declining to give the bill a second reading, the Australian Government is required to present on the first day of the Autumn sitting of the House legislation that contains a genuine and comprehensive framework for the introduction of equity crowdfunding to Australia, that:

- (1) can be used effectively by both unlisted public companies and privately held firms;
- (2) provides improved protections for retail investors, stronger than those currently proposed by the Government; and
- (3) avoids placing a heavy regulatory or investor relations burden on startup enterprises and small businesses.”—

  - (b) is hurting Australian families with his cuts to family payments and paid parental leave to give a \$50 billion handout to big businesses, including the big banks;
  - (c) is punishing some of the most vulnerable people in Australia, including pensioners and carers, with his robo-debt mess; and
- (2) therefore, condemns the Prime Minister for being:
  - (a) so out of touch that his hopelessly divided Government punishes families, pensioners, carers and new mums while giving a \$50 billion handout to big businesses;
  - (b) unable to explain how cutting \$2.7 billion in family payments leaves families better off; and
  - (c) so distracted by the chaos within his Government that he's only focused on looking after himself and not Australian families.
