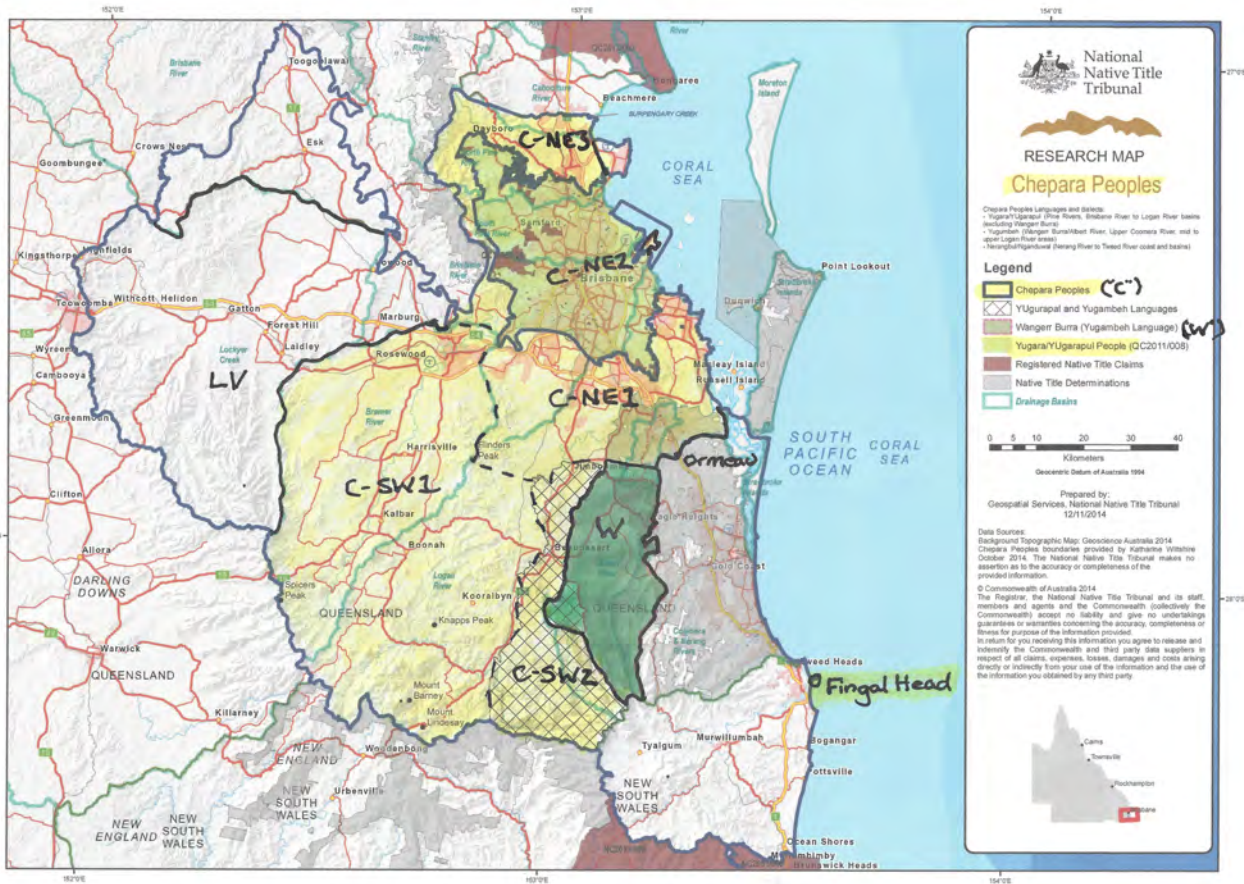

All persons who are members of the native title claim group and who have connection to:

- (1) the/an apical ancestor/s;
- (2) language, culture, acknowledgement and observance of law and customs; and
- (3) country from the mid-1820s, are invited to attend a meeting.

With representation and voting rights from each main descent group in attendance, the objective of the meeting is to:

1. Authorise the claim names, apical ancestors and land holding areas for making native title determination applications on behalf of the proposed Native Title Claim Groups;
2. Authorise the Applicants to make the proposed Applications and deal with all matters arising in relation to it under the Native Title Act 1993 (Cth); and
3. Make decisions on any other matters relating to the native title claims including:
 - a. Make decisions about directing and supervising the Applicant in performance of their duty
 - b. Authorising the native title rights and interest to be claimed under the proposed Applications

Please note: At least two family Elders or representatives of each main descent line should attend the meeting. All descent groups need to have an authorised member to represent their family descent line and a contact person (via mobile text and email). Each main descent line is responsible for supplying connection documents (e.g. death certificates and family tree).
