## FORMAT

- Manuscripts should be typed and printed on one-sided A4 paper.
- Manuscript word length should be no less than 60,000 words, nor greater than 140,000 words, including notes and references.
- The manuscript's title should appear on every page, as either a header or footer.
- All pages should be numbered sequentially, not by chapter.
- Manuscripts must be in English or with English translations of language/s.
- The author/s name/s must appear only on this entry form and **nowhere on the manuscript or synopsis**.

## SUBMISSIONS

- There is no entry fee.
- Electronic submissions will not be accepted under any circumstances. This includes email, fax or any form of storage device (e.g. CD, USB stick, etc).
- Each submission must have a separate entry form. Where there are multiple authors, each must complete and sign the entry form. Unsigned entry forms will not be accepted.
- Multiple submissions will not be accepted. This means that a single author can make only one submission to the award. They can either submit a manuscript as a single author, or as one of up to three authors of a manuscript, but not both.
- Submissions must include a synopsis detailing what the manuscript is about. This must not exceed one page and include the title of the thesis at the top.
- Submissions received will be acknowledged by letter, or email where an email address is provided.
- Entries open 1 July 2016; submissions received prior to this will not be accepted.
- Entries close 5pm EST, 31 January 2017. Late submissions will not be accepted. Entries post-marked 31 January 2017 that arrive after this date will be accepted.
- Manuscripts **must not** be bound or stapled in any way. The pages must be loose.
- Manuscripts will not be returned. Author/s must send only a copy of their work, not the original.

**CHECKLIST:****This submission includes:**

- Entry form completed in full, signed by all authors and attached (must be original).
- A one-page synopsis of the manuscript (rationale) attached. Please ensure the title of your thesis is at the top.
- Author/s name/s appears only on the entry form, nowhere on the summary or manuscript.
- A copy of a certified Proof of Aboriginality form OR details of two culturally appropriate referees for each author.
- A copy of the manuscript, unbound and conforming to the Format and Submissions sections in this Entry Form and the Conditions of Entry.
