Production history

These recordings were collected between 25 June 1998 and 27 April 2001 by Kim McKenzie during field work at Maningrida and Blythe River in the Northern Territory of Australia. The field trips were part of a project, later to become known as *People of the Rivermouth : the Joborr texts of Frank Gurrmanamana* which was published as a book and CD-ROM, to record the social conventions of the Burarra people. Speakers contribute in the Maringarr / Gidjingali language and English. They include Frank Gurrmanamana, Betty Ngurrabangurraba, Dominic Munbulmara, Jamie, Les Hiatt and Kim McKenzie. The collection was deposited with AIATSIS on 6 September 2007.
