## 2015 Congressional Voting Record

### THE 114TH CONGRESS, 1ST SESSION: ZEROES OUTPACE HEROES IN DEEPLY DIVIDED CONGRESS

Americans don't need a pollster to explain our country's current political trends, even though most polls have concluded that the first session of the 114th United States Congress amounted to a disappointing "status quo." Congressional votes fell along party lines with very little compromise as the Republicans continued their shift to the extreme political right while the Democrats continued to stay largely in the middle. As a result of the divisive language in Washington, the people's faith in government continues to dwell amid historically low digits.

To frame the political climate another way, the first session of the 114th Congress was so lousy that even John Boehner (R-OH) couldn't take it. The now former Speaker of the House announced that his plans to resign the Speakership and his Congressional seat in September of 2015, one day after Pope Francis's historic visit to Capitol Hill.

Maybe Boehner capitulated when the Pope criticized the Republican response to global warming and immigration, or perhaps Francis performed a miracle and got Boehner to finally recognize that the "trickle down effect" of Reaganomics doesn't exist.

Maybe Boehner grew tired of defending repeated government shutdowns, provoked in large part by Boehner's unmanageable caucus battling over a bill to fund the government beyond Sept. 30.

Maybe the former Speaker became fed up with the "Tea Party" and the unrelenting rhetoric from similar hard-line conservatives to resign. In any case, after Boehner's resignation, the GOP's favorite poster boy, Rep. Paul Ryan (R-WI) was elected as the 54th Speaker of the House.

Former Speaker Boehner served almost nine years as the Republican Leader in the House of Representatives, and spearheaded the GOP's anti-Obama agenda which pushed the House Republicans further and further to the extreme right. Under his leadership, the U.S. economy suffered a \$24 billion dollar loss after the GOP forced a 16-day government shutdown over their efforts to defund the Affordable Care Act -- a health care law that was approved by Congress, upheld by the Supreme Court, and reaffirmed by the American voters. Tragically, the \$24 billion dollar loss was just the government shutdown, and not even the tip of the proverbial failure iceberg. Boehner's legacy will also include making Bush-era tax cuts permanent (which disproportionately benefited the wealthiest Americans), banning spending "earmarks", and reforming Medicare with the "doc fix" that changed the way doctors were reimbursed for Medicare patients.

Boehner's resignation also symbolizes the end of a Republican era. Boehner was known as a "country-club Republican" who enjoyed working on deals over

18-hole rounds of golf. He was also known for being able to craft some lasting relationships with Democrats like President Barack Obama.

With the chaotic recruitment of Rep.

## THE 114TH CONGRESS: 1ST SESSION

Paul Ryan (R-WI) to serve as the new Speaker, it's not yet clear what direction the House will take, but so far little has changed as the Tea Party loyalists continue to dominate the floor with tactics that prioritize throwing tantrums instead of working on tasks normally associated with governing.

Several important specific issues were at stake in 2015. With the 112th and 113th Congresses going down as some of the most unproductive Congresses in history, the 114th Congress first session did not get off to a great start. In the first 170 days alone, the Republican-led Congress voted on ZERO job bills, choosing instead to focus taxpayer money on attempting to repeal or undercut the Affordable Care Act (Obamacare), remove environmental protections, and increase taxes on the middle-class by \$2,000 while giving America's wealthiest another tax break.

2015 continued the GOP's long-standing obsessions with repealing the Affordable Care Act, weakening Medicare, and restricting women's rights to health care. None of this is really surprising since it's become their standard health care posture. In October, the passage of HR 3762 in the House of Representatives showed their commitment to promoting these misguided priorities. The "Restoring American Healthcare Freedom Reconciliation Act of 2015" aimed to gut the major provisions of the President's health-care law and essentially make it unworkable. In addition, the bill would have phased out an expansion of Medicaid, and paused federal funding of Planned Parenthood by prohibiting Medicaid reimbursements for Planned Parenthood services.

Speaking of Planned Parenthood, in September brought about unfortunate *de'ja vu*, the GOP-led Congress once again tried to hold the American economy hostage by threatening a second government shutdown - this time over funding for Planned Parenthood.

It should be noted that Congress has already imposed strict regulations on the funds that go to this national women's health organization, with none of the public funding Planned Parenthood receives going toward abortion services. Instead, the monies go toward the other 97% of the organization's programs, including providing tests and treatments for sexually transmitted diseases, contraception education, pregnancy tests, along with cancer tests and treatments.

Luckily, with just seven hours left before the deadline, the House of Representatives passed a bipartisan bill that would fund the federal government through December 11.

Trade dominated much of the debate and continues. ADA was very vocal about the Trans-Pacific Partnership (TPP) trade deal, which was negotiated throughout the year by corporate lobbyists behind a shroud of secrecy. We are concerned about the effect this trade deal will have on American jobs, wages, safety and environmental standards. In addition, the trade deal will permit corporations to challenge any of our laws that they think might limit corporate profits before a Trade Commission dominated by corporations, not a court of law. As a result, corporations can challenge laws protecting our environment, public health and safety in a corporate-dominated body, not in US Federal Court, and this undermines American democracy.

2015 was also a big year for education policy in Washington. The Democrats fought to reform student loans, address school dropout prevention, expand access to high-quality preschools, and to make college more affordable. On the other side of the political fence, Republicans shortchanged students by proposing a budget that would have frozen federal Pell grants, aimed to cut funds for scientific research, and pull funding for early childhood and K-12 education. Sides came together

to pass the "Every Student Succeeds Act" (ESSA) in December 2015, which replaced the disastrous Bush-era "No Child Left Behind Act" (NCLB).

Also, not surprisingly, the Republican-led Congress sought to deregulate Wall Street in a wide swath of ways, from attempting to roll back Dodd-Frank regulations to relaxing environment and energy restrictions. The GOP attempted to undercut environmentalists by promoting misleadingly titled legislation like the "Federal Water Protection Act," which would have actually undercut the Environmental Protection Agency's (EPA) authority to prevent water pollution, and the "Ratepayer Protection Act of 2015" which would have allowed states to avoid complying with a Clean Air Act compliance rule.

2015 was also a memorable year for foreign relations in Washington. Former Speaker John Boehner invited Israeli Prime Minister Benjamin Netanyahu to address a joint session of Congress to speak about the Iran nuclear negotiations. After the address, 47 of the Senate's 54 Republicans sent a letter to the leadership of the Islamic Republic of Iran in an attempt to cast doubt on the Obama administration's authority. This prompted the #47traitor hashtag to trend throughout the country and left many, including those of us at Americans for Democratic Action, disturbed that they would undermine our nation's foreign relationships in search for political gains.

While 2015 saw some important debate and political posturing it was short on substance in the handful of bills it actually passed. Right-wing Republicans regard 'compromise,' a keystone of effective democratic governance, to be a dirty word. With a deeply divided Congress, a Presidential race without precedent, and the balance of power up for grabs in the elections, expect 2016 to feature much of the same.

## HOUSE VOTE DESCRIPTIONS

**1. House Vote 82 - H.R. 636 - American Small Business Tax Relief Act of 2015.** A bill to make permanent provisions to let small businesses recover the cost of capital investment without regard to revenue off-set and without a comprehensive approach to provide similar benefits for low-income persons or for other social purposes, such as renewable energy. Passed 272-142: February 13, 2015. A no vote is a +.

**2. House Vote 128 - S.J.Res.8: A joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the National Labor Relations Board (NLRB) relating to representation case procedures.** On the passage of S.J. Res. 8, a resolution to disapprove of the NLRB rule of December 15, 2014 related to regulations for processing union representation cases. Passed 232-186: March 19, 2015. A no vote is a +.

**3. House Vote 136 - Ellison (D-MN) Amendment 81 to H. Con. Res. 27, FY 2016 Budget and setting budget levels for 2017-2025.** The Ellison Amentent is a vote on the Congressional Progressive Caucus substitute Budget. Failed 96-330: March 25, 2015. A yes vote is a +.

**4. House Vote 161 - H.R. 1105 - Death Tax Repeal Act of 2015.** Vote to repeal the Estate Tax and Generation-skipping transfer tax. Passed 240-179: April 16, 2015. A no vote is a +..

**5. House Vote 184 - Van Hollen (D-MD) H. Amendment 123 to H.R.2029 — Consolidated Appropriations Act of 2016.** An amendment on the military and veterans administration appropriation bill, to make Defense

spending clear and straightforward by eliminating the entire “Overseas Contingency Operations” of the Defense Department. Failed 191-229: April 30, 2015. A yes vote is a +.

**6. House Vote 219 - Passage of H.R. 1732 - The Regulatory Integrity Protection Act.** A bill that would undercut the Environmental Protection Agency’s efforts to clarify and strengthen the Clean Water Acts’ treatment of wetlands and streams necessary for drinking water for millions of Americans. Passed 261-155: May 12, 2015. A no vote is a +.

**7. House Vote 237 - Nadler (D-NY) Amendment 41 to H.R. 1735 - National Defense Authorization Act for Fiscal Year 2016.** H.R. 1735 would authorize Fiscal Year 2016 funds for the military and would limit funds to dismantle nuclear weapons. The Nadler Amendment would delete that limitation, thus allowing the dismantling of nuclear weapons. Defeated 178-242: May 15, 2015. A yes vote is a +.

**8. House Vote 362 - H.R. 1314 - Concurring in portion of senate amendment preceding title II.** This bill combined President Obama’s request for fast track authority or Trade Promotion Authority (TPA) with a stimulus-level extension of the Trade Adjustment Assistance (TAA) program. The vote for this bill was spilt into two parts, one on TAA and the other on TPA. Passed 219-211: June 12, 2015. No vote is a +.

**9. House Vote 384 - Passage of H.R. 2042 - the Ratepayer Protection Act of 2015.** A vote to extend the deadline for compliance with Stationary Source Carbon Dioxide from Fossil Fuel-fired Existing Source Electric Utility

Generators under the Clean Air Act. Under this legislation, no state would be required to submit a plan or comply with a federal rule. Passed 247 to 180: June 24, 2015. A no vote is a +.

**10. House Vote 413 - Frederica Wilson (D-FL) Amendment 56 to H.R. 5 - Student Success Act.** The Wilson amendment would provide for school dropout prevention and reentry programs and provides grants to raise academic achievement levels for all students. Failed 192-237: February 3, 2015. A yes vote is a +.

**11. House Vote 466 - Passage of H.R. 3009 - the Enforce the Law for Sanctuary Cities Act.** The bill denies states criminal alien assistance, community policing and other law enforcement funds if it has a law or procedure restricting communication with the Immigration service about an individual’s immigration status. Passed 241-179: July 23, 2015. A no vote is a +.

**12. House Vote 493 - Passage of H.R. 3461 - To approve the Joint Comprehensive Plan of Action, signed at Vienna on July 14, 2015, relating to the nuclear program of Iran.** A vote to approve the Joint Comprehensive Plan of Action relating to Iran’s nuclear program. Failed 162-269: September 11, 2015. A yes vote is a +.

**13. House Vote 505 - Passage of H.R. 3134 - Defund Planned Parenthood Act of 2015.** The bill would end federal funding for Planned Parenthood for one year. Passed 241-187: Sept. 18, 2015. A no vote is a +.

**14. House Vote 540 - Passage of HR 3192 - the Homebuyers**

**Assistance Act.** The bill prohibits until February 1, 2016 enforcement of integrated disclosure requirements for mortgage loan transactions under the Real Estate Settlement Procedures Act of 1974, the Truth in Lending Act, and regulations under those laws. Prevents suits for violating the requirements before February 1, 2016, so long as there was a good faith effort to comply. Passed 303-121: October 7, 2015. A no vote is a +.

**15. House Vote 559 - Passage of H.R. 10 - Scholarships for Opportunity and Results Reauthorization.** Prohibits the Education Department from limiting D.C. Opportunity Scholarships program (vouchers). By voice vote Rep. Eleanor Holmes Norton (D-DC) amendment was voted down to require that the voucher program be evaluated using strong research design and limiting voucher students to less than half of school enrollment. The bill limits D.C. right to self-government. Passed 240-191: October 21, 2015. A no vote is a +.

**16. House Vote 568 - Passage of H.R. 3762 - Restoring American Healthcare Freedom Reconciliation Act of 2915.** The bill would end funds for prevention, repeal premium assistance, small-employer tax credit, penalty for not buying insurance, Medicaid expansion, requirement that insurance companies provide minimum service, fees on prescription providers tax on employer-sponsored benefits, medical devices, or insurance, and Planned Parenthood funds. Passed 240-189: October 23, 2015. A no vote is a +.

**17. House Vote 636 - Passage of H.R. 1210 - Portfolio Lending and Mortgage Access Act.** The bill would gut the Truth-in-Lending Act,

creating safe harbors from lawsuits for depositing institutions that fail to comply with certain home loan requirements. Passed 255-174: November 18, 2015. A no vote is a +.

**18. House Vote 637 - Passage of H.R. 1737 - Reforming the Consumer Financial Protection Board Indirect Auto Financing Guidance Act.** The bill nullifies a CFPB bulletin on indirect auto lending and compliance with the Equal Credit Opportunity Act, imposes unprecedented restrictions on the CFPB's ability to root out discriminatory practices, undermining lenders' fair lending compliance programs. Passed 332-96: November 18, 2015. A no vote is a +.

**19. House Vote 643 - Passage of H.R. 4038 - American Security Against Foreign Enemies (SAFE) Act.** Requires additional Department of Homeland Security screening and FBI action to ensure each covered alien from Iraq and Syria receives an extra background investigation before being admitted as a refugee. Passed 289-137: November 18, 2015. A no vote is a +.

**20. House Vote 693 - Passage of H.R. 644 - Trade Facilitation and Trade Enforcement Act.** Provides trade benefits to importers, exporters and other private entities, establishes an Automated Commercial Environment Computer System, protection of Intellectual Property, and investigation of currency manipulations. Passed 256-158: December 11, 2015. A no vote is a +.



This voting record is offered only as a guide in judging the legislative performance of Members of Congress, and has several inherent limitations. It does not measure a legislator's work in committees. It does not reflect the failure of Congress to deal with major issues, or the individual's degree of responsibility. Nor does it reflect a legislator's lifetime of work.

The methodology of the ADA Voting Record calls for Members who miss a vote, for whatever reason, to be penalized in their final score. Therefore, a Member who agreed with ADA's position on 19 votes but was absent on the 20th would receive a score of 95%.

## SENATE VOTE DESCRIPTIONS

**1. Senate Vote 1 - Warren (D-MA) S. Amendment No. 1 in the form of a substitute for H.R. 26 - Terrorism Risk Insurance (TRIA) Program.** The amendment would restore the compromise Senate TRIA bill and eliminate an unrelated provision added by the House at the last minute before leaving town to roll back Dodd-Frank and override regulators' rules, exposing the financial system to risk. Defeated 31-66: January 8, 2015. A yes vote is a +.

**2. Senate Vote 63 - Cloture to proceed to vote on S. 531 - Immigration Rule of Law Act of 2015.** The bill would prohibit use of funds to carry out certain Executive actions on immigration (deferred deportations). Rejected 57-42 (60 votes needed): February 27, 2015. A no vote is a +.

**3. Senate Vote 67 - S.J. Res. 8.** Congressional disapproval of NLRB rule on representation case procedures. Passed 53-46: March 3, 2015. A no vote is a +. Vetoed by President Obama.

**4. Senate Vote 68 - To Override President's veto of S. 1 - Keystone XL Pipeline Approval Act.** Failed 62-37 (2/3 needed to override a veto): March 4, 2015. The President's veto was sustained. A no vote is a +.

**5. 78 - Sanders (I-VT) S. Amendment 323 to S. Con Res 11, the Fiscal Year 2016 Budget Resolution also setting levels for FY2017-FY2025.** Sanders amendment would create millions of middleclass jobs by investing in the nation's infrastructure, paid for by closing loopholes in the corporate and international tax systems. Rejected 45-52: March 24, 2015. A yes vote is a +.

**6. Senate Vote 84 - Wyden (D-OR) S. Amendment 471 to S. Con Res. 11, the 2016 Budget Resolution also setting FY2017-FY2025 levels.** Wyden amendment opposes cutting Social Security benefits, raising the retirement age, or privatizing Social Security. Failed 51-48 (60 votes required): March 24, 2015. A yes vote is a +.

**7. Senate Vote 86 - Warren (D-MA) S. Amendment 652 to S. Con Res. 11, 2016 Budget Resolution,** to make college more affordable for middle class families by allowing borrowers with outstanding loans to refinance at a rate equivalent to the Federal student loan borrowers' rate in 2013-2014, with the cost offset by requiring millionaires to pay at least 30% effective Federal tax rate. Rejected 46-53: March 25, 2015. A yes vote is a +.

**8. Senate Vote 90 - Bennett (D-CO) S. Amendment 601 to S. Con Res 11,** the Budget Resolution. Bennett amendment opposes privatizing Medicare, cutting the guaranteed benefits, increasing out-of-pocket spending and turning Medicare into premium support. Rejected 46-53: March 25, 2015. A yes vote is a +.

**9. Senate Vote 94 - Stabenow (D-MI) Amendment No. 523 to S. Con. Res. 11,** the Budget Resolution. The amendment would prevent tax benefits that move jobs overseas, end offshore tax loopholes, including inversions, provide incentives to move jobs back to the US. Rejected 46-54: March 26, 2015. A yes vote is a +.

**10. Senate Vote 107 - Whitehouse (D-RI) S. Amendment 867 to S. Con. Res. 11,** the 2016 Budget

Resolution. Whitehouse amendment would establish a deficit-neutral reserve fund to make it more difficult for corporations and billionaires to secretly influence elections by making unlimited undisclosed campaign expenditures and prevent them from making false statements to the Government. Rejected 47-52: March 26, 2015. A yes vote is a +.

**11. Senate Vote 121 - Schatz (D-HI) S. Amendment 1063 to S. Con Res. 11,** the 2016 Budget Resolution. The Schatz amendment would ensure that all legally married same-sex spouses have equal access to Social Security and veterans' benefits and receive equal treatment under the law. Passed 57-43: March 26, 2015. A yes vote is a +.

**12. Senate Vote 131 - Warren (D-MA) S. Amendment 1094 to S. Con Res. 11,** 2016 Budget Resolution also setting FY 2017-FY2025. Warren's amendment would provide a deficit-neutral reserve fund to expand Social Security. Rejected 42-56: March 27, 2015. A yes vote is a +.

**13. Senate Vote 133 - Cardin (D-MD) S. Amendment 367 to S. Con Res 11,** the 2016 Budget Resolution. Cardin amendment would provide a deficit-neutral reserve fund to aid voter re-enfranchisement after incarceration. Failed 47-51: March 27, 2015. A yes vote is a +.

**14. Senate Vote 188 - S.Amdt. 1327 to S.Amdt. 1221 to H.R. 1314 - Bipartisan Budget Act of 2015.** Warren Amendment on Investor-State Dispute Settlement to H.R. 1314, Trade Promotion Authority/ Fast Track Authority to prohibit the application of fast track authority for international trade agreements – like

the new Trans-Pacific Partnership (TPP) - that include “Investor-State Dispute Settlement” (ISDS) provisions. Failed 39-60: May 22, 2015. A yes vote is a +.

**15. Senate Vote 210 - Ernst (R-IA) S. Amendment 1549 to HR 1735, Defense Authorization Act of FY 2016.** Ernst Amendment would provide military aid to Kurdistan. Failed 54-45: June 16, 2015. A no vote is a +.

**16. Senate Vote 236 - Franken (D-MN) S. Amendment 2093 to S. 1177, Every Child Achieves Act.** Franken amendment would end discrimination based on actual or perceived sexual orientation or gender identity in public schools. Failed 52-45 (60 votes required): July 14, 2015. A yes vote is a +.

**17. Senate Vote 276 - Motion to waive all budgetary discipline and pass Conference Report on HR 1735,** authorizing appropriations for military activities of Defense and Energy Departments and prescribes personnel strength. Passed 71-26: October 7, 2015. A no vote is a +.

**18. Senate Vote 285 - Wyden (D-OR) S. Amendment 2621 to S. 754, Cyber Security Information Sharing Act.** Wyden amendment would require the removal of personal information from cyber threat indicators before private entities or DNI share cyber security information. Failed 41-55: October 27, 2015. A yes vote is a +.

**19. Senate Vote 295 - Cloture motion to proceed to action on S. 1140, Federal Water Quality Protection Act,** a bill that would

undercut EPAs authority to prevent water pollution. Failed 57-41 (60 votes required): November 3, 2015. A no vote is a +.

**20. Senate Vote 321 - Manchin (D-WV) S. Amendment 2908 to HR 3762, American Health Care Freedom Reconciliation Act of 2015,** a bill to undo the individual mandate and medical device tax of the Affordable Care Act. Manchin motion would waive budgetary discipline and ensure all individuals who should be prohibited from buying firearms are listed in the National Instant Criminal Background Check System and provide responsible consistent background checks. Failed 48-50: December 3, 2015. A yes vote is a +.
