Process of IT Service

1. Citizen who wishes to file the Income Tax Return will approach the CSC Centre.
2. CSC Centre shall provide the pre-printed Income Tax Service Application to Citizen for filling the same and apply for the Income Tax Service. (To download the Application, Click on "Download Application Form" link)
3. While filling the Application, Citizen/VLE can contact Tax Genius Customer Care directly in case of any Clarifications. (Tax Genius Helpline: 08099800800.)
4. Citizen submits the filled-in Application form at CSC Centre.
5. Processing at CSC Centre:
 - a) CSC scans the IT Service Application form and other documents if any into a single PDF file.
 - b) CSC clicks on "Income Tax Filing-Upload" link available in the landing page, fills in mandatory Customer information (Name, PAN, Date of Birth, etc.) and uploads the scanned PDF file.
 - c) Transaction will be completed and payment will be processed through CSC PG
 - d) On Receipt of Cash from Citizen, CSC Provides the Transaction Receipt to Citizen
6. Tax Genius process the Application within **10 working days** by directly interacting with the Citizen. In case of any process Rejections, Tax Genius informs the Citizen and MIS reports will be shared to CSC.
7. Application Processing Status will be intimated to Citizen through SMS and Email. Alternatively, Citizen can enquire the status of IT Application through Tax Genius Customer Care.
8. Once the Application is processed at Tax Genius, Acknowledgements will be sent across to Citizens Email ID and CSC centre. Upon Citizens request, CSC centre has a provision to download the acknowledgements from Transactional Reports




