# **INSTRUCTION FOR FILING A CASE WITH THE COURT**

**IMPORTANT** You are entitled to be represented by a student Public Defender. The Public Defender is not an attorney but a student who is familiar with the rules and procedures used in Student Government Association judicial process. The Public Defender's office is a FREE service provided by your University of Texas at El Paso Student Government Association. Please contact the Defender's office if you need assistance with this form or with your appeal.

#### PART I: PARTIES

Person filing case should be the person who actually submits the attached documents to the Court.

## PART II: NATURE OF CASE

Check the box that applies to your situation.

## PART III: ACTIONS REQUESTED

Unless you are requesting a hearing under emergency circumstances, check the box for "PRELIMINARY HEARING". If you are requesting a PRELIMINARY HEARING – EMERGENCY CIRCUMSTANCES", you must be able to show that a delay would cause some harm that could not be easily corrected later. An example of an emergency circumstance would be a case where some action is going to take place in the immediate future and action can not be easily changed once it has happened (an election, payment of a fine, expulsion from a class or school, etc.)

You may also request an "INJUNCTION" to prevent an action from taking place or to preserve the status quo until your case can be heard. Although an INJUCTION may be requested whether you are filing for a regular hearing or an emergency hearing the injunction must be justified in writing by stating what action is sought and what is necessary to prevent some harm or injustice.

If you check the "OTHER" option, simply explain in your own words, as briefly as possible, what action you believe the Court should take and why.

#### WHAT HAPPENS NEXT?

A Justice of the Supreme Court must sign your request before any other action can take place. As your option, you may either locate a Justice and have your request signed; have the SGA Administrative Secretary deliver your request to a Justice or have the Public Defender perform this procedure

Once signed, you will be notified of a hearing date and time and told whether any other actions you requested have been granted and/or any other actions you should take.
