Production history

These recordings were collected on 5 July 1980 and 9 July 1982 by anthropologist Jon Altman during fieldwork at Momega, Mianyari, Bulgai and Jim Jim settlements in the Northern Territory of Australia. The contents of the recordings are discussions about access rights to communities, incursions of mining companies, land rights, mining royalties, Land Councils, housing, infrastructure and employment. Participants in these discussions include Jimmy Nyumanyuma (?), Ngalumak (?), Anchor Galumba, Crusoe Kuningbal, Mick Alderson and unidentified speakers. The collection was deposited with AIATSIS on 11 May 2010.
