Production history

These recordings were collected by Dr Wayne Atkinson between 21 January and 12 February 1980 in northern Victoria and south-west New South Wales, Australia. They feature oral history interviews in English with Yorta Yorta men and women who once lived on Cummeragunja and Coranderrk stations. Speakers include Mick Davis, Bevan Nicholls, Colin Walker, Dan Atkinson, Rupert Cooper, Iris Atkinson, Priscilla McKray, Ivy Sampson and Kevin Atkinson.

The collection was deposited at AIATSIS on 28 February 1980.
