### Production history

These recordings were collected by Dr Wayne Atkinson between 5 March and 11 June 1980 in northern Victoria and south-west New South Wales, Australia. They feature oral history interviews in English with Yorta Yorta men and women who once lived on Cummeragunja station. Speakers include Clare Moulton, Rebecca Murray, Eddie Walker and Mally Cooper (Green).

The collection was deposited at AIATSIS on 22 May and 26 June 1980.
