### Production history

This collection comprises three cassettes capturing part of the proceedings of the Aboriginal Land Rights Teach-In, recorded on the 18 March 1979 at Sydney University, as well as an oral history interview with Joan Garvan recorded in 2010, in which she describes her involvement with the Aboriginal Land Rights Support Group (ALRSG) who coordinated the Teach-In. The ALRSG were a group of non-Indigenous people who offered support to Aboriginal and Torres Strait Islander people campaigning for land rights. The speakers at the Teach-in included Joe McGinness, Mick Miller, Lawrence Dugong, Marcia Langton, Pat O'Shane and Steve Albert, among others. The collection was deposited at AIATSIS on 12 January 2011.
