COLLECTION OVERVIEW

Scope and contents note

Jane C. Goodale, Professor of Anthropology at Bryn Mawr College, Pennsylvania, from 1961-2008, conducted cultural anthropological studies among the Tiwi people of North Australia, and the Kaulong people of West New Britain Province, Papua New Guinea from 1954 to 2002.

The Jane C. Goodale papers held by AIATSIS Library document Goodale's fieldwork among the Tiwi people of Melville and Bathurst Islands of northern Australia that commenced when she joined the 1954 Melville Island Expedition led by Charles P. Mountford. The papers cover Goodale's return visits to the Tiwi Islands in 1962, 1980-81, 1986-87, 1996-97, 1999 and 2002.

Well represented in the papers are primary ethnographic data collected in field notebooks, typescript transcriptions of these notes, diaries, and genealogies. Also a significant part of the collection are Goodale's published and unpublished manuscripts, articles and addresses based on data generated from her fieldwork on the Tiwi people, and correspondence received or sent while in Australia.

Provenance

The collection was donated to AIATSIS Library by Professor Jane C. Goodale in March 2008

Material separated from the collection

Goodale was an accomplished photographer and documented her field notes with visual images which were generally captioned and then organised in large folders.

Approximately 3900 colour transparencies that accompanied the field notes taken during her visits to Australia, more particularly Melville Island and Bathurst Islands, from 1954-2002 were transferred to the Institute's Audiovisual Archive in June, 2010. Also included in the transfer were a number of early black and white photographic prints and negatives and, a few audio cassette tapes. For a listing of the audio tapes see [Appendix 1](#).

BIOGRAPHICAL NOTE

Jane Carter Goodale, American anthropologist and photographer, was born in Boston, Massachusetts, on 18 May 1926. She was the second child of Susan Bainbridge Sturgis and Robert Lincoln Goodale. After graduating from Oldfields School in Maryland in 1944 Goodale went on to study anthropology at Radcliffe College receiving a B.A. in 1948, and an M.A. in 1951. She then moved to the University of Pennsylvania and was awarded her Ph.D. in 1959. She studied with and was influenced by Carlton Steven Coon, A. Irving Hallowell, and Ward Goodenough. From 1950 to 1961 she was a research assistant at the University of Pennsylvania Museum. In 1959 Goodale joined the faculty at Bryn Mawr College where she worked until her retirement in 1995 and continued to hold the position of Professor Emerita until her death on 5 November, 2008. She also briefly taught at Barnard College, Columbia University and the University of Pennsylvania in 1960, and at the Darwin Institute of Technology in 1986 to 1987. During her tenure at Bryn Mawr she served as Chair of the Anthropology Department twice from 1972 to 1977 and from 1988 to 1990.

Goodale undertook her first fieldwork at Melville Island in North Australia in 1954, where she stayed for ten months among the Tiwi people and conducted research for her dissertation (1959) and book *Tiwi wives* (1971). Goodale continued to visit Melville Island for fifty years.

Following her early work in Australia, Goodale undertook research in Papua New Guinea in 1962. Working in tandem with anthropologist, Ann Chowning, Goodale focused her research

on the Kaulong speaking people of West New Britain, while Chowning studied Senseng-speaking people. The correspondence they maintained between their two host villages is now published as the *Two-party line* (1966).

Goodale published extensively on social life, self-perception, identity, gender identity, and gender relations among the Tiwi people of North Australia and Kaulong people of New Britain Island. She is especially known for her three monographs *Tiwi wives: a study of the women at Melville Island of North Australia* (1971), *To sing with pigs is human: the concept of person in Papua New Guinea* (1995), and *The Two party-line: conversations in the field* (1996). In addition to books, she has also published chapters in books, articles, and given numerous conference presentations.

Goodale was a Fellow and held the position of Chair, Nomination Com Sec. American Anthropological Association (AAA); Council Member, American Ethnological Society (AES); Honorary Fellow, Executive Board Member, then Chairman of Board for three consecutive one year terms of the Association for Social Anthropology in Oceania (ASAO); Editor, Secretary, President of Philadelphia Anthropological Society (PAS); and Secretary/Treasurer of Association of Senior Anthropologist (ASA).

Her honours included Phi Beta Kappa; Sigma Xi; Honorary Fellow Association for Social Anthropology in Oceania (Elected 1987); and was nominated for President, American Anthropological Association 1976.

SERIES DESCRIPTION

Series 1 Melville Island Expedition field notes, 1954

On 14 February 1954 Goodale left New York for Australia to join the 'National Geographic Society's' Expedition which was to investigate the art, mythology, and ethnology of the Aborigines of Melville Island under the leadership of CP Mountford. The Expedition originally had three members, Mountford, W.E. (Bill) Harney and Jane C Goodale. They were later joined by three others. Goodale was there to study the daily life and role of the female half of the population. The expedition lasted for six months but Goodale obtained a grant from the University Museum, Philadelphia, that enabled her to spend an additional four months to

complete some of her work and make a collection of the perishable material culture (Ref. 'Melville Island' in *Bulletin of the Philadelphia Anthropological Society*, vol.8, no.3, May 1955, pp.2-4 in Series 12 Folder 1).

This series contains the field notes compiled by Goodale on her first independent fieldwork to Melville Island in Northern Australia in 1954. Included are four hard covered brown notebooks and some smaller notebooks with rough notes on 'Women's business', 'Myths - camp', a funeral, and genealogical notes. See also Series 7 Folders 1-3.

- 1-4 Melville Island 1954, vol.1-4. Four hard-covered brown notebooks with hand-written and typescript notes and some sketches. These notes have numbered pages arranged chronologically with descriptions of daily activities, observations of ritual customs, and kinship charts and details of conversations with informants.
- 5 'Social organization' 1954. Hard covered brown notebook with genealogical data of 38 Tiwi people.
- 6-10 Small field notebooks etc. Thirteen small notebooks with miscellaneous hand-written notes, including word lists and songs. Topics include 'Women's business' (Folder 5).
- 11-13 Myths - camp infor – men' (Folder 7), 'Margaret's baby's funeral' (Folder 8), 'Weights' (Folder 9) etc. Also two typescript pages on the Tiwi alphabet (Folder 6) and a book of cheque butts used by Goodale (Folder 13).
- 14 Tiwi language. Book 1. This undated notebook contains words and phrases in the Tiwi language with their English translation. The notebook possibly relates to Goodale's first visit in 1954, and includes tape numbers indicating that they were accompanied by tapes recorded by Goodale. These tapes were not found amongst the papers received by the Library in 2005.

Series 2 Melville Island field notes, June 1962

In 1962 Goodale returned to Australia, more particularly Melville Island, for the month of June where she 'revisited the Tiwi and collected more extensive genealogies and some additional kinship terminology' (Ref: Series 9, Folder 5-6) . This series includes a journal diary covering half the month and one field diary. The journal refers to Goodale's arrival in Australia, the difficulties she initially experienced in doing her fieldwork, and genealogies of the Tiwi peoples of Melville Island.

Series 3 New Britain field notes, 1963-64

This series includes three miscellaneous field notebooks and another with records of house payments etc. by Goodale possibly compiled during her 1963-1964 visit to the island of New Britain, Papua New Guinea. Found within the diary was letter to Goodale from her mother, Susan B. Goodale. This letter was replaced with a photocopy and the original transferred to Series 7 Folder 8.

Series 4 Melville and Bathurst Island field notes etc., 1980 – 1982

Goodale made another visit to Melville Island during 1980-1981. This series includes her field notes and related research papers from that fifteen month trip. Included are seventeen 'Spirax' shorthand field notebooks with notes relating to land rights submissions that followed the passing of the Aboriginal Land Rights (Northern Territory) Act 1976. Goodale appears to have been involved in documenting the claims of the Tiwi to land rights for the Tiwi Land Council. The notebooks have diary type entries describing her trip to Melville and Bathurst Islands and includes reports on customs, daily life, genealogies, conversations with informants - especially Happy, and vocabulary lists. Some of the notebooks have loose notes and related correspondence. There are smaller notebooks documenting preparations and expenses for the field trip; and a housing report of the residents of Snake Bay/Milikapiti done as a volunteer by Goodale for the Milikapiti Housing Association. Correspondence and notes relating to Goodale's involvement with the Tiwi Land Council's 'Application to close the sea' that dates from this period are located at Series 16 Folder 7-8.

The pages of notes have numbers written in red which are possibly related to cassette tapes recorded by Goodale during her visit. Notebook 17 includes a hand-written letter from

Goodale's mother, Susan B. Goodale, discussing the family life in the United States and plans for her daughter's return from field work.

- 18-19 Field trip notes 1980-1981. Four small notebooks listing expenses, travel etc. Also some loose notes.
- 20 Milikapiti Housing Association Survey, 1981. Hand-written and typescript copies of Goodale's report dated 31 July 1981, with related maps held in Manuscript Plan Cabinet. Also summary 'Census of population and housing' for Melville and Bathurst Islands and other Indigenous Australian populations of the Northern Territory, 1979. Summary placed in this folder by Library in 2010.
- 21 Sketch town plan, Milikapiti, 1980. Several versions, possibly for Milikapiti Housing Survey (see Folder 20). Two larger versions also in Manuscript Plan Cabinet. Also copies of a small map of the Tiwi islands depicting language groups, undated.
- 22 Photograph album. Entitled 'Melville Island – NT. Australia 1980-81 J.Goodale', the album includes a 'Drawing by Maxine' with note 'To our Grandmother Jane Goodale...!' and colour photographic prints with captions. Rehoused in archival folder album based on Goodale's original arrangement.

Series 5 Melville Island field notes, 1986 – 1987

From June 1986 to September 1987 Goodale held the position of Visiting Principal Lecturer at the Darwin Institute of Technology. This gave her the opportunity to visit periodically on Melville and Bathurst Islands, and the communities of Milikapiti, Pularumpi and Nguiu and surrounding areas. In a letter to Bryn Mawr College dated 30 October 1985 Goodale writes 'I am currently involved in a number of writing projects resulting from my 1980-81 visit. One of these is a revised 'up-to-date' chapter for the 1960 book by C.W.M. Hart and Arnold Pilling, *The Tiwi of North Australia*...a paper on Card Playing, and another on Development and Women on my data collected in 1980-81 and I plan to begin writing a book on continuity and Change in Tiwi Culture while I am in Darwin'.

This series includes field notes, and music recordings made by Goodale during her visit to Melville and Bathurst Islands in 1986 -1987.

- 4-7 'Ancol' shorthand notebooks. Four notebooks entitled 'Change questionnaire', 'TLC-86'; '6/87-2. Jan1→' and 'Fr. Falan's Census for Milikapiti, 1965?'. Also three copies of 'Tiwi attitudes to change – schedule of questions', undated, 7pp.

- 8 Kimberley Conference, 1986-1987. 'Spirax' shorthand notebook with notes on the conference and comments/conversations with people involved.
- 9 Field trip notes 1986-1987. Includes a 'Steno notebook' and a small 'Memo' notebook listing expenses, travel, draft letters, memoranda and related correspondence about her appointment at the Darwin Institute of Technology.
- 10 Tiwi history notes. Small blue covered memo notebook with lists of significant events in Tiwi history from the 1930s. Also gives names of persons holding various administrative positions in the community.
- 11-12 Research notes. Including 'Tiwi '80-81. Book 1 June 30-', original typescript (39pp); 'List of traditional owners for Mumupwi', compiled by Andree Grau, typescript copy (13pp); 'Punukupali'; 'Munupi'; word lists headed 'Language 80/1-3., and hand drawn maps depicting houses and roads in Milikapiti, 1987.
- 13 Recordings entitled 'Tiwi and other Aboriginal songs'. CD copied from original cassette tape with about 30 minutes of recordings and, accompanying typescript index. The Library has made another CD of the tape and this is held MS4676-1CD. The original cassette was transferred to the Audiovisual Archives in June, 2010.

Series 6 Melville and Bathurst Island field notes, 1995-2002

This series includes field notes compiled by Goodale on visits to Melville Island in 1995-1997, 1999 and 2002 and other destinations in Australia. On these visits Goodale was undertaking research and continuing to work with the Tiwi Land Council. En route she often travelled to Canberra and Darwin.

The spiral bound notebooks contain diary entries, descriptions of daily activities, observations of ritual customs, kinship charts and details of conversation with informants. Folder headings are based on those used by Goodale on each notebook. From the numbering it appears that there may be notebooks missing from the series.

Series 7 Correspondence, 1953-1999

This series includes the correspondence relating to Goodale's field trips to Australia that extended over a fifty year period from 1954. The early letters are between, C.P. Mountford (who headed the the 1954 Melville Island Expedition), Goodale, anthropologist, Carleton Coon, and editorial staff at National Geographic Magazine that sponsored the Expedition. Later correspondence include letters received by Goodale from Arthur Pilling concerning his proposal to update the book *The Tiwi of North Australia*, by C.W.M. Hart and Arthur Pilling (first published in 1960), letters from Indigenous Australian women on Melville Island, and a grant application with associated correspondence. While on her 1980-1981 visit to Australia Goodale wrote at least three times a month to her mother Susan B. Goodale, in the USA, documenting her daily activities, impressions of Australia and her work in general. These letters are located in a folder entitled 'Letters home'. Two original letters from Susan B. Goodale can also be found in this series.

Headings of folders are those used on the original folders and arrangement within the folders is chronological. When there a number of letters from a particular correspondent these are grouped together.

Series 15 Milikapiti files, circa. 1930-1999

From early European settlement in Australia, Bathurst and Melville Islands were considered Crown Land until 1902 and were administered by the government of South Australia until the Northern Territory was transferred to the Commonwealth Government. During this period areas were set aside as 'reserves' for Indigenous Australian peoples who were controlled through legislation such as the 'Aboriginal Ordinance 1918'.

From 1902 to 1940 Melville Island was leased to the Vestey Company. That lease was surrendered to the Commonwealth in 1941 and Melville Island was declared a 'reserve for Aboriginal native inhabitants' under the 'Crown Lands Ordinance of the Northern Territory'.

In 1910 permission was given to the Catholic Church to establish a mission on 10,000 acres of land and in the following year a Catholic mission was established which grew into the town of Nguiu. Under the *Northern Territories Aboriginal Act 1910* the rest of the island was proclaimed an Aboriginal 'reserve' in 1912.

In 1947 an elected Legislative Council was created responsible to the Commonwealth Minister for the Interior. In 1951 the administration of that Council and hence the administration of Melville and Bathurst Islands, became the responsibility of the Commonwealth Minister for Territories.

1961 saw the formation of a Tiwi Tribal Council. However there was no effective Tiwi body until the formation of community councils at Nguiu and Milikapiti in 1971.

Following the passing of the *Australian Land Rights Act (Northern Territory) 1976* the Tiwi were administered by the Northern Land Council in the Northern Territory. In June 1977 the Tiwi formed the Interim Tiwi Land Council which became the Tiwi Land Council in September 1978.

This series comprises lists and summaries, compiled by Goodale, of monthly and annual reports, correspondence, surveys, reports and official documents created by the local council at Milikapiti on Melville Island.

Series 16 Tiwi Land Council papers, 1978-1999

September 1978 saw the formation of the Tiwi Land Council (TLC). The Council meets monthly on a rotating basis in the three largest Tiwi communities.

The primary function of the TLC is 'to protect, to assist, and to consult with the Aboriginal owners of Tiwi Land with respect to the management of land and to their various interests in the land' (Ref. Tiwi Land Council, 14th Annual Report, 1992/93).

This series includes minutes of meetings of the TLC held during the time that Goodale was visiting the Tiwi islands and, papers relating to matters with which she had some involvement.
