#### **BIOGRAPHICAL/ADMINISTRATIVE NOTE**

Scarlett Pictures was formed in Sydney in 1998, primarily as a vehicle for Kath Shelper's productions. She was the recipient of the 2005 Inside Film Award for Rising Talent.

A majority of Kath Shelper's films were made with Indigenous filmmakers about Indigenous subjects/themes.

Her production credits include *Confessions of a Headhunter, Plains Empty, Bush Mechanics, Above the Dust Level*, and *Green Bush*. She was a founding member of the film production company Film Depot along with fellow producers Louise Smith and Matthew Dabner.

She completed her first feature film in 2009, *Samson & Delilah*, directed and filmed by Warwick Thornton, starring Rowan MacNamara and Marissa Gibson and featuring Mitjili Napanangka Gibson. The film premiered at the Adelaide Film Festival, February 2009, and won the Camera d'Or for best first feature at the Cannes Film Festival 2009.
