

13 Food Safety Industry Chain and Community Resilience Building







WHAT ARE THE MAIN ISSUES

- Food safety risk monitoring and evaluation started late in China and governmental monitoring alone can no longer meet the demand as market economy develops
- Standards overlapping or even contradiction is severe
- The food safety awareness of both producers and consumers is inadequate

POSSIBLE SOLUTIONS

- Establishment and implementation of a unified, highquality and comprehensive food safety standard system
- Improvement of food safety monitoring and risk evaluation mechanism
- Shortening or bridging the intermediate links in the circulation of agricultural products instead of monitoring scattered merchants
- Public awareness raising and basic food safety knowledge education: establishing education platform, company practice sharing, publicity of theme days, etc.

HOW CAN UNDP HELP

- Constructing the technology integration systems covering the standard, quality control, tracing and certification, and the testing and pilot demonstration of the system in selected Food Safety Parks in Jiangxi Province
- Establishing an education platform concerning public awareness with online and offline advertisement and training activities
- Developing a new model of "Internet +Modern Agriculture + Community" to raise community residents' awareness of food safety and to promote development of community resilience, leading to a win-win situation of consumers and farmers
- Capacity building activities regarding company experience sharing
- Promoting international cooperation on food safety by taking the opportunity of the Belt and Road and South-South Cooperation

- Improve nutrition, food safety and food security for China's most vulnerable women and children

主要问题

- 食品安全风险的监控和评估在中国开展较晚,同时政府单独监管不再能够满足快速发展的市场经济的需求;
- 食品标准的重叠甚至矛盾的现象十分严峻;
- 生产者和消费者对于食品安全的认识不充足

可行措施

- 建立并实施统一、高质量和综合的食品安全标准 体系
- 改善食品安全监管和风险评估机制
- 缩短或连接农产品流通的中间环节以取代逐个监管的分散的农产品商
- 提高及增强公共意识和食品安全知识的教育,如: 建立食品安全教育的平台,分享企业实践的经验 以及宣传主题日等等

UNDP如何帮助

- 构建覆盖到标准、质量监管、跟踪和认证的科技整合系统,同时在江西省选定的食品安全园区对该系统进行测试和试点展示应用
- 建立针对公共意识的教育平台,该平台包含了线上和线下的宣传和训练活动
- 开发全新的"因特网+现代农业+社区"的模式,用以提升社区居民对于食品安全的意识和推进社区适应力的发展、最终做到让消费者和农民双赢的局面
- 开展针对公司经验分享的能力建设活动
- 利用"一带一路"和南南合作的机会以促进关于食品安全问题的国际合作

UNDP的过往经验和成功案例

- 在黑龙江省开展强化乳制品安全的活动
- 针对中国最易受影响的女性和儿童,开展改善营养、食品安全和粮食安全的活动
