4. An update from the Chair including the year in review

J Johnson provided an overview of the previous year, noting the following:

- In this election year, the VTIC Board consciously chose to invest in research during 2013/14 that would provide the foundation for a solid election year campaign. Although the results of the campaign are yet to unfold or fall outside of the financial year reported on today, the investment in that campaign was made during 2013/14.
- J Johnson acknowledged the VTIC Board colleagues for contributing their time and lending their support to this organisation:

- J Johnson also noted that VTIC continues to foster its working relationship with VECCI.

5. Annual Operations Report – Dianne Smith

D Smith gave an update on VTIC's work during the past year which has seen a focus on the value proposition to members. VTIC undertakes two key activities: a united and strong voice on behalf of our industry to governments and stakeholders; and the delivery of high quality business services as part of the membership subscription.

D Smith presented on-screen a breakdown of the sectors represented within VTIC's membership:

- 40% Accommodation
- 9% Attractions
- 18% Destinations

- 7% Events
- 12% Services
- 14% Tour and Transport

D Smith also noted that VTIC's membership revenue increased by 33% in 2013/14.

2014 Pre-election campaign

D Smith reported that VTIC's pre-election campaign has five key platforms which are based on being most reasonable, achievable and jobs-focused.

VTIC's summary agenda has aimed to:

- improve the intrastate marketing of Victoria;
- support growth of medium sized, regional events;
- boost visitation from Asian markets;
- get small businesses online; and
- address capacity constraints in Melbourne, and grow Melbourne sustainably.

The message to both parties is simple: tourism equals jobs and is a serious economic driver.

This campaign was reinforced by a significant increase in media activity and also by community announcements on PRIME 7.

In addition to this research and the campaign we advocated on a range of issues, largely driven by VTIC's policy committees (names shown on screen). All voting members could nominate to be on these committees, and Premium members have an automatic seat.

Committees and Policy Outcomes

In addition to the Pre-election research and campaign, VTIC advocated on a range of issues, largely driven by the policy committees.

Developments of each sector are detailed below:

Accommodation:

- The re-instatement of the national Survey of Tourist Accommodation;
- o The level playing field and the sharing economy
- Assisted with the formation and ongoing network for the backpacker segment: Victorian Backpacker Advisory Group (VBAG).

Attractions:

 ensuring tourism is supported in both state and federal budgets; specifically, the State Government's \$45 million arts funding commitment, which included \$3m for 2014-15 to support renewal of permanent exhibition spaces and new children's exhibition at the Melbourne Museum;

- \$5m for 2014-15 for asset replacement works at the Melbourne Exhibition Centre.
- VTIC also helped drive the growing of Victoria's Chinese New Year celebrations.

Events:

- Supported the extension of the contract for the Australian Formula One Grand Prix;
- the uncapping of airline seats from China during the Chinese New Year period, which assisted selected major events such as the Australian Open;

• Destinations:

- o Protecting the National Parks Investment bill,
- o Public transport challenges, and how myki ticketing works for visitors.
- VTIC was pleased with a Free CBD Tram Travel Zone being introduced in Jan 2015 yet has requested the boundaries be expanded.

• Tour and Transport:

- Three key issues included Accreditation, licensing and industry development
- Some effective liaison with Transport Safety Victoria was undertaken in regards to enforcement and other changes to bus accreditation;
- Red tape reforms including the enabling of Segway tours on pubic paths.
- Supported the growth of flights, and access to and from Victoria's airports.

Tourism Services and Hospitality:

 Advanced the need to improve the profiling of the value of the industry, and issues of visa reforms and the Tourist Refund Scheme.

VTIC also made submissions to both the State Government Inquiry into Heritage and Ecotourism, Commission of Audit process, and to the Red Tape Commissioner.

VTIC Events:

VTIC ran 20 events in the 2013-14 FY, including:

- the Tourism and Events Excellence Conference;
- the annual Visitor Information Centre Summit;
- Victoria Tourism Week featuring the Leadership Dinner;
- the Student Summit;
- Industry Christmas Party;
- Ideas Forum;
- ACCC Forum;
- Premium member lunches with The Right Hon. Lord Mayor Robert Doyle and Shadow Minister for Tourism John Eren MP.

Membership of the National Tourism Alliance:

In 2013-14, VTIC continued our membership of the National Tourism Alliance, which provides an avenue to advocate on issues at a national level, particularly relevant in what was a federal election year. These issues included the freezing the Passenger Movement Charge and the administration of federal programs such as the TQUAL accreditation scheme and the Export Market Development Grant program.

Awards:

In 2013-14, VTIC awarded the Lynette Bergin Tourism Fellowship to Natalie Duke; and the Small Business Award to Rachel Donovan.

General Service Agreement with Tourism Victoria:

Included in General Service Agreement with Tourism Victoria for 2013/14 was the delivery of the preparatory workshops, mentoring and peer reviews programs for the Victorian Tourism Awards; administration and facilitation of the Victorian Visitor Information Centre Reference Group and the Visitor Information Centre Summit.

Additional programs:

In 2013-14, VTIC also managed Business Events Victoria, and provides administrative support for Cultural Tourism Victoria and the Young Tourism Network.

D Smith acknowledged the work of Brendan Maher, Kathryn McKenzie and Jess Derham as Chairs of Business Events Victoria, Cultural Tourism Victoria and the Young Tourism Network respectively.

<u>Federal Government's T-QUAL Tourism Quality Projects Funding Program</u>

VTIC was successful in the Federal Government's T-QUAL Tourism Quality Projects
Funding Program. Development of the project, titled "Online Tools for Better Visitor
Servicing" commenced during 2013/14.

VTIC also released results of the 2013 Local Government Health Check.

Staff changes:

D Smith noted the several staff changes throughout 2013-14 acknowledged the many contributions of those whom have moved on, in particular Monica Lougoon and Melinda Anderson.

Industry and Corporate Partners:

D Smith acknowledged our industry and corporate partners: Tourism Victoria, the Regional Tourism Boards, local governments, the National Tourism Alliance, Accommodation Association of Australia, City of Melbourne, Public Transport Victoria, Parks Victoria, Destination Melbourne, KPMG, OAMPS, Melbourne Airport, and Prime7.

7. Special Resolution – Amendment of the Constitution

The following amendments were made to the VTIC Constitution:

- To remove the election process for positions on a Policy Committee and replace it with a process whereby a Voting Member nominates to be part of a Policy Committee relevant to their sector.
- 2. To stipulate in Clause 34.8 that an appointment of a Policy Committee member will be for two years and will expire at the end of that period. All Policy Committee Members must remain a financial Voting Member of the Company for the duration of their term.
- 3. To amend Clause 32.2 such that Policy Committees must meet at least three (3) times per year. Previously this was four (4) times per year.
