

The Frederator Plush Toy Random Chance Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Sweepstakes may only be entered in or from the 50 United States and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the Sweepstakes if you are not located within the United States.

1. How to Enter. To enter the “Frederator Plush Toy Random Chance Sweepstakes” (“Sweepstakes”), you must download the Channel Frederator App at the following stores:

Then register by entering your name and email address. All entrants who meet the eligibility requirements below will be automatically entered into the random drawing (“Random Drawing”).

All entrants must have a valid email address. No automated entry devices and/or programs permitted. Receipt of entries will not be acknowledged or returned. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Only fully completed entry forms are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.

2. Start/End Dates. Sweepstakes begins at 12:00:01 am Eastern Time (“ET”) on September 3, 2015 and ends at 11:59:59 pm on October 3, 2015 (“Sweepstakes Period”).

3. Eligibility. Participation open only to legal residents of the fifty United States or the District of Columbia, who (i) are 18 years or older as of date of entry and (ii) registrants of the App. Void outside of the 50 United States and the District of Columbia, and where prohibited, taxed or restricted by law.
