
The pilot and disabled people

The pilot only includes 0.01% of people on social assistance and the extra \$500 paid to disabled people comes at a cost - the loss of vital supports (see table below). The pilot works to shift the cost of medical care and assistive devices onto the individual, leaving them worse off. 
