Membership fees

The monthly membership fee is 1% of your net monthly income. The minimum is 7 Euros per month. In case of financial difficulties, this amount can be lowered or waived. Every member is free to pay a higher fee.

Membership fees can be paid via bank standing order, direct debit or in cash. In each case, all payments must be confirmed by our treasurer in your membership card.

(Called Dauerauftrag in German. For us, this is the easiest. You can do this via online banking by setting up a transaction that will automatically transfer your membership fee every month to the above account. Alternatively, you can do this directly in your bank.)

Monthly direct debit: By signing this mandate form, I authorise Allgemeines Syndikat Berlin (creditor ID: DE8022200000993555) to send instructions to debit my account and my bank to debit my account in accordance with the instructions from Allgemeines Syndikat. As part of my rights, I am entitled to a refund from my bank under the terms and conditions of my agreement with my bank. A refund must be claimed within 8 weeks starting from the date on which your account was debited.
