About this report

This report provides annual data about the student visa and Temporary Graduate visa programme administered by the Department of Immigration and Border Protection (the department). The report has been provided to assist education providers, representative bodies and policymakers.

It is expected that this report will be further developed over time to increase and improve information sharing about the student visa and Temporary Graduate visa programme.

It is important to note that the information used in this report comes from a new data source. Consequently, figures for previous financial years have been revised and may differ slightly from those previously published by the department.

Data is sourced from several departmental visa processing and recording systems. Data can be dynamic and there can be delays in transmission of information from the department's global operations. Variations in figures between this report and previous issues can occur. The current financial year should always be considered provisional.

For privacy reasons < 5 has been used where a number in a table is between 1 and 4. In addition, the number of countries reported on has been increased to 50 for lodgements, grants and grant rates.

Definition of terms

Applicant type:	<p>Under the Migration Regulations 1994 (the Regulations), there are two types of applicants. These are primary applicants and secondary applicants. These terms are defined below.</p> <p>If the table or graph heading includes the word 'primary', such as 'primary applications' or 'primary visa holders', dependants (secondary applicants) are not included.</p>
Citizenship country:	<p>The country of citizenship of the visa applicant or visa holder. Where a visa applicant or visa holder has more than one citizenship country, either the citizenship of the travel document or the citizenship nominated by the visa applicant is used.</p>
Destination:	<p>Where a visa holder has moved from one type of visa to another. This most commonly occurs where a temporary visa holder applies for a permanent visa. However, many temporary visa holders go on to apply for a further temporary visa. The original visa is determined by the last visa held prior to the destination visa being granted. Destination visas include visas granted onshore and offshore.</p>
Granted:	<p>Unless otherwise specified, the number of visas granted includes primary and review grants.</p>
Last visa held:	<p>This refers to the last substantive visa held by a visa holder (that is, the last visa other than a bridging visa) prior to a point in time. The last visa held may have expired or still be in effect.</p>
Lodged:	<p>Lodged is the count of paper applications received in a departmental office or submitted electronically.</p>
Offshore:	<p>In this report, refers to the location of the client at the time the application was lodged. Generally, student visa applicants subject to Assessment Levels 2-3 are required to lodge their first student visa application while outside Australia.</p>
Onshore:	<p>In this report, refers to the location of the client at the time the application was lodged. An onshore applicant may already hold a visa of the same kind or may be applying for another type of visa. Student visa applicants subject to Assessment Level 1 can lodge their first student visa application while in Australia.</p>
Primary applicant:	<p>The primary applicant is the person who must satisfy the primary criteria for the grant of a visa under the Regulations. In this case, it would be the person proposing to study in Australia.</p>
Primary application:	<p>An application lodged by a primary applicant.</p>
Primary grant:	<p>An outcome where a decision maker (which may include system generated decision making) makes an assessment based on the initial visa application which results in a visa being granted to an applicant.</p>
Primary visa holder:	<p>A person who has had a primary application for a visa granted.</p>
Secondary applicant:	<p>Secondary applicants must satisfy the secondary criteria for the grant of a visa under the Regulations. In this case, a secondary applicant is generally a dependant of the primary applicant.</p>
Secondary application:	<p>A visa application lodged by a secondary applicant.</p>
Secondary visa holder:	<p>A person who has had a secondary application for a visa granted.</p>
Snapshot date:	<p>The snapshot date is a point in time at which a count is undertaken. In this report, the number of visa holders in Australia at a point in time is used.</p>
Visa applicant:	<p>Used to refer to clients applying for a visa. Unless otherwise specified, the term covers both primary and secondary applicants.</p>
Visa holders in Australia:	<p>The number of visa holders lawfully in Australia. This is not a count of all valid visas, as a number of visa holders may be outside Australia on the snapshot date.</p>

Background to the student visa programme

International students must have a valid visa for the duration of their studies in Australia. Most international students will need a student visa. However, visitor visas permit up to three months study and working holiday maker visas permit up to four months study. Further information about these visa options are available at:

There are eight types of student visa:

1. English Language Intensive Course for Overseas Students sector (ELICOS) (subclass 570) visa. This visa is for international students undertaking a stand-alone English language course that leads to a certificate level award or non-formal award.
2. Schools sector (subclass 571) visa. This visa is designed for international students applying to study in Australia in a primary, junior secondary or senior secondary school course or an approved secondary school exchange program.
3. Vocational Education and Training sector (subclass 572) visa. This visa is designed for international students applying to study in Australia and whose main course of study is a certificate, vocational education and training diploma, vocational education and training advanced diploma, vocational graduate certificate or vocational graduate diploma.
4. Higher Education sector (subclass 573) visa. This visa is designed for international students applying to study in Australia and whose main course of study is a bachelor degree, associate degree, higher education diploma, higher education advanced diploma, graduate certificate, graduate diploma or Masters by coursework.
5. Postgraduate Research sector (subclass 574) visa. This visa is designed for international students who want to study a Master's degree by research or a Doctoral degree in Australia.
6. Non Award sector (subclass 575) visa. This visa is designed for international students who want to study non award foundation studies or other full time courses not leading to an Australian award.
7. AusAID or Defence sector (subclass 576) visa. This visa is designed for international students who are sponsored by AusAID or Defence to study a full-time course of any type in Australia.
8. Student Guardian (subclass 580) visa. This visa is designed for a parent or close relative to accompany an underage student to Australia.

To be eligible for a student visa, applicants must be accepted for full time study in a course listed on the Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS). Applicants must also meet financial, health insurance, English language proficiency and health and character requirements

There is no limit on the number of student visas issued each year. If applicants meet requirements, they will be granted a student visa. Student visas are issued for the entire period of study in Australia, as evidenced by the Confirmation of Enrolment (CoE) documentation provided by the applicant's education provider. Visas are issued in alignment with the period for which the applicant has Overseas Student Health Cover (OSHC).

Family members

Students can apply to have partners and dependant children under the age of eighteen accompany them to Australia. These family members are known as secondary visa holders and are counted in student visa numbers. A parent or guardian seeking to accompany an international student to Australia may be eligible for a Student Guardian (subclass 580) visa.

Course Packaging

Many international students choose to package their principal course with a foundation or ELICOS course. These students are granted a subclass of visa that relates to their principal course. Consequently, the visa grant data does not necessarily reflect the numbers of international students enrolled in these courses. Background to the student visa programme - continued

Ability to work

Student visas include a visa condition that, once the course has commenced, allows most students to work for up to 40 hours per fortnight while their course is in session and for unlimited hours during course breaks. The limitation imposed by this visa condition reflects the purpose of a student visa; that it is to allow entry to Australia in order to study, not to work. Secondary visa holders are subject to a visa condition that limits them to 40 hours work per fortnight at any time.

Higher degree by research students on a subclass 574 (Postgraduate Research Sector) student visa may work unlimited hours once their Masters or PhD course has commenced. Dependents of students studying a Masters or PhD research course have no limitation on their work hours.

Assessment Levels

There are three Assessment Levels in the student visa program. They serve to align student visa evidentiary requirements to the immigration risk posed by applicants from a particular country applying for a particular student visa. Assessment Level 1 represents the lowest immigration risk and Assessment Level 3 the highest. The higher the Assessment Level, the greater the evidence an applicant is required to demonstrate to support their claims for the grant of a student visa.

Streamlined visa processing

The department assesses student visa applicants who lodge their applications on or after 24 March 2012, with a Confirmation of Enrolment (CoE) from a participating higher education provider in Australia at Bachelor, Masters or Doctoral degree level as though they were a lower migration risk (similar to the current Assessment Level 1), regardless of their country of origin. This is in response to recommendations 3, 5, 6, and 18 of the Hon Michael Knight AO's report, Strategic Review of the Student Visa Program 2011 (the Knight Review).

Financial requirements

Students and their families need to be aware of the costs involved in studying and living in Australia. In order to meet the financial requirements for the grant of a student visa, applicants must be able to demonstrate that they have access to sufficient funds to cover tuition fees, travel costs, educational costs for any accompanying school age children and living costs for the full study period.

Genuine Temporary Entrant (GTE) requirement

The GTE requirement was introduced on 5 November 2011 to enhance the integrity of the student visa program.

The GTE requirement explicitly addresses whether the individual circumstances of an applicant indicate that their intention is for a temporary stay in Australia.

Factors that the department may consider as part of the GTE requirement are set out in a Ministerial Direction available at www.immi.gov.au/gateways/agents/pdf/direction-53-assessing-gte.pdf and include:

- circumstances in the applicant's home country;
- the applicant's potential circumstances in Australia;
- the applicant's immigration history;
- the value of the course to the applicant's future; and/or
- any other matter relevant to the applicant's intention to stay temporarily.

Overseas Student Health Cover (OSHC)

Overseas students must have health insurance for the duration of their stay in Australia. Overseas Student Health Cover (OSHC) is insurance to assist international students meet the costs of medical and hospital care that they may need while in Australia.

Background to the student visa programme - continued

Visa refusals

A decision to refuse a student visa application is made when the delegate of the Minister is not satisfied that the applicant meets the legal criteria for grant of a visa. When refusing a visa application, the department provides an applicant, or their agent, with a written decision record that sets out the reason for the decision.

Reasons for refusal of student visa applications may include:

- failure to meet financial requirements;
- failure to meet English language requirements;
- fraudulent documentation present in the application;
- failure to satisfy the department that the applicant is a genuine student; and/or
- failure to meet GTE requirements.

Processing Standards

The department gives priority to offshore applications to ensure that prospective students receive their visas in time to travel to Australia to commence their courses. Onshore students are granted bridging visas pending finalisation of their new student visa applications and can still commence their courses.

Depending on the relevant assessment level the service standards are that 75% of offshore applications are finalised within 14 to 90 days and 75% of onshore applications are finalised within 14 to 30 days. It should be noted that approximately 80% of onshore applications are incomplete when lodged and this adds to processing times as officer's request and then wait for applicants to provide required information.

Visa refusals

A decision to refuse a student visa application is made when the delegate of the Minister is not satisfied that the applicant meets the legal criteria for grant of a visa. When refusing a visa application, the department provides an applicant, or their agent, with a written decision record that sets out the reason for the decision.

Background to the Temporary Graduate visa programme

The Skilled Graduate (Subclass 485) visa was renamed the Temporary Graduate (Subclass 485) visa on 23 March 2013, and has become a key component of the Temporary Visa Programme. Previously, the Subclass 485 visa was a component of the Skilled Migration Programme.

The Temporary Graduate visa has two streams, the Graduate Work stream and the Post-Study Work stream :

- Graduate Work stream - for international students who have recently graduated with the skills and qualifications that relate to an occupation on the Skilled Occupations List. Applicants in this stream must have completed a trade qualification, diploma or degree. Successful applicants are granted a visa of 18 months validity.
- Post-Study Work stream - for international students who have recently graduated with an Australian Bachelor degree, Masters degree or Doctorate from an Australian educational institution. This stream is only available to international students who applied for, and were granted, their first student visa on or after 5 November 2011. Successful applicants are granted a visa of two, three or four years duration, depending on the highest educational qualification they have obtained.

This visa provides eligible graduates with the opportunity to gain practical work experience in Australia following their studies. More information on the Temporary Graduate visa can be found on the department's website at:

Eligible visas

To be eligible for the Temporary Graduate visa, graduates must have completed their studies in Australia while on a qualifying student visa which includes subclasses 572, 573 or 574.

Australian study requirement

The Australian study requirement is defined as study in Australia in a course registered on the Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS) for a period of at least two academic years (92 weeks). The course should be conducted in English and should be completed in no less than 16 calendar months. All Temporary Graduate visa applicants must meet the Australian study requirement in the six months immediately prior to lodging their visa application.

Family members

Family members must meet legislative requirements and must provide evidence of their relationship to the Temporary Graduate visa applicant. Additionally, family members can apply to join the Temporary Graduate visa holder in Australia after the Temporary Graduate visa has been granted.

Ability to work and study

There are no restrictions on the type of work a Temporary Graduate visa holder can do. Temporary Graduate visa holders may work or study in any field, regardless of their study and qualifications. Dependents and secondary applicants are able to work and study on the Temporary Graduate visa.

Processing time service standards

The processing time service standard for the Temporary Graduate visa is 75% of applications should be finalised within 12 months, however, actual processing times may vary depending on a range of factors. Recent key initiatives in the financial year 2013-14

July 2013

On 1 July 2013, the processing of Temporary Graduate (subclass 485) visa transferred from the Skilled Migration programme to Temporary Visas. Information on the processing changes can be found at:

October 2013

On 31 October 2013, AusAID ceased to exist as an executive agency and DFAT has assumed responsibility for international aid and development. From 14 December 2013 the Migration Regulations 1994 (the Regulations) were amended to include a 'deeming' provision so that all references to AusAID would be taken to mean DFAT (or equivalent term). A full substitution of all references to AusAID with 'Foreign Affairs' (or equivalent term), took place on 1 July 2014.

March 2014

From 22 March 2014, Schedule 2 of the Regulations was amended to repeal the visa criterion relating to 'substantial compliance'. This criterion was removed to provide decision makers with the discretion to take into account exceptional circumstances that may have led to a student visa holder unintentionally breaching a condition of their Student visa.

On 22 March 2014 the government simplified the Assessment Level (AL) Framework by removing AL4 and AL5. As a result the AL Framework now comprises three assessment levels (AL1 to AL3) with former AL4 countries/sectors reduced to AL3. The financial requirement for AL3 student visa applicants was also reduced from 18 months to 12 months. However, as a result of this change, funds for AL3 applicants are required to be provided by the visa applicant or their close relative.

Also on 22 March 2014, streamlined visa processing arrangements, similar to those currently in place for universities, were introduced for prospective students of low immigration risk education providers who offer bachelor, masters or doctoral degree level courses.

Executive Summary

Key Points

- Student visa lodgements have now been increasing since 2010-11. In 2013-14, lodgements increased by 9.2 per cent compared with the previous year. In the same period, offshore lodgements increased by 22.2 per cent while onshore there was a decrease of 7.6 per cent.
- Total grants increased by 12.6 per cent, driven by significant growth in offshore grants of 26.3 per cent in 2013-14 compared with the previous year. This growth was mainly a result of Higher Education visa grants.
- There were 339 454 student visa holders in Australia as at 30 June 2014. Of these visa holders, 59.8 per cent held a Higher Education visa and 20.8 per cent held a VET visa.
- In 2013-14, 122 334 visas were granted to former student visa holders. Of these, 25.4 per cent were granted a tourist visa and 22.3 per cent were granted a further student visa.

1 Applications lodged

This is the third consecutive year of growth in student visa lodgements. Overall student visa lodgements increased by 9.2 per cent in 2013-14 compared with the previous year. There were 317 570 applications lodged this year, compared with 290 761 last year.

In 2013-14, offshore lodgements increased by 22.2 per cent (to 200 189) compared with the previous year. In the same period, onshore lodgements decreased by 7.6 per cent to 117 381.

Lodgements for Higher Education and VET visas represented 73.8 per cent of total student visa lodgements in 2013-14.

There was growth in offshore lodgements for all subclasses in 2013-14, the most significant being the Higher Education visa which increased by 33.7 per cent (to 112 110). However, all subclasses experienced a decline in onshore lodgements, the most significant of which were the VET and Higher Education visas which fell by 6.8 and 7 per cent respectively.

In 2013-14, China and India remained the top source countries for student visa lodgements with 63 661 and 39 374 lodgements respectively. Student visa lodgements from 10 of the top 15 source countries have increased. This is especially evident for offshore applications from Chinese and Indian nationals (26.3 and 98.9 per cent increase compared with 2012-13).

2 Visas granted

There were 292 060 student visas granted in 2013-14, an increase of 12.6 per cent from the previous year. Of the total student visas granted, 179 147 were to offshore applicants and 112 913 to onshore applicants. Similar to the number of applications lodged, the number of visas granted increased for the third consecutive year.

The most common visas granted in 2013-14 were Higher Education visas at 152 344 grants, followed by VET visas at 60 648 grants. Compared with 2012-13, Higher Education visa grants increased by 19.7 per cent and VET visa grants increased by 3.6 per cent.

Compared with last year, in 2013-14 offshore grants increased by 26.3 per cent (to 197 147) and onshore grants decreased by 3.9 per cent. The growth in offshore grants was driven by increased grants for Higher Education visas (38.3 per cent).

In 2013-14, China continued to be the top source country for international students with 60 315 student visa grants, followed by India whose nationals were granted 34 130 student visas. Together they represented 32.3 per cent of total student visa grants in 2013-14.

Offshore grants increased by 26.3 per cent in 2013-14 compared to the previous year. There was growth in all of the top five source countries for offshore grants - China increased by 26.8 per cent, India by 128.6 per cent, Vietnam 24.5 per cent, Brazil 31.2 per cent and Thailand 45.6 per cent.

Onshore grants decreased by 3.9 per cent in 2013-14 compared to the previous year. This decrease was driven by 4.5 per cent fewer grants for Higher Education (55 218 in 2012-13 compared with 52 732 in 2013-14) and 1.9 per cent fewer grants for VET visas (44 925 in 2012-13 compared with 44 082 in 2013-14).

3. Visa grant rates

In 2013-14, 93.1 per cent of student visa applicants were granted a visa. The grant rate was unchanged from the previous year.

Offshore grant rates in 2013-14 increased to 91.6 per cent from 91.1 per cent in the previous year. Onshore grant rates dropped in 2013-14 to 95.6 per cent from 95.7 per cent in 2012-13.

Offshore grant rates increased for both Higher Education visas (91.3 to 91.8 per cent) and VET visas (75.9 to 77.3 per cent) in 2013-14 when compared to the previous year.

The offshore grant rate for Chinese nationals in 2013-14 was 95.1 per cent compared with 94.1 per cent in 2012-13. The grant rate for offshore Indian nationals increased this year to 89.6 per cent from 81.7 per cent in the previous year.

4. Visa holders in Australia

The number of student visa holders in Australia increased by 11.6 per cent from 30 June 2014 (339 454 students) compared with 30 June 2013 (304 251 students).

On 30 June 2014, 59.8 per cent (203 049) of student visa holders in Australia held a Higher Education visa and 20.8 per cent (70 497) held a VET visa.

Chinese nationals represented the largest cohort of student visa holders in Australia on 30 June 2014 at 22.4 per cent (76 117) followed by Indian (12 per cent, 40 580) and Vietnamese (5.9 per cent 20 028) nationals.

5. Destinations

In the 2013-14 programme year, there were 122 334 visas granted to former student visa holders. This is a decrease of 12.3 per cent from the same period in the previous year (139 484 visas).

Of these former student visa holders, 25.4 per cent moved onto a Tourist visa with 31 022 visas granted. A further 27 252 (22.3 per cent) were granted another student visa and 20 870 (17.1 per cent) granted a Subclass 485 visa.

6. Subclass 485 visa

There were 18 463 Subclass 485 visas lodged in the 2013-14 programme year. This is a decrease of 25.2 per cent when compared with the previous year (24 687).

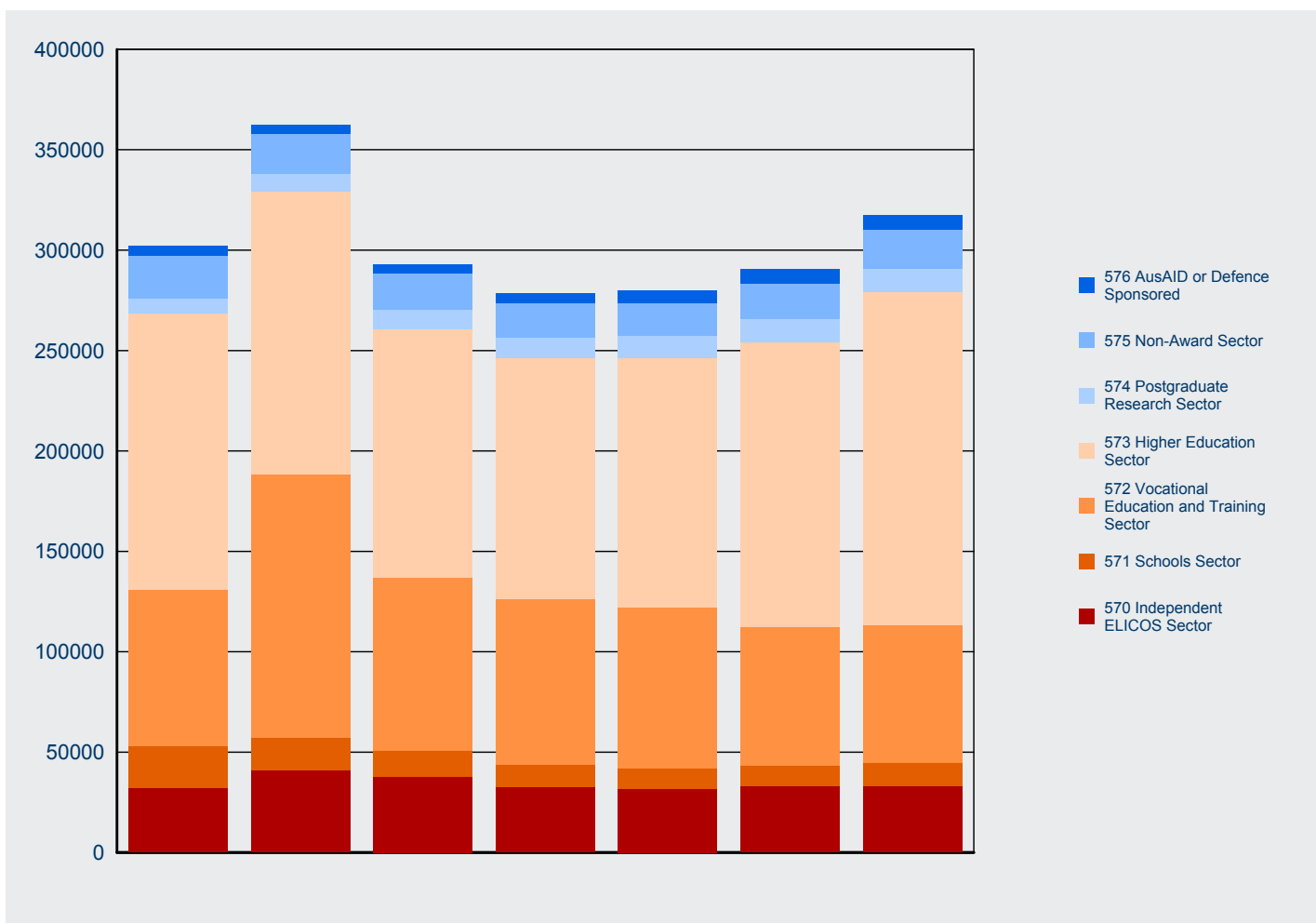
Grants also decreased by 35.6 per cent to 22 867 (from 35 495) in the same reporting period. The decrease in grants can be attributed to the lower lodgement rate.

On 30 June 2014 there were 25 198 Subclass 485 visa holders in Australia which was lower than 30 June 2013 when there were 36 224 visa holders.

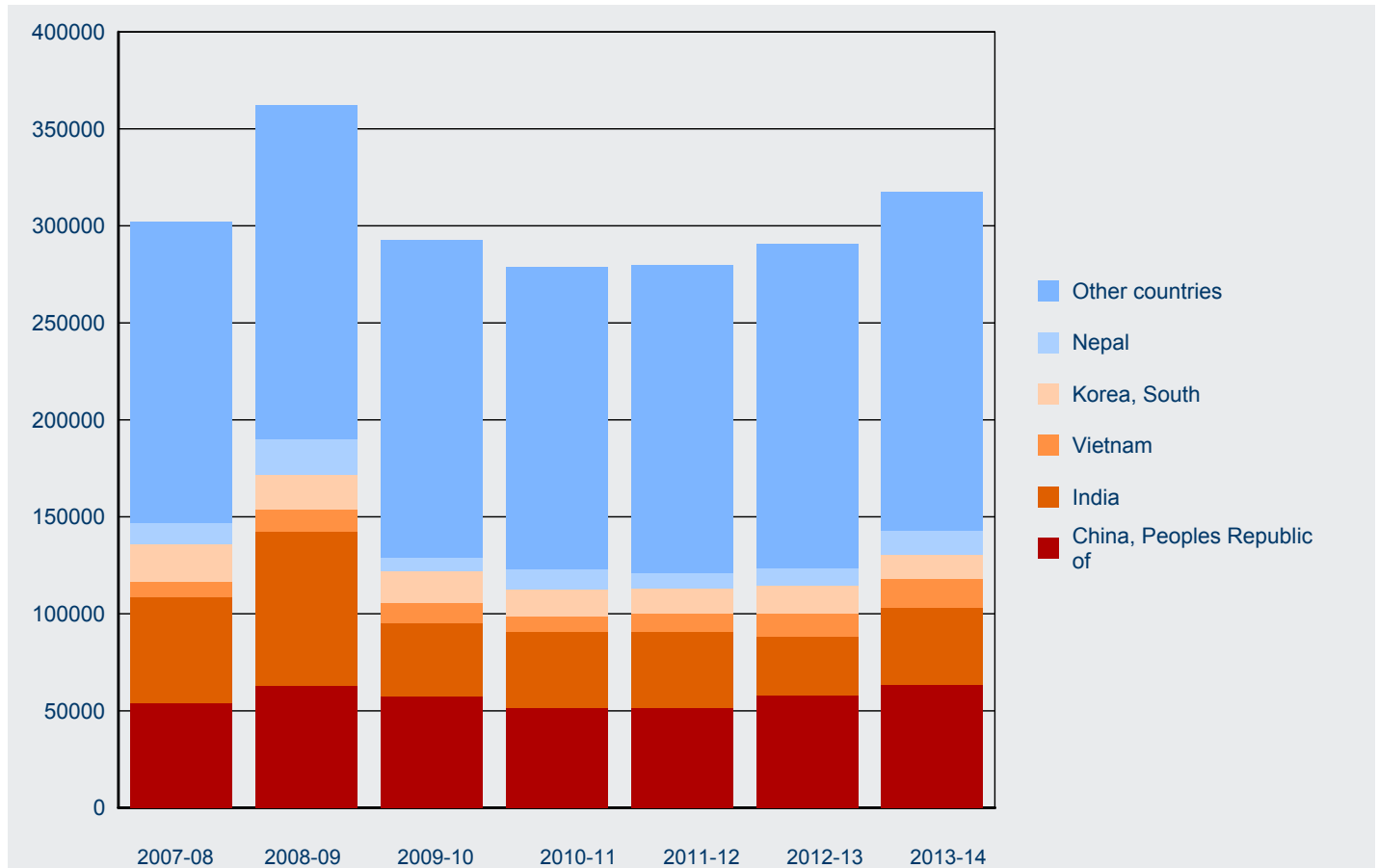

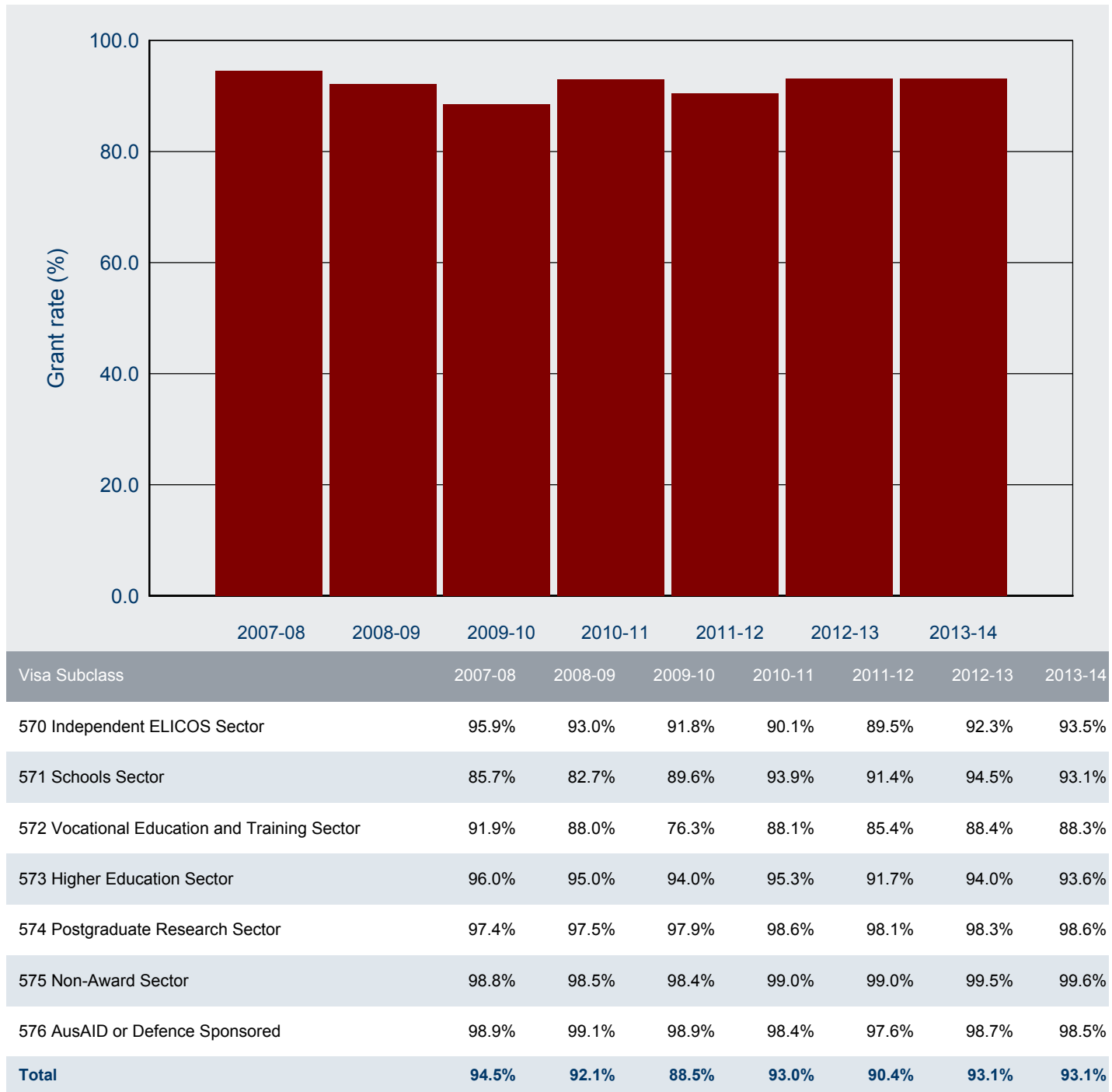

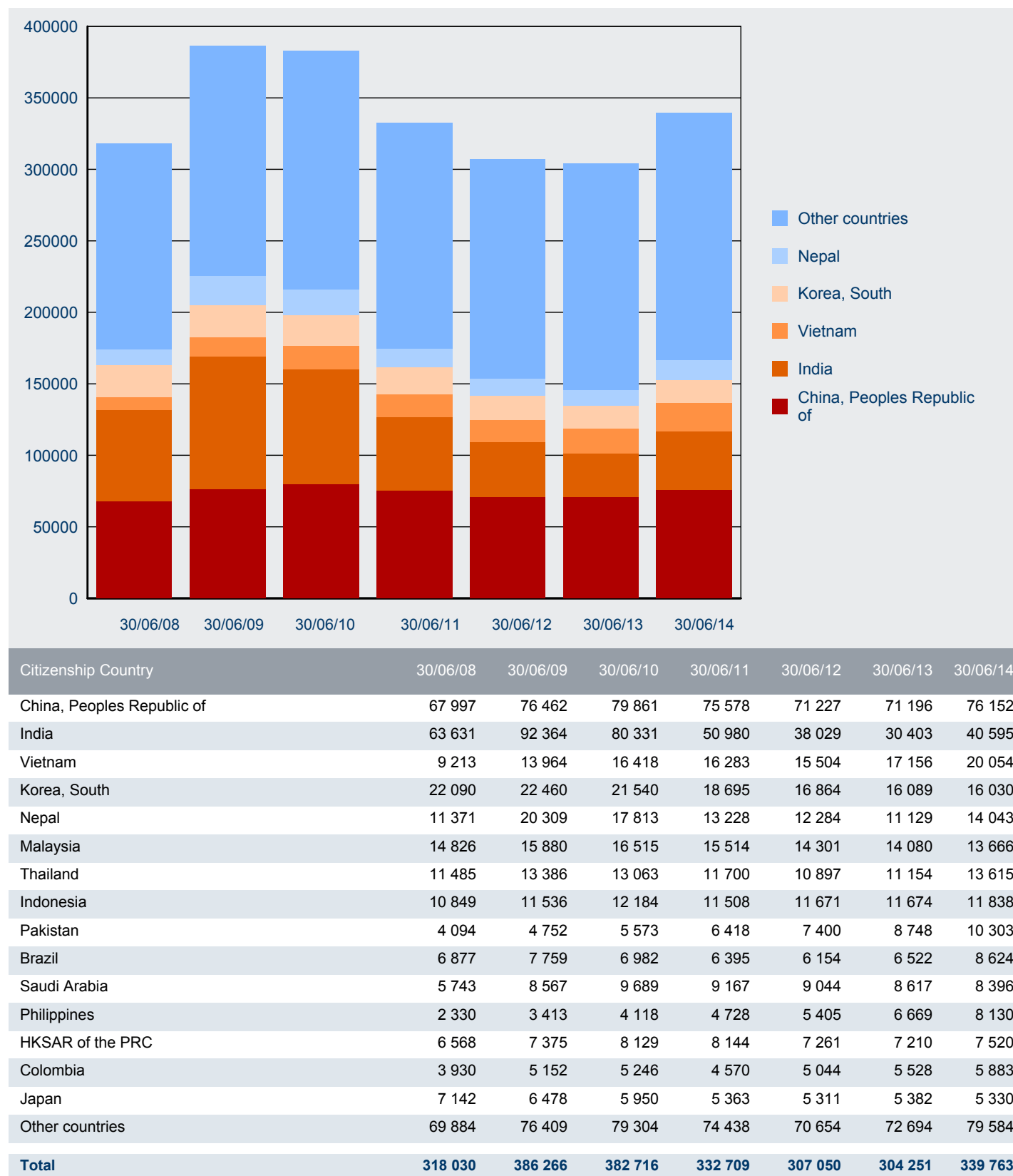

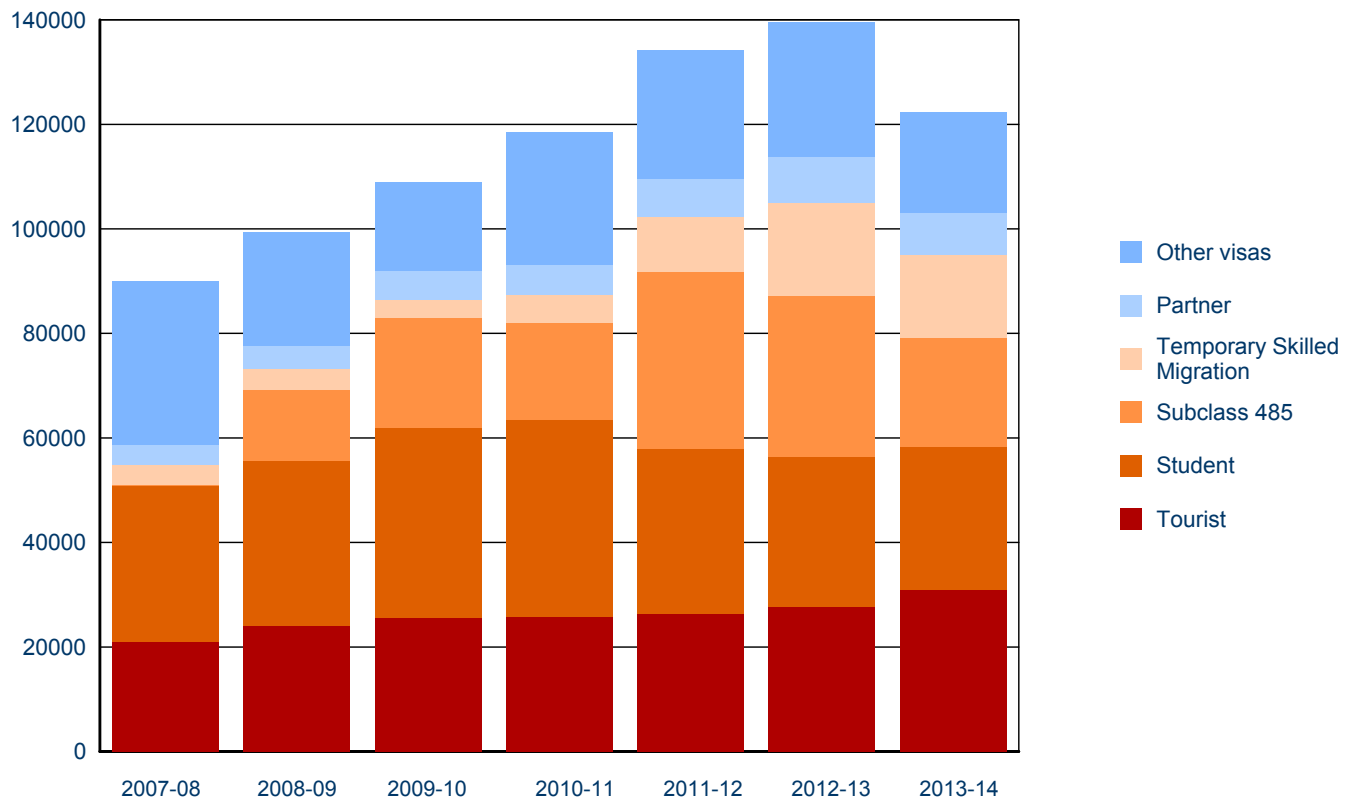
4.02 Number of student visa holders in Australia by citizenship country at 30 June for last seven financial years

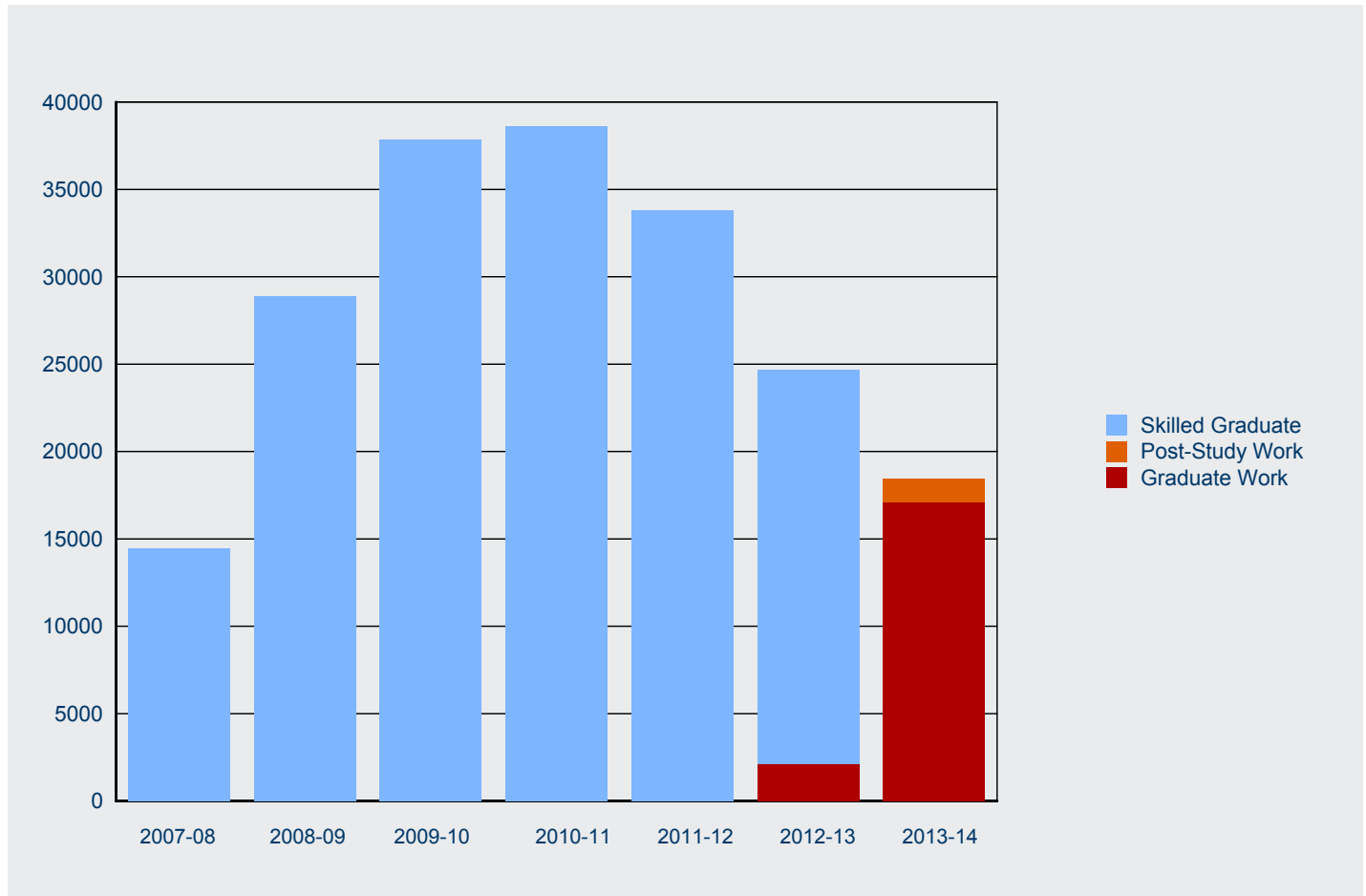

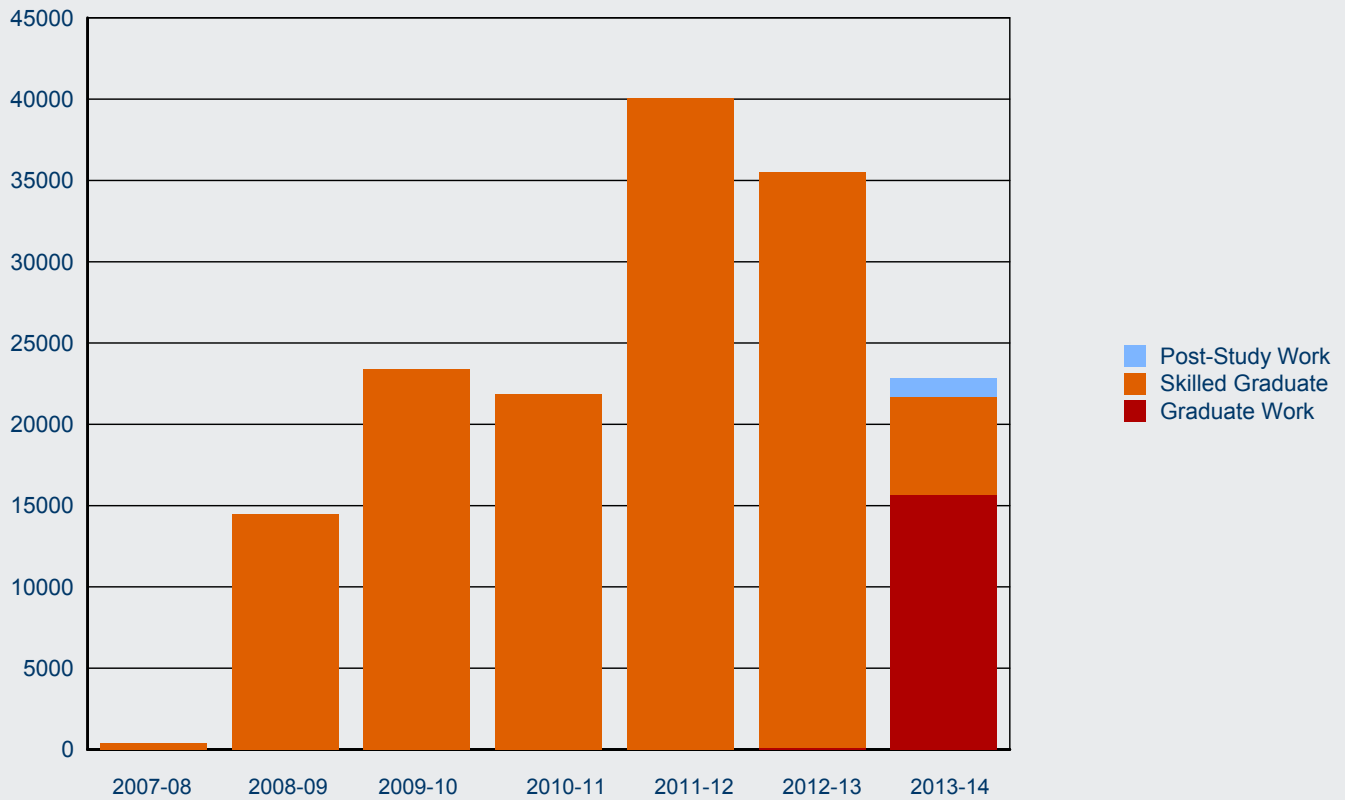

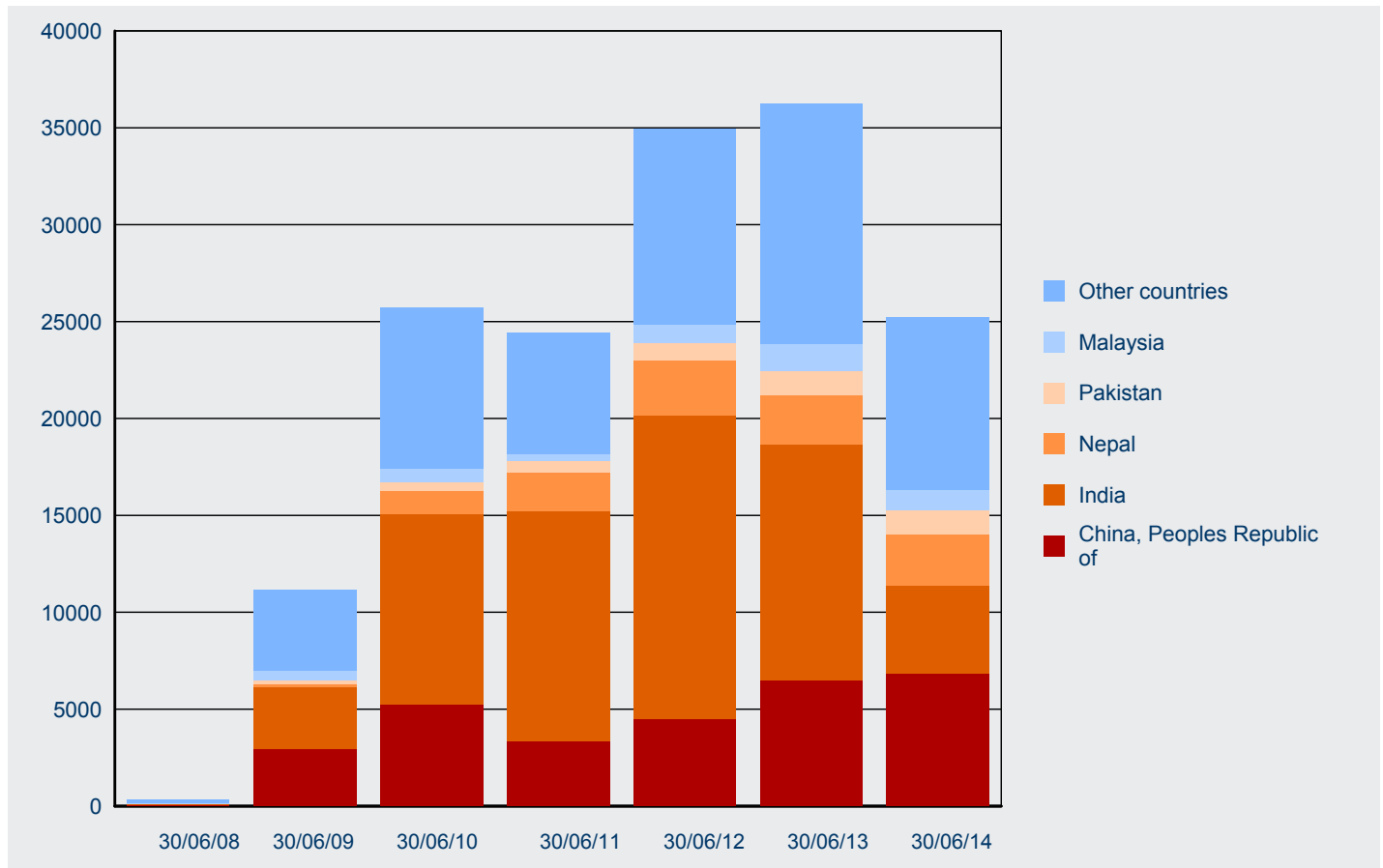
6.02 Number of subclass 485 visa granted by visa stream in the last seven financial years
