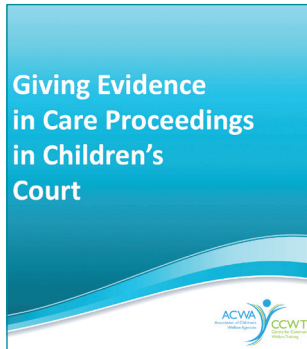
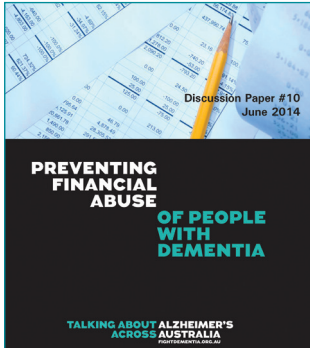


Our grants fund innovative projects

Our purpose is to advance the fairness and equity of the justice system. We aim to improve access to justice, particularly for socially and economically disadvantaged people.

Our high quality, evidence-based work informs and supports the planning and delivery of legal assistance services

We identify legal needs

Through the Legal Australia-Wide (LAW) Survey, the Law and Justice Foundation established a unique evidence base on the legal needs of the community. Our research reveals what legal needs exist among disadvantaged groups including people with disability, Indigenous Australians and single parent families.

We identify what works

We evaluate the effectiveness of initiatives and programs in improving access to justice. Our work with Legal Aid NSW, Victoria Legal Aid and other frontline agencies builds the evidence base. We deliver tools for a strategic approach to service planning and evaluation.

We lead initiatives to use data better

As pioneers of research into legal assistance services, we integrated CLC, Legal Aid and LawAccess data to map service delivery and we developed new indicators of legal need. Our current work on courts and tribunals provides insights to support important civil justice reform.

We respond to priority access to justice issues

We examine emerging issues in legal assistance service delivery. Our research on lawyer availability in rural, regional and remote NSW illustrates our ability to respond to requests for information to aid policy and planning.

We foster relationships

We support collaborations in the justice community including the Legal Information and Referral Forum, the NSW Legal Assistance Forum and Legal Aid NSW's Cooperative Legal Service Delivery program.

We advance plain legal language and education

Our Plain Language Law (PLL) and Justice Access Research Alert (JARA) newsletters keep 3,000 subscribers up-to-date with the latest information and research.
