## **OVERVIEW**

Kevin "Rashid" Johnson is the Minister of Defense of the NABPP-PC and a long time revolutionary prison organizer and accomplished artist and Marxist theoretician. He has been held in segregation since 1993. Recently, on December 12, 2011, he was assaulted by guards at Red Onion; a large swatch of his hair was ripped out and his shoulder was dislocated. Rather than be provided with medical care, he was subjected to a cross-gender strip search and left in chains until the next day. Six weeks later he was transfered to Wallens Ridge, where he can be contacted at:
