Entry to premises refused by 33(1) 33(9) local police called to assist. 33(1) 33(9) still refused entry to police. 33(1) 33(9) sharpening knives from within premises. 33(1) 33(9) has history of violence, self harm & anti police. Negotiations at 33(1) 33(9) who were deployed. Negotiations were commenced by SOG but were unsuccessful. At 2220 forced entry was effected. 33(1) 33(9) observed on bed with his hands hidden underneath the bed sheets. 33(1) 33(9) bedroom of unit and locked the door.

Male went back inside apartment and barricaded himself inside. 2 1/2 hours of negotiations was not responded to other than erratic behaviour and animal noises. CIRT C & C area eventually he opened rear door. CIRT members attempted to secure subject who is 6 foot and strong. 2 members were struggling to secure male in narrow hall way and two others assisted. Even then male was not secure therefore Taser on Drive Stun mode deployed for 5, 2 & 1 seconds. Immediate effect male secured and taken to the Alfred for Psyche assessment.

Male picked up a Claw Hammer and aggressively moved toward CIRT members. 2 Tasers deployed with one on a second cycle due to fighting nature and demeanour of subject this allowed time to secure subject with no further force required.
