A brief of the requirements have been described in the following sections.

# **1. ELIGIBILITY CONDITIONS:**

**A.** The Bidders should fulfil the following eligibility conditions for participating in the Expression of Interest (EOI). The Bidders should enclose documentary evidence for fulfilling the eligibility conditions:

## **B. CREDENTIALS**

Only organizations having the following credentials are requested to respond:

- a Organization having registration under Societies Registration Act of 1860 with up-to-date validity/ Trust/Charitable organization/ Society or charitable companies registered under Section 25 in the Companies Act, 1956 or Companies Act, 2013. (Agencies should provide copies of certificate along with by-laws of the organization).
- b Organization attending at least 60 differently abled and emotionally retarded children at present.
- c Organizations must engage minimum two Yoga teacher having minimum qualification preferably Bachelor degree in Yoga / Diploma in Yoga therapy from recognised /reputed institution and should have experience to impart Yoga training to differently abled children. (Attested copies of certificate of qualification of the Yoga Instructors/ Teachers under the organization). Organizations with speech therapists will be preferred.
- d Organizations should also have the capacity to provide AYUSH Consultancy services every month in the form of health check -up, counselling, speech therapy, life style modifications, Ayurveda treatment etc.
- e Organizations with presence in Kamrup Metro and Kamrup Rural will be preferred.
- f NGOs/Organization must be registered under NITI Aayog Portal and should submit the copy of system generated Unique ID.

# 2) SCOPE OF WORK

- a) The organization will have to work with differently abled and emotionally retarded children with a range of problems, associated with them like delays in development, poor memory, slow learning rates, attention problems, difficulty generalizing what they have learned, and lack of motivation.
- b) Pranayams like Anulom-vilom, Bhambri, Udgeeth and Yoga Nidra calm the nerves and mind. They improve mental health and capabilities of such person. Earnest effort should be made to enable these children to lead a happy life.
- c) The Organization will have to provide consultancy services in the form of health check up/ Counselling/ speech therapy/yoga and

lifestyle modification and training and Ayurvedic treatment. They must have the necessary medical expertise in this regard.

## **3. PROCEDURE, TERMS AND CONDITIONS.**

- **a)** The EOI is to be submitted on one bids basis i.e. Technical Bid.
- b) The Bid needs to be submitted in a sealed envelope super scribing "Expression of Interest (EOI) for implementing the scheme – Jivadhara – an AYUSH intervention for differently abled and emotionally retarded children "containing sealed covers, super scribing on top of envelop "Technical Bid"
- **c)** Bid responses must be addressed as under and drop/reach in the office of the National AYUSH Mission, Assam, Banphool Nagar Path House No:-01, Basistha Road, Dispur, Ghy-06.
- d) The Bid document in sealed cover, should reach the National AYUSH Mission, Assam, on the above address, not later than the prescribed last date of submission of bids. Bids submitted after the due date and time would not be considered and summarily rejected. It is the responsibility of the Bidder to ensure that the bids are received in time by the deadline.
- e) The National AYUSH Mission, Assam reserves the right to solicit additional information from Bidders.
- f) The National AYUSH Mission reserves the right to accept the whole, or part of or reject any or all bids without assigning any reasons thereof and to select the Bidder(s) which best meet public interest.
- **g)** The National AYUSH Mission reserves the right not to accept bid(s) from agency (ies) resorting to unethical practices or on whom investigation/enquiry proceedings have been initiated by Government investigating Agencies/Vigilance Cell.
- h) All information contained in the EOI document, or provided in subsequent discussions or disclosures, is proprietary and confidential. No information may be shared by the bidder with any other organizations / agencies.

## 4. PERIOD OF CONTRACT:

The contract will be for one year (12 months) from the date of award of the work subject to the satisfaction based on monthly performance reviews by NAM, Assam Consultants. If performance is satisfactory, NAM, Assam may extend the contract period for further period on the same terms & conditions.

## **5. AMENDMENT OF EOI DOCUMENT:**

At any time before the submission of bids, the NAM, Assam may amend the tender EOI document by issuing an addendum/corrigendum in writing or by announcing it through newspaper or website. The addendum/corrigendum shall be binding on all the agencies. To give the Agencies reasonable time in which to take an amendment into account in their bids, the NATIONAL AYUSH MISSION may, if the amendment is substantial, extend the deadline for the submission of bid.

### 6. PENALTY CLAUSE

- **a.** The Service Level Agreement (SLA) will be signed with successful bidder. Any breach in SLA will lead to penalty and later termination of the contract.
- b. If at any given point of time it is found that the bidder has made a statement which is factually incorrect or if the bidder doesn't fulfil any of the contractual obligations, the EOI inviting authority may take a decision to cancel the contract with immediate effect. Further, performance security of the agency may also be forfeited.

### 7. ARBITRATION:

- a. If any dispute, difference, question or disagreement shall at any time, hereafter arise, between the parties hereto or the respective representatives or assignees in connection with or arising out of the contract the NAM, Assam, would appoint a sole arbitrator, which shall be accepted by the Agency. The decision of the arbitrator would be final and binding on both the parties.
- **b.** It is also term of the contract that Service Provider shall not stop the work under this contract and work shall continue as expected to continue whether the arbitration proceedings have commenced or not.
- **c.** The Venue of the arbitration shall be at Guwahati. Subject to aforesaid, the provision of the Indian Arbitration Act, 1996 and any statutory modifications or

re-enactments thereof and rules made thereunder and for the time being in force shall apply to the arbitration proceedings under this clause.

#### 8. APPLICABLE LAW AND JURISDICTION:

This contract, including all matters connected with this contract, shall be governed by the India laws, both substantive and

procedural, for the time being in force and shall be subject to the exclusive jurisdiction of Gauhati High Court, if required.

# 9. SIGNING OF BID

The original and all documents of the Bid shall be typed or written in a legible hand writing and shall be signed by the Bidder or a person duly authorized to sign by the Bidder with official seal. The person or persons signing the Bid shall initial all pages of the Bid.

# **10.** Award of contract to the eligible Service Provider:

The Director, AYUSH & Member Secretary, EB, State AYUSH Society, Assam shall award contract to Service Provider on the basis of recommendation of Selection Committee.
