- Office of PM devalued, integrity compromised, governance suffered, mismanagement of Indian economy, sense of insecurity and dent to national and global image of India








Serious Challanges to National Security

External

- More than 500 incidents of border violations by China in just last 2 years
- Failed to expedite infrastructure development on Indo-Tibet border. Only 17 projects completed out of 503 planned
- Continued terror threat from Pakistan with infiltration and suicidal attacks in border areas
- Indian soldiers beheaded but Mr. Antony tried to say perpetrators were 'merely' dressed in Pakistani Army dress

Internal

- Rising graph of crime in cities and violence against women
- Over 72 lakh criminal cases pending in courts
- Miserable failure to check inflow of illegal immigrants
- Cycle of violence and stone pelting in J&K between 2008-10 left more than 150 dead
- Since 2006 more than 6000 civilians killed in attacks by LWE
- Since 2005, more than 1000 people killed outside J&K and NE due to Jihadi terrorism
- Unable to set up NCTC
- POTA stalled while politics held up GUJCOCA
- Communalized fight against terror to such levels that Bihar government failed to take adequate steps for security for Hunkar Rally.





Failure of Foreign Policy

- Delinking terror and dialogue has given Pakistan a handle to tilt the equation in its favour. Leverage arising out of January 04, 2004 Vajpayee-Musharraf agreement in India's favour has been lost
- India has increasingly lost its goodwill among its others neighbors leading to a situation of increasing influence of China in the neighborhood.
- Man Mohan Singh's term ends with a series of incidents wherein the USA has humiliated India
- Government has failed to operationlise reactors for production of electricity through nuclear energy
- Inability to enter into mutually beneficial relationships with East Asian countries especially Japan & Vietnam
- India has backed off from oil explorations in the South China Seas following inmidation





Neglect of Development of North-East

- Dr. Manmohan Singh is a Rajya Sabha Member from Assam since the year 1991. He has been the Finance Minister of India for five years and the Prime Minister of India for the last ten years but not even a single major industry has been setup in Assam in the last ten years.
- The entire focus on the development on North-East initiative by te NDA Government which created a separate department for the development of North-Easr has almost come to a halt.
- The infiltration of illegal immigrants from Bangladesh continues unabated.
- The State and the Government of India in the ministry of environment have failed to protect the one horn Rhino which is the proud symbol of Assam.





Failure in Education and Healthcare

- More than 40% teaching positions in IITs, 30% in Central universities and 25% in IIMs are lying vacant.
- Deemed universities mushroomed from 27 to 150, most in violation of rules and standards.
- Healthcare has received the least attention from the UPA-II government.
- In this year Budget, the Finance Minister has chosen to cut down the grant to the Ministry of Health and Family Welfare by 20.6%



Undermining Institutions

Systemic weakening and compromising of sanctity of institutions

- CAG attacked because it exposed scams like 2G, Coalgate, CWG, etc
- Questionable appointment of PJ Thomas as CVC which was set aside by SC
- Use and abuse of CBI for targeting political opponents and shielding corrupt
- Compromised sanctity of parliamentary bodies like JPC and PAC
- Public criticism of Election Commission by Union Ministers
