THE MARK OF LIFE Toward an imaginative way to destroy the existent

Ideas born from the fates, words accompanied by action carrying the mark of life. We have crippled Roberto Adinolfi, one of so many sorcerers of the atom with a candid spirit and a clean conscience. Roberto Adinolfi, nuclear engineer, administrator in charge of Ansaldo Nuclear; he has steered the Ansaldo-FIAT Consortium as its technical director, the consortium was created for the design of the Italian plants of Montalto di Castro and Trino Vercellese; in the past he has collaborated in the renovation of the Superphenix and has constructed the plants at Cernavoda in Ro-

mania. Before nuclear fell into disgrace, he was one of the most responsible together with Scajola for the return of nuclear energy to Italy. Member of the Unicen Commission for nuclear regulation and Vice President of the Italian Nuclear Society, part of the Governing Board of the European technology platform Sustainable Nuclear Energy.

Despite not liking violent-style rhetoric, it has been with a certain pleasantness that we armed ourselves, with pleasure that we loaded the magazine. Grasping the pistol, choosing and following the target, coordinating mind and hand were necessary steps, the logical consequence of an idea of justice, the risk of a choice and at the same time a confluence of enjoyable sensations. A little bit of justice, some lead in the lea to leave a lasting memory of what was to him a grey assassin. The target is a colorless scientist, a technician, a word sadly in fashion these days which behind a fictitious neutrality hides the long arm of capital, a director little inclined to appear in the spotlight, at this time a villainous responsible who has not only designed and renovated nuclear plants that have caused and are causing deaths around the world. Not only has he designed and collaborated in the creation of deadly plants, but he has also promoted nuclear plants and their exploitation with Ansaldo scheming with various governments; science, politics and economics in perfect union.

In past centuries science had promised a golden era, today it is being carried out toward self-destruction and more total slavery. The science-technology pairing has never been at the service of humanity, in its deepest essence it shows

the imperative need to eliminate everything that is irrational, to dehumanize, to annihilate, to effectively destroy humanity. Capitalism with the help of science tends to annul conflicts, individuals today are free to realize their subjective selves only through the consumption and production of goods. The machine orders, the human performs. Capital orders, the consumer consumes.

Science orders, technology kills. State and science, capitalism and technology are only one thing, one single Moloch.

Increasingly close accords between states, diffuse capitalism, scrupulous science, criminal technology are inexorably killing the planet. A few kilometers to the north in France, Switzerland, Romania the nuclear plants can no longer be counted. In the European Union alone there are one hundred ninety-seven, twelve within the Italian borders. Adinolfi knows well that it is only a matter of time before a European Fukushima reaps death on our continent. We are certain, engineer, that if even for just a second you felt jointly responsible for Damocles' sword hanging over our heads. We have bad news for you: for each action there is an equal and opposite reaction, and your body shows it.

With this action of ours we return to you a tiny part of the suffering that you, man of science, are pouring into the world. Roberto Adinolfi, lead man of Ansaldo Nuclear, tentacle of Finmeccanica, monstrous artificial octopus. It is its tentacles that everywhere strangle, murder and oppress. Finmeccanica means Ansaldo Energy with its nuclear tombs. Finmeccanica means Ansaldo Breda with its high-speed trains that devastate the land. Finmeccanica means Selex Sistemi Integrati, Dirstechnical Service, Inc. Elsac Datamat with its equipping of the racist US police for the control of the Mexican border, with its delirious design of electronic walls at the Libyan border against migrants, and its sophisticated electronic supplies to the Chilean police.
Finmeccanica means Avio Alenia,
Galileo and Selex with their deadly F35 fighter bombers, and the terrible aerial drones without pilots. Finmeccanica means interforce range from Salto to Quirra in Sardegna. Finmeccanica means bio- and nano-technology.
Finmeccanica means death and suffering, new frontiers of Italian capitalism.

Human beings are made of flesh and dreams. Our dream is that of a humanity free from every form of slavery, that grows in harmony with nature. A dream that we make live in the moment in which we fight to realize it. Our dream has for us a name, "anarchy," and we are ready to gamble everything in order to realize it. We are not alone in this adventure, in the whole world a new anarchy is blossoming opposite of an ideological and cynical anarch-ism, an anarch-ism empty of any breath of life, which only finds its realization in theory and attendance at assemblies and manifestations, the whole cowardice of a citizenism that stinks of death. A new anarchy is rising from the ruins of this anarch-ism, thousands and thousands of cells that speak among each other through thousands and thousands of actions.

Damiano Bolano, Giorgos Nikolopoulos, Panaviotis Argyrou, Gerasimos Tsakalos, Michalis Nikolopoulos, Olga Ikonomidou, **Christos Tsakalos, Haris** Hatzimichelakis, the imprisoned members cell of the CCF/FAI are the brothers and sisters who gave their determination and courage to fight, their consistency and projectuality have made us strong. Camenish, Pombo da Silva, Eat and Billy, Tortuga, Silvia, Costa, Billy and so many other prisoners in the prisons around the world, Russia, Mexico, Chile, Indonesia, Switzerland, the United States, were the ones who taught us not to fear prison. De Blasi, Pinones, Di Napoli, Cinieri, Morales, Sole, Baleno and so many killed by state repression, were the ones who taught us not to fear death. It was the brothers and sisters and those who we do not know of the Italian FAI/IRF who have proceeded to give a concrete informal organizational perspective. With their determination, constancy and persistence, in spite of the general pessimism, against a critique - a critique always full of envy, against a

realism without hope, against everyone and everything, they have succeeded in keeping the flame of the new anarchism alive. A flame becoming bright like the sun when the sisters and brothers of the CCF have brought their contribution of courage-actionorganization.

If we were realists we would not have armed our hands. If we were realists we would not take on such risks, we would live our existence producing and consuming, maybe being indignant. We are the crazy lovers of freedom and we will never renounce the revolution and the complete destruction of the state and its violence. In our anarchist and nihilist revolt, the hope of a future without borders, wars, social classes, economy, exploited and exploiter. The possibility of realizing this dream is for us like a gleam of light in the darkness. However dim this gleam may be, it is always worth reaching for, cost what it may, the quality of our life will be enriched.

To you anarchists who accuse us of being unrealistic, adventurist, suicidal, provocative, martyrs, we say that with your "social" struggle, with your citizenism you work for the reinforcement of democracy. Always in search of consensus, without ever crossing over the limit of the "possible" and the "rational," the only compass guiding your action is the penal code. Willing to risk only up to a point, always ready to find infinite ideological justifications so as not admit to your own fears. We are sure one day you will have the last word on us, as in the past you have had with your last experience of armed struggle. In a few years you will write a good book on our story, criticizing our errors and our shortcomings; from the heights of your "coherency" nothing is revolutionary enough, but no one, not even you, will be able to take away the pleasure that today we have fully realized and lived, here and now, our revolution.

If we consider the lives of the vast majority of us anarchists we

realize that we are not so distant from the alienation of those who produce, consume and die. We produce and consume radical culture and alternative music and slowly, ever so slowly, die without ever having taken arms against and shot an oppressor. All our revolutionary tension is unleashed in fiery articles for our journals and websites, in fiery words to our songs and the sporadic clash in the plaza, enough to silence one's own conscience. It is clear that what we are making is a self-critique, we do not feel that we are something different from other anarchists. By holding a stupid pistol, we have only taken one step in many for escaping from the alienation of "Now is not the moment..." "The times are not ripe..."

Vanquishing fear was simpler than what we had imagined it. Doing today what only yesterday we thought impossible is the only solution that we have found for breaking down the wall of daily oppression, of the impotency and resignation that we have seen up to now as pawns in an insurrectionalist anarchism of mere facade that with its lack of courage legitimates power. We could strike while looking for "consensus" on where the tooth hurts, for example some functionary of Equitalia [tax collection agency in Italy, which is very unpopular these days - transl.l. but with this action we are not looking for "consensus." What we are looking for now is complicity. In the recent past, a cell of the FAI/IRF severely wounded a functionary of Equitalia, which has received a wide approval, something that the self-named "social" anarchists in recent years have tried countless times to achieve without much success. The brothers and sisters of the "Free Eat and Billy Cell" have shown with that action that in the end consistency pays, and that it is not necessary to limit oneself to action in order to get "consensus." These comrades have shaken from our backs a malediction that has for too long been weighing on anarchists' backs, the malediction of this badly interpreted search for social consensus that binds the hands of those who are aware of the urgency to act, here and now.

In these times in which so much certainty of the state-capital is sinking, the idea of freedom cannot be derogated: the idea of social struggle in which we recognize ourselves and we want to move ourselves is that of a people in arms against any form of state, political, or

economic oppression. We do not consider ourselves representative of citizens indignant over some malfunctioning of a system that they want to continue to be part of. Exchanging rage and indignation in the place of a process of revolt against the status quo is a sign of a dangerous revolutionary myopia. With the entangling of comrades, even generous ones, into the cultivation of a field of dissenting democracy, with its own little cliques and consortia and its miniature politicians, generosity transforms into assistance, the spectacularization of the clash with relative manipulation by the media. Only the radicalization of the conflict can lead to paths of social and individual freedom.

Identify the target, "hit where it hurts most," know to recognize the enemy even when it is playing the lamb. Make the arms of critique and the critique of arms work hand in hand. There is neither rhetoric nor spectacle in an action carried out with the appropriate selection of means and objective.

With this action we give rise to the "Olga Cell." We enthusiastically adhere to the FAI/IRF, uniting with so many groups of the new anarchist international around the world, Mexico, Chile, Peru, Argentina, Indonesia, Russia, England, Italy, Spain, Greece...

Projecting and carrying out this action were anarchists without any "military" experience, without any specialization, only the anarchists who with this our first action want to definitively mark a line between ourselves and that anarch-ism that burns only when chatting and is soaked in gregariousness. We have taken the name of a sister of ours from the CCF, Olga Economidou because in her consistency and strength as part of the "Imprisoned Members' Cell of the CCF," she resides at the heart of the FAI/IRF. In our next action, the name of another Greek brother, an action for each of them. With Adinolfi's wounding we propose a campaign of struggle against Finmeccanica, murderous octopus. Today Ansaldo Nuclear, tomorrow another of its tentacles - we invite all the groups and individuals of the FAI to strike this monstrosity with all necessary means.

Statement from the imprisoned members of the CCF: Bullets of words for the bullets of FAI/FRI

It is a wonderful moment, the moment that the enemy kneels and falls from the determination of your brothers and sisters. A few days ago Roberto Adinolfi, CEO-magister of the nuclear energy company Ansaldo Nucleare, was shot by our brothers and sisters of the Olga Cell of the Informal Anarchist Federation (FAI)—International Revolutionary Front (FRI).

Roberto Adinolfi is a high priest of the new totalitarianism of science and technology imperatives. Science has become the modern religion of our time, promising an apathetic society the lethargy of a stuffed belly and artificial paradises in exchange for the coldness of an empty heart drowned in compromise.

The empire of scientific totalitarianism is fed by the vanity of an anthropocentric authoritarian civilization. A civilization imposed on our desires, our choices, the nature and animals, turning life into a quantitative scale to fit its miserable statistics. At the same time, contemporary people end up unable to even dare to live authentically, without hypocrisy, and as they sink deeper into their reliance on technological substitutes of real life they create illusions and superficial relationships. Now, with their scientific discoveries, they can 'offer' us more time to grow old but deprive us of a way to live authentically. So, science generates the coldest of all monsters of the human folly. It lays the technological fascistization of our lives. It lays genetic testing, electronic monitoring, laboratory animals, research statistics, the dictatorship of machines and numbers.

Alongside the high priests of nuclear energy like Adinolfi poison and plunder the nature, animals and people, dressing up their scientific crimes in the guise of evolution. The shootings of Adinolfi are the new poetry of anarchist action. In the social machine of indolence and compromise, the humanitarian appeals and the reformist inhibitions concerning 'respect' for human life will never miss. But in our own consciousness code things are clear. We don't have any respect for human life as SELF-WORTH. What human life per se does is to produce the option of CHOICES. The CHOICES are those that give value to human life, or devalue and trivialize it. Thus. what is the reason to respect the human life of small and large tyrants like Adinolfi, who haven't for even a moment respected our own lives?

The practice of armed attacks was, is and will be an integral part of the new anarchist urban guerrilla warfare. The choice of the COMRADES of FAI/FRI to name the cell that has attacked Adinolfi as Olga Cell after our comrade Olga **Ekonomidou** is a great honour for us and a profound act of friendship, one we will never forget. The bullets and the words of FAI/FRI have managed to break the impregnable of the specific conditions imposed on Olga in Diavata prisons and to storm the solitary cell where she is being held under disciplinary punishment, monitored 24 hours a day through CCTV camera; they have, thus, given

her strength and smile now that she knows everything continues.

For us, the Italian FAI/FRI is the Conspiracy's second home, and half of our heart belongs to the Italian FAI/FRI. We look forward to the time when we will join our sisters and brothers of FAI/FRI and surge forward into new battles for the lasting anarchist insurrection. Both FAI/FRI and Conspiracy of Cells of Fire are not a prescription for canned answers, but they are a good way to begin with questions and queries for an authentic and free life. Comrades of FAI/FRI: may a bullet come with our every word, as thought comes with your every bullet... And life's magazine continues to be loaded with dreams, desires, anxieties, tears, smiles, concerns, discussions, actions...

One day after the responsibility claim by the Olga Cell of FAI/FRI, we were informed by the media that the Bologna's prosecution office, via the ridiculous puppet-public prosecutor Enrico Cieri, issued arrest warrants against us for the booby-trapped parcel that was sent to Berlusconi. More precisely, arrest warrants were issued for five of us (Panagiotis Argirou, Giorgos Nikolopoulos, Haris Hadjimihelakis, Gerasimos Tsakalos and Christos Tsakalos), as well as for two unrelated guys that have no connection whatsoever with the Conspiracy and the insurrectionary anarchy of FAI/ FRI.

The warrants against us are in retaliation by the Bologna's prosecution office for the attack of our sisters and brothers of the FAI/FRI Olga Cell. It is a desperate attempt of the Italian authorities to interrupt and impede the informal international network that has developed among the tens of FAI/FRI cells. But in vain. The invitation-inducement of Italian comrades to create an informal anarchist federation of anarchist of praxis and its constant advancement is already in the minds and hearts of comrades from around the world. No prosecution can ever stop it anywhere.

The comrades of FAI/FRI had written in one of their texts 'Do not say that we are few', and we now add 'Do not say that they can stop us...' The Informal Anarchist Federation travels over borders and cities, carrying with it the momentum of a lasting anarchist insurrection. As the CCF imprisoned members' cell, along with our comrade and brother Theofilos Mavropoulos, we are TOGETHER with the FAI/FRI on this journey of no return. We have burned the bridges behind us, and any inhibition has died. We are anarchists of praxis, and all we can say to the Bologna's prosecution office is this: Your warrants are nothing but shitpapers to us, and we are completely indifferent towards the ridiculousness of your existence as the Italian State's judicial representatives. It is a dangerous time for the prosecutors' mafia nowadays. The lives of worms like you might soon meet with a heavy rain of bullets, or a powerful bomb in your car, or an explosive parcel in your hands... The arrest warrants in retaliation against us is yet another proud proof that the FAI/FRI Olga Cell counteracted with outstanding accuracy, causing panic in the enemy. The attacks that our sisters and brothers preannounced through their communiqué are an admirable continuation of the challenge unleashed by both FAI/FRI and CCF against the Power and the social machine. That is the challenge of the lasting anarchist insurrection. That is the challenge of the international cooperation of anarchists of praxis.

And if some of us are now captives in the enemy's hands, that does not frighten us or make us regret. On the contrary, prison feeds the wolf within us, and our rage against the Power and its society grows stronger. All of us, along with Eat, Billy, Gabriel, Marco, Silvia, Billy, Costa, Jock and the imprisoned comrades in \$hile, Mexico, Italy and elsewhere, nor for a moment were we left alone. Because we have all of you, the unknown free brothers

and sisters, whose actions we feel as our own actions, whose words are met with our own...

Eat & Billy, members of the Long Live Luciano Tortuga Cell - FAI/IRF jailed for less than 2 years

The two combatants in Yogyakarta, Billy Augustan and Reyhard Rumbayan (Eat) finally returned to stand trial for the 8th session. The trial was held on Tuesday, May 15, 2012. Billy & Eat sentenced for 1 year 8 months. Both comrades had been in prison since October 7, 2011, shortly after their successful attack against an ATM bank. In the hearing held in the District Court of Lahore, the verdict against the two combatant's revolutionary actions was read by the Chief Justice, Mulyanto. Both are considered guilty of causing fire and explosion in accordance with Article 187, paragraph 1 of the Criminal Code junto 55. The trial of the Long Live Luciano Tortuga **Cell / International Revolutionary Front** (IRF) - Informal Anarchist Federation (FAI) will be continued again to hear a response from the revolutionary comrades, Billy and Eat. Confirmation of this date has not confirmed. Energy to the fighters!

"Turn off the main switch in this dump. Here the beautiful becomes ugly, the choice becomes a habit and the meaningless important. Prison dirties creases and swallows pieces of dreams, desires, thoughts and feelings. Its most permanent residents, the majority of the prisoners are now a part of the appliances of the prison. Bars, yard, cameras, locks, prisoners mix all together and re-enact the world of captivity. Nothing is worthy in here. Come let's go and don't look back... Only fire will cleanse this place... "

Prison and its numbered residents. Prison and the degradation of its prisoners. Prison and its myths... Behind the iron door of prison which closes, there is a captive world which has nothing to envy of the "free" world. Away from the illusions of an alleged value code of the outlaws, a makebelieve solidarity between the prisoners and supposed self-organized struggles and revolts, the society of the prisoners is the mirror of the law abiding society.

Conservatism, hypocrisy, racism, misery, compromise and snitching, this is the civilization of the prisoners. Remnants of human shadows next to leftover smack and pills. Human rodents, customers of the prisons, decadent misprints of the bosses of this world, who have been exiled to prison as excessive weight of this earth. Most prisoners are guards of themselves.

They have learnt to double-lock themselves in pills, smack, slavery, habits, the passive counting of days for the miserable repetition of their subjugated self. Prisoners justify their role as the waste of an even more sordid society.

We do not intend to become a part of this sad community of human imitations and shadows. We keep ourselves away from the annoying noise of the mob and we separate those few minorities of the prisoners who do not forget the meaning of freedom. We meet with those who did not kneel in captivity, who did not exchange their dignity with powders.

and pills, who did not lower the eyes in front of the authorities and the laws, who did not let the prison be built inside them.

As for the rest we will not fall into the trap of humanism and pity. We do not appreciate passive emotions. Whoever surrounds themselves with the motif of resignation or accepts the victimized figure of the "con", might win over the sensitivity of the philanthropists and sociologists but from us receives only a deep contempt. We are hostage anarchist guerrillas and not just prisoners. To say things as they are is not a result of some informal elitism or discrimination: simply in this way we attack the attempt of the state to hide the existence of the anarchist constant revolt and its hostages.

As anarchist hostages of democracy we never separated ourselves from our values and ideals. We remain enemies of justice and its courts, promoting the self-organization of our action and self-redress far from any kind of mediators.

The undisputed fact that we are against prisons, does not mean that we are in solidarity with all prisoners.

A short while ago in Thebes prisons the service purposely transferred to the wing where our comrade Olga Economidou was, a prisoner which her attitude and her "penal" actions could not have been tolerated by the morals, character and dignity of Olga. As we have mentioned there are prisoners who are as sordid as the society of law abiding citizens.

Our comrade acted consciously resulting in finding herself before the prosecutor of the prison, accused of "beating an inmate" and was imposed with a disciplinary transfer. Now she is in the isolation unit of the female prisons of Diavata where she was transferred with a special transfer and where she refused to be subjugated to the humiliating body search.

The precepts of the officer in charge to conform to the body search, invoking the example of other "anarchist" prisoners who have compromised with this correctional measure, fell into the void... We are not all the same... neither do we do the same prison time.

Anyway, everyone is not characterized by the political label they have put on them or has adopted on their own, but by their choices and their CONSISTENCY to them.

The prosecutor of Diavata prisons because of her refusal to be strip searched imposed on Olga 10 days confinement to an isolation cell.

We, her comrades in the Conspiracy Cells of Fire, are next to her, to her choices which are our choices as well and send her our most warm embrace with our unrepentant commitment... we remain for ever in the battle...

P.S. We also want to express our solidarity to anarchist Rami Syrianos who remaining consistent, he has also refused to succumb to the humiliation of the strip search, which is essentially the humiliation of dignity, and is for a month now in an isolation regime in Nigrita prisons. Rami has already begun prison food abstention....

Declaration of Nikos Maziotis, member of Revolutionary Struggle

Nikos Maziotis, Pola Roupa and Kostas Gournas are anarchist comrades in Greece who have taken responsibility, as well as of slain comrade Lambros Foundas, of membership of Revolutionary Struggle. This armed struggle organisation achieved many critical attacks against high-profile anti-capitalist and anti-state targets in Athens, Greece. They are currently on trial.

24/10/11

This trial is a political trial in which revolutionaries are judged, who chose armed struggle to fight for the overthrow of capitalism and the State, the overthrow of the criminal regime that you, as judges, defend.

Your court is a special court set up under the orders of the American and British imperialists and custodians of the Greek State. They who enforced the lawmaking of special 'antiterrorism' provisions which adjust more criminal charges and maximize sentences; they who enforced the establishment of special courts that sit inside prisons, within a suffocating security environment, and undermine the trial publicity to prevent the people from finding out on the revolutionaries' political views; they who enforced the implementation of occasional special conditions of detention; and all these with the aim of imposing stricter repression against the armed resistance and the action of armed revolutionary organizations in Greece.

And that's because the previous repressive regime - which lacked any special provision regarding the 'formation of a terrorist organization', and also still had the mixed jury courts with civilians jurors - was disqualified as insufficient and ineffective. By this way you prove that, although you do not recognize political opponents and political prisoners, you do recognize us indirectly as political enemies and dangerous for the economic and political regime that you serve, by applying in practice specific laws and special provisions against us, by putting us on trial in a special court, as opposed to the treatment of all those that your Power considers as 'common criminal offenders'.

By this way you prove the timeless fierceness of Power towards its political enemies.

Besides, what authority ever officially acknowledged political opponents and political prisoners?

The guerrillas of the Greek People's Liberation Army (ELAS) during the Axis occupation of World War II, as well as the Democratic Army of Greece (DSE) during the Greek Civil

War were taunted and hunted down as 'brigands' (symmorites) by the collaborationist and postwar monarch-fascist regime, and were tried by emergency courts-martial.

Members of armed revolutionary organizations are prosecuted as 'terrorists' and tried by special courts, like yours. The label of 'terrorist' is applied to revolutionary fighters by every authority, whether in the form of military regimes and dictatorships, like the one during 1967-74, or the postwar constitutional oligarchy that by euphemism was named 'democracy', or the current junta of betrayers and quislings of the PASOK government that submitted the people to the Power of the international economic oligarchy by signing the treaty of the Memorandum.

All freedom fighters and armed combatants across the world were prosecuted under charges of 'terrorism': members of the Red Brigades in Italy, members of RAF, the Movement 2nd June and the Revolutionary Cells in West Germany, members of the Communist Combatant Cells in Belgium, members of Action Directe and GARI in France, the 1st May, as well as anarchists, autonomous fighters and members of MIL in the Francoist Spain and members of GRAPO in the post-Franco regime, Tupamaros fighters in Uruguay, Che Guevara, members of FARC in Colombia, Farabundo Martí National Liberation Front (FMLN) in El Salvador, Shining Path (Sendero Luminoso) and Túpac Amaru Revolutionary Movement (MRTA) in Peru, fighters of revolutionary organizations in Turkey, members of PKK, IRA and ETA, and of course here, in Greece, the fighters of the 17 November (17N) and the Revolutionary People's Struggle (ELA).

As for the charges: those who should sit in the dock today to apologize are the ones who have committed crimes against the people, the ones who have committed the biggest social robbery in history, namely the members of the PASOK government, the prime minister Giorgos Papandreou, the finance minister Evangelos Venizelos and the former finance minister Giorgos Papakonstantinou, the ministers Loverdos, Koutroumanis, Pangalos, Chrysochoidis, Papoutsis, Diamantopoulou, all of the ministers and their deputies, as well as the members of the political parties who enact laws for plundering the population, those who deprive people of primary needs, food, housing, work, health care, education, dignity, those who deprive people of their very own lives, those who signed the Memorandum of subservience to the IMF/ ECB/EU Troika, those who signed the

Medium-Term Program and approved the latest bailout loan contract, humiliating and turning the people into a serf of the supranational and domestic economic aristocracy.

All these individuals are the traitors of the people nowadays, just like Georgios Tsolakoglou (a military officer who became the first prime minister in the Greek collaborationist government during the Axis occupation) and Ioannis Rallis (the third prime minister of that Nazi-controlled government). Those who should also sit in the dock today to apologize are the members of the previous government of New Democracy (Nea Dimokratia), the former prime minister Kostas Karamanlis, the former finance ministers Giorgos Alogoskoufis, Petros Doukas, Giannis Papathanasiou, the ministers P.Panagiotopoulos, G. Voulgarakis, V. Polydoras, S. Tsitouridis, F.Palli-Petralia.

All these individuals must apologize for robbery at the expense of the people; for robbery at the expense of public social insurance funds, as has happened in the case of the so-called structured notes (a structured government bond issued in 2007) that certain social insurance funds bought and made big loses on; for robbery at the expense of public assets, as in the case of public sector land swap deal with the Greek Orthodox monastery of Vatopedi; for crimes against the people's liberties, as in the case of wiretaps against hundreds of citizens during 2004-5 that were ordered by the US Embassy in Athens aiming at the security for the 2004 Olympic Games (the wiretapping was continued for at least a year after the event), a case that resulted in the death (now discussed as murder) of an employee of the Vodafone telecommunications company; for the abductions and the battering of Pakistanis in 2005 that were ordered by the British authorities; for the tortures against immigrants, such as those in the police department of Aghios Panteleimonas in Athens in 2005; for the deprivation of social security and medicopharmaceutical care for thousands of workers after the insurance reform bill which was introduced by the employment minister Palli-Petralia in 2008; for physical assaults against protesters, as in the case of the student demonstrations in 2007: for the beatings and assassinations of immigrants at the Aliens Police Directorate in Petrou Ralli Street; for the murder of Alexis Grigoropoulos.

Those who should sit in the dock to apologize are the members of the ruling class, the principal criminals of the international and domestic financial elite, big businessmen and major shareholders, executives of multinational and multidisciplinary corporate groups, hedge funders and stock market gamblers, bankers and managers of central banks, shipping tycoons and industrialists, such as Vardinoyannis family members, Latsis family members, Kostopoulos, Lavrentiadis, Mytilineos, Bobolas, Vgenopoulos, Greek and foreign bondholders of the Greek debt, directors of international monetary financial institutions, such as the IMF former managing director Dominique Strauss-Kahn and the current managing director Christine Lagarde, the ECB president Jean-Claude Trichet, the European Commission president J.M.Barroso and the vice-president Olli Rehn - all of them are the real bosses of this country -, all those that condemn populations to wretchedness, poverty, hunger and death, and when they don't kill with imperialist invasions and wars, they kill through the violent imposition of programs of international monetary financial institutions like the IMF and the World Bank.

Those who should sit in the dock to apologize are you, the professional judges, because you are accomplices and servants of all those bastards and criminals; and the same goes for the regime's protectors, the armed dogs of Power, the contemporary Chites (WWII military forces of Grivas' Organization X) and Tagmatasfalites (WWII security battalions of collaborationists), the police and various security units, such as YAT, YMET, DELTA, DIAS, special guards, those who guard and protect the rich and the bosses and politicians, those who assault the people during demonstrations and strikes, those who kill youths, immigrants and fighters, those who torture detainees in police stations.

You are all members of a structured and extremely well-organized criminal and terrorist organization that is called *the State*, whose mission is to defend the interests of the rich.

Your mission is to defend the criminal regime that is called *capitalism*. All those that you serve should be held accountable for robbery and looting against the people, at the expense of the population's income, at the expense of wages, pensions, public assets and public social insurance funds.

It is those you serve that should be held accountable to all who have nothing to eat and look for food in garbage bins, to all who are dying, or their life and health are exposed to danger because of deficiencies in hospitals and the healthcare system's deterioration; to all who lose their life in so-called 'occupational' accidents, all who lose their jobs and are condemned to poverty and misery, all who lose their homes and find themselves on the streets, all who commit suicide because of debts, while those criminals live profusely.

You will judge us on behalf of all of those scumbags and criminals that the people would like to see hanged at Syntagma Square. This trial is a crime. Because our prosecution and imprisonment is a criminal and antisocial act.

Because you, as judges and prosecutors, are abettors to a criminal regime that terrorizes the people and the social majority every day.

Because we are needed by our actions for the people's liberation from the totalitarianism of capitalism and the State.

Because the people not only have not been terrorized by the activity of Revolutionary Struggle (*Epanastatikos Agonas*), but there are many who endorsed the organization's actions, as these aimed against the economic and political Power, against the regime which oppresses and exploits them on a daily basis.

Because terrorism is nothing less than the robbery and the looting committed by the State, the government and the financial elite at the expense of the people. Terrorism is the people's condemnation to poverty and deprivation. Terrorism is the violence of police praetorians against protesting people.

As revolutionaries, members of Revolutionary Struggle, we have no reason to apologize for anything. It is you and the regime's members whom you defend that have reasons to apologize.

On the contrary, we have reasons to be proud of our participation in Revolutionary Struggle. We are proud because it is always right to take to the arms against injustice, exploitation and oppression.

Armed struggle for the overthrow of capitalism and the State is more timely and needed than ever.

We are here to proclaim that only Social Revolution, which will overthrow your criminal regime, will serve justice.

New Red Brigades suspects call for "revolution" during court hearing

15/5/12

Milan - 12 suspected members of a group linked to Italy's far-left Red Brigades called in court for armed revolution. "This is the right moment, long live the revolution," said Alfredo Davanzo, when asked about the recent upsurge in subversive and anticapitalist action in the country and the shooting of the CEO of Ansaldo Nucleare, Roberto Adolfini. Davanzo, one of the alleged members of the New Red Brigades, an offshoot of the organisation that fought in Italy in the 1970s, made the remarks after being questioned at the start of an appeal hearing in Milan. "We don't have to justify anything or defend ourselves for anything, it's a political question" said Vincenzo Sisi, one of Davanzo's codefendants, in a declaration to the court. "But looking at the catastrophe of capitalism, there is no other way out than armed struggle." The 12 suspected members of the New Red Brigades are facing a new trial after an appeals court struck down on legal grounds their convictions on terrorism charges including possession of weapons. They had been sentenced to between 4 and 14 years. Twenty relatives and leftmilitants made a vigil of solidarity and appeared in the public gallery. The Italian Technocrat Mario Monti announced that he could take the army against violent radical left and anarchist demonstrators, which he accuses of being behind riots against the government and its economic policies. On 13 May, Monti raised the so-called 'level of readiness' in key locations of Italy, after another wave of action hit the country. Italian Interior Minister Anna Maria Cancellieri has confirmed the intention to involve the military. Cancellieri proclaimed that an attack on Equitalia [Italy's tax collection office] is an attack

On 12 May, two Molotov cocktails were thrown at the tax authority building in Livorno and a letter-bomb was delivered to the Rome branch of Equitalia.

Barcelona: May 1-4 actions by Anarchist Nihilists (Catalonia)

THE CITY OF THE BOMBS WILL BURN AGAIN

May 1, 2012 In Poblesec:

- At about 9:50 PM, the "Passeig de l'Exposcio" street was blocked off with burning dumpsters.
- At 10:30 PM, Jaume Fabra street was also blocked.

In Bonanova:

- At 12:40 AM the windows of 10 luxury cars were destroyed, the hoods and windows stoned and destroyed, and then the tires were punctured.
- At 1:30 AM, Ganduxer street was blocked off with 5 burning dumpsters.
- At 2:40 AM various houses in the wealthiest area were attacked with paint bombs.
- At 3:00 AM the doors of a 5-star hotel were attacked with blunt objects.

May 2, 2012 In El besos:

- At 3:20 AM, La Rambla Prim was blocked off with five burning dumpsters.
- At 3:50 AM, a La Caixa bank branch was attacked, two molotov cocktails thrown at two ATMs.
- At 4:10 AM on Carrer del Taulat, a row of 10 dumpsters were set on fire, also, in order to block off the street burning furniture was used.
- At 4:30 AM, the windows of a Caixa Sabadell bank were destroyed with rocks and hammers and then paint was thrown. Then, the ATM was set on fire.

In Raval:

- At 4:20, simultaneously other compas in the Raval neighborhood blocked off the Carrer de la Cera with 5 burning dumpsters with molotov cocktails.
- At 4:50 AM on Carrer Aurora, a row of 8 dumpsters were set ablaze.
- At 5:20 AM, 3 bank branches were hit with rocks and hammers, also paint was thrown against them.

May 3, 2012

In the metro area of Barcelona:

- On Carrer Calderon de la Barca, at 4:50 PM, a telephone booth was hit

hard with hammers and rocks until it was knocked over.

- At 6:20 PM, a row of 6 dumpsters were set on fire in Europa street with several molotov cocktails.
- At 10:40 PM, two telephone booths were set on fire.
- On Carrer de la Gravina, a religious and state-aided private school was attacked with 4 molotov cocktails, as well as the windows of the exterior kitchen being destroyed with rocks and hammers.

May 4, 2012 Montcada i Reixac:

- At 2:30 AM, a row of 10 dumpsters were set alight on Carrer de Bogatell, also two ATMs were burned.

In La mina:

- At 11:30 PM. Carrer de Tessalia was blocked with burning dumpsters and a Caixa Laietana branch was attacked with hammers and rocks.

Communique

We have lost confidence in the democratic middle class, we have lost confidence in a society that when faced with social conflict asks for more repressive measures, asks for more police, more harassment, personalize the "insecurity" of the lower classes asking for their imprisonment, deportation (in the case of immigrants), or enclosure... it's certain that if they could they would surround the lower neighborhoods with electric fences. All this, acting as if the problem is not the economic inequality of the system, not a social problem created by the structures of capitalism and the state, that the root problem is not private property and social inequality... that while some have 40 homes, others do not even have a roof to live under, that the system does not allow you possibilities, that it condemns you for life. These people ask for more police, more CIES [immigrant detention centers], they say that the main problem is the immigrant youth (for example) and they vote for the extreme right. Therefore, we do not fight for these "democrats,"

for these "free citizens" (or rather such idiots that they believe they are free...), we fight for the kid who has to provide for his family alone, who spends his days on the street searching for food or in the scrap heaps, who is wary when he imagines his future, who lives in secluded rat holes having to rob at gunpoint, for those who live below the poverty line and show themselves violently against this. We fight for those kids who were expelled from their schools or institutions for not adhering to the authoritarian rules of the classroom and the centre, for "getting bored" of authoritarian indoctrination, disrespecting the bourgeois schemas and therefore were punished and expelled. We fight for all of them because they are the only ones who whether unconsciously or not - rebel against the capitalist society, who suffer fascist and police aggressions.

But we do not resign ourselves, and we do not make ourselves victims. We propose the response... faced with all this, we opt for the social threat, for insecurity, for pressure and punishment toward systematic structures, for nighttime arsons, for the internal and asymmetric threat, for FEAR as a form of vengeance on the system and the society that constitutes and supports it. We are in civil war between the system along with the society that supports it against the marginal youth. They imprison, repress, occupy with police... we contest with violence, with insecurity, with social tension, with panic. Violence from below will do nothing but intensify and so they will have to shield they houses, their cars, their banks, their churches. While those from above rob us of life, enclose us, discriminate against us... they will have their fear on stepping into the street, fearing and having to equip themselves with cameras, police, security systems.

While the youth continue to be marginalized and exploited, the middle bourgeois class, the bosses, the cops... will live with fear and terror of those who assault them, rob them, attack them. The streets are ours.

Arm your hands, spit your hatred against the tyrant.

June 11: International Day of Solidarity with Long-Term Anarchist Prisoners

June 11th began as an international day of solidarity with long-term anarchist prisoner Jeff "Free" Luers in 2004. At the time, Jeff was serving 22+ years. Infuriated by the environmental devastation he saw occurring on a global scale, Jeff torched three SUVs at a car dealership in Eugene, Oregon. The sentence imposed on him was meant to send a clear message to others who were angered by capitalism's continued war on the Earth's ecosystems - and to those who were willing to take action to put a stop to it. Jeff is, after all, not alone in his concerns about climate change, fossil fuels, pollution and genetically modified organisms.

After years of struggle, Jeff and his legal team won a reduction in his sentence and he was released from prison in December 2009. But in the years intervening Jeff's arrest and release, the FBI had carried out a series of indictments and arrests in an attempt to devastate the radical environmental and anarchist communities. Two of the people caught up in this maelstrom of repression were **Eric McDavid** and **Marie Mason**.

Eric McDavid was arrested in January 2006 after being entrapped by a paid government informant – "Anna" – and was charged with a single count of conspiracy. Eric – who never carried out any actions and was accused of what amounts to "thought crime" – refused to cooperate with the state and took his case to trial. After a trial fraught with errors, the jury convicted Eric. He was subsequently sentenced to almost 20 years in prison. More information on Eric's case can be found at:

Marie Mason was arrested in March 2008 after her former partner – Frank Ambrose – turned informant for the FBI. Facing a life sentence if she went to trial, Marie accepted a plea bargain in September 2008, admitting her involvement in the burning of an office connected to GMO research and the destruction of a piece of logging equipment. At her sentenc-

ing in February the following year, she received a sentence of almost 22 years. More information on Marie's case can be found at:

Marie Mason and Eric McDavid share the unfortunate distinction of having the longest standing sentences of any environmental prisoners in the United States. This is a time to continue and strengthen the very work for which Eric and Marie are now serving so much time - to struggle against capitalism, ecological devastation, and the ever more diffuse forms of control in this prison society.

CALL OUT FOR SOLIDARITY

Everywhere that there exists dynamic struggle against the state and capitalism, there is some degree of repression. Capitalism knows well how to protect its interests, and it entails targeting and eradicating those who challenge it's dominance. While we continue our daily struggle against this monster, we also fight to make sure our friends and comrades who have been imprisoned by the state aren't forgotten, that their material and emotional needs are taken care of, and that they remain connected to the movements that they have been forcibly yanked away from.

Last year, as one small gesture to address this, June 11th was called as a yearly day of solidarity with two of our longest-imprisoned anarchist comrades. Marie Mason and Eric McDavid. While we realize that many of us don't have spare time or resources to put toward organizing for prisoners who primarily exist in a U.S. context, we hope that their names and stories, as well as the lessons learned from their cases, can become well known everywhere. In our actions and solidarity, we wish to draw connections between Marie's and Eric's cases and those of imprisoned anarchist comrades all over the world who are experiencing firsthand these alarming trends of lengthy sentences and increased repression. This is a preliminary call addressed to all those who fight against this prison society to take action on June 11th, in solidarity with Eric, Marie and all long-term anarchist prisoners.

The cases of Marie and Eric appear fundamentally different at first glance. We choose to connect them in the context of June 11th, not only because of their similar sentences and the fact that they both remained incredibly strong in the face of intense harassment, but also to highlight and analyze the U.S. government's multi-faceted strategy of repression.

Marie Mason was arrested in 2008 after more than 30 years of both above ground and clandestine organizing and action. She has been involved in both environmental and labor struggles, edited many radical publications, and was involved in water rights, antiinfrastructure and anti-logging and development projects in the Midwestern United States. She had already been subjected to years of FBI harassment when she was indicted for a string of Earth Liberation Front (E.L.F.) arsons that had occurred in 1999 and 2000. Her indictment was only possible due to the collaboration her ex-husband, Frank Ambrose, with the FBI. Due to continuing expenses, pressure and threats of a life sentence in prison, she took a non-cooperating plea deal that recommended her for 15-20 years. Citing her actions and her unwillingness to collaborate, the State turned on its word and sentenced her to nearly 23 years. Since being incarcerated, she has suffered health problems and has had many difficulties accessing vegan food, has been harassed and threatened constantly and has been relocated to a prison in Texas, nearly 2000 km away from her family, or, approximately the distance between

Barcelona and Berlin. In the special "medical" unit she is currently held captive in, correspondence with the outside world is extremely controlled; her conditions can be likened to a Communications Management Unit in the U.S. or the FIES units in Spain. Some of her supporters and her family are still attempting to pursue legal means of reducing her sentence, but judicial avenues seem to be thoroughly exhausted at this point.

Eric McDavid, on the other hand, is a young anarchist who was arrested for committing no action except thoughtcrime. In 2005 he was befriended by a young girl named Anna who apparently shared his passion for taking action in defense of the environment. However, "Anna" was actually a government informant, paid over \$65,000 to infiltrate the anarchist and radical environmentalist scenes to entrap people.

Anna heavily pressured Eric and two friends, Lauren and Zachary, to take action, and even went as far as to pay for renting a remote cabin in the woods where they could practice making bombs. The cabin was filled with hidden recording devices and cameras, and was funded by the FBI, who also paid for the transportation, bomb materials and provided bomb recipes. When the government felt that they had gathered enough information, they swooped in and arrested Eric, Lauren and Zach. At this point, no actions had been carried out. Lauren and Zach, under pressure from both the state and their families, collaborated with the government, while Eric remained strong and did not. His case went to trial and he was convicted and sentenced to 20 years in prison. Although jurors in the trial later stated that they didn't understand the case and didn't think the trial was fair, all of Eric's appeals have failed.

These two arrests are just a small part of a broader plan of repression by the U.S. government known by anarchists as "the Green Scare", an allusion to the Red Scare of the 1950's in which communists in the United States were harassed, blacklisted and deported. Eco-anarchists and animal rights activists in the U.S. have faced a similar brand of coordinated harassment since 2001, being named the #1 domestic terrorism

threat in the United States even though their action, through careful planning and consideration, have never harmed humans or animals. In 2005, the government's "operation backfire" plan completely ripped apart the underground E.L.F. movement in the northwest United States, and subsequently Eric, Marie and others have been targeted for two apparent purposes: the first being to completely wipe out the E.L.F. in the United States, and the second being to foster a culture of fear and obedience. The state has unfortunately been quite successful in this task, thanks to tactics such as extensive surveillance. infiltration, and clever uses of laws such as the AETA (Animal Enterprise Terrorism Act, a law that makes it an act of terrorism to cause financial impact on businesses that profit from animal exploitation), as well as laws against organized crime and conspiracy charges.

We don't encourage solidarity on the basis of long-term sentences because we believe in a possibility for a reasonable or fair sentence for any prisoner (though both Marie's and Eric's 20+ year sentences are well in excess of the sentencing guidelines for their so-called crimes.) We focus on the longevity of their sentences because, whatever the circumstances of their arrest, the government is using these lengthy sentences to send a message, and to scare broadening circles of people into compliance and fear. By locking Eric and Marie up for decades, the state wishes to erase them. If, minimally, once a year, our comrades names are shouted from the rooftops and written on the walls, our enemies will have not fully succeeded in this sinister task. Of course we're reminded of the absence of our comrades daily, but we hope that this yearly day of solidarity can be a starting point for keeping them the minds of a greater number of people more regularly.

Last year, events and actions occurred in over 30 cities across the U.S. and internationally. We

were impressed by the expressions of solidarity, from a public noise demonstrations and events across the US to fundraiser dinner shows in Israel, and actions of sabotage from as far away as Russia and Peru. The heyday of the E.L.F. in the United States is over. We're moving into a dynamic period of growing social antagonism, and need to make sure that prisoners such as Marie and Eric aren't left behind or forgotten.

Solidarity for them should not be relegated to prisoner support specialists or those who knew them personally – their absence is of importance to all of us, and support for them should be generalized. The struggle to free Marie, Eric and others is the struggle against the society that not only creates and maintains prisons, but also commits the environmental devastation that Marie and Eric raged against.

To other comrades facing or serving long term imprisonment: we send warm greetings to Eat and Billy, undergoing trial in Indonesia for acts of sabotage; imprisoned members of Conspiracy Cells of Fire and Revolutionary Struggle in Greece; Billy, Costas and Silvia in Swizerland; Tortuga, Freddy, Marcelo and Juan in Chile and all those implicated in the Caso Bombas; All other noncooperating Green Scare defendants in the U.S., some of whom are about to be released: Daniel McGowan, Sadie, Exile, Jonathan Paul and the recently re-captured Justin Solondz. These are just a small sampling of cases, but unfortunately we could go on and on. We have no definition for what "long term" imprisonment could mean - every moment the state steals our loved ones away from us is too long.

Organize an event or action on June 11th, this year and every year. Let's fight together, for the destruction of this prison society and to help remind our comrades they're never alone!

About anarchist comrade Rami Syrianos being in isolation (Greece)

8 May 2012 - Anarchist comrade Rami Syrianos starts a trolley food denial today, demanding his exit from the solitary confinement of Serres' Nigrita Prison, where he is being held since a month and a half ago, awaiting the execution of a disciplinary jail transfer imposed against him. His court is scheduled for May 21. Rami is accused of robbing a state auction house and is being held for over a month (since 26th of March) in solitary confinement of Serres' Nigrita Prison, in the 'cells for the newcomers'. After the latest postponement of his court -for which he was moved the same morning to the courts of Thessaloniki and was turned back the same day to Nigrita Prison- he denied once again the humiliating process of body search [the prisoner is supposed to take off his underwear and cough while bending] and was taken subsequently to the prosecutor the next day, which imposed him the penalty of 'disciplinary jail transfer'.

Our comrade is being isolated from the prison's wings ever-since, in one of the "newcomers' cells". These particular spaces, apart of the name, are not at all different than the typical solitary confinement cells. Spaces made for the ones that arrive to any jail for a first time as well as for those coming back from an 'exit permission'. Isolated from all the common-used spaces, without any yarding (in our comrade's case, he's permitted to have a walk of half an hour in a corridor in order to make one-two phonecalls per day...)

We should note, speaking in their own terms, that the maximum disciplinary isolation penalty that someone could get cannot surpass 10 days... We note this not to denounce just another 'irregularity' of the prison system, which on its own basis consists anyway probably the worst irrationalism of the human existence, but to let one of its largest aspects be shown. Apart of depriving "freedom", the physical restriction, the control and supervision, it's more about flattening

the prisoner's dignity. When all the previous are not enough to achieve this, the system needs to invent other ways...

And while Rami Syrianos remains isolated for over a month, waiting for the prison transfer that is imposed to him, his lawyer was informed today [27/4] through the ministry of justice that the disciplinary decision has not been yet sent to the ministry, obviously not by any mistake, meaning that his 'accommodation' in Nigrita Prison under solitary confinement is being extended.

We would like to remind that our comrade continues the trolley-food denial since 11/4, in solidarity with the hunger strikers of the C.C.F. members as well as with Alexandros Mitrousias, Kostas Sakkas and Giorgos Karagiannidis, as the comrades of C.C.F. keep on striking demanding the final transfer of P.Argyrou and G.Tsakalos from the Domokos' prison [this hungertsrike is now over].

PS: We would like to mention the fact that another prisoner, C.D., was the only one from the whole 2nd wing of the jail that started a trolley-food denial in solidarity with Rami Syrianos' situation, a denial that started since the very first day of Rami's penalty and that is being continued up to now. C.D. denied to enter inside his cell on April 14th, protesting Rami's absence from the common spaces of the prison. He was obliged to spend a night in isolation and threatened to receive a disciplinary penalty as well, a threat that was hopefully not made.

ACTION CHRONOLOGY

An, -as always-, incomplete overview of recent attacks, sabotages, and suppressed news:

1 May - Buenos Airies, Argentina: European Union headquarters bombed. Here is the claim: "To be sincere, we must highlight that the reason why we attacked the European Union diplomatic headquarters was principally to let the Greek comrades on hunger strike and the Italian comrades who have recently suffered raids and arrests know that we are here and that the overwhelming distance separating us will not stop us from feeling complicit in the revolutionary war. But the arrests of the Chilean comrades a few days ago in the context of the Security Bank trial struck us full-on in the jaw, and we therefore couldn't avoid avenging them. This noble gesture of love is directed toward those already mentioned and those we still haven't mentioned. Likewise, it is a call to attention for the capitalists and their mercenaries. Remember that attacks on symbols of POWER will continue to spread. Your cars, police, and banks are going to burn and explode. To the groups and individuals who, like us, have the possibility of struggling from this side of the prison walls, we say that it is necessary to extend the offensive against Power. TO SOW TERROR WITHIN EVERY AUTHORITARIAN HEART. TO SPREAD CHAOS. TO EXTEND AND STRENGTHEN THE INFORMAL ANARCHIST FEDERATION." -Cell of Conspirators for the Spread of Chaos / FAI

- 1 May Bristol, UK: Stones and hammers destroy the windows and ATMs of 3 banks; Lloyds, HSBC and Natwest. 'Money Shop', a high-interest lender/cashier was also smashed, as well as 4 estate agents.
- 2 May Athens, Greece: Themis Skordeli, a neo-fascist political candidate of the extreme-right Golden Dawn organisation has her motorbike burned in her neighbourhood by anti-fascists. The arson occurs during the middle of the day and targets a well-known violent leader of racist patrol attacks.

6 May - Mucia, Spain: ATMs set on fire of various banks, like Banco Santander, known for its role in the arms industry. The names of our dead fighters-comrades were painted on the walls around the city - Patricia Heras, Lambros Foundas, Salvador Puig Antich, Alexis Grigoropoulos, and others.

11 May - Diavata prisons, Greece:

A gathering was carried out by about 50 people outside the female prisons of Diavata, where comrade Olga Economidou is imprisoned. Then they moved to the front of the mens prisons where comrades Sokratis Tzifkas, Vaggelis Chrisohoidis and Polycarpos Georgiadis are imprisoned.

11 May - Concepción, Chile: Banco Itau is bombed at 1am downtown by Illegal Cell Daniel Riquelme Ruiz - Informal Anarchist Federation / International Revolutionary Front. Extract from the claim: "On this foggy May night, compañero Mauricio Morales Duarte was there, in our hands and in the roar that ran through the streets of Concepción.

Strength, Tortuga! FOR TOTAL LIBERA-TION"

15 May - La Paz, Bolivia : Anarchist Cell for Revolutionary Solidarity

FAI/FRI Bolivia took responsibility for a dynamite attack against a Renault dealership. Extract from the claim: "With this action we want to send a warm and fraternal greeting to the compañerxs members of the R.O. CCF: Christos and Gerasimos Tsakalos, Paniagotis Agirou, Haris Hadzmihelakis, Damiano Bolano, Giorgos Polydoros, Giorgos and Mihalis Nikolopoulos, Olga Ikonomidou and the anarchists Theofilos Mavropoulos and Rami Siriano imprisoned in the prisons of Greece. Strength also to the compañera Stella Antoniou! We do not forget to greet the comrade Luciano Pitronello and the rebels in Peru, Chile, Indonesia, Cataluña and Italy."

? May, Cochabamba, Bolivia : Autonomous Fraction of Rebel Thieves / FAI-IRF take responsibility for burning ATMs.

? May, Milwaukee, USA: 2 banks smashed in solidarity with injured anarchist cub Luciano Tortuga in Chile, who is due to start his trial soon for his bomb attempt against Santander Bank in Santiago. **Network of Wisconsin Snapper Turtles** claimed the action.

Solidarity actions requested for anarchist hostage David Lamarte (Uruguay)

On the 10th of May, our brother, friend and compañero David Lamarte was imprisoned.

David is being processed by the courts, and faces a sentence that ranges from 3 months to 3 years, though this has not yet been determined. They are accusing him of having broken some taxi metres on May 1st, during a working class action that opposed the official union, who are basically on the side of the government. David is a friend and anarchist who has been in struggle with us for over 15 years, from his participation as an adolescent in the old Anarko Punk Resistence, to the picket lines of the Sindicato Unico de Automovil con Taximetros y Telefonistas (SUATT - Automobile, Taximetres and Telephone Operators Trade Union), and currently, within various anarchist collectives.

The SUATT, formerly the SUA, was the union stronghold for direct action, which maintained the old *Federacion Obrera Regional Uruguaya* (Regional Uruguayen Labour Federation) throughout the 20th century.

Today, it is one of the most combative unions in the country, who must also fight against the arrogance of mafia bosses and constant police harassment. We are asking comrades to pass this information on as far and wide as possible. Any and all expression of solidarity are appropriate.
