# **Cable Operators Can** Now File Section 111 **Statements of Account Electronically**

The U.S. Copyright Office is pleased to announce that beginning with the January 1 to June 30, 2017, accounting period (2017/1), cable systems operating under the section 111 statutory license for secondary transmissions of broadcast programming will be able to sign and submit these documents to the Licensing Division electronically. In addition to being more efficient, electronic submissions are less expensive for licensees. Details of this new process, including access to the electronic short- and long-term Statement of Account forms, are available on the division's *website*. With a focus on digitizing section 111 cable statement of account (SOA) records, this project will make PDF files accessible to patrons and staff on computer terminals in the Copyright Records Reading Room, located in the Madison Building of the Library of Congress. The interns had the chance to learn all stages of the project from preparing, scanning, and converting documents to quality control to inputting metadata and coding files in Dreamweaver. Each step is an important part in developing the directory and, ultimately, providing a beneficial experience to its users.

It has been a rewarding opportunity for the interns as well. Working at the Copyright Office and taking part in this project is a chance to expand their skills in an office environment and start pursuing future goals. #### Did you know?

The Licensing Division of the U.S. Copyright Office was established in 1978 and helps administer seven licenses provided for in the Copyright Act of 1976 and subsequent amendments. They include:

- Statutory license for secondary transmissions by cable systems (*section 111*)
- Statutory license for making of ephemeral recordings (*section 112*)
- Statutory license for public performance of sound recordings by means of digital audio transmission (*section 114*)
- Compulsory license for making and distributing of phonorecords (*section 115*)
- Statutory license for secondary transmission of distant television programming by satellite carriers (*section 119*)
- Statutory license for secondary transmissions of local television programming by satellite characters (*section 122*)
- Statutory obligation for distribution of digital audio recording devices and media (*section 1003*)

## **Important Reminders**

**SATELLITE:** The **\$725 filing fee per statement** in addition to the appropriate royalty fee is to be filed between **January 1 and January 30**, inclusive.\*

**CABLE:** The **filing fee (\$15 for each SA-1, \$20 for each SA-2,** or **\$725 for each SA-3) per statement** in addition to the appropriate royalty fee is to be filed between **July 1 and August 29**, inclusive.\*

\* Please remit the royalty fee and filing fee in one EFT payment.
