Dear Department of Environment, Land, Water and Planning Staff (DELWP),

URGENT: "Pending/taped out" logging coupe 833-510-0011 within rainforest areas and without minimum assessments for rare, threatened or protected species values

- 1. The commencement of logging is believed to be imminent or underway within VicForests logging coupe 833-510-0011 off Round Top track in the Purgagoolah Forest Block of East Gippsland (**the Purgagoolah coupe**). This coupe is listed as "harvest pending" on VicForests "timber Harvesting Safety Zone List" (http://www.vicforests.com.au/timber-harvesting-safety-zones, accessed 22/11/16) and coupe boundary tapes have been placed within this forest area including at the locations displayed below.
- 2. This coupe has not been subject to any pre-logging threatened species surveys according to analysis of VicForests' published contracted survey results published at http://www.vicforests.com.au/planning-1/protecting-biodiversity/targeted-species-surveys.
- 3. As a result, the planned logging within the Purgagoolah coupe is about to occur without any pre-logging targeted threatened species surveys having been undertaken to determine the extent of the threat of serious and/or irreversible damage posed by VicForests logging operations in the Purgagoolah coupe.

<u>Summary of observations regarding rare, threatened and/or protected species found within coupe</u> 833-510-0011

4. During a preliminary investigation of conservation values within coupe 833-510-0011 from Sunday 20 to Monday 21 November the biodiversity conservation values listed in Table 1. and shown in Figure 1. (map) below were encountered.

VicForests Failure to apply the Precautionary Principle in breach of 2.2.2.2 of the Code

- 5. VicForests has not undertaken any threatened species surveys in the Purgagoolah coupe, despite this forest been good quality habitat for a number of identified rare, threatened and/or protected species such as Yellow Bellied Gliders, Frog species, Spiny Crayfish species, rainforest and rare rainforest species and likely good quality habitat for other rare, threatened or protected species.
- 6. Sections of the Victorian Biodiversity Atlas (inc. VBA_FAUNA25-100, VBA_FLORA25-100 and VBA_FAUNA_GRID_1M) show that the following 30 rare, threatened and/or protected species have been recorded within approximately 5km of the Purgagoolah coupe:

- 7. Logging in the Purgagoolah coupe (833-510-0011) without undertaking threatened species surveys breaches VicForests legal obligations to comply with the precautionary principle including sections 2.2.2.2 and 2.2.2.4 of the *Code of Practice for Timber Production 2014* (*the Code*).
 - "2.2.2.2 The **precautionary principle** must be applied to the conservation of biodiversity values. The application of the precautionary principle will be consistent with relevant monitoring and research that has improved the understanding of the effects of forest management on forest ecology and conservation values. ...
 - 2.2.2.4 During planning identify biodiversity values listed in the Management Standards and Procedures prior to roading, harvesting, tending and regeneration. Address risks to these values through management actions consistent with the Management Standards and Procedures such as appropriate location of coupe infrastructure, buffers, exclusion areas, modified harvest timing, modified silvicultural techniques or retention of specific structural attributes."
- 8. *The Code* defines the precautionary principle as:

"'precautionary principle' means when contemplating decisions that will affect the environment, careful evaluation of management options be undertaken to wherever practical avoid serious or irreversible damage to the environment; and to properly assess the risk-weighted consequences of various options. When dealing with threats of serious or irreversible environmental damage, lack of full scientific certainty should not be used as a reason for postponing measures to prevent environmental degradation."


- 9. Logging in the Purgagoolah coupe without conducting pre logging threatened species surveys constitutes a threat of serious or irreversible environmental damage and there is a lack of full scientific certainty relating to that damage. Specifically, it is probable that there is a significant threat to the identified rare, threatened and/or protected species such as Yellow Bellied Gliders, Frog species, Spiny Crayfish species.
- 10. The observed and likely presence of protected species such as those listed above and the threat of serious or irreversible damage and the lack of scientific certainty relating to that damage trigger the pre-conditions for the application of the precautionary principle.
- 11. The principles upheld in the *Brown Mountain (EEG v VicForests)* Victorian Supreme Court judgement (VSC 8547) similarly apply to the circumstances discussed within this letter such that application of the precautionary principle requires the completion of targeted species surveys, including for the identified rare, threatened and/or protected species such as Yellow Bellied Gliders, Frog species, Spiny Crayfish species and the other species listed above prior to logging¹.
- 12. VicForests failure to conduct pre logging targeted species surveys prior to the commencement of logging in the Purgagoolah coupe will constitute a breach of 2.2.2.2 and 2.2.2.4 of *The Code* and Section 46 of the *Sustainable Forests (Timber) Act* 2004 (Vic) and will be unlawful.
- 13. As DELWP are responsible for enforcing VicForests compliance with *the Code*, as stated in 1.2.6 of *the Code* (reproduced below), action must be taken immediately to prevent the breaches of *the Code* detailed above from occurring.

"1.2.6 Compliance on State forest

The Code is a prescribed legislative instrument made and enforced under relevant law listed in the Conservation, Forests and Lands Act 1987. For the purposes of each relevant law the **Secretary** is an **authorised officer** and is therefore responsible for ensuring compliance with the Code on State forest. Compliance is also monitored by other authorised officers appointed by the Secretary pursuant to the Conservation, Forests and Lands Act 1987."²

Coupe demarcation tapes indicating imminent logging of rainforest and rainforest buffers

- 14. Coupe demarcation tapes have been recorded at times within and elsewhere within very close proximity to Warm Temperate Rainforest that is greater than 0.4 hectares in area at the location listed in the table above and shown in the map of Figure 1. below. Logging activities undertaken to the extent of these tapes will breach section 2.2.2.7 *the Code*.
- 15. Warm Temperate Rainforest communities in East Gippsland "must not be harvested"³ and rainforest areas greater than 0.4 hectares must be provided a 40m buffer.⁴
- 16. Additional areas of Warm Temperate Rainforest vegetation observed within and adjacent to the Purgagoolah coupe beyond those shown in the attached map may also have coupe demarcation tapes within the required 40m buffer.





Actions required to be taken by DELWP to prevent further breaches of the Code

- 17. DELWP must ensure that VicForests apply the precautionary principle at all times during their operations. This can be achieved in part by DELWP issuing a direction to VicForests to not commence or continue logging in the Purgagoolah coupe unless appropriately designed and undertaken surveys for protected species have been undertaken and all appropriate responsive management actions have been fully implemented at least to the minimum standards required by the regulatory framework.
- 18. To this end, DELWP should immediately issue a directive to VicForests to not commence or to halt logging in the Purgagoolah coupe until appropriate surveys have been conducted.
- 19. Logging in the Purgagoolah coupe without conducting appropriately designed and undertaken surveys for threatened and protected species is or will be undertaken in breach of sections 2.2.2.2 to 2.2.2.4 of *the Code*.
- 20. DELWP should investigate plans to log and/or the logging of coupe 874-507-0020 for non compliance with *the Code* with regard to the issues outlined above including VicForests plans to log up to and in to a Warm Temperate Rainforest community without providing a mandatory 40m buffer as discussed and shown in the map of Figure 1. above. DELWP must fully investigate, prevent and prosecute VicForests for any and all breaches of the regulatory framework governing logging operations in Victoria's State Forests.
- 21. Please inform me what steps DELWP will take to prevent unlawful logging in the Purgagoolah coupe. As the Purgagoolah coupe will soon be or is currently been logged this matter requires your urgent attention.
- 22. Thank you, I look forward to your response as soon as possible and to hearing that DELWP will restrain VicForests from logging in any coupes that have not been subject to appropriate threatened species surveys and where appropriate responsive management actions meeting at least the minimum standards required by the regulatory framework have not been implemented.
