They planned to claim responsibility for these actions on behalf of the Earth Liberation Front (ELF). All three subjects were indicted by a federal grand jury on 1/25/2006 for violating 18 USC 844n. A Sacramento, California anarchist prisoner support group, which maintains contact with McDavid and posted their contact information on the internet. As a result, they have received numerous letters similar to the enclosed from individuals and groups throughout the United States and Europe.

On 5/16/2006, writer received a copy of the enclosed postcard from the Sacramento County Main Jail. The return address reads: \_\_\_\_\_\_\_ - P/O Box (illegible) East Brunswick, 3057, Victoria, Australia. The PO Box number is partially cut off on the photocopy. Verbatim text from the post card is set forth below:

Hi there Eric,

My name is \_\_\_\_\_, I am part of a group who gets together every now and then to write to prisoners that we support. V. Sorry to here that you are inside. I am a nursing and midwifery student who is interested in working in indigenous health. There are many problems and issues in Indigenous health in this country as I am sure there would be in yours. It's coming to winter here. Not looking forward to it. Already everybody has colds. However, it has to be done if I am to finish this course. Really hope this card finds you well. Hope you like the picture of this very dry country I live in. Feel free to write me at the address above. Solidarity, \_\_\_\_.

Text ends.

ACS checks on the name and partial address were negative.
